His Honour was pleased, in Her Majesty's name, to give assent to these Bills.

The same was announced, by the Clerk of the House, in the following words:—

"In Her Majesty's name, His Honour the Lieutenant-Governor doth assent to these Bills."

Then the Honourable the Speaker addressed His Honour the Lieutenant-Governor, as follows:—

MAY IT PLEASE YOUR HONOUR:

We, Her Majesty's most dutiful and loyal subjects, the Legislative Assembly of the Province of British Columbia, in Session assembled, approach Your Honour, at the close of our labours, with sentiments of unfeigned devotion and loyalty to Her Majesty's person and Government, and humbly beg to present for Your Honour's acceptance, a Bill intituled "An Act for granting certain sums of Money for the Public Service of the Province of British Columbia."

To this Bill the Clerk of the Legislative Assembly, by His Honour's command, did thereupon say:—

"In Her Majesty's name, His Honour the Lieutenant-Governor doth thank Her Majesty's loyal subjects, accept their benevolence, and assent to this Bill."

Then His Honour the Lieutenant-Governor was pleased to deliver the following Speech:—

Mr. Speaker,— Gentlemen of the Legislative Assembly,—

I am glad to find that, during the Session of the Legislature now closing, you have shown that you realize the changed condition and improved prospects of the Province, and that your labours have been largely devoted to the consideration of measures having in view the furtherance of settlement and the establishment of new and the extension of old industrics.

The settlement arranged between the Dominion and Provincial Governments, and embodied in an Act passed by you, will be fully consummated when the confirmatory measure introduced by the Premier of Canada into the House of Commons at Ottawa shall have been ratified by the Parliament there. The benefits likely to accrue from the settlement of the long

pending disputes between the Dominion and the Province, and the re-establishment of satisfactory relations, with the concomitant advantages of Island Railway construction, the opening to settlement of the Railway Lands, and the completion of the Dry Dock, can not easily be over-estimated.

The Session has been marked by more than usually important legislation. The Land Act, which it has been my pleasure to approve, is, I think, calculated to promote settlement and prevent the acquisition of large areas of Crown Lands for merely speculative purposes.

The object of the Bills on the Chinese question which you have passed, and of the address which I have forwarded to His Excellency the Governor-General in Council, is undoubtedly good.

The new Mineral Act, I trust, will have the effect intended, of fostering the important

mining industries of the Province.

The Timber Act is important, and it is to be hoped that it will operate so as to protect our valuable forests from spoliation and be productive of revenue, while not in the least degree interfering prejudicially with the extensive lumber industry of the country.

I am glad to find that you have made liberal provision for Public Works in the various districts. The greatest care will be exercised in expenditure, with a view to obtain results

calculated to advance the general interests.

It is gratifying that immigrants in considerable numbers continue to seek homes in our favoured Province. It will be necessary to take immediate and active steps to open up new sections of country for settlement purposes, to meet as far as possible the tide of immigration which is setting in upon our shores.

In relieving you from further attendance upon your duties, I sincerely hope that our anticipations of prosperity may be fully realized, and that you may have the satisfaction of knowing that your patriotic efforts to promote the general welfare of the country have been

successful,

The Honourable Mr. Robson, Provincial Secretary, then said,—

Mr. Speaker and Gentlemen of the Legislative Assembly:
