And be it further Resolved, That a humble Address be presented to His Honour the Lieutenant-Governor in Council, praying that the necessary regulations may be promulgated for the purpose of bringing into force the said daylight saving throughout this Province in accordance with the provisions of the said Act, and that copies of this Resolution and the preamble thereto be forwarded to the Honourable the Clerk of the Executive Council and other proper officials of the Provincial Government.

The Hon. Mr. Lougheed presented to Mr. Speaker a Message from His Honour the Lieutenant-Governor, which read as follows:—

J. W. FORDHAM JOHNSON,

Lieutenant-Governor.

The Lieutenant-Governor transmits herewith a Bill intituled "An Act to amend the 'Coal and Petroleum Act,'" and recommends the same to the Legislative Assembly.

Government House, March 22nd, 1932.

Ordered, That the said Message, and the Bill accompanying the same, be referred to a Committee of the Whole House forthwith.

(IN THE COMMITTEE.)

Resolved, That the Committee rise and report to the House, recommending the introduction of a Bill (No. 37) initialed "An Act to amend the 'Coal and Petroleum Act,' " a draft of which is annexed to this Resolution.

Resolution and Bill reported. Report adopted. Bill introduced and read a first time. Second reading at the next sitting.

On the Order being called for the second reading of Bill (No. 28) initialed "An Act respecting Chiropractors," Mr. Speaker delivered the following decision:— Honourable Members:

In connection with Bill No. 28 ("An Act respecting Chiropractors") I have to point out to the House a number of irregularities.

Sections 4, 5, and 7 of the Bill confer certain powers upon the Crown which cannot be made the subject of legislation by a private member without the consent of the Crown being obtained. These sections place certain machinery in the hands of the Provincial Secretary and the Lieutenant-Governor in Council, the effect of which is to constitute the Government the moving force in bringing the British Columbia Chiropractors' Association into being, and also casts upon the Government a supervision concerning certain future operations of said association. These provisions violate the parliamentary rule that a private member may not interfere with, control, or dictate the activities of the Crown by conferring powers upon it. Private members cannot take away from the constitutional advisers of the Lieutenant-Governor the initiative in introducing measures affecting the Executive Government and the prerogatives of the Crown. (See in this connection the decision of Mr. Speaker Marchand, Desjardins' Speakers' Decisions (Quebec), p. 383, March 24th, 1890; also decisions in Vol. 1, B.C. Speakers' Decisions, indexed under heading "Government Policy.") The consent of the Crown must, therefore, be obtained before legislation of this nature can become law.

Section 13 of the Bill is subject to the same objection, as it imposes fines and imprisonment penalties which can only be done with the consent of the Crown. (See decision of Mr. Speaker Anglin in the Canadian House of Commons Journals, Vol. 10, p. 119; and my own decision of last Session, recorded at pp. 128 and 129 of the Journals of this House, 1931.)

Section 14 is irregular in that it provides that fines recovered under the Bill shall be paid to the Board of Chiropractors. This is an interference with the revenues of the Crown and must be first recommended by a Message from His Honour the Lieutenant-Governor, not perhaps necessarily under the sign-manual, but, in any event, by the formal declaration of the authorized Minister from his seat recommending the matter to the consideration of the House. (See the decision of Mr. Speaker Trimble at p. 48 of the Journals of this House for 1877; and the decision of Mr. Speaker Turcotte in Desjardins' Speakers' Decisions (Quebec), pp. 125, 127, May 20th, 1881.)

Section 16 provides that persons belonging to the Chiropractors' Association shall be exempt from jury service. If a private member could initiate legislation of this kind, every class of persons within the Province could be similarly exempted. Such matters lie within the constitutional prerogative of the Crown and must receive its consent.

Section 21 interferes with the duties of a Crown official and obviously is a usurpation of the Crown's prerogative.

All the above sections, with the exception of section 14, can be made regular by a submission to the House of a formal consent by the Crown at any time before the third reading of the Bill. But, if not obtained, constitutional procedure will prevent the Speaker from putting the motion for third reading to the House. (*See* decision of Mr. Speaker Wurtele in Desjardins' Speakers' Decisions (Quebec), p. 231, April 30th, 1885.)

With regard to section 14, as this interferes with the revenues of the Crown, it must, as above intimated, be preceded by Royal Message, and I must accordingly rule it out of order forthwith.

C. F. DAVIE, Speaker.

On the Order being called for the second reading of Bill (No. 29) intituled "An Act respecting Drugless Physicians," Mr. Speaker delivered the following decision:—

Honourable Members:

Bill No. 29 ("An Act respecting Drugless Physicians") is also open to some of the above objections.

Sections 4, 5, and 9, for the reasons before mentioned, require the consent of the Crown.

Section 13 likewise, in my view, requires Royal consent. The "Summary Convictions Act" contains machinery for imprisoning convicted persons who have not paid fines. The decision to impose a prison sentence upon citizens of the country is a constitutional responsibility falling upon the Government, to be exercised by it after mature consideration concerning the liberties of the subject. Such a matter, in my view, is essentially one of Crown prerogative in accordance with the principles underlying responsible government, and not one which should be left to the mere whim of a body of private citizens clothed with no authority responsible to the people.

The House resumed the adjourned debate on the second reading of Bill (No. 27) initialed "An Act to confer certain Powers upon the Lieutenant-Governor in Council relating to the Business of Insurance."

Bill read a second time.

To be committed at the next sitting.

On the Order being called for the second reading of Bill (No. 30) intituled "An Act to amend the 'Amusements Tax Act,' "Mr. Speaker delivered the following decision:---

Honourable Members:

On the motion for second reading of Bill (No. 30) intituled "An Act to amend the Amusements Tax Act," the honourable and learned member for Omineca raised an objection against the discussion of the merits of the Bill by the Honourable the Minister of Finance on the grounds that the matter of the amusements tax had been brought forward in the Budget Speech, and that if, during the debate thereon, another debate on the amusements tax itself were raised, the House would be confronted with a dual debate upon one subject.

The point raised by the honourable and learned member is of considerable importance in connection with the business of the House, and falls under the term of "blocking." It is a fundamental rule of parliamentary practice that a question already ordered for consideration by the House may not be anticipated by a motion (May, 272) or by a debate (May, 307). The effect of this rule of procedure is that the introduction of a Bill will block discussion upon a motion (whether previous or not) involving the same subject-matter. The abuse to which this practice lends itself became the subject of a debate in the British Commons on March 27th, 1907, and, after attention had been drawn to the injustices of the procedure, the House passed the following resolution: "That to put a motion on the Order Paper of this House, or to introduce a Bill, so as to prevent discussion in this House of motions for which procedure has been obtained in the ballot, or of definite matters of urgent public importance, is hurtful to the usefulness of this House and an infringement of the rights of its members" (171 Parl. Deb. 4s., pp. 1883 to 1891). However, no sessional or Standing Order was passed to cover the matter, and later on in the Session the matter again came up (176 Parl. Deb. 4s., 631). Sir Henry Campbell Bannerman asked the Speaker whether the effect of the presentation of a Bill of which notice had been given would prevent discussion of a motion which stood in his name. The Speaker replied: "Reluctantly, I feel compelled to answer that question in the affirmative. The rule against anticipation is well known, and I cannot discriminate between Resolutions put down by the Government and Resolutions put down by a private member. The right honourable gentleman will, I have no doubt, remember an occasion before Easter when something of the same sort occurred. A Bill was given notice of with the view of preventing a Resolution being taken. On that occasion I was obliged to hold that the fact that notice had been given of a Bill prevented the Resolution coming on. I may add this: that the rule, however good it was originally, is liable to be stretched, and may become a considerable abuse."

With reference to the point of order raised for my decision, I find, on referring to the Votes and Proceedings, that the "Amusements Tax Act" was introduced into the House on March 17th, and that the Estimates, upon which the Budget Speech was founded, were presented to the House one day earlier—namely, on March 16th—and there appears therein an item of estimated revenue derivable from the amusement-tickets tax amounting to \$375,000.

I am accordingly obliged to rule that the effect of introducing the "Amusements Tax Act" will be to prevent discussion on the amusements tax during the Budget or any other debate other than in debate on second reading of the "Amusements Tax Act."

In order to remedy this situation in so far as Tax Bills are concerned, it would be a convenient practice in the future if the Finance Minister would delay introducing taxation legislation until after the conclusion of the Budget debate.
