### Thursday, 16th January, 1913.

THREE O'CLOCK P.M.

This being the first day of the first meeting of the Thirteenth Parliament or Legislative Assembly of the Province of British Columbia, for the dispatch of business, pursuant to a Proclamation of His Honour Thomas Wilson Paterson, Lieutenant-Governor of the Province, dated the 27th day of February, 1912, the Members having been sworn took their seats.

His Honour Thomas Wilson Paterson, Lieutenant-Governor of the Province, having entered the House, took his seat on the Throne.

The Honourable Dr. Young, Provincial Secretary, said:—

Gentlemen of the Legislative Assembly:

I am commanded by His Honour the Lieutenant-Governor to announce that His Honour does not see fit to declare the causes of his summoning you at this time, and will not do so until you have chosen a Speaker to preside over your Honourable Body. His Honour hopes to be enabled to declare, during the afternoon, his reasons for calling you together.

His Honour was then pleased to retire.

Mr. A. H. B. Macgowan, the fourth Member for Vancouver District, moved, seconded by Mr. R. H. Pooley, Member for Esquimalt District, that D. M. Eberts, Esquire, Member for Saanich District, do take the Speaker's Chair, and preside over the meeting of this Assembly, and it was so Resolved.

Thornton Fell, Esquire, K.C., the Clerk of the House, having declared David MacEwen Eberts, Esquire, duly elected, he was taken out of his place by the mover and seconder, and conducted to the Chair, where, standing on the upper step, he

expressed his grateful thanks to the House for the great honour they had been pleased to confer upon him by choosing him to be their Speaker.

And thereupon he sat down in the Chair, and the Mace was laid upon the table.

His Honour the Lieutenant-Governor again entered the House, and taking his seat on the Throne, the Speaker-elect then spoke to the following effect:—

MAY IT PLEASE YOUR HONOUR:

The House of Assembly have elected me as their Speaker, though I am but little able to fulfil the important duties thus assigned to me.

If, in the performance of those duties, I should at any time fall into error, I pray that the fault may be imputed to me, and not to the Assembly, whose servant I am, and who, through me, the better to enable them to discharge their duty to their King and country, humbly claim all their undoubted rights and privileges, especially that they may have freedom of speech in their debates, access to Your Honour's person at all seasonable times, and that their proceedings may receive from Your Honour the most favourable interpretation.

The Honourable Dr. Young then said:-

Mr. Speaker:

I am commanded by His Honour the Lieutenant-Governor to declare to you that he freely confides in the duty and attachment of the House of Assembly to His Majesty's person and Government, and not doubting that their proceedings will be conducted with wisdom, temper, and prudence, he grants, and upon all occasions will recognize and allow, their constitutional privileges.

I am commanded also to assure you that the Assembly shall have ready access to His Honour upon all seasonable occasions, and their proceedings, as well as your words and actions, will constantly receive from him the most favourable construction.

His Honour the Lieutenant-Governor was then pleased to open the Session by the following gracious Speech:—

Mr. Speaker and Gentlemen of the Legislative Assembly:

In welcoming you to the First Session of the Thirteenth Parliament of British Columbia, it affords me pleasure to recall that during the past year the Province was honoured by a visit from His Royal Highness the Governor-General, accompanied by Their Royal Highnesses the Duchess of Connaught and the Princess Patricia. The cordial welcome they received, together with the interest they evinced in the Province, must be regarded with much gratification by the people of British Columbia.

In assuming your duties, you will find that during the year the Province has enjoyed an exceptional degree of prosperity. The influx of immigration and settlers has also been unprecedented.

The financial condition of the Province continues most satisfactory, the surplus and revenue enabling the continuance of expenditure necessary for the growing needs of the country.

The honours which have been won by British Columbia fruit and agricultural products in former years on this Continent and in Great Britain have been augmented by the success attained by similar exhibits during 1912.

It is interesting to note that the results of the mining industry have greatly surpassed those of any similar period in the history of the Province.

The extension of railway-construction, due to the aid given by the Province, has been most marked. The plans of these various lines are being substantially carried out, and the completion of the works involved may be expected well within the time set by law. A Bill will be laid before you furthering the arrangements in respect to the completion of the Canadian Northern Pacific Railway system.

Owing to the increase in the work of the Department of Finance, a measure will be submitted for your approval with a view to forwarding the efficiency of the

Auditing Branch of the Department.

You will also be asked to consider amendments to the "Land Act," made necessary by the development of that branch of the Public Service.

By reason of the increased work which has fallen on the Judiciary, you will be asked to provide for legislation authorizing the appointment of an additional member to the Court of Appeal, as well as one to the Supreme Court, and also for another Junior County Court Judge for the County of Vancouver.

Following the completion of the work of the Royal Commission on Taxation, it is proposed to introduce legislation giving effect to various changes in the

"Taxation Act."

The plans for the Provincial University Buildings at Point Grey have been adopted, and, in furtherance of the establishment of this institution, you will be asked to set aside an additional grant of land for University purposes.

The work of the Municipal Commission has been completed, and it is hoped that the result of the investigation may be presented to you during the present

Session.

An inquiry into the conditions of labour throughout the Province is now in progress, and the information gathered will be placed before the House as soon as available.

The Commission on Agriculture is pursuing its investigations in order to ascertain the best methods of encouraging that industry and of securing increased settlement of the agricultural lands of the Province.

The Report of a Special Commission to investigate general conditions in the dairy industry has been completed and will be duly presented to you.

Owing to complaints with reference to the Doukhobor Settlements in the Province, an inquiry has been held under the authority of a Royal Commission. The evidence and findings will be placed in your hands.

I am pleased to inform you that, as a result of the representations made to the Federal authorities, an investigation will shortly be authorized to inquire into the financial relations between the Dominion and the Province.

The Dominion Government has concurred in the appointment of a Commission for the purpose of adjusting the questions concerning Indian Reserve lands that have arisen between the Dominion and the Province.

The development of Strathcona Park is progressing satisfactorily, and, mindful of the great value of conserving the magnificent scenic beauties of the Province as a source of attraction to the outside world, as well as for the benefit of our own people, my Government is considering the setting aside of areas at Mount Robson, as well as aiding in the improvement of a park at Kaien Island.

An earnest endeavour has been made to arrange for the most efficient utilization of the former Songhees Reserve, and an agreement has been reached whereby a portion of the land is set aside for railway terminals, while the remainder will be dealt with in the best interests of the public.

The increasing importance of the Agent-General's Office in London and the necessity for more commodious quarters there have resulted in steps being taken towards securing a building in keeping with the needs of the Province. Negotiations to this end are now in progress.

Owing to the approach of the time when the Panama Canal will be completed, it is desirable that the interests of British Columbia should not be overlooked. I am sure that you will gladly support any efforts that may be made by the Federal Government towards securing adequate recognition of all rights to which Canadian shipping may be entitled.

With a view of bringing about an early settlement of various departmental matters pending between the Province and the Dominion, the First Minister and the Attorney-General visited Ottawa some weeks ago. They were enabled, as a result of their conferences with the Dominion Government, to effect the adjustment of many long-outstanding questions.

The Public Accounts for the fiscal year will be laid before you early in the Session.

The Estimates of Expenditure will also be submitted for your consideration. In leaving you to your deliberations, I have every confidence that you will be guided by the desire to promote the welfare and prosperity of the Province.

His Honour the Lieutenant-Governor was then pleased to retire.

Prayers by the Right Rev. Lord Bishop of Columbia.

Mr. Speaker reported that, to prevent mistakes, he had obtained a copy of His Honour's Speech.

which said Committees shall severally be empowered to examine and inquire into all such matters and things as shall be referred to them by the House, and to report from time to time their observations and opinions thereon, with power to send for papers, persons, and records.

Resolved, That if it shall appear that any person hath been elected or returned a Member of this House, or endeavoured so to be, by bribery or other corrupt practices, this House will proceed with the utmost severity against all such persons as shall have been wilfully concerned in such bribery or other corrupt practices.

On the motion of the Hon. Mr. Bowser, Bill (No. 1) intituled "An Act to amend the 'County Courts Act'" was introduced and read a first time.

#### REPORT No. 2.

LEGISLATIVE COMMITTEE ROOM, 22nd January, 1913.

Mr. SPEAKER:
