 - 4. If so, was same rented to said company or sold?
 - 5. If rented, the amount charged?
 - 6. If sold, the amount for which it was sold, the dates of payment, and the balance still due? The Hon. Mr. Barrow replied as follows:—
 - "1. Yes.
 - "2. One Class 24 Bucyrus drag-line excavator (100-foot boom) fully equipped; cost \$45,000.
 - "3. Used by the Marsh Construction Co., Ltd.
 - "4. Sold under conditional sale agreement,
 - "5. Auswered by No. 4.
- "6. \$45,000, together with interest at the rate of 7½ per cent. per annum, under the following terms: In twenty consecutive equal monthly payments of \$2,350 each, the first payment to be made on the 6th day of January, 1921, and payments thereafter to be made on the 6th day of each and every month until the said twenty-four payments of \$2,350 each are fully paid and satisfied; and a further payment of \$2,031.55 on the 6th day of September, 1922; the machinery and equipment to remain the property of the Board until the payments are completed. Balance still due, \$40,300."

Mr. Jones asked the Hon. the Minister of Agriculture the following questions:-

- 1. What was the total acreage of land purchased by the Government in the Merville Settlement and at Creston Settlement?
 - 2. What acreage has been cleared and ready for crop at Merville, also Creston?
 - 3. What sum of money has been expended on clearing at each settlement?
- 4. How many lots have been sold and what is the total acreage sold at Merville, also at Creston?
 - 5. How many settlers have houses built on their lots at each settlement?
 - 6. What amount was realized from acreage sold at each settlement?
 - 7. On what terms was the land sold?
 - 8. Is the Government carrying on clearing operations at present in either settlement?

The Hon. Mr. Barrow replied as follows:-

- "1. Total acreage purchased at Merville, 13,660.09; Creston, 5,936.05.
- "2. At Merville 867.08 acres have been cleared and 300.3 acres have been partially cleared. At Creston 285½ acres have been cleared and 38 acres have been partially cleared.

- "3. Amount spent on clearing at Merville to June 1st, 1920. \$176.514.26. Since that time clearing operations have been carried on by the settlers under the progress-loan system. Amount spent on clearing at Creston to December 31st, 1920, \$84,450.04.
- "4. Fifty lots have been sold at Merville, comprising 2,796,706 acres. The agreements for sale have been duly signed. In addition there are seventy allotment-holders whose agreements are at present being completed. At Creston no lots have actually been sold, as the agreements are under discussion. The number of allotment-holders at December 31st, 1920, were seventy-six, comprising 1,558.99 acres. There are six men awaiting allotments.
- "5. At Merville thirty-eight settlers have permanent farm-houses on their lots; three settlers have temporary houses. In addition there are forty-seven shacks, thirty-one sheds, seven temporary barns, and three permanent barns. At Creston there are thirty-three permanent farm-houses. Constructed to December 31st, 1920, 18; under construction to December 31st, 1920, 15. Those settlers not having permanent houses are housed in temporary quarters.
- "6. At Merville the total amount realizable on the fifty completed agreements above mentioned is \$67,183.80, less forty-eight rebates of \$500 each. A nominal amount, \$84 only, has been paid in, as the payments do not fall due until October, 1922. At Creston, none. (See answer No. 4.)
- "7. Land sold under agreement for sale. First payments fall due in October, 1922; interest commences to run from October, 1921. Time, up to twenty-five years, at the settler's option.
- "8. At Merville no clearing has been done by the Board since June 1st, 1920. Settlers since that date have been working under the progress-loan system. At Creston rough clearing, blasting, and pick-up being carried on. Grubbing and ploughing, when weather breaks up, by large Holt tractor. The Board is completing the first 5 acres on each allotment."

Mr. Esling asked the Hon. the Minister of Mines the following questions:-

- 1. Did one C. P. Williams and Francis Percy do certain work for the Government under the provisions of the "Mineral Survey and Development Act"?
- 2. If so, what was the nature of the work done by each, and during what periods did they work?
 - 3. What amount was paid to each?
 - 4. What vote was it charged to?
 - 5. Was either one of said parties in any way connected with the Coast Range Steel, Limited?
- 6. What was the nature of the reports given by each to the Government as the result of their labours?
 - 7. In what portions of the Province did each work?

The Hon. Mr. Sloan replied as follows:-

- "1. C. P. Williams, with Francis Percy as assistant, were employed as Engineers to assist in carrying out the provisions of the 'Mineral Survey and Development Act.'
- "2. Determining the available tonnage of iron ores, coal, and fluxes suitable for the manufacture of iron and steel and the accessibility of such deposits to transportation. Commenced work in November, 1920; work yet unfinished.
 - "3. \$10,000 to C. P. Williams.
 - "4. Statutory Vote, 'Mineral Survey and Development Act.'
 - "5. No information.
 - "6. Answered by No. 2.
- "7. Vancouver Island and adjacent islands and southern portions of the Province, including the Kootenay districts."
 - Mr. Hunter asked the Hon. the Minister of Public Works the following questions:-
- 1. Have the surveys of possible routes for the Trans-Provincial Highway from the Coast to the Interior been completed?
 - 2. Are the surveyors' plans and reports now in the hands of the Government?
 - 3. What was the cost of each of such surveys and by whom was each carried out?
- 4. What is the estimated cost of construction of the proposed highway over each of the routes surveyed and reported upon?
- 5. When may a definite announcement as to the route selected be expected from the Government?

The Hon. Dr. King replied as follows:-

- " 1. No.
- "2. Yes, excepting that of Hope-Princeton via Dewdney Trail, Whipsaw Creek Summit.
- "3. Hope to Princeton, by E. G. Cleveland, \$13,137.53; Fraser Canyon, by F. J. Dawson for location and Dufresne & Whittaker for railway crossings, under the supervision of District Engineer Gwyer, \$20,233.66.
- "4. Hope-Princeton, via Gibson Pass, \$892,522; Fraser Canyon, including railway crossings, \$1,129,302.
 - "5. Matter still under consideration."

Mr. Kergin asked the Hon, the Minister of Public Works the following questions:-

- 1. Has the Department of Public Works ever been approached regarding the construction of a road at the town of Alice Arm, said road being for the purpose of giving access from the proposed Dominion Government Wharf to the town of Alice Arm; and, if so, when?
 - 2. Has same been recommended by the District Engineer?
- 3. Has the Department of Public Works given any assurance that this work would be carried out?
 - 4. If yes, on what occasions and dates?
 - 5. Has any money ever been set aside for this work, and what amount?

- "5. Yes; \$24,000.
- "6. Yes; \$24,000.
- "7. Instructions issued February 25th to start work.
- "8. Answered by No. 7.
- "9. Yes."

Mr. Jones asked the Hon. the Minister of Lands the following questions:-

- 1. What was the balance standing to the credit of the Forest Protection Fund on December 31st, 1920?
- 2. Are there any claims for fighting fires during 1920 which have been passed for payment but which have not yet been paid?
- 3. If so, what do such claims amount to, with particulars of same, and what is the reason for withholding payment?
- 4. What effect will the non-payment of these amounts have on logging operators both on the Coast and in the Interior?

The Hon. Mr. Pattullo objected to the fourth question as being out of order, and stated that the answers to the first three questions would be found in the printed reports already laid on the table.

Mr. Speaker ruled that question 4 was out of order.

Mr. Speaker gave the following ruling on the question of the ruling of the Chairman of Committee, which was challenged:—

"Tuesday evening the Honourable the Leader of the Opposition appealed from the ruling of the Chairman of the Committee of the Whole House on Bill No. 21 to myself. The appeal involves a point of practice. I have not been able to find that the Imperial House has a Standing Rule exactly similar to our Rule No. 99, which says that questions of order arising in Committee of the Whole House shall be decided by the Chairman, subject to an appeal to the House, without the Committee rising.

"The practice in the Imperial House, quoting from May (12), page 409, is as follows: 'Order in debate in a Committee is enforced by the Chairman. He is responsible for the conduct of business therein and from his decision no appeal should be made to the Speaker.' I find, however, in 1912, the following language used by the Speaker of the Imperial House of Commons: 'It may be that the Speaker is not a Court of Appeal from the Chairman of Ways and Means, but, on the other hand, there may be occasions on which there are decisions on which the House may wish to have the opinion of the Speaker in regard to the construction of the Standing Order, and not particularly in reference to what occurred in Committee, but in reference to what may occur in the House, too. I see no objection.' (Parl. Deb., 5s 40, page 1338.)

"The point the honourable gentleman has raised I understand to be whether or not the question of closed towns may be discussed in the discussion of section 7 of Bill No. 21, being 'An Act to amend the "Forest Act." It is submitted that the discussion of closed towns is germane to the discussion of the subject-matter of section 7. The construction of no Standing Order is involved, and I think the House itself may be fairly left, and indeed properly left, to express its opinion as to whether or not the proposed discussion is germane. Without, therefore, going further than to remind the House that not only discussions but proposed amendments in Committees must be strictly germane, I shall submit to the House the question, 'Shall the Chairman be sustained?'"

"Dear Sir,—I beg to report that the Douglas Fir and Turpentine Company, Limited, have made application for a loan under the provisions of subsections (g), (i), and (k) of section 4, chapter 34, Statutes of 1919, for the purpose of purchasing bottles and barrels and for working capital in the manufacture of turpentine and by-products.

"The above application has been submitted for the consideration of the Advisory Council, whose recommendation is as follows:—

- "A thorough inquiry has been held into all the circumstances affecting this loan. I find that the loan is justified, in that all the conditions required by section 8 of the 'Department of Industries Act' are fully complied with.

Ordered, That the said Message, and the Bill accompanying the same, be referred to a Committee of the Whole House forthwith.
