"The Ministries of Environment and Energy, Mines and Petroleum Resources are currently preparing to develop, with industry, broad guidelines for emergency response plans related to oil and hazardous chemical spills. Industry emergency response plans will be revised as required as a result of this activity.

"Imperial Oil Ltd., Chevron Canada Resources, Shell Canada Limited and PetroCanada Inc. (PetroCanada) each have a refinery in Vancouver; PetroCanada has another in Taylor; and Husky Oil Operations Limited has one in Prince George.

"Contingency plans are reviewed at least annually and sometimes twice yearly. Emergency planning and review is usually very extensive, considering design and construction of facilities, employee training, security and storage, maintenance, safety and health, environmental impacts, in-plant emergencies, transportation, community emergency response, and communications.

“Emergency response plans are reviewed with employees in continuous training and emergency response exercises, as their knowledge and understanding of emergency response plans is considered essential to appropriate emergency response. This review extends to drivers, agencies and service stations.

“The four refineries in the Vancouver area, and Trans Mountain Pipe Line Company Limited (TMPL), have a mutual aid agreement to assist each other with equipment and manpower in the event of an emergency. Emergency response plans are also filed with the Greater Vancouver Regional District, the National Energy Board (in the case of TMPL), the Provincial Emergency Program and the Municipality, including the fire department.

“TANK FARMS AND BULK PLANTS

“A major petroleum products bulk plant inspection and spill prevention program was established by the Ministry of Environment and carried out during 1985-86. Requirements for operating procedures, plant maintenance, equipment and facilities were provided to industry at that time. The currently planned review of guidelines for oil and chemical emergency response planning will also encompass these facilities.

“In general, tank farm and bulk plant emergency response plans are reviewed annually, following the same procedures for review and staff training as for refineries. Emergency response plans are posted and accessible to all employees. A review of all bulk plants indicates that up-to-date emergency response plans are completed or currently under review.”
