Most control programs are administered locally by regional districts and municipalities assisted by grants from the Ministry of Agriculture and Food. Only small quantities of pesticides were used by this Ministry for test and demonstration purposes for 1981–1982. Total cost of each program is not available since employment and transportation costs are also involved.

"3. Only small quantities of pesticides remained in storage this past fiscal year. Almost all of these pesticides are used for test and demonstration purposes during the year.

"4. See 3."

43 Ms. *Brown* asked the Hon. the Minister of Human Resources the following questions:

With reference to the Individual Opportunity Plan-

- 1. How many persons obtained regular full-time employment through the plan?
- 2. How many persons obtained part-time employment through the plan?
- 3. How many persons found employment at the minimum wage through the plan?
- 4. How many persons were still in jobs after 3 months and after 6 months?

The Hon. G. M. McCarthy replied as follows:

"The information requested by Ms. *Brown* in questions 1 to 4 is not collected by the Ministry of Human Resources. The focus of the Individual Opportunity Plan is to increase the independence of income assistance recipients by helping them develop individual plans that specifically meet their own needs. Rather than automatically referring employable clients to jobs for which they may or may not be suited or prepared, Ministry staff are assessing their skills, aptitudes and employment goals before develop-ing individualized 'actions plans'.

"A plan may have several steps and may vary in the amount of time required to complete it—from days to years.

"While employment is the eventual long-term goal for clients involved in the Opportunity Plan, it will not always be the short-term objective. Some participants will first be involved in training or up-grading courses.

"Approximately 6,500 income assistance recipients are involved in Individual Opportunity Plans during any given month. Program areas include: work experience, over 1,000 clients; education and training, over 3,500 clients; counselling and self directed placement, over 1,900 clients.

"This is an increase of 2,400 since July 1981.

"From July 1981 to May 1982, approximately 14,000 people participated in an Individual Opportunity Plan.

"An example of the success of one of the above programs is Job Action. This selfdirected program assists almost job-ready clients to acquire the skills needed to find and keep a job.

"On the average, 100 clients participate in Job Action each month with approximately 1,500 income assistance recipients having participated since its inception. The average number placed in employment is 70 per cent.

"This program currently available in nine regions, received in 1982/83, \$1 million in additional funds to allow for expansion to other areas in the Province.

"The Employment Opportunity Program is a joint program offered by the Ministry of Labour and Ministry of Human Resources specifically oriented towards job creation through work experience.

"Employers provide on-the-job training and work experience for income assistance recipients in return for a wage subsidy from the Ministry of Labour.

"483 income assistance recipients participated in this program during 1981/82.

"A special pilot project is being developed in Vancouver jointly with the C.E.I.C. geared towards single female parents on income assistance."

Honourable Members:

Shortly before the hour of adjournment yesterday afternoon, upon the Order being called for Second Reading of Bill (No. 81), *Rate Increase Restraint Act*, objection was taken that as the said Bill had received its First Reading during the morning sitting of the House, Standing Order 81 should have precluded a motion for Second Reading of the Bill on the same day without leave of the House.

Objection was also taken that as the Hansard "blues" indicated the Bill was *Ordered* for Second Reading "at the next sitting after today", the Bill ought not to have appeared on the Order Paper for Second Reading until today. Mr. Speaker made a statement as follows:

Honourable Members:

Yesterday, at the conclusion of the sitting, certain matters occurred affecting the procedure and dignity of this House upon which the Chair feels obliged to comment, lest uncertainty remains in the minds of any honourable members.

I have had the opportunity to examine the "Blues" and the parliamentary authorities which bear on the proceedings in question.

In relation to the procedural matters, it seems to the Chair that the essence of the problem was that the House Leader moved a motion to adjourn before the Minister of Finance had moved the motion to refer Bill (No. 86) to the Committee of the Whole for consideration at the next sitting after the day upon which the said Bill received second reading.

Honourable members have, from time to time, urged the Chair to intervene immediately should the Chair perceive any irregularities in proceedings. I refer to the Speaker's decision made as recently as September 22, 1982, in this House which states, in part, as follows:

"However, there is no question that the Speaker, when of the opinion that any proceedings are contrary to the rules and practices of the House, should draw to the attention of the House that fact".

In the proceedings which arose yesterday there is no doubt the Speaker did not give the Minister of Finance the opportunity of moving the normal motion prior to recognizing the House Leader. Perhaps the Chair might be permitted to say in its defence that the Government House Leader moved the adjournment motion in a rather pre-emptory fashion, but in any event, it is undoubtedly the Chair's responsibility to intervene when he perceives a motion being offered to the House of any nature and from any source which might be considered an abuse. Standing Order 44 expressly empowers the Speaker to refuse to put such a motion. However, in the heat of the moment, the Chair undoubtedly fell into error by prematurely recognizing the Honourable House Leader, and it was only after hearing the points of order raised by the Minister of Finance to the effect that he had believed that leave to commit Bill (No. 86) forthwith had not been refused, that the Chair was fully cognizant of the problem.

It was the Chair's opinion at this point, that the Minister of Finance should be permitted the opportunity to move the normal committal motion, leave having been refused to commit the Bill forthwith. To suggest that any honourable member could properly interrupt *pro forma* proceedings relating to the progress of a Bill with a motion to adjourn is not in accordance with the Chair's understanding of accepted parliamentary practice.

A further examination of the "Blues" leaves the Chair with the impression that some honourable members were of the opinion that had the adjournment motion been voted upon and either passed or defeated, the Bill in question could not have proceeded further. This is, of course, not in keeping with the authorities and I refer all honourable members to the 18th edition of Sir Erskine May, page 353, which clearly states that a motion for committal may be received at any time after second reading.

I will now touch briefly on a further matter, which, in the Chair's opinion, seriously affects the dignity of this House. To differ with the Speaker's ruling is the undoubted right of every member of every parliamentary body in the Commonwealth. But how that disagreement is expressed is a matter which has been the subject of comment over many hundreds of years of British parliamentary history. In this jurisdiction, any member who disagrees with the ruling of the Chair may, of course, appeal such a decision to the House under the existing rules. If a member of the House feels aggrieved by a decision or a series of decisions which he perceives to be inappropriate or unfair, he may move a substantive motion by giving notice of such motion in the usual way. He may not, under any circumstance, stand in this Chamber and use the language which was used yesterday at the close of proceedings.

It has been held time and again that an accusation of partiality in the discharge of the Speaker's duties is a breach of privilege or contempt of the House and I refer all honourable members to Sir Erskine May's Parliamentary Practice, 18th edition, page 148.

Let me conclude by saying again that every member has the undoubted right to disagree with the rulings of the Chair, but this right does not carry with it a licence to express that disagreement in terms that amount to contempt of the Legislature.
