SECOND SESSION 1953

Tuesday, September 15th, 1953.

THREE O'CLOCK P.M.

This being the first day of the first meeting of the Twenty-fourth Parliament or Legislative Assembly of the Province of British Columbia for the dispatch of business, pursuant to a Proclamation of the Honourable CLARENCE WALLACE, Lieutenant-Governor of the Province, dated the 28th day of July, 1953, the members having been sworn took their seats.

His Honour CLARENCE WALLACE, Lieutenant-Governor of the Province, having entered the House, took his seat on the Throne.

The Hon. W. D. Black, Provincial Secretary, said:-

Members of the Legislative Assembly:

I am commanded by His Honour the Lieutenant-Governor to announce that His Honour does not see fit to declare the causes of his summoning you at this time, and will not do so until you have chosen a Speaker to preside over your Honourable Body. His Honour hopes to be enabled to declare, during the afternoon, his reasons for calling you together.

His Honour was then pleased to retire.

The Hon. W. A. C. Bennett, member for South Okanagan Electoral District, addressing himself to the Clerk, moved, seconded by Mr. Webster, member for Vancouver East Electoral District, that *Thomas James Irwin*, Esquire, member for Delta Electoral District, do take the Speaker's chair and preside over the meetings of this Assembly, and it was so *Resolved*.

E. K. DeBeck, Esquire, the Clerk of the House, having declared Mr. Thomas James Irwin duly elected, he was then taken out of his place by the mover and seconder, and conducted to the chair, where, standing on the upper step, he expressed his grateful thanks to the House for the great honour they had been pleased to confer upon him by choosing him to be their Speaker.

And thereupon he sat down in the chair, and the mace was laid upon the table.

Prayers by The Lord Bishop of New Westminster.

His Honour the Lieutenant-Governor again entered the House, and taking his seat on the Throne, the Speaker-elect (standing on His Honour's right) then spoke to the following effect:—

MAY IT PLEASE YOUR HONOUR:

The House of Assembly have elected me as their Speaker, though I am but little able to fulfil the important duties thus assigned to me.

If, in the performance of those duties, I should at any time fall into error, I pray that the fault may be imputed to me, and not to the Assembly, whose servant I am, and who, through me, the better to enable them to discharge their duty to their Queen and country, humbly claim all their undoubted rights and privileges, especially that they may have freedom of speech in their debates, access to Your Honour's person at all seasonable times, and that their proceedings may receive from Your Honour the most favourable interpretation.

The Hon. W. D. Black then said:-

MR. SPEAKER:

I am commanded by His Honour the Lieutenant-Governor to declare to you that he freely confides in the duty and attachment of the House of Assembly to Her Majesty's person and Government, and not doubting that their respective proceedings will be conducted with wisdom, temper, and prudence, he grants, and upon all occasions will recognize and allow, their constitutional privileges.

I am commanded also to assure you that the Assembly shall have ready access to His Honour upon all seasonable occasions, and their proceedings, as well as your words and actions, will constantly receive from him the most favourable construction.

His Honour the Lieutenant-Governor was then pleased to open the Session by the following gracious Speech:—

Mr. Speaker and Members of the Legislative Assembly:

It is with pleasure that I welcome you to the First Session of the Twenty-fourth Parliament of British Columbia.

Since the Legislature last convened, the year has been marked by the Coronation of Her Most Gracious Majesty Queen Elizabeth the Second.

In no part of the Commonwealth were the ceremonies, attendant upon the Coronation, observed with greater affection and loyalty than in this Province.

It is fitting to note that British Columbia was, by invitation, officially represented in London on the auspicious occasion.

I unite with you in general thanksgiving that a truce has been negotiated in the Korean theatre of war, and it is my fervent prayer that terms of an armistice may be determined in the not too distant future and that a foundation will be laid for a lasting peace.

I join with you in extending condolences to those families which have suffered bereavement as a result of the conflict, and I hope that those of our men still serving overseas will soon enjoy happy reunions with their loved ones.

During the course of this Session my Government will submit measures of considerable importance.

Foremost among these will be legislation implementing the over-all policy of my Government.

Amendments to the "Social Security and Municipal Aid Tax Act" will be introduced to include further exemption on meals. 2 Eliz. 2

You will be asked to authorize the setting-up of an Assessment Commission to establish equalized assessment values for school purposes throughout the Province.

It is proposed to grant further tax relief by the reduction of automobile licences, applicable to private passenger-cars.

It is proposed to introduce certain measures to ensure fair remuneration to female employees.

On June 12th, 1952, a plebiscite on the liquor problem was held, and, as a result of this, my Government appointed a Commission of Inquiry. In consequence of their findings, remedial measures will be introduced for the consideration of the Legislature.

Legislation will be presented contributing to the solution of the Doukhobor problem.

You will be asked to authorize the distribution of the fund created under the "Police and Prisons Regulation Act" amongst certain former members of the Provincial Police Force.

You will be asked to consider amendments to the "Provincial Elections Act."

As a result of a great increase in the population of British Columbia in recent years, a committee will be set up during this Session to study the possibility of a redistribution of seats for this Legislature.

You will be asked to pass an Act to secure additional revenue from the natural resources of the Province, and to introduce an Act to amend the "Taxation Act."

An Act will be presented to control the ribbon development on the main highways of the Province.

A Supply Bill will be presented for the remaining six months of the fiscal year ending March 31st, 1954.

Legislation affecting branches of public service of a character devised to improve existing Acts will be placed before you.

I pray that the blessing of Divine Providence will rest upon your labours.

His Honour the Lieutenant-Governor was then pleased to retire.

The Speaker reported that, to prevent mistakes, he had obtained a copy of His Honour's Speech.

The letter of the Deputy Provincial Secretary and the certificate of the Chief Electoral Officer of the result of the election of members to represent the respective electoral districts of the Province in the Legislative Assembly at the general election were read, as follows:—

"The elections were duly held pursuant to the provisions of the 'Provincial Elections Act.'

2. What provision, if any, has been made to take care of those awaiting admission? The Hon. W. D. Black replied as follows:—

"4. 1949, \$17,291.90; 1950, \$46,259.72; 1951, \$59,598.32; 1952, \$81,284.75; and 1953, \$18,000 (estimated, all accounts not yet closed)."

Mr. Howard asked the Hon. the Minister of Lands and Forests the following questions:---

1. In the period for which records are available since the granting of Forest Management Licence No. 1 to Columbia Cellulose Limited, what has been the total timber cut according to species?

2. What was the average revenue per 100 cubic feet of said timber cut, according to species, received by the Government?

3. What was the total Government revenue received from said timber cut, according to species?

The Hon. R. E. Sommers replied as follows:---

"1. Total cut by species from date of issuance of Management Licence No. 1 to August 31st, 1953: Cedar, 138,793 cubic feet; spruce, 3,613,048 cubic feet; hemlock, 9,217,401 cubic feet; balsam, 4,221,262 cubic feet; cottonwood, 423,660 cubic feet; lodgepole pine, 56 cubic feet; cypress, 541 cubic feet; hardwoods, 37 cubic feet; total, 17,614,798 cubic feet.

"2. Average revenue per 100 cubic feet not available; stumpage rates received on Crown lands portion of licence, after all costs of management have been allowed, have varied by species according to various cutting permits issued, as follows: Hemlock, \$1.86 to \$4.34 per 100 cubic feet; balsam, \$1.50 to \$3.83 per 100 cubic feet; spruce, \$2 to \$4.80 per 100 cubic feet; cedar, \$1.60 to \$3.15 per 100 cubic feet; cypress, \$1.70 to \$2.57 per 100 cubic feet; other species, \$2.10 to \$2.60 per 100 cubic feet; and fuel logs, 35 cents.

"3. Total revenue received from said timber cut is \$390,248.35; no breakdown of revenue by species is available."

Mr. Laing asked the Hon. the Minister of Trade and Industry the following questions:-

1. What was the tonnage and value of iron ore exported from the Province during the past year?

2. What was the destination?

3. What tonnage was extracted from Provincial Crown lands

The Hon. W. R. T. Chetwynd replied as follows:---

"1. 1952, 838,691 tons, \$5,841,174, and 1953, first seven months, 562,053 tons, \$4,168,706.

"2. Japan, the United States, and Germany.

"3. None."

Mr. Howard asked the Hon. the Minister of Lands and Forests the following questions:---

1. Has a forest management licence been granted to the Hecate Development Company in the Skeena, Prince Rupert, and Mackenzie Electoral Districts or any part of any of them?

2. If yes, (a) what was the date of issuance, (b) what provisions were made for royalty and stumpage rates, and (c) at what rates are such royalties and stumpage chargeable?

3. If the answer to No. 1 is no, (a) in what manner is your Department dealing with the application of the said company for such a licence, and (b) at what stage of development, if any, is your Department's investigation into the said company's application?

"3. Advertising of the application has been completed and the application is currently under final review."

(a) Cash balance as at August 31st, 1953, \$4,613,535.86; (b) this fiscal year, \$5,142,274.38 represents prepaid payments by registrants; and (c) the available cash balance as at August 31st amounted to \$4,613,535.86 and is a result of cumulated operations of the Hospital Insurance Fund, including all previous payments from Consolidated Revenue; the subsidy for the 1953-54 fiscal year, amounting to \$4,033,428, has not yet been credited to the Hospital Insurance Fund during this fiscal year.

And whereas it appears that the representation of the people in this Legislature may not now be on an equitable basis:

Therefore be it Resolved, That a Special Committee, consisting of ten members of the Legislature, be appointed to consider the desirability of amending section 14 and Schedule C of the "Constitution Act," being chapter 65 of the "Revised Statutes of British Columbia, 1948," and to make recommendations in respect thereof to this Legislature as to the desirability of increasing the number of members to be elected to the Legislature and as to the distribution of the members amongst the electoral districts of the Province:

And be it further Resolved, That in making their inquiry the Committee be empowered to examine and inquire into all such matters and things as may be pertinent to the subject and to send for persons, papers, and records as required:

And be it further Resolved, That the Committee be composed of the Hon. W. D. Black and Messrs. Parker, Bate, Chant, Reid, Turner, Nimsick, Moore, Laing, and Giovando.

A debate arose.

Motion agreed to.

The dictionary definition of this word is: "Addicted to vice or immorality. depraved and wicked." You will readily see that the use of this word is unparliamentary if referring to members or acts of members. I would ask members carefully to abstain from the use of any words casting reflections on other members or acts of members.

I would refer you to May's 15th Edition, page 431, and I quote: "Debate must not stray from the question before the House to matters which have been decided during the current Session or anticipate a matter appointed for the consideration of the House or of which notice has been given."

I draw the attention of members to this fact so that they may not fall into error.

2. If so, at what points were such counts taken and what vehicle traffic was recorded in each case on each date?

The Hon. P. A. Gaglardi replied as follows:-

"1. Yes; on Highway No. 3, August, 1953.

"2. Points where counts were taken in August, 1953, are shown as follows: 0.5 mile east of Princeton and east of Copper Mountain Road, 1 mile west of Keremeos, 400 feet west of Kaleden Junction, 0.2 mile south of Kaleden Junction, 0.2 mile north of Oliver, 5 miles south of Oliver, 0.5 mile east of Osoyoos Bridge, 0.25 mile west of Rock Creek Bridge, 3 miles east of Rock Creek Village, 4.7 miles east of Midway, 1 mile east of Greenwood, 300 feet west of Danville Customs Road, 0.25 mile east of junction with road to Danville Customs, 4.5 miles east of bridge at Grand Forks, 200 feet west of Cascade Junction, 300 feet north of Cascade Junction, 300 feet east of junction with road to Christina Lake, 400 feet west of junction with road to Paterson Customs, between Rossland and Trail Cemetery gates, 0.5 mile east of Tadanac, 1.8 miles east of Castlegar Ferry, 200 feet east of South Slocan Junction west of Slocan Village, and 1 mile west of Nelson; traffic count figures are not yet compiled."

Mr. Winch asked the Hon. the Minister of Health and Welfare the following questions:--

1. How many hospital beds for (a) acute and (b) chronic patients are now available in the Province?

2. What is the respective percentage of the above in relation to the general population?

3. What is the respective percentage of the above to the general population as recommended by (a) the Government and (b) medical authorities?

4. What number of bed facilities for (a) acute and (b) chronic patients are now under construction?

The Hon. E. C. F. Martin replied as follows:-

"1. (a) 7,035 hospital beds (hospitals operated by the Department of Veterans' Affairs and Indian Health Services are not included) and (b) 1,587 hospital beds and 1,844 beds in institutions and boarding homes licensed under the 'Welfare Institutions Licensing Act.'

"2. (a) 5.75 beds per 1,000 population and (b) 2.76 beds per 1,000 population (including beds in institutions and boarding homes licensed under the 'Welfare Institutions Licensing Act.')

"3. (a) The Government considers that an over-all ratio of approximately six acute hospital beds per 1,000 population is adequate to meet the needs of the civilian population (a minimum of three beds per 1,000 population for chronic patients with approximately one bed per 1,000 being for patients requiring therapeutic care and two per 1,000 for patients requiring largely domiciliary or custodial care) and (b) no information available.

"4. (a) Seven facilities for acute patients with a total capacity of 422 beds are now under construction and (b) two facilities for chronic patients with a total capacity of seventy-two beds are now under construction."

Mr. Brown asked the Hon. the Minister of Public Works the following questions:-

1. How much was appropriated for expenditure on Highway No. 16 for the period April 1st, 1953, to September 30th, 1953?

2. What portion of the amount appropriated was spent for that purpose as of August 31st, 1953?

3. As at March 31st, 1953, how much remained unspent of the funds appropriated for Highway No. 16 for the fiscal year 1952–53?

The Hon. P. A. Gaglardi replied as follows:-

"1. \$643,200.76, major construction and maintenance.

"2. \$459,662.25, major construction and maintenance.

" 3. \$67,763.40, major construction."

Mr. Brown asked the Hon. the Minister of Public Works the following questions:----

1. What amount has been spent by the Department of Public Works in the Fort George Electoral District since March 31st, 1953?

2. What amount was appropriated for expenditure in the Fort George Electoral District covering the period April 1st, 1953, to September 30th, 1953?

3. If more was spent on public works in the Fort George Electoral District in the same period than was voted for that purpose, from where did the excess derive?

The Hon. P. A. Gaglardi replied as follows:---

"1. \$567,023.53, to August 31st, 1953, major construction and maintenance.

"2. \$991,925.36, major construction and maintenance.

"3. See answers to Nos. 1 and 2."

Mr. Laing asked the Hon. the Attorney-General the following questions:-

1. What was the date of issuance of the last beer licence in the Province?

2. (a) How many winery licences have been issued in the Province since August 1st, 1952, (b) what is the name and address of the licensee in each case, and (c) are the above wineries in production and have they made sales to the Government Liquor Board?

The Hon. R. W. Bonner replied as follows:-

"1. By Government edict of April, 1951, with the exception of any licences approved at that time, no new licences were to be issued, and no deviation therefrom has been made; the last beer licence in the Province was issued on November 3rd, 1951, to the Hotel Sidney at Sidney, in pursuance of the plebiscite held on April 17th, 1951, under the 'Liquor-control Plebiscites Act'; plans for the building in respect of which this beer licence was issued were filed with the Board and approved on February 5th, 1951.

"2. (a) Two permits, under section 36 of the 'Government Liquor Act,' to manufacture or produce wine were issued by resolution of the Board, dated September 22nd, 1952. (b) By resolution of the Board, No. 19831, dated September 22nd, 1952, a wine manufacturer's or producer's permit was issued to the Pacific Wine Growers, of 3295 West Broadway, Vancouver. The full names and addresses of the officials of the company, as reported, are as follows: Saul Kaganoff, 3295 West Broadway, Vancouver; Morris Kagnoff, 3027 West Thirteenth Avenue, Vancouver; and Nathan Kagnoff, 3236 West Twenty-sixth Avenue, Vancouver. By resolution of the Board, No. 19832, dated September 22nd, 1952, a wine manufacturer's or producer's permit was issued to the British Columbia Wineries Limited, of 800 Hall Building, 789 West Pender Street, Van-The full names and addresses of the company, as reported, are as follows: couver. Directors-Jacob G. Derksen, 1004 Central Road, Yarrow, producer; Earl Pearcy, Langley Fruit Packers Limited, R.R. 3, Langley Prairie, business executive; John H. Edmonds, 1642 Stephens Street, Vancouver, business-man; Joseph Augustus, 903 Steveston Highway, Lulu Island, B.Sc. in Agriculture, farmer; Henry H. Goossen, 1050 Central Road, Yarrow, producer; Atlee Pearcy, R.R. 3, Langley Prairie, business-man; secretary, Elmore Meredith, 800 Hall Building, 789 West Pender Street, Vancouver, barrister. The full names and addresses of bond or share holders are as follows: Joseph Augustus, 903 Steveston Highway, Lulu Island, farmer; Henry H. Goossen, 1050 Central Road, Yarrow, producer; Atlee Pearcy, R.R. 3, Langley Prairie, business-man; Jacob G. Derksen, 1004 Central Road, Yarrow, producer; John H. Edmonds, 1642 Stephens Street, Vancouver, business-man; and Earl Pearcy, Langley Fruit Packers Limited, R.R. 3, Langley Prairie, business executive. (c) So far as is known, neither of these companies is in operation and neither has made any sales to the Liquor Control Board; under date of August 12th, 1953, they were notified that their permits had expired."

Mr. Haggen asked the Hon. the Attorney-General the following questions:---

1. Are any guards being maintained at schools, railways, or highways in the Grand Forks District, Rossland-Trail District, Nelson-Creston District, or Kaslo-Slocan District?

2. If so, how many guards have been maintained and what is the present cost per week of maintaining same?

3. Is the Province paying any proportion of the cost of such guards and, if so, what?

The Hon. R. W. Bonner replied as follows:-

"1. Yes; school guards and guards on railway bridges; none on highways.

"2. No information for cost of guards by the week, but there are approximately sixty-two school guards, plus holiday relief guards, at a cost of \$11,300 per month and thirteen bridge guards at a cost of approximately \$2,400 per month.

"3. The Province reimburses the school districts for the cost of school guards and pays the bridge guards direct."

Mr. Calder asked the Hon. the Minister of Public Works the following questions:---

1. What bridges, if any, were repaired within the Atlin constituency in 1952 and how much was spent on each?

2. What bridges, if any, does the Department propose to have repaired in 1953? The Hon. P. A. Gaglardi replied as follows:—

"1. Stewart-Hyder No. 2, \$335.62; Stewart-Hyder No. 3, \$6,668.31; Stikine Avenue, \$284.18; McKee, \$827.09; Surprise Lake, \$1,317.10; Spruce Creek, \$954.09; Casca No. 1, \$30.71; Casca No. 2, \$298.50; Casca No. 8, \$91.33; Six Mile, \$52.33; Tuya, \$156.45; Twenty-four Mile, \$15.35; Bitter Creek, \$186.04; Bear River, \$152.56; Stewart-Hyder No. 1, \$4,389.88; Marmot River, \$274.24; Alice Arm Shore Road Bridge, \$68.88; Fletcher Creek, \$1,441.23; York, \$88.13; Canyon Creek, \$34.52; Paul Klay-Duc, \$43.17; South Fork, \$1,047.70; Bernachie, \$93.96; Glacier Creek, \$223.88; Goat Creek, \$25.06; Log, \$98.26; Rainey Creek, \$71.71; Birch Creek, \$936.18; Esperanza, \$35.23; Jones, \$22.79; Keystone, \$2,687.94; Kitsault, \$5.07; Cascade, Cobalt, and Silver Lake Bridges on Big Missouri Road rebuilt and ten bridges filled out of mining grant of \$15,000.

"2. The following bridges have been repaired during the calendar year 1953 to date: Hitchcock Creek, Base Camp, Glacier Creek, Fourth of July, Telegraph Creek, Halfway, Casca No. 1, Casca No. 2, Casca No. 4, Waterfall, Stikine Avenue, Second South Fork, Tahltan, Tuya, Bitter Creek, Bear River, Glacier Creek, Stewart-Hyder No. 1, Stewart-Hyder No. 2, Stewart-Hyder No. 3, Kitsault Suspension, Alice Arm Shore, South Fork, Rainey Creek, Bear Creek, Surprise Lake, Birch Creek, and Keystone; proposed bridge work during the balance of 1953 consists of the replacement of the Bear River Bridge and the Gingit Bridge and repairs to Halfway, Tuya, Tahltan, and Casca Bridges."

Mr. Howard asked the Hon. the Minister of Public Works the following questions:----

1. Has the Department of Public Works been approached by the Aluminum Company of Canada relative to the building of a road from Kitimat to Highway No. 16?

2. If so, did the Aluminum Company of Canada make an offer to contribute toward the cost of building the said road?

3. If they did, what amount of money was offered?

4. Has the Department discussed with the British Columbia Power Commission the building of such a road?

5. Has the British Columbia Power Commission made any offer to contribute toward the cost of building such a road?

6. Has the Department undertaken to make a survey of such a road?

7. If so, what is the estimated cost of construction?

8. Does the Department plan to start upon the construction of such a road?

9. If so, when?

The Hon. P. A. Gaglardi replied as follows:-

"1. Yes; May 13th, 1953.

"2. No definite offer, but manager of Aluminum Company said he was prepared to recommend to his company that it contribute toward the cost an amount equivalent to the value of the road to the company.

3. Who are the registered owners of these clubs or, in case of incorporation, who are the directors and shareholders?

4. What is the annual licence fee exacted in each case?

5. On what dates were each of these licences last renewed by the Government and on whose authority?

The Hon. R. W. Bonner replied as follows:-

"1, 2, and 3. The Liquor Control Board has no knowledge of what the British Columbia Liquor Inquiry Commission considers 'the so-called "propriety" clubs.'

"4. The annual licence fee for any club licence is \$100.

"5. All clubs heretofore holding club licences received renewals for 1953."

Mr. Eddie asked the Hon. the Minister of Public Works the following questions:-

1. With respect to alterations to the north and south approaches to the Pattullo Bridge have plans been finalized?

2. Has any division of cost been arrived at as a result of negotiations between the Provincial and Federal Governments?

3. If yes, how is the cost apportioned?

4. Have any plans been finalized as a temporary expediency to relieve the congestion of traffic presently occurring in busy hours?

The Hon. P. A. Gaglardi replied as follows:--

"1. Yes.

"2. No.

"3. Answered by No. 2.

"4. Plans are being discussed with New Westminster City Council."

Mr. Strachan asked the Hon. the Minister of Labour the following questions:---

1. Have any compensable accidents occurred on the Alcan project?

2. How many compensable accidents have occurred on the Alcan project since the time construction commenced until August 30th, 1953?

3. How many of these occurred on the section of the Alcan project under construction by the Morrison-Knudsen Company?

4. Were any of the accidents referred to in No. 3 fatal?

5. If so, how many?

6. How many of the accidents referred to in No. 2 occurred on the section of the Alcan project under construction by the Kitimat Constructors Limited?

7. Were any of the accidents referred to in No. 6 fatal?

8. If so, how many?

9. Does the Compensation Board have a Safety Inspector stationed on the Alcan project?

10. If not, why not?

The Hon. L. Wicks replied as follows:---

"1. Yes.

"2. The records of the Workmen's Compensation Board show that for the period ended August 30th, 1953, 3,688 cases, including 2,482 requiring medical attention only, have been charged to the contractors of the Aluminum Company of Canada Limited.

"3. Three thousand one hundred and fifteen cases, including 2,187 requiring medical attention only, have been charged to the Morrison-Knudsen group.

"4. Yes.

"5. Forty fatal accidents have been reported by the Morrison-Knudsen group, of which seventeen occurred in aeroplane wrecks when workmen were being transported to or from the job.

"6. Five hundred and forty-three cases, including 271 requiring medical attention only, have been charged to the Kitimat Constructors group.

"7. Yes.

"8. Four fatal accidents have been reported by the Kitimat Constructors, all arising from an aeroplane crash while the workmen were being transported from the job.

"9. The Workmen's Compensation Board has not had a Safety Inspector stationed at any one point on the Alcan project, but one Inspector has been assigned to that area and has devoted practically full time to the project; in addition, three other Inspectors have covered the territory on a number of inspection tours and regular inspections have also been made by the silicosis department.

"10. Answered by No. 9."

Resolved, That the House, at its rising, do stand adjourned until 2.30 o'clock p.m. to-morrow.
