 - (d) by adding the amounts determined under paragraph (c) (i) and (ii) and the total is the tax payable in respect of that taxation year.
- "(2) Subsection (1) shall be deemed to have come into force on January 1, 1978, and is retroactive to the extent necessary to give it effect on and after that date."

 - (No. 35) Constitution Amendment Act, 1979.
 - (No. M 209) University of Victoria Foundation Act, 1979.
 - (No. Pr. 401) An Act to Amend the Trinity Western College Act.

His Honour was pleased in Her Majesty's name to give assent to the said Bills.

The said assent was announced by *Ian M. Horne*, Q.C., Clerk of the House, in the following words:

"In Her Majesty's name, His Honour the Lieutenant-Governor doth assent to these Bills."

His Honour the Lieutenant-Governor was then pleased to retire.

On the motion of the Hon. G. B. Gardom, it was Resolved—

That the House, at its rising, do stand adjourned until it appears to the satisfaction of Mr. Speaker, after consultation with the Government, that the public interest requires that the House shall meet, or until Mr. Speaker may be advised by the Government that it is desired to prorogue the First Session of the Thirty-second Parliament of the Province of British Columbia.
