# Thursday, 21st February, 1901.

## THREE O'CLOCK, P. M.

This being the first day of the second meeting of the Ninth Parliament or Legislative Assembly of the Province of British Columbia, for the dispatch of business, pursuant to a Proclamation of His Honour the Honourable Sir HENRI GUSTAVE JOLY DE LOTBINIÈRE, Lieutenant-Governor of the Province, dated the seventeenth day of January, 1901,

His Honour the Honourable Sir *Henri Gustave Joly de Lotbinière*, Lieutenant-Governor, having entered the House, took his seat on the Throne, and was pleased to deliver the following gracious Speech :---

## Mr. Speaker and Gentlemen of the Legislative Assembly :

I now welcome you to the Second Session of the Ninth Parliament.

Since your last meeting we have had to deplore the loss of our beloved Sovereign, Queen Victoria, who, during her long and beneficent reign, had become endeared to the hearts of all her subjects. In no part of Her Majesty's dominions were her many noble qualities as a Queen and a woman more highly admired, or has her death been more deeply lamented, than in British Columbia. I trust you will take an early opportunity to pass an address of condolence to the Royal Family, expressing the deep sense of bereavement which is felt by the people of this Province.

While deploring the event which rendered necessary the succession of Albert Edward, Prince of Wales, it is a satisfaction, nevertheless, to welcome as our Ruler one upon whom we can rely to follow in the footsteps of his mother; and I will ask you to couple with your resolution of condolence one of welcome and congratulation to our new Sovereign, King Edward VII., on his accession to the Throne.

As a mark of appreciation of the valiant services rendered by the volunteers from British Columbia who went to South Africa to assist the Empire in the war with the Transvaal and the Orange Free State, my Government will introduce a measure authorising the conveyance to them of free grants of land.

A measure will be submitted amending the School Act.

There will be submitted for your consideration a Bill having for its object the encouragement of the wood pulp industry in British Columbia.

I am pleased to know that the dairy industry continues to develop in so satisfactory a manner, and that new creameries are being established. My Minister of Agriculture has obtained the promise of continued co-operation on the part of the Dominion in rendering expert assistance in their construction and subsequent operation, and in giving instruction in the manufacture of butter and cheese.

Recognizing the importance of encouraging Provincial trade in agricultural and other natural products, and in particular of promoting a market for the produce of farmers in the mining districts, efforts have been made to secure such a reduction of freight rates as will materially tend in that direction; and I am pleased to announce that this will be brought about.

For the purpose of promoting settlement, my Government is considering the advisability of introducing legislation having in view the extension of the system of small holdings.

A measure will be introduced with the view of aiding in the construction of a railway from the Boundary Creek District to the Coast; of a railway to the northern end of Vancouver Island; and of a railway in Canadian territory from the Coast to the northern boundary of the Province.

The industries of the Province, I am happy to state, are in a prosperous condition. It is to be deplored, however, that the recent explosion at Comox should have resulted in such disaster to life and property, and the relatives of the deceased miners are entitled to our deepest sympathy in their great bereavement.

During the recess, Commissions were issued to inquire into the conduct and general administration of the Asylum for the Insane; the rights of settlers in the Esquimalt and Nanaimo Railway Company's land belt; and the adjustment of mining claims in the newly organised Porcupine District; and full reports of the Commissioners in each case will be laid before you at an early date.

Provision was made by you at the last Session of the Legislature for the appointment of a Commission to inquire into the working of the Mining Acts, and much preliminary information has been obtained by the Department of Mines in anticipation of the Commission being issued; but it having been announced that the Dominion Government also intended issuing a Commission with respect to our mineral resources, a postponement was deemed desirable, in order to ascertain to what extent these Commissions might be able to co-operate to the advantage of the Province.

Amendments will be introduced to perfect, as far as possible, existing mining laws.

The Act regulating immigration, passed at last Session, has come into effect, and the necessary machinery for its enforcement has been put into operation.

A delegation, consisting of my First Minister and the Honourable the Attorney-General, recently proceeded to Ottawa to lay before the Dominion Government the claims of British Columbia to increased recognition in the matter of railway development, and in other respects, and to arrive at a settlement of certain matters requiring adjustment between the two Governments. The report of the delegation will be laid before you at an early date.

The Estimates of Receipts and Expenditure, which have been prepared with due regard to economy and the requirements of the Province, will be submitted shortly.

I now leave you to your deliberations, and trust that they may, with the blessing of Divine Providence, be instrumental in materially advancing the interests of the Province.

His Honour the Lieutenant-Governor was then pleased to retire.

## To the King's Most Excellent Majesty :

Most GRACIOUS SOVEREIGN,—We, Your Majesty's dutiful and loyal subjects, the Members of the Legislative Assembly of British Columbia, in Parliament assembled, humbly approach Your Majesty with feelings of deepest sorrow at the death of our late revered Sovereign, Queen Victoria, and beg that Your Majesty will accept these our words as a heartfelt expression of a bereavement which we share with Your Majesty and the members of the Royal Family.

In common with the people of the Dominion of Canada and Your Majesty's loving subjects throughout the wide extent of the Empire, we deplore the loss of one whose beneficent rule held sway over their hearts by bonds of true affection.

In the sixty-four years of her reign, the most memorable and illustrious of modern times, Her Gracious Majesty had endeared herself to millions of her subjects, to whom the name of Queen Victoria had become a treasured household word. Her wise, just and constitutional rule was extolled throughout the civilized world; while, in life, her example of womanly virtues extended an undying influence and left an holy impress on the nineteenth century.

In no part of Your Majesty's Empire was the news of the death of our late beloved Sovereign, your mother, received with more profound feelings of grief than in British

Columbia, and in none other do Your Majesty's subjects pray more earnestly that the Divine Ruler of all may console Your Majesty and the members of the Royal Household in so great an affliction.

While deploring the demise of our beloved Queen, which came in the fullness of years, we rejoice in the accession of your Majesty as one who has had great experience in public affairs, and who has declared it his aim to follow in the footsteps of his noble mother. To your Majesty's reign we look for the continuance of that wise policy which has been attended by so many blessings to the human race.

On behalf of the people of British Columbia we hasten to assure your Majesty of their sincere attachment to your Majesty's person, and to those stable principles of Government and institutions of State upon which British Sovereignty is most securely founded. When the enemies of our late Sovereign declared war in South Africa our volunteers were prompt to respond to duty's call, and we now extend the confident assurance that under your Majesty, when occasion demands, their loyalty and devotion will not be less zealous, nor their arms less strong, to strike for the Empire and King Edward VII.

We welcome your Majesty to the Throne of your ancestors, and rejoice in the manifestation of a desire to uphold in all the glory of their traditions those great principles of freedom and true nobility which have made the name of Britain great among the nations.

On the motion of the Hon. Mr. Turner, seconded by the Hon. Mr. Eberts, it was Resolved,-

In common with British subjects throughout the world, we deeply deplore the loss of our beloved Sovereign, Queen Victoria, who, during her long and glorious reign, endeared herself to the hearts of her people by her many noble qualities as a Queen and a woman. We shall take an early opportunity to pass an address of condolence to the Royal Family, expressing the deep sense of bereavement which is felt by the people of this Province.

2. While deploring the death of our great Queen, it is yet a satisfaction to welcome as our new Sovereign one upon whom we can rely to follow in the footsteps of his mother; and with our resolution of condolence we shall couple one of welcome and congratulation to King Edward VII., on his accession to the Throne.

3. It will afford us great pleasure to give our assent to any measure which may be introduced to provide some mark of appreciation of the services rendered to the Empire by the British Columbia volunteers, who acquitted themselves so valiantly in the South African war.

4. Any measure dealing with the important subject of education shall have our most careful consideration.

5. The establishment of the manufacture of wood pulp is a matter of great importance to this Province, and we are pleased to be informed that it is the intention of His Honour's Government to submit to us a Bill having for its object the encouragement of this industry.

6. We have received with much pleasure the assurance that the dairy industry continues to develop in a satisfactory manner, and that His Honour's Minister of Agriculture has obtained the promise of continued co-operation on the part of the Dominion in rendering expert assistance and instruction in the establishment of creameries, and in the manufacture of butter and cheese.

7. We trust that the efforts of His Honour's Government to secure a reduction in freight rates upon agricultural and other products will be crowned with success.

8. We are of opinion that the settlement of the country would be promoted by judicious legislation extending the system of small holdings.

9. The necessity for better transportation facilities is so urgent that a measure to aid the construction of lines of railway from the Boundary Creek District to the Coast, from the

As the Dominion Government have announced their intention of issuing a Commission to inquire into the mineral resources of this Province, we have no doubt His Honour's Government acted judiciously in postponing the appointment of the Commission authorised last Session by this House to inquire into the working of our Mining Acts, until it could be ascertained to what extent these Commissions might be able to co-operate to the advantage of the Province.

14. We shall carefully consider any amendments that may be introduced to perfect, as far as possible, the existing mining laws.

15. It is satisfactory to be assured that the Act regulating immigration, which was passed at the last Session of this House, and which came into force on the first day of January of this year, has been duly enforced.

16. We shall await with much interest the report of the delegation, consisting of His Honour's First Minister and of His Honour's Attorney-General, which recently proceeded to Ottawa to lay before the Dominion Government the claims of British Columbia to increased recognition in the matter of railway development, and in other respects, and to arrive at a settlement of certain matters requiring adjustment between His Honour's Government and that of the Dominion.

17. We thank His Honour for informing us that the Estimates of Revenue and Expenditure for the ensuing fiscal year will shortly be laid before us. We are confident that they will be found to have been framed with every regard for economy consistent with the efficiency of the public service.

18. His Honour may rest assured that the measures which may be brought before us shall receive our earliest consideration, and we trust that our deliberations, under the Divine guidance, will conduce to the prosperity and welfare of the people of the Province.

We join with Your Honour in deploring that the recent explosion in one of the great coal mines of Vancouver Island should have resulted in such disaster to life and property; and with Your Honour we extend to the relatives of the deceased miners our deepest sympathy in their great bereavement.

We shall carefully consider the reports of the Commissioners appointed to inquire into the conduct and general administration of the Asylum for the Insane at New Westminster, the rights of settlers in the Esquimalt and Nanaimo Railway Company's land belt, and the adjustment of claims in the newly organised Porcupine District.

As the Dominion Government have announced their intention of issuing a Commission to inquire into the mineral resources of this Province, we have no doubt Your Honour's Government acted judiciously in postponing the appointment of the Commission authorised last Session by this House to inquire into the working of our Mining Acts, until it could be ascertained to what extent these Commissions might be able to co-operate to the advantage of the Province.

We shall carefully consider any amendments that may be introduced to perfect, as far as possible, the existing mining laws.

It is satisfactory to be assured that the Act regulating immigration, which was passed at the last Session of this House, and which came into force on the first day of January of this year, has been duly enforced.

We shall await with much interest the report of the delegation, consisting of Your Honour's First Minister and of Your Honour's Attorney-General, which recently proceeded to Ottawa to lay before the Dominion Government the claims of British Columbia to increased recognition in the matter of railway development, and in other respects, and to arrive at a settlement of certain matters requiring adjustment between Your Honour's Government and that of the Dominion.

We thank Your Honour for informing us that the Estimates of Revenue and Expenditure for the ensuing fiscal year will shortly be laid before us. We are confident that they will be found to have been framed with every regard for economy consistent with the efficiency of the public service.

Your Honour may rest assured that the measures which may be brought before us shall receive our earliest consideration, and we trust that our deliberations, under the Divine guidance, will conduce to the prosperity and welfare of the people of the Province.

The Report was adopted.

On the motion of the Honourable the Premier, seconded by the Honourable the Minister of Finance, it was *Resolved*,—

That the Address in reply to the Speech be presented to His Honour the Lieutenant-Governor by such Members as are of the Executive Council.

Pursuant to Order, the House resolved itself into a Committee of the Whole to consider the Message of His Honour the Lieutenant-Governor of 26th February, 1901, transmitting a Bill intituled "An Act to Accelerate the Incorporation of the City of Slocan."

"His Majesty, being this day present in Council, was pleased to make the following Declaration :---

"'YOUR ROYAL HIGHNESSES, MY LORDS, AND GENTLEMEN,-This is the most painful occasion on which I shall ever be called upon to address you.

"'My first and melancholy duty is to announce to you the death of My beloved Mother, the Queen, and I know how deeply you, the whole Nation, and, I think I may say, the whole world, sympathise with Me in the irreparable loss we have all sustained.

"'I need hardly say that My constant endeavour will be always to walk in Her footsteps. In undertaking the heavy load which now devolves upon Me, I am fully determined to be a Constitutional Sovereign in the strictest sense of the word, and as long as there is breath in My body to work for the good and amelioration of My People.

"'I have resolved to be known by the name of Edward, which has been borne by six of My ancestors. In doing so I do not undervalue the name of Albert, which I inherit from My ever to be lamented, great and wise Father, who by universal consent is, I think deservedly, known by the name of Albert the Good, and I desire that his name should stand alone.

"'In conclusion, I trust to Parliament and the Nation to support Me in the arduous duties which now devolve upon Me by inheritance, and to which I am determined to devote My whole strength during the remainder of My life.'

#### "TO THE COLONIES.

"The following message has been forwarded, by command of His Majesty the King, to all Colonies and Dependencies :—

"'The countless messages of loyal sympathy which I have received from every part of My Dominions over the Seas testify to the universal grief in which the whole Empire now mourns the loss of My beloved Mother.

"'In the welfare and prosperity of her subjects throughout Greater Britain the Queen ever evinced a heartfelt interest.

"'She saw with thankfulness the steady progress which, under a wide extension of Self-Government, they had made during Her Reign. She warmly appreciated their unfailing loyalty to Her Throne and Person, and was proud to think of those who had so nobly fought and died for the Empire's cause in South Africa.

"'I have already declared that it will be My constant endeavour to follow the great example which has been bequeathed to Me.

"'In these endeavours I shall have a confident trust in the devotion and sympathy of the people, and of their several Representative Assemblies throughout My vast Colonial Dominions.

"'With such loyal support I will, with God's blessing, solemnly work for the promotion of the common welfare and security of the great Empire over which I have now been called to reign.

## "'EDWARD, R. and I.

## " Windsor Castle, February 4th, 1901."

Be it, therefore, Resolved, That an humble Address be presented to His Honour the Lieutenant-Governor, requesting him to extend to the Governor-General of the Commonwealth the hearty congratulations of this House upon the accomplishment of such a happy and momentous event, and expressing the hope that prosperity and influence may follow the new Federation, and its commercial relations with the Dominion of Canada and this Province may be materially increased; and that, through the loyalty and devotion of the Commonwealth of *Australia* and the Dominion of Canada to the Imperial Throne, the permanent unity of the British Empire may become assured.

Of the revenue of \$264,019.41 received from West Kootenay District during the last fiscal year, how much was received from the Mining Divisions of Trail Creek, Nelson and Slocan, respectively?

The Hon. Mr. Turner replied as follows :---

"Returns furnished by District Assessors and Collectors do not conform to the boundaries of Mining Divisions in showing the revenue derived from each division separately; therefore, the information cannot be given from the data at the department."

Mr. Tatlow asked the Hon. the Provincial Secretary the following question :---

Is it the intention of the Government to proclaim the 24th of May (Empire Day) a public holiday?

The Hon. Mr. Prentice replied as follows :---

", 'H is Majesty, by and with the advice and consent of the Senate and House of Commons of Canada, enacts as follows :—-

"1. Throughout Canada, in each and every year, the twenty-fourth day of May, when not a Sunday, being the birthday of Her late Majesty Queen Victoria, shall be a legal holiday and shall be kept and observed as such under the name of 'Victoria Day.' ".2. When the twenty-fourth day of May is a Sunday, the twenty-fifth day of May shall be, in lieu thereof, a legal holiday throughout Canada, and shall be kept and observed as such under the same name."

The adjourned debate on the second reading of Bill (No. 16) intituled "An Act to amend the 'Public Schools Act'" was resumed.

The debate was again adjourned until to-morrow.

On the motion of Mr. Tatlow, seconded by Mr. Garden, it was Resolved,-

That in the opinion of this House, the promotion of ship-building and ship-owning in the Province is of the highest importance to the future commercial prosperity and advancement of British Columbia, and this House would respectfully urge upon both the Dominion and Provincial Governments the desirability of such a policy.

On the motion of Mr. Curtis, seconded by Mr. Munro, it was Resolved,--

That an Order of the House be granted for a Return of a copy of the judgment recently delivered by the Full Court of the Province with respect to the right of a naturalized Japanese applicant to be placed upon the voters' list, and also of the judgment of His Lordship Chief Justice *McColl* in the same matter.

3. Do the Government consider that it is in the public interest for the Land Registrar of any district to accept a public position like that of the Mayor of *Vancouver*, which takes so large a portion of the incumbent's time, and which is paid by a salary of \$2,000?
