The Petroleum and Natural Gas Act grants the Lieutenant-Governor in Council authority to make regulations or special orders governing the drilling of wells and the production and conservation of petroleum and natural gas including the prescription of (a) the conditions under which drilling operations may be carried out in water-covered areas, and any special measures to be taken in such operations; (b) the minimum standards of tools, casing, equipment, and materials that may be used for drilling, development, and production of petroleum or natural gas; (c) adequate casing and the proper anchorage and cementation thereof; (d) the measures to be taken before the commencement of drilling and during drilling and production to conserve any petroleum, natural gas, or water likely to be encountered; (e) limitations to the methods of operations to be observed during drilling and in the subsequent management of any well and conduct of any operation for any purposes including the protection of life, property, and wildlife, the prevention and extinguishment of fires, the prevention of wells flowing out of control, and the prevention of pollution of water; and (f) the conditions for general conservation of petroleum and natural gas, the waste or improvident disposition thereof, and any other matter incidental to the development and drilling of petroleum or natural-gas wells and their operation and production.

"The Drilling and Production Regulations, made pursuant to the *Petroleum* and Natural Gas Act, include provisions whereby the possibility of pollution is minimized. An owner wishing to drill a well must obtain approval from the Petroleum and Natural Gas Branch before commencing to drill. He must satisfy the Branch that adequate casing, blowout-prevention equipment, and safe drilling and completion practices will be employed in the operation. Branch staff make regular inspection of all drilling and producing operations within the Province to ensure that the regulations are being complied with." **114** Mr. *Eddie* asked the Hon. the Minister of Mines and Petroleum Resources the following questions:—

With reference to the Iron Bounty Act (R.S.B.C. 1960, chapter 200):-

1. Is there an agreement in effect between the Minister of Mines and Petroleum Resources and Consolidated Mining and Smelting Company Limited relative to the operation of its steel furnace?

2. If the answer to No. 1 is yes, (a) what is the term of the agreement as to effective dates and termination date, (b) what is the amount of bounty paid per ton for each of the classifications under section 5, clauses (a), (b), and (c), of the Act, and (c) what was the tonnage on which bounty was paid in each of the classifications mentioned above?
