Tuesday, 8th February, 1921.

THREE O'CLOCK P.M.

This being the first day of the first meeting of the Fifteenth Parliament or Legislative Assembly of the Province of British Columbia, for the dispatch of business, pursuant to a Proclamation of the Honourable WALTER CAMERON NICHOL, Lieutenant-Governor of the Province, dated the 27th day of December, 1920, the Members having been sworn took their seats.

His Honour WALTER CAMERON NICHOL, Lieutenant-Governor of the Province, having entered the House, took his seat on the Throne.

The Honourable Dr. MacLean, Provincial Secretary, said :---

Members of the Legislative Assembly:

I am commanded by His Honour the Lieutenant-Governor to announce that His Honour does not see fit to declare the causes of his summoning you at this time, and will not do so until you have chosen a Speaker to preside over your Honourable Body. His Honour hopes to be enabled to declare, during the afternoon, his reasons for calling you together.

His Honour was then pleased to retire.

The Hon. the Premier, the first Member for Victoria City Electoral District, moved, seconded by the Hon. the Attorney-General, the third Member for Vancouver City Electoral District, That *Alexander Malcolm Manson*, Esquire, Member for Omineca Electoral District, do take the Speaker's Chair, and preside over the meeting of this Assembly, and it was so *Resolved*.

John Keen, Esquire, the Clerk of the House, having declared Alexander Malcolm Manson, Esquire, duly elected, he was taken out of his place by the mover and seconder, and conducted 2

to the Chair, where, standing on the upper step, he expressed his grateful thanks to the House for the great honour they had been pleased to confer upon him by choosing him to be their Speaker.

And thereupon he sat down in the Chair, and the Mace was laid upon the table.

His Honour the Lieutenant-Governor again entered the House, and taking his seat on the Throne, the Speaker-elect then spoke to the following effect:---

MAY IT PLEASE YOUR HONOUR:

The House of Assembly have elected me as their Speaker, though I am but little able to fulfil the important duties thus assigned to me.

If, in the performance of those duties, I should at any time fall into error, I pray that the fault may be imputed to me, and not to the Assembly, whose servant I am, and who, through me, the better to enable them to discharge their duty to their King and country, humbly claim all their undoubted rights and privileges, especially that they may have freedom of speech in their debates, access to Your Honour's person at all seasonable times, and that their proceedings may receive from Your Honour the most favourable interpretation.

The Honourable Dr. MacLean then said :--

MR. SPEAKER:

I am commanded by His Honour the Lieutenant-Governor to declare to you that he freely confides in the duty and attachment of the House of Assembly to His Majesty's person and Government, and not doubting that their proceedings will be conducted with wisdom, temper, and prudence, he grants, and upon all occasions will recognize and allow, their constitutional privileges.

I am commanded also to assure you that the Assembly shall have ready access to His Honour upon all seasonable occasions, and their proceedings, as well as your words and actions, will constantly receive from him the most favourable construction.

His Honour the Lieutenant-Governor was then pleased to open the Session by the following gracious Speech:---

Mr. Speaker and Members of the Legislative Assembly:

I welcome you to the first Session of the Fifteenth Legislature of British Columbia.

Since last Session a referendum was held to ascertain the will of the electorate regarding continuance of the present "Prohibition Act" or substitution therefor of sale of liquors in sealed packages under Government control. Legislation to give effect to the decision of the electorate will require your careful consideration.

In pursuance of its policy to increase agricultural production, my Government, through its Land Settlement Board, has let a contract for the construction of dykes to protect a large area of land at Sumas, in the Fraser Valley.

In several of the settlement areas constituted under the provisions of the "Land Settlement and Development Act" creameries have been established to encourage the dairying industry. This policy will be continued wherever such assistance appears warranted.

You will be asked to provide a sum of money for subsidizing the use of explosives in the clearing of land for agricultural purposes and to assist *bona-fide* mineral prospectors.

Legislation passed in previous Sessions dealing with the matter of irrigation is proving efficacious and the solution of the problem is now assured.

The irrigation project undertaken by my Government in South Okanagan District has been advanced expeditionally. Part of the lands and a portion of townsite property will be placed on the market at an early date.

While the timber industry suffered a decline during the latter half of the year, the aggregate production exceeded that of the previous year and the outlook for 1921 is improving. Legislation will be submitted extending the time for payment of timber-licence fees in arrears.

Amendments to the "Coal-mines Regulation Act" making further provision for the safety of coal-miners will be laid before you.

STH FEBRUARY.

On the initiative of my Government a conference has been arranged with the United States Bureau of Mines, to take place in the month of September this year, for consideration of the standardization of mine-rescue work and apparatus, with a view to further safeguarding underground workers.

I am pleased to advise you that the system of correspondence schools introduced by the Department of Mines has received the approbation of numerous residents of mining districts who desire to qualify for positions of greater trust and responsibility. You will be asked to continue the grant made for the maintenance of this important educational work.

It is the intention of my Government to acquire the plant and property of Tranquille Sanatorium and hereafter to administer the same, and a Bill to make satisfactory provision for this institution will be submitted.

Provision will be made for the extension of the work of the Department of Health by extending the system of Provincial rural district nurses, and you will be asked to make an appropriation for this purpose.

I am pleased to inform you that work on the Trans-Provincial Highway has been carried on during the past year and that three important links in this highway have been completed. It is the intention of my Government to prosecute actively the continuation of this work during the year.

Consolidation of the "Companies Act" is intended in order to incorporate amendments made since revision of the Statutes in 1911, and certain further amendments to adapt this Act to local conditions will be laid before you.

Numerous amendments to the "Land Registry Act" made since 1911 necessitate consolidation of this Act. Further amendments designed to secure uniformity of expression throughout the rearrangement of its sections will be submitted.

Your attention will be called to the draft conventions and recommendations adopted by the International Labour Conference held in Washington, D.C., in accordance with the labour part of the Treaty of Versailles, and to the copy of a Report of the Committee of the Privy Council, approved by His Excellency the Governor-General on the 6th of November last, submitted to my Government "With a view to such legislative action in line with the proposals of such of the draft conventions and recommendations as are within the Provincial sphere," and legislation will be submitted in accordance therewith.

The Public Accounts for the past fiscal year will be laid before you.

The Estimates of Revenue and Expenditure for the coming year will be submitted for your consideration at an early date.

I now leave you to your deliberations, feeling confident that you will discharge worthily the duties and responsibilities of the Session.

His Honour the Lieutenant-Governor was then pleased to retire.

Prayers by the Rev. Dr. Parker.

Mr. Speaker reported that, to prevent mistakes, he had obtained a copy of His Honour's Speech.

The Hon. the Premier reported that under the powers conferred by subsection (2) of section 6 of the "Civil Service Act Amendment Act," chapter 13, 1920, an Order in Council was passed on the 3rd day of February, 1921, appointing John Keen, Esquire, of Kaslo, B.C., Clerk of the Legislative Assembly, *vice* Thornton Fell, K.C., deceased, and moved, seconded by the Hon. Dr. *King*, that the said appointment be now ratified under the said Act.

Motion carried.

On the motion of the Hon. Mr. Oliver, seconded by the Hon. Mr. Farris, it was Resolved,-That the Speech of His Honour the Lieutenant-Governor be taken into consideration forthwith. Mr. Mackenzie (Vancouver) moved, seconded by Mr. Perry (Fort George),-

That an humble Address be presented to His Honour the Lieutenant-Governor, thanking His Honour for his gracious Speech at the opening of the present Session.

We wish to assure His Honour that legislation dealing with the sale and control of liquor will have our most careful consideration.

We are pleased to learn that a contract has been let for the protection of a large area of agricultural land in the Fraser Valley, and that satisfactory progress is being made with the necessary construction-work.

We are pleased to learn that satisfactory progress is being made under the provisions of the "Land Settlement Act," and that creameries are being established in localities where justified.

The proposal to provide moneys to be used in cheapening the cost of explosives used in clearing land for agricultural purposes and for the use of *bona-fide* mineral prospectors will have our favourable consideration.

We are pleased to know that legislation dealing with the problem of irrigation is working out satisfactorily.

We note with satisfaction that the production of timber has been maintained during the year, and that there are reasonable prospects for an improvement in the near future.

The proposed amendments to the "Coal-mines Regulation Act" will have careful attention.

We note with satisfaction that the Government has proposed to take part in a conference for the standardization of mine-rescue work and appliances in connection therewith for the purpose of further protecting the safety of underground workers.

We are pleased to note that the system of correspondence schools, introduced by the Department of Mines, is producing satisfactory results.

We approve of the action of the Government in acquiring the plant and property of Tranquille Sanatorium, and the necessary legislation will have our cordial approval.

The proposal to extend the system of Provincial rural district nursing is commendable, and the necessary moneys will be provided.

The activity of the Department of Public Works in the construction of the Trans-Provincial Highway has our approval, and we learn with pleasure that the work will be vigorously prosecuted during the present year.

Legislation for the consolidation of the "Companies Act" and the "Land Registry Act" will receive our careful consideration, as will also legislation dealing with the hours and conditions of labour.

The Public Accounts for the past fiscal year will be carefully scrutinized.

The Estimates of Revenue and Expenditure will have our careful attention.

We assure Your Honour that we shall give our most careful and serious attention to all the duties of the Session, and that all questions shall have our most thoughtful and conscientious consideration.

Prayers by the Rev. J. G. Inkster.

The Hon. the Minister of Finance presented the Report of the Comptroller-General of the Province, 1920-21.

The Hon. the Minister of Railways presented the Balance-sheet of the Pacific Great Eastern Railway as at June 30th, 1920.

Mr. Hinchliffe asked the Hon. the Provincial Secretary the following questions-

1. How many Civil Servants have been retired from Government employ since their reinstatement in the Service after discharge from the C.E.F.?

2. What are the details of each case?

3. In what cases, with particulars, are reinstated Civil Servants receiving lower salaries than would have been the case had they not enlisted?

4. Have all the temporary employees who were appointed to take the places of men on active service, pending the return of the latter, been retired?

The Hon. Dr. MacLean replied as follows:-

"1. Two.

"2. Inefficiency.

"3. None.

"4. No; but every Civil Servant given leave for military duty was reinstated on application after his discharge."

Dr. Rose asked the Hon. the Minister of Agriculture the following questions:-

1. What disposal has been made of the carcasses of animals slaughtered for tuberculosis since March 31st, 1920?

2. Has any precaution been taken to prevent these carcasses being used for human consumption?

The Hon. Mr. Barrow replied as follows :---

"1. Carcasses for which compensation has been paid have been destroyed in the presence of the Veterinary Inspectors.

"2. Where compensation has been paid precautions have been taken to prevent carcasses being used for human consumption."

Mr. Pooley asked the Hon. the Minister of Agriculture the following questions :---

1. Has the Government received payment yet for the four horses and one stud colt procured by one Silverthorne in November, 1918, from the Government Frondeg Farm stock?

2. If so, when was payment made and what was the amount received?

3. If not, have any proceedings been taken to collect said sum, and when, and what was the result of said proceedings?

4. Does the Government know where the horses are now?

The Hon. Mr. Barrow replied as follows :---

"1. No payments of principal received, but interest to February 28th, 1920, has been paid.

"2. Interest of \$53.73 received April 6th, 1920.

"3. No proceedings instituted.

"4. No official knowledge as to whereabouts of horses."

Mr. Lister asked the Hon. the Provincial Secretary the following questions :---

1. How many appointments were made to the Civil Service during 1920?

2. How many of the appointees were returned soldiers?

The Hon. Dr. MacLean replied as follows :--

"1. Adult male: Permanent, 133; temporary, 175. Adult female: Permanent, 63; temporary, 222. Juniors: Permanent, 15; temporary, 32.

"2. Permanent, 105; temporary, 130."

Pursuant to Order, the House again resolved itself into a Committee of the Whole to consider the motion of the Hon. the Premier of the 11th February regarding Government control and sale of liquor.

Resolved, That an humble Address be presented to His Honour the Lieutenant-Governor, praying that he cause to be placed before the House for its consideration at an early date a Bill which will provide for Government Control and Sale in Sealed Packages of Spirituous and Malt Liquors.

And, further, that such Address be presented to His Honour the Lieutenant-Governor by such Members of this House as are of the Executive Council.

Resolved, That the Committee rise and report the Resolution.

Resolution reported and adopted.

Prayers by Mr. Speaker.

The Certificate of the Deputy Provincial Secretary of the result of the election of a Member to represent the vacancy in the Electoral District of Delta created by the resignation of that seat by the Hon. John Oliver was read, and Ordered to be placed on the Journals of the House, as follows:—

"PROVINCIAL SECRETARY'S OFFICE,

"VICTORIA, February 21st, 1921.

"Whereas a vacancy occurred in the Legislative Assembly by reason of the resignation of the Honourable John Oliver, a Member thereof for the Delta Electoral District; and

"Whereas on the 15th day of January, 1921, a writ for the election of a Member to represent the aforesaid Electoral District was duly issued to the Returning Officer of the said Electoral District:

"Now I do certify that on the 21st day of February, 1921, the said writ was returned to me by the Returning Officer with certificate endorsed thereon, whereby it appears that the electors of the said District have chosen *Alexander McDonald Paterson* to represent the Delta Electoral District in the Legislative Assembly.

Alexander McDonald Paterson, Member elected to represent Delta Electoral District, having been duly sworn, was introduced by the Hon. the Premier and Mrs. Smith, and took his seat.

On the motion of the Hon. the Premier, seconded by the Hon. Mr. Farris, the Rules were suspended and the name of Mr. Paterson added to the Select Standing Committee on Agriculture.

On the motion of Mr. Duncan, seconded by Mr. Burde, it was Resolved,-

That an Order of this House be granted for a Return of all correspondence passing between the Hon. the Minister of Mines and the Esquimalt & Nanaimo Railway Company with respect to bringing the administration of all minerals in the Esquimalt & Nanaimo Land Grant under control of the Government.

By the Hon. the Minister of Agriculture—The Third Annual Report of the Land Settlement Board.

By the Hon. the Provincial Secretary-Return of information respecting the Registrars of Voters, 1920.

By the Hon. the Minister of Mines-Return of correspondence relating to the dual control of the Esquimalt & Nanaimo Railway Belt.

On the following resolution being called, Mr. Hanes asked leave to withdraw same :--

Whereas it is desirable that an inquiry should be held into the cost of coal supplied to the consumers of British Columbia:

Therefore be it Resolved, That a Select Committee of five Members of this House be appointed, with instructions to inquire into all matters, including cost of production, wholesale and retail prices of coal supplied to residents of British Columbia; with power to call for persons, books, papers, and documents, to examine witnesses under oath, and to report their findings, recommendations, and evidence to the House.

Leave was granted.

Bill (No. 7) intituled "An Act to amend the Law relating to the Devolution of Estates in Land, and to consolidate and amend the Acts relating to the Transfer of Land, and providing for the Registration of Titles to Land" was again committed.

Progress reported.

Committee to sit again at the next sitting.

Mr. Jones asked the Hon. the Minister of Lands the following questions:-

1. What amount is being expended per month on salaries and expenses in connection with the work of the Lumber Trade Commissioner and his staff?

2. Has the lumber trade expressed dissatisfaction with the lack of results following upon such expenditures?

3. What service has the Lumber Trade Commissioner rendered to the industry?

The Hon. Mr. Pattullo rose to a point of order that the question was in breach of the Rules.

Mr. Speaker ruled that question No. 1 asks for information probably contained in the Public Accounts recently laid upon the table. If the information is therein contained the question should not be asked. Question No. 2 contains an allegation of fact and an improper inference. The question is therefore not in order and the series will be dropped from the Order Paper.

Mr. Jones asked the Hon. the Minister of Lands the following questions :---

Was the Pacific Logging Congress held in Vancouver during the month of October, 1920?
 What members of the British Columbia Forest Service were present, and at how many sittings of the congress was each present?

3. What monthly salary was each receiving at that time?

4. Was the value of these public employees' services such that they could be spared for an appreciable period without hindrance to the public service?

The Hon. Mr. Pattullo replied as follows :--

"1. Yes; on October 6th, 7th, 8th, and 9th.

"2. M. A. Grainger, Chief Forester, and W. Turnbull, Lumber Trade Commissioner, attended on four days; H. R. Christie, Assistant Chief Forester, and C. S. Cowan, Assistant Forester, attended on three days; H. K. Robinson, Assistant Forester, attended on two days. All District Foresters who were in Vancouver at that time in connection with the annual meeting of District Foresters, and sundry members of the Vancouver Forest District organization, attended at intervals.

"3. \$335 per month; \$260; \$300; \$220; \$225.

"4. The employees in question were there in the interests of the public service."

Mr. W. A. McKenzie asked the Hon. the Minister of Lands the following questions :--

1. On what dates did prices of cement for Southern Okanagan Settlement Area advance from \$3.90 per barrel to \$4.05 per barrel, and from \$4.05 per barrel to \$4.35 per barrel?

2. Have prices for 1921 advanced? If so, what is the price per barrel delivered f.o.b. Penticton?

3. Does the Government know whether a commission is being paid by the British Columbia Cement Company, Limited, to a man in Penticton on all cement purchases in connection with Southern Okanagan Settlement Area?

4. If so, what is the amount of said commission?

The Hon. Mr. Pattullo replied as follows :--

"1. August 7th, 1920, and September 17th, 1920, respectively.

"2. Not on any purchase to date.

"3. No.

"4. Answered by No. 3."

Mr. W. A. McKenzie asked the Hon. the Minister of Lands the following questions :-

1. Were any loans or grants made to any municipal corporation in aid of irrigation-works during the months of October and November, 1920, by the Department of Lands?

2. If so, what municipalities received such grants and loans, and for what length of time were they made in each case, and what amounts were granted or loaned in each case?

The Hon. Mr. Pattullo replied as follows :--

"2. Answered by No. 1."

Mr. W. A. McKenzie asked the Hon. the Minister of Lands the following questions:-

2. Have logging operations been carried on during the winters of 1919-20 and 1920-21?

3. Has logging been done by contract or by day-labour?

4. Has work in connection with sawmill been under the direction of F. H. Latimer, C.E., during years 1919 and 1920? If not, under whose direction has it been?

5. How far is Mr. Latimer's office from sawmill?

6. Did the Government recently call for tenders for logging the area adjacent to sawmill? If so, what are the names of the different tenderers, the amount of tender in each case, and to whom has contract been awarded, and at what price per thousand?

7. What is the total cut to December 31st, 1920?

8. What has been the cost per thousand, delivered where required?

The Hon. Mr. Pattullo replied as follows :--

"1. \$7.50 to \$12 per thousand, depending on distance hauled and road-construction necessary. "2. Yes.

"3. By contract and day-labour.

"4. Up to April 1st, 1919, under direction of F. H. Latimer through superintendent at mill; from April 1st, 1920, to December 15th, 1920, under direction of A. E. Griffin, contractor, through superintendent at mill, under general supervision of F. H. Latimer.

S. How many thousand feet B.M. did contractors haul during the year 1920?

The Hon. Mr. Pattullo replied as follows :---

4. Have any oil claims been staked in British Columbia during the last twelve months? If yes, how many, and where?

S. What other allowances did he receive, such as: (a) Travelling expenses; (b) board? Give particulars in each case.

9. Was said Kane injured during the time he was in the employ of Government? If so, did injury occur while performing Government work?

"4. Yes, under supervision of Project Engineer.

3. What was the verdict of jury?

4. If the verdict of the jury was indefinite, has there been an inquiry into said causes?

5. Have there ever been requests for such inquiry?

6. If so, has the Department ordered such inquiry?

7. If not, why not?

The Hon. Mr. Sloan replied as follows :--

"1. Yes.

"2. Yes.

"3. We, the jury on the inquiry into the deaths of John Monks *ct al.* at Coal Creek on April 5th, 1917, hereby find that these men met their death by an explosion, the first cause of which is unknown to us by the evidence adduced.

"'We, however, would recommend from evidence received that the single shift would, if practical, be a great factor in preventing an explosion such as this.

"'In witness whereof, as well the aforesaid Coroner as the jurors aforesaid, have to this inquisition put their seals on the day and year and at the place first above mentioned.

"' (Signed) WILLIAM JACKSON, Foreman.

JAMES LINN. JOHN J. WOOD. WM. ROBSON. GEO. CODY. WM. MOBRISON.
