Whereas the Legislative Assembly of *Queensland*, Australia, passed An Act intituled "The Chinese Immigrants Regulation Act of 1877," which has received the assent of the Imperial Government, the principles of which, if made law by the Parliament of Canada, would beneficially regulate the immigration of Chinese into this Province;

Be it, therefore, Resolved, That the Government of the Dominion of Canada be respectfully requested by this Legislative Assembly, by telegram from the Hon. the Speaker, to cause an Act similar in principle to the "Chinese Immigrants Regulation Act, 1877," of Queensland, Australia, to become law during the present Session of the. Parliament of Canada.

Mr. Gallagher asked the Honourable the Chief Commissioner of Lands and Works the following Question:—

Is it the intention of the Government to amend the "Cassiar Trail Toll Act, 1876," so as to permit all Provincial produce to pass free of said Toll?

The Honourable Mr. Walkem replied as follows:--

"The Dominion Government, through the Department of Justice, have expressed themselves strongly against allowing legislation which imposes tolls on foreign goods or produce but exempts home produce from such tolls, as such legislation tends to interfere with trade and commerce."

Pursuant to Order, the House resolved itself into a Committee of the Whole to consider the motion, That a Supply be granted to Her Majesty.

On Mr. Speaker resuming the Chair, Mr. Galbraith, Chairman of the Committee,

reported the motion.

Resolved, That a Supply be granted to Her Majesty.

# Thursday, 22nd April, 1880.

Two o'clock, P.M.

Mr. Smithe presented the Fourth Report from the Select Standing Committee on Private Bills and Standing Orders, which was read and received.

The Honourable Mr. Beaven presented a Statement of Appropriation and Expenditure showing the sums voted from 1st January, 1879, to 30th June, 1880; and the Expenditure corresponding thereto, from 1st January, 1879, to 31st March, 1880; also, the sums under-expended and over-expended. (See Sessional Papers.)

The Honourable Mr. Beaven presented a Detailed Statement of Expenditure from 1st January to 31st March, 1880. (See Sessional Papers.)

On the motion of the Honourable Mr. Beaven, seconded by Mr. E. Brown, it was Resolved,—

Whereas the payment of taxes and licences is evaded by the Chinese population: And, whereas, an Act has been passed in *Queensland*, *Australia*, and assented to by the Imperial Government, to the effect hereinafter mentioned.

Be it therefore Resolved, That the Government of the Dominion of Canada be requested by this House to cause a Bill to be passed, empowering the Province of British Columbia to pass an Act to the following effect:—

1. The sum payable by Chinese for a free miner's certificate shall be fifteen dollars, and for a business licence shall be double the rates levied under the various Licences Ordinances and Acts of the Province, for each year during which the same is to be in force.

And no free miner's certificate or business licence shall hereafter be issued to any such Chinese except on payment of such sums as aforesaid respectively.

2. Any Chinese who shall be found mining or carrying on business on any gold field, not having in his possession a free miner's certificate or business licence lawfully issued to him;

And any person who shall upon any gold field employ in mining any Chinese who

has not in his possession a free miner's certificate lawfully issued to him,

Shall, on conviction thereof, forfeit and pay a sum not exceeding twenty-five dollars, and in default of immediate payment the amount of such penalty shall be levied by distress and sale of the goods and chattels of the offender, and in default of such distress, or if sufficient distress be not found, the offender shall be liable to be imprisoned, with or without hard labour, for any period not exceeding three months.

- 3. In any prosecution for any offence against the provisions of this Act, the averment in the information that any person named therein had not in his possession at the time of the alleged offence a free miner's certificate or business licence lawfully issued to him, shall be sufficient proof that such person had not such free miner's certificate or business licence, unless the defendant shall prove the contrary.
- 4. Any information for any offence against this Act, may be heard and determined by any two Justices of the Peace, and any such Justices may hear and determine the same in a summary manner at any place where any offender shall be found within the limits of any gold field.
  - 5. No Chinese shall be entitled to be naturalized.
  - 6. This Act shall be styled and may be cited as the "Chinese Tax Act."

The Honourable Mr. Walken asked leave to introduce a Bill, No. 29, intituled "An Act relating to Partition."

Ordered, That leave be granted. Bill introduced and read a first time.

Ordered to be read a second time to-morrow,

Mr. Wilson asked leave to introduce a Bill No. 30, intituled "An Act to protect the Independence of Parliament."

Ordered, That leave be granted.

Ordered to be read a first time on Monday next.

Mr. Wilson asked the Honourable the Provincial Secretary the following Question: Is it the intention of the Government to place any amount upon the Estimates for defraying the claims of Messrs. Edwards, Shields, Smith, and Kampton, for the destruction of panthers or wolves?

The Honourable Mr. Humphreys replied as follows:—

"Until the Estimates are presented, I am not in a position to say what claims will be defrayed."

The Honourable Mr. Beaven delivered to Mr. Speaker a Message from His Honour the Lieutenant-Governor, signed by His Honour.

The said Message was read by Mr. Speaker, and is as follows:-



An Act amending the "Members' Indemnity Act, 1875."

An Act respecting the Esquimalt Graving Dock.

His Honour was pleased, in Her Majesty's name to give assent to these Bills.

The same was announced by the Clerk of the House, in the following words:-

"In Her Majesty's name, His Honour the Lieutenant-Governor doth assent to these Bills."

Then the Honourable the Speaker addressed His Honour the Lieutenant-Governor, as follows:—

#### MAY IT PLEASE YOUR HONOUR:

We, Her Majesty's most dutiful and loyal subjects, the Legislative Assembly of the Province of British Columbia, in Session assembled, approach Your Honour, at the close of our labours, with sentiments of unfeigned devotion and loyalty to Her Majesty's person and Government, and humbly beg to present for Your Honour's acceptance, a Bill intituled "An Act for granting certain Sums of Money for the Public Service of the Province of British Columbia."

To this Bill the Clerk of the Legislative Assembly, by His Honour's command, did thereupon say:—

"In Her Majesty's name, His Honour the Lieutenant-Governor doth thank Her Majesty's loyal subjects, accept their benevolence, and assent to this Bill."

Then His Honour the Lieutenant-Governor was pleased to deliver the following Speech:—

Gentlemen of the Legislative Assembly:

The state of the public business now enables me to close the Session.

I have given my assent to the various measures of public utility which you have passed, and I feel persuaded that the care and attention which you have bestowed upon them will be fully appreciated by the country.

It is gratifying to find that you have approved of the policy submitted for your consideration in connection with Railway matters, and that the new arrangement lately made with the Dominion Government respecting the construction of the Graving Dock has met with your sanction.

You are to be congratulated on the result of your untiring efforts to secure the commencement of the Provincial portion of the Canadian Pacific Railway, as, apart from the national advantages to be derived from the work, its active prosecution will unquestionably effect a vast improvement in our existing industries, and give life to many valuable ones that are now dormant.

I have to thank you for the provision you have made for the public service, and to

assure you that it will be carefully administered.

In now relieving you from your duties, I sincerely trust that our mutual hopes and anticipations of prosperity may be realized.

The Honourable Mr. Humphreys, Provincial Secretary, then said,-

Mr. Speaker and Gentlemen of the Legislative Assembly:

It is His Honour the Lieutenant-Governor's will and pleasure that the Legislative Assembly be prorogued until Monday, the Ninth day of August next, to be then here holden, and this Provincial Legislative Assembly is accordingly prorogued until Monday, the Ninth day of August next.
