MR. SPEAKER:

Your Select Standing Committee on Social Welfare and Education begs leave to report as follows:—

Your Committee held three meetings during the course of the Session.

Dr. Amyot, Provincial Deputy Minister of Health, addressed one meeting on general health conditions in British Columbia.

Major Moilliet addressed the meeting on the subject of juvenile delinquency and a remedial plan for delinquents of higher teen-age boys. Your Committee thought enough of this plan to recommend that the Attorney-General be approached with a view to obtaining Major Moilliet's services on the Borstal Committee.

Dr. Paskin, vice-president of the Naturopaths' Association, gave an illuminating address on his experiences in the cause and treatment of rheumatoid arthritis.

Your Committee has resolved as follows:-

It was Resolved, That this Committee recommend that, in view of the serious social and economic problem involved in the increasing incidence of arthritis and other rheumatoid diseases, the Provincial Government should take steps to increase facilities in existing hospitals for the more advanced methods of treatment for both indoor and outdoor patients, and the development of hot springs and other natural medicinal resources at suitable locations where all sound measures to help arthritis might be applied.

The Committee feels that the Legislature should take advantage of the existence of this Committee and submit to it matters which they could investigate and report upon.

Of the sessional allowance of three thousand dollars paid to each member of the Legislative Assembly who attended the session that commenced on the twenty-first day of February, 1946, it is declared that two thousand dollars was by way of remuneration and one thousand dollars for expenses incidental to the discharge of his duties as a member."

For providing for an annual tax on every person occupying or using real property or any building or structure or any part thereof for the purpose of carrying on within the municipality any business, trade, profession, or other occupation, the tax to be based on the annual rental value of the real property occupied or used for the purpose of such business or businesses, and to be known as a "business tax":
- "'(b.) For classifying the businesses, trades, professions, or other occupations for the purpose of the tax:
- "(c.) For fixing the rates applicable to each class of business, trade, profession, or other occupation:
- "'(d.) For making such regulations pertaining to assessment, appeal from assessment, collection, and all other matters as may be necessary for the proper administration of the tax:
- "'(e.) For fixing dates for payment and imposing penalties, not exceeding ten per centum of the amount of the business tax remaining unpaid after the date fixed for payment.
- "'(2.) Every person subject to the business tax shall have his business tax abated to the extent of any trade-licence fee paid by him to the municipality in respect of the same business.
- "'(3.) An occupant of property shall not be freed from taxation under this section by reason only of the fact that he is the owner of such property.
- "'(4.) Every person assessed for business assessment shall be liable for the payment of the tax thereon, and the same shall not constitute a charge upon the real property occupied or used.
- "'(5.) The liability imposed by this section shall be a debt recoverable by action brought by the Corporation in any Court of competent jurisdiction.
- "'(6.) Every person liable to the business tax who violates any of the provisions of any by-law made under this section shall, on summary conviction, be liable to a penalty not exceeding two hundred and fifty dollars for every such violation.
- "'(7.) The Council may by by-law require and thereupon it shall be the duty of every owner or agent renting or leasing premises to any person to notify the assessor within seven days of the commencement of all occupancies and changes in occupancy.
- "'(8.) Any person who fails to comply with any of the provisions of this section or of any by-law made thereunder shall be liable, on summary conviction, to a penalty not exceeding ten dollars for every day on which such failure continues."

Bill (No. 16) intituled "An Act respecting Agrologists" was committed, reported complete with amendments, and, by leave of the House, the Rules were suspended, and the Bill read a third time and passed.

Order called for "Motions and Adjourned Debates on Motions."

The debate was continued on the motion moved on the 26th day of March by Mr. H. E. Winch, and seconded by Mr. Gargrave,—

That a Select Special Committee of the Legislature be appointed on veterans' and displaced war-workers' affairs: (1) To consider ways and means of assisting British Columbia war veterans and war-workers to re-establish themselves and to promote their general welfare, and, towards the attainment of this objective, to receive representations and recommendations, written or oral, from veterans' and other interested organizations; (2) to consider proposals for new or amending legislation relating to or affecting veterans and displaced workers in the Province; (3) to review the findings of the British Columbia Post-war Council with a view to seeing whether any further implementation of the recommendations at this Session would assist employment and industrial development; (4) to recommend policy in the interests of war veterans and displaced war-workers for the consideration of the Assembly and of the Federal Parliament, said Committee to report to the Legislature during the present Session the results of its deliberations, and to be empowered to send for persons, papers, and records, and to examine witnesses under oath.

And the amendment thereto moved by Mr. Stevenson, and seconded by Mr. Bennett,-

That all the words after "That" in the first line be struck out, and the following be substituted therefor:—

"We commend the Government for the implementing, up to date, of the many recommendations contained in the reports of the Post-war Rehabilitation Council, and for the Post-war Bureau which has for its purpose the continued study and implementation of further recommendations contained in those reports."

Amendment agreed to.

Motion as amended agreed to.

Mr. Corsbie moved, seconded by Mr. Rowland,-

Whereas farmers in many sections of British Columbia have expressed the necessity for obtaining agricultural lime at reasonable prices:

And whereas the Province of Nova Scotia, although not a lime producer, has been able to make lime available at lower rates than those appertaining in British Columbia:

And whereas lime is a prime agricultural necessity, not only for its chemical action on the soil, but for its beneficial action in increasing the nutritional value of agricultural produce:

Therefore be it Resolved, That this Legislative Assembly request the Provincial Government to give early consideration to ways and means of making agricultural lime more easily available to British Columbia farmers at lower prices than those now being charged.

A debate arose.

The motion was negatived.

By leave of the House, the following notice of motion standing on the Order Paper in the name of Mr. Turner, was withdrawn:—

That this Legislative Assembly regrets that the Government has not recognized: (1) That the increasing automobile accident and fatality rates and the inadequate number of automobiles carrying public-liability and property-damage insurance are cause for considerable alarm; (2) that an increasing number of responsible organizations have expressed themselves in favour of compulsory automobile insurance; (3) and, in view of the foregoing, have not appointed an interdepartmental committee to examine all factors relating to the merits of the present system of automobile insurance, with particular reference to compensation for injury and incapacitation, with instructions to the committee to examine alternative forms of insurance which give compensation to all persons injured through automobile accidents and to make recommendations thereon to the Government.

Mr. H. E. Winch moved, seconded by Mr. Gargrave,-

That this Legislative Assembly regrets that the Government has not taken action to appoint a Royal Commission to inquire into the following questions: (1) Whether any moneys have been subscribed to political campaign funds by brewing and distilling interests or their agents or agencies: (2) whether assurance and protection have been promised or given by political parties, their agents or candidates, to liquor interests in consideration of moneys promised or received; (3) the feasibility of supplementing existing legislation so that campaign contributions from those dealing in the production and distribution of liquor commodities would be illegal and that an adequate punishment, including imprisonment, be imposed for any offence thereunder; (4) the advisability of bringing the brewing and distilling industry, in all its productive and distributive operations, under public ownership; (5) present methods of distribution and recommendations as to possible improvements; and (6) the advisability of pursuing a major educational campaign for temperance and the best methods of conducting same.

A debate arose.

The motion was negatived.

Mr. Gargrave moved, seconded by Mr. H. E. Winch,-

Whereas the rise in the cost of living has made the lot of our citizens in receipt of old-age pensions extremely difficult:

And whereas the Provincial Government has recognized this fact by granting an additional \$5 monthly bonus:

And whereas it is still necessary to improve conditions for our senior citizens:

Therefore be it Resolved, That this House petition the Government of the Dominion of Canada, urging that the "Old Age Pensions Act" be amended to provide for the complete removal of the means test, and that the maximum pension be raised to meet increased living costs, and that the age at which persons become eligible for pension be reduced to 65 years for men and 60 years for women.

A debate arose.

The motion was negatived.

Mr. Gargrave moved, seconded by Mr. H. E. Winch,-

That this Legislative Assembly regrets that the Government has not taken any action to implement the recommendations of the Post-war Rehabilitation Council as outlined on page 117 of their interim report filed in the Legislature on Thursday, February 4th, 1943, as follows:—

"That wherever conditions exist in company towns restricting the establishment of business, cultural, religious, and other institutions, and the free movement of citizens, such restrictions should be abolished:

"That legislation should be enacted to make such communities fully available to employees of the industry concerned and others, and to permit them to build and own houses, to purchase land to enable the establishment of private, co-operative, and other enterprises—not necessarily owned or controlled by the company or owners of company towns—for purposes of trading and the general conduct of legitimate business, in order that company towns shall be on the same footing as other communities in this Province and fully open to the self-government, enterprise, residence, and enjoyment of our people."

Mr. R. H. Carson moved in amendment, seconded by Mr. King,-

That all the words after the word "Assembly" in the first line be struck out, and the following substituted therefor: "That this Legislative Assembly recommends the Government take further steps to provide an efficient and comprehensive supervision of company towns, and the development of all communities in rural areas."

Amendment agreed to.

Motion as amended agreed to.

Mr. Brett moved, seconded by Mr. Corsbie,—

That this Legislative Assembly express the view that the action of the Parliament of Canada in taxing co-operative associations constitutes a serious limitation upon the activities of people in their effort to achieve economic democracy through co-operation:

Further, that this Legislative Assembly request the Government to protest the restriction imposed by the "Income War Tax Act" upon the disposition by co-operatives of their earnings, and urge: (1) That subsection (9) of section 5 of the "Income War Tax Act," as enacted by 1946 Canada Statutes, chapter 55, section 4, subsection (13), which provides that no co-operative be allowed to distribute tax-free patronage dividends to the extent of reducing its taxable income below a level of 3 per cent. on capital employed, be repealed; (2) that co-operatives be allowed to set aside limited reserves to guard against the impairment of capital and unexpected losses at least to

the extent of the minimum required by Provincial law before taxable income is determined.

A debate arose.

The motion was negatived.

Mr. Turner moved, seconded by Mr. Corsbie,-

Whereas housing in Canada is still in a very serious condition:

And whereas there is no immediate relief in sight for the large number of citizens whose low incomes preclude them from owning their own homes:

Therefore be it Resolved, That this Legislature recommends that the Provincial Government do request that the Federal Government readjust its housing policy to provide for the establishment of Provincial housing authorities which shall seek to co-ordinate the activities of Federal, Provincial, and municipal governments for the purpose of supervising the planning, construction, and management of low-rental housing projects.

Mr. Ritchie moved in amendment, seconded by Mr. W. J. Johnson,-

To strike out all the words following "serious condition," and to substitute the following:—

"Whereas the Federal Government has assumed full responsibility for Canada's housing problem and exercises complete control over materials entering into the construction of homes:

"And whereas this Legislature views with approval the passing by the Federal Government of an Order in Council providing for depreciation at double the rates normally allowed on approved rental housing projects and the provision, through priorities, for building materials for such rental housing projects, the shortage of which now impedes the construction of homes:

"Therefore be it Resolved, That this Legislature, in the light of the critical housing conditions existing, respectfully suggests a policy of closer co-operation between the Federal Government and those industries manufacturing and supplying commodities now in short supply, the lack of which now curtails the building of homes so urgently required."

Amendment agreed to.

Motion as amended agreed to.

The Hon. Mr. Carson moved, seconded by the Hon. Mr. Kenney,-

That this Legislature recommends that the question of the application of Campbell Construction Company, Ltd.; Fred Mannix & Company, Ltd.; Dawson, Wade & Company, Ltd.; General Construction Company, Ltd.; Emil Anderson Construction Co.; W. C. Arnett & Company, Ltd.; and Campbell-Mannix Companies for an increase of the contract prices, based upon increased costs due to circumstances beyond their control, arising out of Legislative Acts and directives of Governmental authorities, and set out as follows: (1) The amendments to the "Hours of Work Act" and the amendment of the "Annual Holidays Act" during the 1946 Session of the British Columbia Legislature; (2) the directives issued by the Regional War Labour Board for British Columbia that granted wage increases across the board; (3) the recent orders made by the Motor Carrier Branch of the Public Utilities Commission that increased truckhire rates; (4) the orders made by the Wartime Prices and Trade Board that increased prices of materials; and (5) the general shortage of men, materials, and machines; be referred to a Judge of the Supreme Court or of the Court of Appeal to sit as an arbitrator to determine what is the fair and equitable amount by which such contract prices should be increased.

The Hon. Mr. Wismer moved in amendment, seconded by the Hon. Mr. Hart,-

That the motion be amended by inserting the words "if anything" after the word "what" in the next to last line.

Amendment agreed to.

Motion as amended agreed to.

The debate was continued on the motion made on the 1st instant by Mr. H. E. Winch, and seconded by Mr. Gargrave,—

That this House regrets that the University of British Columbia Board of Governors has not seen its way clear to accept the recommendation of this Legislature that a medical school be established this year, and recommends reconsideration of their decision by the Board of Governors.

Mrs. Hodges moved in amendment, seconded by Mr. Straith,—

That the Resolution on Votes and Proceedings moved by Mr. H. E. Winch be amended by striking out all the words after the word "recommends" and substituting therefor the following: "That the Government be asked to investigate the availability of hospital accommodation throughout the Province for medical school purposes."

The amendment was negatived.

The motion was agreed to.

The Hon. Mr. Pearson presented the following papers:-

The Annual Report of the Mental Hospitals for the Year ended March 31st, 1946.

The Thirty-fourth and Thirty-fifth Reports of the Medical Inspection of Schools for the Years ended June 30th, 1945 and 1946.

Mr. E. E. Winch asked the Hon. the Attorney-General the following question:

What action, if any, has been taken or is being contemplated relative to providing psychological and psychiatric examinations in (a) public schools, (b) Provincial gaols, and (c) to all young persons dealt with in the Juvenile Courts?

The Hon. Mr. Wismer replied as follows:-

"The Government has not yet come to a decision on these matters."

Resolved, That the House, at its rising, do stand adjourned until 10.30 o'clock a.m. to-day.

And then the House adjourned at 5.24 a.m.

His Honour was pleased, in His Majesty's name, to give assent to the said Bills.

The said assent was announced by the Clerk of the House in the following words:—
"In His Majesty's name, His Honour the Lieutenant-Governor doth assent to these
Bills."

Then Mr. Speaker addressed His Honour the Lieutenant-Governor as follows:—May it please Your Honour:

We, His Majesty's most dutiful and loyal subjects, the Legislative Assembly of the Province of British Columbia, in Session assembled, approach Your Honour at the close of our labours with sentiments of unfeigned devotion and loyalty to His Majesty's person and Government and humbly beg to present for Your Honour's acceptance Bill (No. 73) intituled "An Act for granting certain Sums of Money for the Public Service of the Province of British Columbia."

To this Bill the Clerk of the Legislative Assembly, by His Honour's command, did thereupon say:—

"In His Majesty's name, His Honour the Lieutenant-Governor doth thank His Majesty's loyal subjects, accept their benevolence, and assent to this Bill."

Then His Honour the Lieutenant-Governor was pleased to deliver the following gracious speech:—

Mr. Speaker and Members of the Legislative Assembly:

At the close of the Second Session of the Twenty-first Parliament, I relieve you of your legislative duties with every assurance that the measures you have enacted and the provisions you have made will inure to the benefit of the people, and further promote those developments that have been so wisely planned for the economic advancement of the Province. I wish also to express my appreciation of the diligence with which you have attended to the business of this House.

Ratification of the tax agreement with the Dominion Government will stabilize our revenues for the next five years, thereby permitting business to plan for the future, and also expedite a Dominion-Provincial Conference which would deal with social welfare measures and the public investment programme so essential to high-level employment.

Impletion of the Royal Commission's Report on Provincial-Municipal financial relations should be of great benefit to the cities and municipalities by enabling them to administer their affairs on a sound fiscal basis.

Provision of a further \$10,000,000 for the British Columbia Power Commission will assure the carrying-out of power expansion and rural electrification which is so important to the development of the Province.

The further provision of funds to bring our public works programme for roads, bridges, and buildings up to \$50,000,000 should do much to open up the Province and provide new opportunities based on the development of our natural resources.

It is gratifying to note that much has been done to encourage agricultural pursuits through such measures as those implementing the Royal Commission's Report on Irrigation, Dyking, and Drainage; establishing a new land-settlement policy based on scientific studies; widening the scope of land-clearing assistance and other provisions.

Modification of the "Petroleum and Natural Gas Act"; further impletion of recommendations made by the Royal Commission on Forestry so as to bring about sustained yield; expansion of the work of the British Columbia Scientific and Industrial Research Council; establishment of a Department of Fisheries; the progress made with respect to surveys in connection with the proposed extension of the Pacific Great Eastern Railway, and many other steps taken by my Government give evidence that no opportunity is being overlooked in the effort to open up our vast resources, and thereby create a wide range of opportunities for our young men and women who are equipping themselves to play their part in the development of this great Province.

The granting of a further cost-of-living bonus to old-age pensioners, extension of health services, improvement in our labour laws, and provision of protective measures will greatly improve the welfare of the people.

Provision of adequate funds for the establishment of a Medical Faculty at the University of British Columbia should give great encouragement to the Board of Governors to begin immediately with the institution of so important and so urgently needed a Faculty.

Redrafting of the Elections Act has widened the scope of the franchise and made possible a more efficient administration of the voting arrangements.

Revision of our liquor laws will tend to improve the administration of the sale of liquor.

The splendid financial position of the Province will commend itself to all.

I thank you for the adequate provision you have made for the public services.

In relieving you of your labours, I trust the blessing of Divine Providence will accompany you to your homes.

The Hon. Mr. Pearson, Provincial Secretary, then said:—

Mr. Speaker and Members of the Legislative Assembly:

It is His Honour the Lieutenant-Governor's will and pleasure that the Legislative Assembly be prorogued until it shall please His Honour to summon the same for dispatch of business, and this Provincial Legislative Assembly is hereby prorogued accordingly.
