Tuesday, February 8th, 1949.

THREE O'CLOCK P.M.

This being the first day of the fifth meeting of the Twenty-first Parliament or Legislative Assembly of the Province of British Columbia for the dispatch of business, pursuant to a Proclamation of the Honourable Charles Arthur Banks, Lieutenant-Governor of the Province, dated the 3rd day of December, 1948.

His Honour CHARLES ARTHUR BANKS, Lieutenant-Governor of the Province, having entered the House, took his seat on the Throne.

The Hon. Mr. Pearson, Provincial Secretary, said:-

Members of the Legislative Assembly:

I am commanded by His Honour the Lieutenant-Governor to announce that His Honour does not see fit to declare the causes of his summoning you at this time, and will not do so until you have chosen a Speaker to preside over your Honourable Body. His Honour hopes to be enabled to declare, during the afternoon, his reasons for calling you together.

His Honour was then pleased to retire.

The Hon. Mr. Johnson then announced the appointment by the Government of Mr. Edwin Keary DeBeck as Clerk of the Legislative Assembly, subject to the ratification by the Legislature.

The Hon. Mr. *Johnson* then announced the resignation of the member for Kamloops Electoral District as Speaker of the Legislative Assembly, owing to ill-health.

The Hon. Mr. Johnson, Premier, member for New Westminster Electoral District, addressing himself to the Clerk, moved, seconded by Mr. H. E. Winch, first member for Vancouver East Electoral District, that John Hart, Esquire, LL.D., first member for Victoria City Electoral District, do take the Speaker's chair, and preside over the meeting of this Assembly, and it was so Resolved.

E. K. DeBeck, Esquire, the Clerk of the House, having declared John Hart, Esquire, duly elected, he was then taken out of his place by the mover and seconder, and conducted to the chair, where, standing on the upper step, he expressed his grateful thanks to the House for the great honour they had been pleased to confer upon him by choosing him to be their Speaker.

And thereupon he sat down in the chair, and the mace was laid upon the table.

His Honour the Lieutenant-Governor again entered the House, and taking his seat on the Throne, the Speaker-elect then spoke to the following effect:—

MAY IT PLEASE YOUR HONOUR:

The House of Assembly have elected me as their Speaker, though I am but little able to fulfil the important duties thus assigned to me.

If, in the performance of those duties, I should at any time fall into error, I pray that the fault may be imputed to me, and not to the Assembly, whose servant I am, and who, through me, the better to enable them to discharge their duty to their King and country, humbly claim all their undoubted rights and privileges, especially that they may have freedom of speech in their debates, access to Your Honour's person at all seasonable times, and that their proceedings may receive from Your Honour the most favourable interpretation.

The Hon. Mr. Pearson then said:-

MR. SPEAKER:

I am commanded by His Honour the Lieutenant-Governor to declare to you that he freely confides in the duty and attachment of the House of Assembly to His Majesty's person and Government, and not doubting that their respective proceedings will be conducted with wisdom, temper, and prudence, he grants, and upon all occasions will recognize and allow, their constitutional privileges.

I am commanded also to assure you that the Assembly shall have ready access to His Honour upon all seasonable occasions, and their proceedings, as well as your words and actions, will constantly receive from him the most favourable construction.

His Honour the Lieutenant-Governor was then pleased to open the Session by the following gracious Speech:—

Mr. Speaker and Members of the Legislative Assembly:

I welcome you to the Fifth Session of the Twenty-first Parliament of British Columbia.

Since the Legislature last convened, the people of this Province have been grieved deeply to hear of the illness of His Majesty the King, and I am gratified to learn that my Government, on behalf of the citizens of British Columbia, have suitably expressed concern for his welfare and made manifest their hope that his recovery will not be too long delayed.

British Columbia, in common with other Provinces throughout the Dominion, has rejoiced greatly over the birth of a son to Her Royal Highness the Princess Elizabeth and His Royal Highness the Duke of Edinburgh. My Government have extended to the happy couple the people's expression of warm felicitations and imparted every good wish for the future.

Since you last met, the Province has lost a faithful public servant through the death of Mr. James L. Webster, member for Rossland-Trail. Mr. Webster's kindly disposition and unselfish service to others endeared him to the hearts of all.

It is with pleasure that I welcome to the Legislature two new members—namely, Mr. Robert Denis Browne-Clayton, of South Okanagan, and Mr. James O'Donnell Quinn, of Rossland-Trail. I trust they will enjoy serving the public in their capacities as members of Parliament, and I feel sure that much benefit will be derived from the counsel they have to offer.

During the year just past, British Columbia was stricken by severe flood conditions which required emergency measures. At a special meeting of Parliament, my Government was empowered to carry out certain proposals for the alleviation of conditions

created by the floods. During the course of this Session you will be advised of the progress made in this regard.

You will be informed of the action that has been taken and of measures proposed

for bringing about greater flood-control.

There also will be outlined my Government's policy for irrigation throughout the Province.

My Government will disclose the progress made to bring about the establishment of important industries, particularly as they relate to the processing of paper-pulp, other wood products, and the manufacture of aluminium.

The proposals of my Government for the improvement and development of the Pacific Great Eastern Railway will be placed before you.

Provision will be asked for further expansion of forest-protection work. Appropriations will be placed before you to ensure further development of Mount Seymour Park, which is so important as a recreational outlet for the thickly populated area of the Lower Mainland.

Measures will be submitted to relieve and equalize the incidence of taxation for educational purposes within the rural areas of the Province.

Further alleviation of the burden of text-book costs will be proposed.

You will be asked to make adequate financial provision to enable the University of British Columbia to proceed with its programme of expansion.

Supplementing major undertakings already in progress, provision will be asked for an extensive programme of public works, including main highways, bridges, secondary roads, schools, hospitals, public institutions, and office buildings.

There will be placed before you for consideration amendments to the "Highway Act" providing for the implementation of the recommendation in the Goldenberg Report on Provincial-Municipal Relations as it affects financial assistance to cities in connection with the maintenance and construction of trunk roads.

Legislation will be introduced to establish the New Haven institution for young offenders of the law on a basis which will make it more effective as a corrective institution.

Legislation will be placed before you providing for increased borrowing-powers to finance major public works and power-development.

Acting in accordance with the recent ruling of the Supreme Court of Canada, my Government will recommend the rescinding of legislation which presently prohibits the sale of butter substitutes.

The Public Accounts will be presented and Estimates for the ensuing year will be submitted.

Legislation affecting many branches of public service of a character designed to improve existing Acts will be placed before you.

I pray that the blessing of Divine Providence may rest upon your labours.

His Honour the Lieutenant-Governor was then pleased to retire.

Prayers by the Rt. Rev. H. E. Sexton, Lord Bishop of British Columbia.

Mr. Speaker reported that, to prevent mistakes, he had obtained a copy of His Honour's Speech.

the Lieutenant-Governor by and with the advice of His Executive Council on the 5th day of January, 1949, be now ratified pursuant to the provisions of section 44 of the "Constitution Act," being chapter 65 of the "Revised Statutes of British Columbia, 1948."

On the motion of the Hon. Mr. Johnson (Premier), seconded by Mr. H. E. Winch (Leader of the Opposition), it was Resolved,—

That the appointment made by His Honour the Lieutenant-Governor by and with the advice of His Executive Council on the 28th day of January, 1949, of William Berkeley Monteith, of Victoria, as Law Clerk to fill the vacancy caused by the resignation of Ernest Cambourne McIntyre as Law Clerk be now ratified pursuant to the provisions of section 44 of the "Constitution Act," being chapter 65 of the "Revised Statutes of British Columbia, 1948."

Mr. Speaker reported to the House that he had received the declaration of resignation of William Andrew Cecil Bennett, member representing the Electoral District of South Okanagan, on May 17th, 1948.

Mr. E. E. Winch asked the Hon. the Provincial Secretary the following questions:—

- 1. What is the total amount (a) available or (b) received from the Dominion Government during the current fiscal year for health and welfare purposes?
- 2. How much of the above will be utilized by the respective health and welfare services and for what purposes?

The Hon. Mr. Pearson replied as follows:—

- "1. (a) The Federal health grants available to British Columbia total \$2,529,153 for health purposes for the current fiscal year and (b) answered above.
- "2. Crippled children's grant, \$32,300; professional training grant, \$26,275; hospital construction grant, \$1,018,125.08; venereal disease control grant, \$42,348; mental health grant, \$193,924; tuberculosis control grant, \$209,229.22; health survey grant, \$52,744; public health research grant, \$7,500; general public health grant, \$361,922; and cancer control grant, \$48,533.95."
- Mr. E. E. Winch asked the Hon. the Provincial Secretary the following question:—
 How many members are on the (a) recreational and (b) occupational therapy staff at each Provincial Mental Hospital?

The Hon. Mr. Pearson replied as follows:-

- "(a) Provincial Mental Hospital, Essondale, one female and four males (one to be appointed); Provincial Mental Hospital, New Westminster, one full time (male) and one part time (male); Provincial Mental Home, Colquitz, one part time (male). (b) Provincial Mental Hospital, Essondale, thirteen females (including one qualified school-teacher) and fifteen males; Provincial Mental Hospital, New Westminster, nine females (including six qualified school-teachers) and one male; Provincial Mental Home, Colquitz, four males. (a) and (b) These staff members direct the activities of their departments and are assisted at all times by the attendants and nurses on duty."
- Mr. E. E. Winch asked the Hon. the Minister of Education the following questions:—
- 1. During the past year, how many, if any, Normal School students visited the training-school at the Provincial Mental Hospital at New Westminster for purposes of observation?
- 2. Is it the present or planned policy of the Department to require such attendance by Normal School students?

The Hon. Mr. Straith replied as follows:-

- "1. Visits to mental hospitals are not part of the training programme in Provincial Normal Schools.
- "2. No; training in Normal Schools is basic teacher-training and is general in character. Training in special fields, such as occupational therapy, is offered in certain universities. Special courses in remedial reading, arithmetic, and other techniques for handling slow-learning pupils are offered in the Summer School of Education to supplement Normal School training. Normal School students observe at the special classes referred to in the answer of 9 (2)."
- Mr. McInnis asked the Hon. the Minister of Lands and Forests the following questions:—
- 1. What is the total log-scale in the Fort George Forestry District for the year 1948 and the number of ties produced?
- 2. What is the total revenue accruing to the Government from forest operations in the Fort George Forestry District for the year 1948 (a) from stumpage and (b) from royalties?

The Hon. Mr. Kenney replied as follows:—

- "1. The total log-scale in the Fort George Forest District for the year 1948 was 283,550,698 F.B.M. and the number of ties was 173,380.
- "2. Revenue accruing to the Government for the year 1948 in the Fort George Forest District: (a) From stumpage, \$648,303.40, and (b) from royalty, \$200,692.22."
- $\operatorname{Mr.}\ E.\ E.\ Winch$ asked the Hon, the Minister of Education the following questions:—
- 1. What is the present policy in regard to teaching and training of retarded or otherwise mentally handicapped pupils who cannot keep up with the grade of their years?
- 2. Are special facilities generally available for such assistance according to the nature or degree of their handicap?

The Hon. Mr. Straith replied as follows:—

- "1. Wherever there are a sufficient number of slow-learning pupils, special classes are organized. Ability grouping for instructional purposes is common practice in large school systems.
- "2. In Vancouver, Victoria, and some other large districts special classes are organized for slow-learning pupils."

Resolved, That the House, at its rising, do stand adjourned until 3 o'clock p.m. to-morrow.
