During excavation for the arch abutments the bed-rock upon which they were to be founded was not encountered at the previously determined depths. Drilling disclosed the bed-rock to be at a much greater depth at both arch abutments, necessitating a major revision to the design of the arch abutments and a lesser revision to the design of the steel arch.

"2. Additional cost of revised arch abutments, approximately \$700,000; additional cost of revised steel arch, approximately \$280,000. If correct information regarding depth to bed-rock had been received in the first instance, the estimated cost of the structure would have been increased by approximately the foregoing amounts. The selection of a different site, where possibly improved soil conditions for the bridge might have been found, would have involved similar additional costs to the highway approach work, together with unsatisfactory alignment and grades.

"3. Soils investigation, Rocanen Engineering Company Limited; design of structure and supervision of construction, A. B. Sanderson & Company Limited. "4. The Government."

Mr. Bryan asked the Hon. the Minister of Highways the following questions:----
