Prayers by the Rev. F. W. McKinnon.

Pursuant to Order, the House resumed the adjourned debate on the motion "That Mr. Speaker do now leave the chair" for the House to go into Committee of Supply.

The debate continued.

On the motion of the Hon. Mr. Carson, the debate was adjourned to the next sitting of the House.

The Hon. Mr. Carson presented the Report of the Department of Trade and Industry for the Year ended December 31st, 1944.

Mr. LeBourdais asked the Hon. the Minister of Lands the following questions:-

- 1. Is there any provision for improvement of the Crown ranges of the Interior of the Province in order to extend their use and protect the stock using them?
 - 2. If yes, how is it financed?
 - 3. If yes (to No. 1), how much improvement-work has been done in the past?

The Hon. Mr. Kenney replied as follows:-

- "1. Yes.
- "2. One-third of the grazing fees collected each year is placed in the Range Improvement Fund, under authority of section 14 of the 'Grazing Act.'
- "3. Mud-holes fenced, 235; water developments, 106; corrals, 34; holding-grounds, 23; stock bridges, 29; drift-fences, 220; stock trails, 157; bull pastures, 5; breeding pastures, 76; experimental plots, 18; cattle-guards, 24; horse pastures, 6; stock driveways, 1."
- Mr. Putnam asked the Hon. the Minister of Public Works the following questions:—
- 1. Has any gravelling been carried out in 1944 on the road between Gray Creek and Creston?
 - 2. If yes, what was the total mileage so improved?
 - 3. What amount of money was expended on the work?
 - 4. Has this work been completed?

The Hon. Mr. Anscomb replied as follows:-

- "1 Yes
- "2. Five miles.
- "3. \$7,928 to date.
- "4. No."

Mr. Straith asked the Hon. the Minister of Lands the following questions:-

- 1. Is any major development-work now under way in any of the Provincial parks?
- 2. Have complete development plans been formulated in advance for any of the above parks?
 - 3. If so, what acreage is covered by the plans?

The Hon. Mr. Kenney replied as follows:—

- "1. No; owing to lack of material and labour work in the Provincial parks is on a maintenance basis.
 - "2. Yes,
 - "3. Approximately 5,000,000 acres."

Mr. LeBourdais asked the Hon. the Minister of Lands the following questions:-

- 1. How much range-land is there in the Interior of the Province?
- 2. Is it adequate for the needs of the live-stock industry?
- 3. Is there need for expansion of the live-stock industry?
- 4. If yes, can the industry be expanded on the range available?

The Hon. Mr. Kenney replied as follows:-

- "1. Not known. Up to the start of the war about 2,750,000 acres had been surveyed. There is at least twice that area currently used and an unknown larger area not used. With the return of trained personnel after the war the survey programme will be continued.
- "2. There are local shortages of range, especially the open bunch-grass ranges. This is due to overstocking and, in some cases, poor management. The carrying capacity could be increased by better range practices. There is ample summer range.
- "3. Yes; British Columbia imports large quantities of meat animals and products from other Provinces. In 1942 we imported 8,623,063 lb. of beef, 3,552,268 lb. of veal, and 965,539 lb. of mutton and lamb.
- "4. It is believed so, with careful management. The Forest Service, which administers the Crown ranges under the 'Grazing Act,' has plans for comprehensive surveys and estimates of capacity, as well as for proper management of the range when personnel is available."

Mr. LeBourdais asked the Hon. the Minister of Lands the following questions:-

- 1. Are wild and useless horses a nuisance on the ranges of the Interior of the Province, and in what way?
 - 2. If yes, is there any provision made for control of these animals?
 - 3. Is control being exercised this year?
 - 4. What control has been exercised in the past?
 - 5. What results are obtained?

The Hon. Mr. Kenney replied as follows:-

- "1. Yes: (a) They use a great deal of forage that useful animals should get; (b) they are on the range early in the spring and eat the grass before it has time to grow, pulling much of it out by the roots from the soft ground; (c) they trample much range, especially in the spring when it is soft; and (d) they lead gentle horses away.
- "2. Yes; section 5 of the 'Grazing Act' provides for the closing of ranges to horses for set periods and the destruction or round-up of any animals found on the range during the closed period.
- "3. The Cariboo Grazing District is closed from January 1st, 1945, to March 31st, 1945. Several permits have been given for destruction of wild horses in this area.
 - "4. This form of control has been exercised for about twenty years.
- "5. Results are good where the work is carried out regularly and conscientiously. Since control started there have been approximately 10,000 horses destroyed or shipped out for use."

Mr. Putnam asked the Hon. the Minister of Public Works the following questions:—

- 1. Has the Nelson-Balfour Highway been improved by widening near Crescent Bay?
 - 2. If yes, what mileage of work was undertaken?
 - 3. What was the cost of such work?

The Hon. Mr. Anscomb replied as follows:-

- "1. Yes.
- "2. One mile.
- "3, \$4,854."

Resolved, That the House, at its rising, do stand adjourned until 8.30 o'clock p.m. to-day.

Pursuant to Order, the House resumed the adjourned debate on the motion "That Mr. Speaker do now leave the chair" for the House to go into Committee of Supply.

The debate continued.

The debate continued.

On the motion of Mr. R. C. MacDonald, the debate was adjourned to the next sitting of the House.

Mrs. Steeves asked the Hon. the Provincial Secretary the following questions:-

- 1. Is the Government's grant of 70 cents *per diem* per patient given to hospitals in order to assist them in their services to indigents?
- 2. Is it with the Government's consent that hospitals which are receiving the Government grant are now dunning certain people for expenses incurred during the period when they were on relief and received free hospitalization?

The Hon. Mr. Pearson replied as follows:-

- "1. Per capita grants to hospitals are given primarily as general aid but may be regarded partially as offsets to costs incurred by non-paying patients.
- "2. Hospitals can not refuse to admit patients because of indigent circumstances without forfeiting their right to Government *per capita* grants. The Government, however, does not control the right of hospitals to collect from patients who are able to pay."

Mrs. Hodges asked the Hon. the Minister of Education the following questions:-

- 1. Has a Provincial Director of Educational and Vocational Guidance been appointed for the schools of the Province?
 - 2. If yes, give his name, qualifications, duties, and his plan of procedure to date.

The Hon. Mr. Perry replied as follows:-

- "1. Yes.
- "2. Harold P. Johns.
- "(a.) Qualifications: B.A. (University of British Columbia), M.A. (University of British Columbia), graduate study in educational and vocational guidance in the University of Washington, six years as boys' counsellor in Victoria High School, organizer and head of Victoria Schools' Guidance and Placement Department, and lecturer at the Department of Education's Summer School of Education, Victoria.
- "(b.) Duties: (1) To organize and supervise educational and vocational guidance in the schools of British Columbia; (2) to stimulate the interest of teachers and to encourage the in-service training of teachers; and (3) to assist teachers by making available to them literature of use in guidance classes.
 - "(c.) Plan of procedure to date:-
- "(1.) Visits to schools: Twenty-six junior or senior high schools have been visited since September for the purpose of discussing the problems of each school and assisting in organizing the guidance services; at twenty-three of these schools staff meetings were held.
- "(2.) Visits to teachers' conventions: Four teachers' conventions were attended; meetings were held with guidance workers at each of the conventions.
- "(3.) Materials issued to schools and inspectors to stimulate and assist guidance workers: (a) Three 'Guidance Bulletins' have been issued, dealing with: (i.) Organization—procedure and suggestions; (ii.) vocational guidance and occupational information; (iii.) child study (gathering and filing information about individual students) and counselling. (b) Lists of inexpensive materials dealing with jobs and training for jobs (issued by professional or trade organizations, Government agencies, and publishing houses specializing in occupational information) have been sent to teachers bi-monthly; up to the present time 446 pamphlets have been listed (maximum price, \$1; the majority 25 cents or less). Two organizations, the Canadian Institute of Engineering and the Pharmaceutical Association of British Columbia, have cooperated by supplying each school with copies of pamphlets on their professions.
- "(4.) Preparation of occupational information for vocational guidance classes:
 (a) Work has been commenced on a proposed 'Occupational Information Series' for British Columbia schools; the co-operation of the Bureau of Economics and Statistics and a number of professional organizations should be noted in this regard; the series, when issued, will be in loose-leaf form, thus enabling new or revised job summaries to be included in the book without necessitating complete republication. (b) Negotiations have been conducted with the British Columbia Products Bureau of the Vancouver Board of Trade for the making of a series of film-strips and commentaries on jobs in British Columbia industry; at a meeting held in Vancouver on February 15th the bureau members unanimously adopted this proposal.
- "(5.) Teacher-training: (a) Two lectures were given to the teacher-training class of the University of British Columbia; (b) a 'Guidance Workshop' has been arranged for the Department of Education's Summer School of Education in July and August of this year."

Mrs. Jamieson asked the Hon. the Minister of Education the following questions:-

- 1. Was a report of the Public Library Commission's survey of library service in Provincial institutions received by the Minister of Education?
- 2. What action, if any, has been taken to improve the library service of Provincial institutions?

The Hon. Mr. Perry replied as follows:-

- "1. Yes.
- "2. On the authority of the Hon. the Attorney-General, under the direction of the Public Library Commission and with the co-operation of Vancouver Public Library, library service is being progressively and satisfactorily developed in both the men's gaol and women's gaol at Oakalla Prison. The sum of \$1,830 is provided in the estimates for 1944–45 for this purpose. Funds to the amount respectively of \$250 and \$350 were made available by the Provincial Secretary's Department during the current fiscal year for the purchase of books and periodicals for the Provincial Home at Kamloops and Allco Hospital, Haney. At the request of the Department these books and periodicals were selected and ordered by the Public Library Commission."

Mr. Gillis asked the Hon. the Minister of Lands the following questions:-

- 1. How many acres a year are being reforested by planting?
- 2. Has this objective been attained during the past four years?
- 3. Where are these areas located?
- 4. What are the costs of planting, including the snag falling for fire protection? The Hon. Mr. Kenney replied as follows:—
- "1. 10,000 acres.
- "2. Yes; for the period 1941 to 1944, inclusive, a total of 40,413 acres have been planted.
- "3. The major projects have been as follows: (a) Nanton Lake, near Powell River, 2,635 acres; (b) Campbell River region, 19,696 acres; (c) Deep Bay region, Vancouver Island, 3,839 acres; (d) Cowichan Valley, Vancouver Island, 10,452 acres; (e) Alberni region, Vancouver Island, 1,279 acres; (f) Timberlands region, near Ladysmith, 1,558 acres; (g) Nanaimo Lakes region, 590 acres; (h) Green Timbers Plantations, 107 acres; and (i) miscellaneous small areas, 257 acres.
 - "4. \$12 per acre."

Mr. Paton asked the Hon. the Minister of Lands the following questions:-

- 1. What data form the basis of decision to implement a forest closure in the Vancouver Forest District?
- 2. Does the Forest Service operate weather recording and (or) forecasting stations as a guide to such decisions?

The Hon. Mr. Kenney replied as follows:-

- "1. The Forest Service operates forest fire-hazard measuring devices in the form of moisture content and relative humidity instruments at twenty-eight selected locations throughout the Vancouver Forest District. Daily records from these stations supplemented by those from a certain number of similar instruments operated by the logging industry at various logging camps are averaged by zones to give hazard build-up curves of fuel moisture content per centum and minimum humidity per centum for each zone. Such curves interpreted in the light of detailed daily weather forecasts (supplied by the Meteorological Bureau, Department of Transport) and records of current and immediate past precipitation serve as guidance for a decision re forest closure action. Some expansion of this work, leading towards more intensive basic data, is planned for 1945.
 - "2. Answered by No. 1."

Mr. Shepherd asked the Hon. the Minister of Lands the following questions:-

- 1. Of the 28,218 acres reclaimed by the Sumas Reclamation project, how many acres were classified as suitable for agricultural purposes?
 - 2. What is the total balance due the Government from this project to date?

The Hon. Mr. Kenney replied as follows:-

- "1. 28,065.84 acres.
- "2. The balance owing to the Government as at December 31st last, according to existing Statutes, was \$852,278.49."

Mr. Eyres asked the Hon. the Minister of Lands the following questions:-

- 1. How many releases from mortgage have been issued by the Land Settlement Board since the passing of the amendment to the "Land Settlement and Development Act" in 1938?
- 2. How many title deeds have been issued to land purchasers by the Land Settlement Board since the passing of the above amendment?

The Hon. Mr. Kenney replied as follows:-

- "1, 154,
- " 2. 200."

Mr. Paton asked the Hon. the Attorney-General the following questions:-

- 1. Has any provision been made relieving members of the Armed Forces home on leave from the payment of drivers' licence fees and examination fees over the period of leave?
 - 2. If so, when?
 - 3. Give particulars.

The Hon. Mr. Maitland replied as follows:-

- "1. Yes.
- "2. By Order in Council passed February 27th, 1945, the provisions of which are retroactive in their operation to January 1st, 1945.
- "3. The licence fee of \$1 for a driver's examination and the licence fee of \$1 for a driver's licence under the 'Motor-vehicle Act' are remitted in the case of members of the Armed Forces returning to British Columbia for a period not exceeding thirty days."

Resolved, That the House, at its rising, do stand adjourned until 8.30 o'clock p.m. to-day.

A meeting was held in January, 1945, to draw up a final report. The drawings are now in the hands of the architect. The report will be ready in April."
 - Mr. Connelly asked the Hon. the Minister of Education the following questions:—
- 1. Have any steps been taken recently by the Department to assist the teachers employed in rural schools of the Province in carrying out the school programme?
 - 2. If the answer is in the affirmative, give some particulars.

The Hon. Mr. Perry replied as follows:-

- "1. Yes.
- "2. (a) A 'Rural School' magazine is published every two months for the special benefit of rural school teachers. Its aim is to assist the teachers in keeping in touch with the best available educational materials and to help them solve problems that arise from time to time in carrying out the school programme. Two issues have already been sent to the schools and the third is now being printed. The magazine has been warmly welcomed by the rural teachers of the Province and by the inspectors. It has also received most favourable comment in other Provinces of Canada. (b) In two of the larger rural inspectorates 'Helping' teachers have been appointed to pay extended visits to schools staffed by inexperienced teachers or teachers without full academic and professional qualifications. These 'Helping' teachers assist the teachers in organizing their work and in drawing up suitable time-tables. They also give demonstrations in the class-room of the best teaching procedures."

LEGISLATIVE COMMITTEE ROOM,

March 8th, 1945.

MR. SPEAKER:

Your Select Standing Committee on Standing Orders and Private Bills begs leave to report as follows:—

That the preamble of Bill (No. 51) intituled "An Act to incorporate the Society of Industrial Accounts of British Columbia" has been proved, and the Bill ordered to be reported with amendments.

Your Committee calls the attention of the House, as is required by Standing Order 113, to an amendment defining classes of membership and the recording and registering of members, and an amendment providing for power of the Lieutenant-Governor in Council to annul any by-law of the Society, which amendments are deemed to be in the public interest to insert in the Bill.

All of which is respectfully submitted.

W. T. STRAITH, Chairman.

The report was read and received.

Mr. Gillis asked the Hon. the Minister of Lands the following questions:-

- 1. How many forest nurseries are now operated by the Forest Branch and where are they located?
 - 2. What is their current output?
 - 3. Is this their full capacity and, if not, what volume of trees can they produce?
 - 4. What are the costs of growing the trees?

The Hon. Mr. Kenney replied as follows:—

- "1. Three—one at Green Timbers on the Trans-Canada Highway five miles south of New Westminster, one near Campbell River, and one near Duncan.
 - "2. 10,000,000 trees per year.
 - "3. No; the three nurseries have a potential capacity of 20,000,000 trees per year.
 - "4. Cost of growing the trees varies from one-quarter to one-third of a cent each."

Mr. King asked the Hon. the Minister of Lands the following questions:—

1. What precautions are taken by the Department for the protection of watersheds which form a source of domestic and irrigation water-supply?

2. In making timber sales in the Provincial Forest Reserves what requirements

are there for perpetuating timber production?

3. Are there any provisions for the utilization of timber values in Provincial parks where such cutting would not be inimical to the purpose for which they were created?

4. What provisions are there for preserving young and advanced second-growth

on vacant Crown land?

- 5. What steps are taken for the preservation of standing timber adjacent to public highways possessing æsthetic value?
- 6. (a) What is meant by the term selection cutting, (b) what are its advantages, and (c) is it being practised in British Columbia stands?
 - 7. What steps have been taken to establish farm wood-lots?

The Hon. Mr. Kenney replied as follows:-

- "1. Before any sale is made a joint report and recommendations are required of the District Forester and the District Engineer of the Water Rights Branch and due regard is paid to irrigation interests and domestic water users. The Chief Forester may disallow a timber sale where any logging may adversely affect these interests. Not infrequently a selection cutting will safeguard the supply of water and control erosion, stream-flow, and floods, and at the same time maintain the stand in perpetuity. Where contamination may be the chief consideration, the Chief Forester may likewise disallow any timber sale application.
- "2. The Chief Forester may require special clauses in timber sale contracts which will encourage natural reproduction by leaving seed trees, provide for the preservation of growing timber to be left uncut, provide for adequate slash disposal and other favourable silvicultural conditions, and restrict the cut to the sustained annual yield capacity of the Provincial forest.
- "3. The Crown timber of any Provincial Class A park is reserved from cutting or sale except as such cutting or incidental sale is, in the opinion of the Chief Forester, necessary or advantageous in developing and improving the park or protecting and preserving the major forest values of the park for the enjoyment of the public. No Provincial Class A park timber shall be sold primarily for revenue. The Crown timber in any Provincial Class B park is available for disposal if, in the opinion of the Chief Forester, disposal of such timber would not be detrimental to the recreational value of the area.
- "4. The Chief Forester may, at his discretion, disallow any application for a timber sale unless satisfied that practical logging methods can be prescribed which will cause the least possible damage to existing reproduction. By directing logging from our thrifty, fast-growing young stands to our mature to overmature forests where growth is more often than not balanced by loss from natural causes such as insects and fungi, we are taking the first step toward sustained yield production. In logging the overmature stands we are then in a position to put the logged areas into production once more. A thinning or improvement cutting in advanced reproduction, such as the removal of cedar poles, will improve the character and composition of the stand at maturity.
- "5. In all cases æsthetic values are given primary consideration and may not be sold without the specific approval of the Chief Forester.
- "6. (a) Selection cutting is the removal of mature timber, usually the largest and dominant trees in an uneven-aged stand, either as single scattered trees or small size groups at relatively short periods. (b) Selection logging in uneven-aged stands repeated at proper intervals ensures the continuous establishment of natural reproduction, main-

tains the proper proportion of age classes, provides a sanitation cutting to remove trees subject to disease by insects or fungi, encourages total production of a stand by a thinning cutting thereby reducing excessive competition for light and moisture, and reduces fire-hazard from logging slash. (c) Selection cutting methods are required under timber sale contracts where considered advantageous, particularly in our Engelmann spruce and Western Yellow pine stands and only trees marked by a trained Forest Officer may be cut.

"7. In the East Kootenay sixty-one Christmas-tree allotment areas have been laid out adjacent to established farms and permits issued to individual farmers who operate under sustained annual production. Income from Christmas trees to the farmers is now definitely an important part of their income. Christmas trees are now considered a legitimate forest crop, and these Christmas-tree wood-lot operations mark the beginning of sustained yield management in British Columbia forests. Also, establishment of experimental wood-lots are under advisement and will be given attention as quickly as money and trained personnel will permit."

Resolved, That the House, at its rising, do stand adjourned until 2.30 o'clock p.m. to-morrow.

Victoria: The three teachers hold the Provincial Primary Specialists' Certificates and two of them took further special training in California last summer; present and prospective pre-primary teachers, all of whom have had extensive pre-training in primary work, are receiving in-service training under the direction of the primary supervisor of the Victoria schools; they will also attend the pre-primary course to be given at Victoria Summer School in July next. Vancouver: The two teachers of pre-primary classes have had seven or more years of successful experience as primary grade teachers; they hold First-class Teachers' Certificates; they have also had special training in pre-school child work; one of them has had a year in nursery-kindergarten-primary training at Columbia University and the other has had special courses at Summer School in the same field.
- "2. Victoria: Specially furnished and equipped rooms have been set up at three centres—Spring Ridge, Oaklands, and Sir James Douglas Schools; each teacher instructs two groups—one in the morning and one in the afternoon. Vancouver: In the Henry Hudson School a primary class-room, specially equipped, has been reserved on the main floor for this work; separate wash-room accommodation is supplied; at the Dawson Annex School a separate building of slightly more than class-room size has been specially fitted up for this work; separate wash-room accommodation is supplied in this building for the little folks; the floors of the class-room are, in each case, covered with clean, waxed linoleum; each centre handles two groups—one in the morning and one in the afternoon."

Mrs. MacInnis asked the Hon. the Minister of Education the following questions:-

- 1. Does the Government make financial assistance available to rural schools for the provision of hot noon lunches?
 - 2. If so, on what basis?
 - 3. In how many rural schools is a hot noon lunch served?

- "1. One new six-roomed school building providing quarters for a kindergarten, a pre-school class, two class-rooms, domestic science and occupational rooms; in addition, quarters are provided for Provincial recreational and physical education classes.
- "2. Two teachers at present, with two more provided for in Estimates, 1945-46; teachers given special training course; in addition, as requisite, helpers are available from amongst other members of the staff.
- "N.B.—The Provincial recreational and physical education room is also available for members of the staff."
- Mr. E. E. Winch asked the Hon. the Provincial Secretary the following question:— What proportion of the pension is left for the personal use of an old-age pensioner when in a hospital or nursing home?

The Hon. Mr. Pearson replied as follows:-

"The Government does not control the right of hospitals or nursing homes to collect from patients who are able to make full or partial payment for services rendered. Our information is that it is customary practice of the majority of hospitals to allow old-age pensioners amounts varying from \$2 to \$5 per month from their pension cheques for comforts or pocket-money. Some hospitals charge a daily rate; for example, we understand the Vancouver General Hospital asks pensioners to pay 60 cents per day. Where it is necessary to give a supplementary social allowance for the care of pensioners in nursing homes in unorganized territory, provision was made by regulation in March, 1944, whereby a comforts allowance may be granted to social allowance recipients up to \$3 per month. Pensioners in nursing homes in municipalities are a municipal responsibility and our information is that in the majority of cases a comforts allowance is granted."
