

Monday, November 2nd, 1925.

THREE O'CLOCK P.M.

This being the first day of the second meeting of the Sixteenth Parliament or Legislative Assembly of the Province of British Columbia for the dispatch of business, pursuant to a Proclamation of the Honourable JAMES ALEXANDER MACDONALD, Administrator of the Government of the Province, dated the 9th day of September, 1925.

His Honour WALTER CAMERON NICHOL, Lieutenant-Governor of the Province, having entered the House, took his seat on the Throne, and was pleased to deliver the following gracious Speech :---

Mr. Speaker and Members of the Legislature:

I welcome you to the Second Session of the Sixteenth Parliament of British Columbia.

Business conditions throughout the Province have improved since you last met. This improvement is reflected in increased building activities and in the expansion of industries.

My Government has, since last Session, continued its efforts to secure a removal of discrimination against British Columbia in the matter of railway transportation rates, and you will be pleased to learn that a considerable measure of success has attended these endeavours. My Government intends that there shall be no relaxation of effort to secure substantial justice for the Province.

Owing to a partial crop failure in Alberta and Saskatchewan in the season of 1924, the exports of grain from British Columbia ports were considerably less than in the preceding year. The improved crops of the present year indicate a very large increase in the amount of exportable grain for the present shipping season, and with the application of Crow's Nest Pass agreement rates, it is confidently hoped that this expected increase will be of such considerable volume as to create material stimulation in the business life of the Province.

The construction of the University buildings has been completed and possession has been transferred to the Chancellor and the Board of Governors. The buildings are now occupied by the students and the teaching staff. Improvement of University grant lands has been continued; a subdivision has been plotted and a number of lots sold. It is the intention of my Government to continue the development of University grant lands for residential and business purposes.

In the construction of University buildings and in the improvement of University grant lands, there have been expenditures in excess of the amount authorized by the "University Loan Act." A Bill to provide the additional moneys required will be placed before you for your consideration. Returns received in respect to the mineral production of the Province indicate that the output for the present year will constitute a new high record.

The value of agricultural production continues to increase.

The value of fisheries production is being maintained, and it is expected that the 1924 yield will be equalled in 1925.

The lumbering business of the Province is now on a more satisfactory basis than heretofore. Exports to Great Britain have largely increased as a result (it is believed) of the educational effects of the Wembley Exhibition.

Owing in part to the very dry season, forest fires have been more numerous and more destructive than usual. The cost of fire-fighting has exceeded the moneys available and you will be asked to make additional provision therefor.

A Bill relating to debentures of the Pacific Great Eastern Railway Company, and for providing a Sinking Fund therefor, will be submitted for your approval.

A Bill to amend and consolidate the laws relating to insurance is in course of preparation, and it is expected that this will be ready for submission during the Session.

· Legislation having reference to the Sumas Dyking District will be placed before you for approval.

The increasing number of inmates in our Mental Hospitals is a matter of serious concern, and will require careful consideration.

Satisfactory progress has been made with the extension of the highway system. Reconstruction of the Cariboo Road through the Fraser River Canyon is proceeding rapidly and, before another Session is due, connection with the road system of the Interior will be had, and a closer connection between the Coast and the inland cities will be established for all time.

The industrial pay-roll continues to show a substantial advance over former years.

The "Hours of Work Act," under the Board of Adjustment, appears to be operating successfully.

The Report of the Survey of the Educational System of the Province has been printed and will be placed before you immediately.

Gentlemen, I now leave you in full confidence that the work entrusted to you will be faithfully performed, and I pray that the blessing of God shall rest upon your labours.

His Honour the Lieutenant-Governor was then pleased to retire.

Prayers by the Right Reverend the Bishop of Columbia.

Mr. Speaker reported that, to prevent mistakes, he had obtained a copy of His Honour's Speech.

The Certificate of the Deputy Provincial Secretary of the result of the election of a Member to represent the Electoral District of Grand Forks-Greenwood was read as follows:----

"Whereas a vacancy occurred in the Legislative Assembly by reason of the death of John McKie, the late Member for the Grand Forks-Greenwood Electoral District; and

"Whereas on the 7th day of April, 1925, a writ for the election of a Member to represent such Electoral District was duly issued to the Returning Officer of the said District:

"Now I do hereby certify that on the 22nd day of May, 1925, the said writ was returned to me by the Returning Officer, with his certificate endorsed thereon, whereby it appears that the electors of the said District have chosen *Dougald McPherson* to represent the Grand Forks-Greenwood Electoral District in the Legislative Assembly.

Dougald McPherson, Esquire, having been duly sworn, was introduced by the Hon. the Premier and the Hon. the Minister of Finance, and took his seat.

On the motion of the Hon. Mr. Sloan, seconded by the Hon. Mr. Manson, it was Resolved,-

That the Certificate of the Deputy Provincial Secretary of the result of the by-election for the election of a Member to represent the constituency of Grand Forks-Greenwood be entered upon the Journals of the House.

On the motion of the Hon. Mr. Oliver, seconded by the Hon. Mr. Sloan, it was Resolved,-

That the Speech of His Honour the Lieutenant-Governor be taken into consideration to-morrow, and that this Order have precedence over all other business, except the introduction of Bills, until disposed of.

Ordered, That the Votes and Proceedings of this House be printed, being first perused by Mr. Speaker, and that he do appoint the printing thereof, and that no person but such as he shall appoint do presume to print the same.

Resolved, That if it shall appear that any person hath been elected or returned a Member of this House, or endeavoured so to be, by bribery or other corrupt practices, this House will proceed with the utmost severity against all such persons as shall have been wilfully concerned in such bribery or other corrupt practices.

Ordered, That the Select Standing Committees of this House, for the present Session, be appointed for the following purposes :---

Seventy-five per cent. of 1925 levy is not due until November 15th, 1925; 1925 arrears will therefore be substantially decreased, if not completely paid up. The credit derived from the adjustment of the purchase price of the land was applied to the reduction of the arrears of irrigation rates.

"5. Estimated at approximately \$475,000.

"6. Operation charges, 1925, \$6,122, not including proportion of office staff salaries.

"7. Rate was levied on basis thought to be sufficient to cover all charges when project completed.

"8. Answered by No. 7."

TWO O'CLOCK P.M.

Mr. *Twigg* moved the adjournment of the House upon a question of urgency, and nine Members rose in their places to support the motion.

A debate arose, and with the leave of the House the motion was withdrawn. Notice of motion relating to the matter mentioned to be given in the usual way.

Mr. Speaker delivered his reserved decision on the point of order raised by Mr. *Davie* on the 12th instant, with reference to the amendment moved by Mr. *Browne* on the 11th instant to the Address in reply to the Speech of His Honour the Lieutenant-Governor at the opening of the Session, as follows:—

"On the 11th instant, on the House resuming the adjourned debate on the Address in reply to the Speech of His Honour the Lieutenant-Governor at the opening of the Session, the Honourable Member for Burnaby moved an amendment, seconded by the Honourable Member for South Vancouver, as follows:—

"'That the following words be added: "We regret, however, that a fraudulent, alien, terrorist organization known as the Ku Klux Klan is attempting to organize in British Columbia; and that the purpose of this body is to perpetuate and promote religious hatred amongst our citizens and to substitute lynch law for duly constituted authority; and that the past record of this society is one of murder, violent assault, and unspeakable crime. Therefore we would urge your Government to take all necessary steps to restrain this seditious movement and bar its membership from all elected or official positions under the Crown."'

"On the House resuming the adjourned debate on the 12th instant, the Honourable Member for Cowichan-Newcastle arose to a point of order that the debate should be restricted to the amendment, whereupon I reserved my decision.

"I find that it is unnecessary for me to deal with the point raised by the Honourable Member for Cowichan-Newcastle, for the reason that I am of opinion that the amendment is out of order on the ground of irrelevancy.

"It is imperative that every amendment must be relevant to the question on which the amendment is proposed. There is no congruity between the proposed amendment and the main motion, the amendment being a new proposition upon an entirely different subject. It is therefore out of order, and I so rule. (See May, 13th Edition, page 285, and decision of Mr. Speaker Pooley, Speakers' Decisions, page 5.)"

The House resumed the adjourned debate on the Address in reply to the Speech of His Honour the Lieutenant-Governor at the opening of the Session.

On the motion of Mr. Lyons, the debate was adjourned to the next sitting.

The petition from Ernest Temple, for leave to introduce a Private Bill for the purpose of directing the Engineer and the Corporation of the City of Victoria to proceed with the determination of all questions between the Westholme Lumber Company, Limited, and the said Corporation, was received.

The House resumed the adjourned debate on the motion moved by Mr. *Twigg* on November 13th, as follows:—

That an Order of the House be granted for a Return of all correspondence between the present Government of British Columbia or any member thereof and the Government of the Dominion of Canada or any member thereof since December 31st, 1916, up to the present date, relative to the return to the Province of British Columbia of what is commonly known as the Peace River Land Block.

Resolution carried.

Pursuant to such Resolution, the Hon. Mr. Oliver presented a Return.

That an Order of the House be granted for the Return of all correspondence between the Attorney-General and the Attorney-General's Department and one William Morrison, of the City of Vancouver, in connection with a complaint made by him claiming maladministration by the Harbour Commissioners of Vancouver, or certain individuals connected therewith, and giving information of certain offences being committed contrary to the provisions of the "Grain Act" of Canada and the "Railway Act" of Canada.

A debate arose, which was, on the motion of the Hon. Mr. Manson, adjourned to the next sitting.

The Report on Bill (No. 2) intituled "An Act respecting certain Appointments to the Executive Council and Departments of the Executive Government of the Province" was adopted.

Bill read a third time and passed.
