### Wednesday, February 17th, 1932.

THREE O'CLOCK P.M.

This being the first day of the fourth meeting of the Seventeenth Parliament or Legislative Assembly of the Province of British Columbia for the dispatch of business, pursuant to a Proclamation of the Honourable JOHN WILLIAM FORDHAM JOHNSON, Lieutenant-Governor of the Province, dated the 13th day of January, 1932,

His Honour John William Fordham Johnson, Lieutenant-Governor of the Province, having entered the House, took his seat on the Throne, and was pleased to deliver the following gracious Speech:—

Mr. Speaker and Members of the Legislative Assembly:

I welcome you to the Fourth Session of the Seventeenth Parliament of British Columbia.

Since the last Session of this House, the high post of representative of His Most Excellent Majesty the King has been filled by the appointment of the Right Honourable the Earl of Bessborough. We, the people of British Columbia, join with our fellow-Canadians in extending a warm welcome to His Excellency and his gracious consort, the Countess of Bessborough.

On the 31st July last the Honourable Robert Randolph Bruce terminated his tenure of office as Lieutenant-Governor of British Columbia. The good wishes of the members of this House particularly, and of the people of British Columbia in general, will accompany him in his retirement.

During the year just closed, the death occurred of Mr. John Andrew Buckham, who presided as the Honourable the Speaker over the proceedings of the Legislative Assembly from 1924 to 1928. His departure from this life was and will be a matter of regret, not only to the members of this House, but to a large number of the people of the Province.

It is regretted that the world-wide state of commercial and industrial depression which has been prevailing for some time past is still present, with its accompanying and resultant problem of unemployment. As to the latter, it is comforting to observe the spirit of willing helpfulness shown by those of the public who have given to those who, through misfortune, have not the comforts and necessities of life. In this crisis the workers and wage-earners, always the first to feel the effects of a downward move in business, have shown a commendable spirit of fortitude and courage. This spirit of mutual help among the people of the Dominion was strikingly manifested in the ready and immediate response to the domestic loan launched by the Federal Government for the purpose of meeting the crisis.

Indications would seem to be that the situation is becoming easier. My Government has been acting in conjunction with that of the Dominion in dealing with the problem, which has been, and still is, a serious one. The municipal corporations, which also are faced with pressing needs in unemployment and fiscal questions, have co-operated in dealing with conditions.

The consideration of this question, which was discussed at the Inter-Provincial Conference held in Calgary last year, will be submitted to a Committee of the House during the present Session. The Report of that Committee will doubtless be a valuable guide in dealing with the subject.

Efforts are continuing with a view to the development of markets for British Columbia products, with results of a beneficial nature so far. It is intended to continue these efforts, associated with which is the development of the principle of trade within the Empire.

A party of excursionists from the British Isles is being organized by the Agent-General of this Province in London and will tour the Dominion during the coming months of May, June, and July. This party will be accompanied by an officer from British Columbia House who is well informed on matters connected with this Province. Doubtless this venture will result in bringing before the members of the party as full a knowledge, as the time will permit, of the advantages of British Columbia as a desirable country for investment of capital and for settlement. The itinerary for British Columbia has been arranged with a view to bringing before the notice of the visitors not only the vastness of our Province, but, in a practical and personal way, its great potential wealth and varied beauty, a tour which cannot fail in due course to result beneficially to the country.

Owing to the General Elections in the Mother Land, the Imperial Conference, which was to have reconvened at Ottawa last year, was postponed to the present year. It is anticipated that such postponement will enable the representatives to deal more fully with the many important questions to be brought before them, especially that relating to closer trade relations between the different units of the vast Empire of which Canada is an important member.

It is reassuring to report that, notwithstanding the effect of world economic conditions on the price of metals and the consequent decline in the value of our mineral production, the aggregate quantity output was nearly equal to that of the previous year. This is a tribute to the successful manner in which the mine operators of British Columbia have attacked the problem of reducing mining and metallurgical costs in order to meet changed conditions. It is also satisfactory to find much more interest being manifested in both lode- and placer-gold mining possibilities of the Province.

My Government, appreciating the importance of extending all practical encouragement to the search for and the development of placer-gold mining resources, will submit proposals directed to that end for your consideration.

Impressed by the work of research disclosing signs of vast possible wealth in that direction, legislation will be placed before you dealing with the administration of oil and natural-gas rights.

The lumber industry has also suffered, thereby throwing many hundreds of men out of work. It is, however, gratifying to note that the efforts made by my Government to establish markets for lumber have reacted very favourably.

Of recent years there has developed what we are bound now to recognize as British Columbia's fourth industry. I refer to the growing volume of our travel and tourist business. A brief glance at the records of the past ten years shows that the volume of travel to this Province has grown substantially and has advanced until it has become a fruitful source of revenue. Even in 1931, a year of universal business recession, British Columbia's tourist trade maintained itself remarkably, the decrease being slightly less than that of the peak year of 1930. It is felt that greater efforts might well be directed towards the fostering of this important phase of a business which benefits every section of the Province.

A Commission has been studying and collecting data on the question of Health Insurance, and it is expected that its Report will be submitted during the present Session.

Owing to the present universal condition of business and industry, which has reflected its effect on the public revenue, certain economies have become necessary. Further efforts in this direction may be required, but the utmost care will be observed by my Government to see that such economies as are necessary will be effected with due regard to efficiency in the administration of the public service.

Legislation will be submitted for your consideration dealing with the "Land Act," the "Placer-mining Act," the "Coal and Petroleum Act," and the "Motor-vehicle Act."

Since the return to the Province of the Railway Belt and Peace River Lands there has been a steady flow of settlers to these sections, especially into the Peace River Block. With

the great natural wealth of that area, particularly in agricultural possibilities, a bright future of development is assured. Transportation facilities, which must naturally ensue, will create a period of growth in that Treasure House of the North which will contribute to the wealth and prosperity of the entire Province.

Reports of the various departments of my Government will be laid before you in due course.

The Public Accounts and the Estimates for the year will also be submitted for your consideration.

Despite the severe experiences and trying conditions which have been undergone by our people during the past year, conditions which have been met with fortitude and strength, I feel that I am but voicing the sentiments of every member of this House, and of the people of this Province, when I say that our faith in the future of this great country, with its wonderful, yet undeveloped wealth, its record of the sturdy pioneers who achieved so much in the face of what appeared to be insurmountable difficulties, is now, and cannot help remaining, unshaken.

Entirely confident that the matters which will engage your attention will be dealt with by you faithfully and in the best interests of the people and the Province, I leave you now to your duties, with the prayer that you may have the guidance of Divine Providence in conducting your deliberations and in reaching your decisions.

His Honour the Lieutenant-Governor was then pleased to retire.

Prayers by the Rt. Rev. Charles de V. Schofield, Bishop of Columbia.

Mr. Speaker reported that, to prevent mistakes, he had obtained a copy of His Honour's Speech.

The Certificate of the Deputy Provincial Secretary of the result of the election of a member to represent the Electoral District of Columbia at the recent by-election was read as follows:—

Lister, Cornett, Beatty, MacPherson, and Wrinch.

On the motion of the Hon. Mr. Tolmie, seconded by Mr. Pattullo, it was Resolved,-

That this House expresses its sincere regret at the death of John Andrew Buckham, member for the Electoral District of Columbia; and that the Clerk convey to Mrs. Buckham and the family of the late member the condolence and sincere sympathy of the members of the Legislative Assembly.

Whereas there was published a statement purporting to have been made by the Chief Engineer of the Canadian Pacific Railway, as head of a Committee of Investigation appointed by the Dominion Government, to the effect that the construction of a railway outlet to the Pacific Coast from Peace River was entirely premature; and Whereas the information obtained by the joint survey hereinbefore cited was available to the Chief Engineer of the Canadian Pacific Railway and the Committee of which he was a member; and

Whereas it is in the public interest that this information should also be available to the public at large, in order to enable the public more intelligently to pass judgment; and

Whereas the Provincial Government has repeatedly refused to make public the findings of said survey:

Therefore be it Resolved, That an Order of the House be granted instructing the Government to table a copy of said findings in this House forthwith.

A debate arose, which was, on the motion of the Hon. Mr. Maitland, adjourned to the next sitting.

Bill (No. 13) intituled "An Act to amend the 'Highway Act'" was committed.

Reported complete without amendment.

Report adopted.

Third reading at the next sitting.
