**12** Ms. *Boone* asked the Hon. the Minister of Regional and Economic Development the following questions:

1. How many applications for loan guarantees have been received by the Economic Development Regions? List those loans approved and provide the dollar value and the region they are in.

2. Provide the terms and conditions for each of these loans.

3. Provide a list of all loans not in good standing.

4. Who administers the budgets previously under the Ministers of State? Who has the final decision on use of those monies? What is the process to receive monies currently under the Minister of State?

The Hon. *S. B. Hagen* replied as follows:

"1. Under the now discontinued Regional Seed Capital Program, the only program administered by the Ministry which saw the Economic Development Regions reviewing applications, there have been 212 applications since the program was announced in March 1988.

"To March 31, 1990, 98 applications had been approved throughout the province for a total guaranteed loan value of \$3,531,450. The Development Region breakdown is as follows:

"2. The standard terms and conditions for loan guarantees under the Regional Seed Capital Program are for a 3-year loan guarantee amounting to the lesser of \$50,000 or 75% of the amount of the term loan. Interest rates charged by financial institutions are negotiated with their clients, and usually range from prime plus 1.5 to 2.5 per cent.

"3. The Ministry's records indicate that 9 per cent of the Regional Seed Capital Program guaranteed loans on the books of the financial institutions were not in good standing as at March 31, 1990 (i.e., loans payments in arrears). We are advised that most of these loans are under negotiation between the bank and the proponent to bring them back into good standing.

"4. The budgets previously under the regional Ministers of State have been incorporated into the Ministry of Regional and Economic Development's Estimates for 1990/91. The Minister of Regional and Economic Development, within the guidelines established by the *Financial Administration Act* and Treasury Board, is responsible for those monies previously allocated to the Ministers of State. The Ministers of State have been superseded by a new model for regional development with the establishment of the eight-member Regional Development Board. This board oversees the Government's regional development initiative, identifies and responds to local priorities and promotes specific regional initiatives."

Prayers by Mr. Reid.

Mr. Speaker delivered a decision as follows:

*Honourable Members:*

The Chair presently has under advisement two allegations of breach of privilege or contempt raised in the House on July 11th, July 12th, and July 16th last. It is most unusual and unique that while such matters are under consideration by the Chair, so many subsequent events occur which may directly or indirectly bear on the issues. I, of course, refer to the announcement of a police investigation, the engagement of the Deputy Attorney General of Alberta, consideration by the Ombudsman, and possible involvement of the Law Society of British Columbia at some stage.

In addition to the alleged matters of contempt placed before the Chair, there have been allegations of breach of the *Criminal Code*, the *Radiocommunication Act* and contravention of the *Privacy Act*. As a consequence, the Chair is very concerned that any ruling by the Chair, at this time, might have the effect of breaching the *spirit* and *intent* of the *sub-judice* rule, although perhaps not offending that rule as it is usually applied.

There exists another unusual circumstance in that the conduct of persons *outside the House*, as well as Members of the House, is interwoven in the issues and is the subject of enquiry and examination.

Under these circumstances the question arises whether the House itself should decide, or should the Chair decide, if the spirit and intent of the *sub-judice* rule should persuade the House to temporarily withhold its own enquiries while other enquiries involving the same circumstances are being conducted.

The Chair has been greatly assisted in resolving this question by a precedent to be found in the *Journals* of the Quebec National Assembly (*Journals*, 26th of March 1974). In that ruling the President (Speaker) held that while he had allowed a matter of privilege to be raised, and a motion to be "announced," he would not allow the matter to proceed further at that time, as it would involve a breach of the *sub-judice* rule. It is my decision to adopt the reasoning of the President of the Quebec National Assembly under similar circumstances.

Therefore, in order to safeguard the rights of those who might be prejudiced by this House pursuing its own remedies, while at the same time other processes are under way, I propose to withhold any further consideration of the issues for the time being.

This temporary disposition of the matter should not lead to the belief that the Chair has any doubt as to the status of electronic surveillance *per se*.

It is imperative that it be universally recognized and remembered that electronic surveillance, even although it may not be in breach of other laws, is a grave contempt of this House. The statement has already been made by this House that, "... parliamentary democracies flourish only when member and constituent can communicate freely, openly and candidly without having the spectre of interception . . . interfering with such communications" (Special Committee of Privilege, Legislative Assembly of British Columbia, June 6, 1980). The activity of electronic surveillance of a Member subjects anyone so involved to the sanctions of this House.
