REPORT.

LEGISLATIVE COMMITTEE ROOM, April 9th, 1954.

MR. SPEAKER:

Your Select Standing Committee on Forestry and Fisheries begs leave to report as follows:—

Investigation of the sale of timber on Mount Bruce Park has indicated the following:----

- (1) Lack of proper business acumen was coupled with a certain lack of responsibility for proper business procedures by a well-intentioned, community-spirited, unpaid Park Board which appears to have been guided by unsound advice. This Board's position concerning the administration of Mount Bruce was never properly established. Even if the Mount Maxwell Park Board was properly constituted for Mount Bruce Park, the sale of all the timber within the boundaries of the park could not be legally authorized.
- (2) Lack of decisive action and proper care on the part of Forest Service officials, particularly the head of the Parks Division, who should have been aware of the actions being taken by the Mount Maxwell Park Board concerning the disposal of the timber on Mount Bruce. Newspaper advertising was carried out and personal visits were made by the Board with the head of the Parks Division and other Forest Service and Government officials. The involved tri-party situation resulting from the timber sale should not have been allowed to develop.
- (3) Failure on the part of the original purchasers, Armand Quesnel and William T. Guyer, operating as the Q.L.K. Logging Company, and their adviser, Mr. Gavin Mouat, to heed the repeated warnings of the Forest Service that the agreement of sale covering the timber was not in order and should be terminated. Such failure resulted in an unfortunate tentative agreement of sale of the timber to Mohan Singh and allowed the latter to become financially involved without adequate warning of difficulties being encountered. This tentative agreement was never finalized in all details and could have been cancelled with little financial loss to the parties concerned when irregularities first became apparent.
- (4) In considering the form of settlement as proposed in the agreement of June 15th, 1951, and having in mind what has transpired since that time, we do not feel that this agreement would be fair to the parties concerned nor could it possibly be carried out under the financial provisions stated. This agreement, therefore, should not be ratified and the proposed Bill

should not be presented. It was felt a more equitable form of settlement should be recommended.

Therefore be it recommended that:---

- (1) The Order in Council setting up Mount Bruce Park be rescinded immediately. In future the suitability of an area for park purposes should be more thoroughly investigated before gazetting takes place.
- (2) Any claim by the Q.L.K. Logging Company for the timber on Mount Bruce shall be considered settled through the payment of \$25,000 already made to the company by Mohan Singh. Of this sum, \$5,000 is now held in trust with the Forest Service, and this shall be returned to the Q.L.K. Logging Company. Mohan Singh shall have no claim on any equipment which is owned by the Q.L.K. Logging Company, the sale of which was provided for in an agreement entered into between the Q.L.K. Logging Company and Mohan Singh.
- (3) To partially compensate Mohan Singh for losses incurred, he should be offered the standing and felled timber on Mount Bruce Park by the Government at the following stumpage rates, inclusive of royalty: Douglas fir, \$6.50 M B.M.; cedar, \$2.15 M B.M.; hemlock, \$2.05 M B.M.
- (4) If he accepts the terms stated, Mohan Singh shall establish proper financial responsibility to the satisfaction of the Minister of Lands and Forests, and shall log the area according to the "Forest Act" regulations and usual timber-sale terms established by that Department, which includes the deposit of 10 per cent of the value of the timber. A time-limit for the removal of timber shall be established.
- (5) If Mohan Singh fails to accept this offer within thirty days of being advised thereof by the Department of Lands and Forests, he shall have no further rights in this matter, and the timber may be offered for sale by the Forest Service in the normal manner under the provisions of the "Forest Act."

MR. SPEAKER:

Your Special Committee on Redistribution begs leave to report as follows:---

Your Committee has met on several occasions to consider the problem of redistribution as laid before us. Since last Session, Mr. Hurley, Chief Electoral Officer, has been of invaluable assistance to the Committee in that Mr. Hurley, following the instructions of the Committee, obtained maps, papers, documents, etc., which were of great value to the Committee in establishing a basis on which to work. Mr. Hurley further has been successful in obtaining certain opinions from members of the Legislative Assembly, Registrars of Voters, and Returning Officers. This information likewise was studied by your Committee.

In view of the short time remaining at the disposal of your Committee during this Session, the Committee felt it was impossible to complete the work in hand at the present Session, but it wishes to report progress.

1. Are any California wines regularly offered for sale in Government Liquor Stores?

2. If so, what brands are offered for sale and what is the price of each?

3. If not, (a) have California wines been offered to the Liquor Commission for resale in Government Liquor Stores, (b) has any request been made to the Liquor Commission to carry California wines for sale in Government Liquor Stores, and (c) whose decision is it that California wines should not be offered for sale in Government Liquor Stores?

The Hon. R. W. Bonner replied as follows:-

"1. No.

"2. Answered by No. 1.

"3. (a) and (b) Yes, and (c) the question of offering California wines is currently being studied by the Liquor Control Board."

Mr. Gregory asked the Hon. the Attorney-General the following question:—

How many of each of the following types of liquor licences have been applied for, pursuant to the "Government Liquor Act, 1953," in respect of the City of Victoria: (a) Dining lounge, (b) hotel, (c) club, (d) restaurant, (e) public house, and (f) resort?

The Hon. R. W. Bonner replied as follows:---

"The release of this information is considered to be not in the public interest because of *inter alia* the forthcoming plebiscite in the City of Victoria."

Resolved, That the House, at its rising, do stand adjourned until 8.30 o'clock p.m. to-day.

By leave of the House, on the motion of the Hon. W. A. C. Bennett, the House proceeded to the Order, "Public Bills and Orders."

Bill (No. 28) intituled "An Act respecting the Right of Employees to organize, and providing for Mediation, Conciliation, and Arbitration of Industrial Disputes" was again committed.

The House continued to sit after midnight.

Bill (No. 28) initialed "An Act respecting the Right of Employees to organize, and providing for Mediation, Conciliation, and Arbitration of Industrial Disputes" was reported complete with amendments, to be considered as amended at the next sitting.

Mr. *Tomlinson* presented the Report of the Select Standing Committee on Municipal Matters, as follows:—

REPORT.

LEGISLATIVE COMMITTEE ROOM, April 12th, 1954.

MR. SPEAKER:

Your Select Standing Committee on Municipal Matters begs leave to report as follows:---

Several meetings of this Committee were duly held.

The executive officers of the Union of British Columbia Municipalities appeared before the Committee and requested amendments to the "Municipal Act," "Village Municipalities Act," "Municipal Elections Act," "Sheep Protection Act," "Town Planning Act," "Insurance Act," and "Trust Companies Act."

For the information of the Committee, the executive officers of the Union of British Columbia Municipalities presented copies of their submissions to the Executive Council of British Columbia, made on February 5th, 1954. The solicitor for the City of New Westminster requested special powers in the matter of providing parking facilities.

The Hon. R. E. Sommers, as member for Rossland-Trail, presented a request on behalf of the Village of Warfield for powers of expropriation to acquire real property for all municipal purposes.

The solicitor for the Elk Creek Waterworks Company Limited, supported by a solicitor representing the City of Chilliwack and the Township of Chilliwhack, urged remedial legislation to relieve water companies of onerous taxation.

Representatives of life insurance agents, with their solicitor, submitted reasons why the request of the Union of British Columbia Municipalities for changes in the "Insurance Act" affecting life insurance agents should not be granted.

A solicitor of the British Columbia Electric Company Limited reminded the Committee of the decision reached by the Select Standing Committee on Municipal Matters of the previous year on the question of a change in utility taxation arising out of the incorporation of the District Municipality of Central Saanich.

The Department of Municipal Affairs submitted amendments to the "Municipal Act," "Village Municipalities Act," "Municipal Elections Act," and "Town Planning Act."

Arising out of the order of the Legislative Assembly, made on Friday, April 2nd, 1954, the Committee heard representations from each of the member municipalities of the Greater Victoria Water District respecting Bill No. 36. While the Committee is of the opinion there is some merit in the contention of the District Municipality of Saanich for increased representation for the three district municipalities on the Administration Board of the water district, a review of Bill No. 36 in the light of section 11 of the "Greater Victoria Water District Act" reveals that the objective cannot be accomplished by Bill No. 36 unless further amendments are made to section 11. It, therefore, is recommended that Bill No. 36 be not proceeded with.

This Committee has the following recommendations to make on some of the matters contained in the submission of the Union of British Columbia Municipalities to the Executive Council:—

- (1) Taxation of Power Transmission-lines: That this be given study by the Department of Municipal Affairs in its various aspects.
- (2) Taxation of Provincial Lands: That the principle of the taxation of Provincial lands in municipalities be approved.
- (3) Federal Aid: That steps be taken to have the Federal Government make again operative the "Municipal Improvements Assistance Act, 1938."

A number of amendments to various Acts were approved which are being submitted to the Legislature for enactment.

All of which is respectfully submitted.

Whereas it appears that no survey has been completed of the proposed road from Squamish to Vancouver via the route through the Capilano Valley:

And whereas no accurate estimate of the cost of building a road via this route can be made until a survey is completed:

And whereas engineering difficulties on this route appear to raise the possibility that this route may cost greatly in excess of the estimates which the Government has announced:

And whereas the Government has not yet obtained permission of the Greater Vancouver Water Board to build any road through its watershed area and it may prove essential eventually to build the connection between Vancouver and Squamish via the route along Howe Sound:

And whereas if it were ultimately necessary to construct this essential road link along Howe Sound after the proposed construction of the Pacific Great Eastern Railway along the same general route, the cost of construction of the road would be greatly increased and construction of the road might interfere with the efficient operation of the railway:

Therefore be it Resolved, That this Legislature urge the Government to investigate the question of whether, in the interests of economy and efficiency and the saving of public funds, surveys of both routes should be completed and the attitude of the Greater Vancouver Water Board be definitely established before actual construction of the said railway grade and the laying of tracks is begun.

On a point of order being raised, Mr. Speaker ruled the motion not in order as involving the appropriation of a part of the public revenue not recommended by a Message from the Lieutenant-Governor in contravention of Standing Order 67.

Order called for "Public Bills and Orders."

On the motion that Bill (No. 28) intituled "An Act respecting the Right of Employees to organize, and providing for Mediation, Conciliation, and Arbitration of Industrial Disputes" be read a third time now, Mr. Laing moved in amendment, seconded by Mr. Gregory,—

"6. (a) 153, (b) 177, and (c) 31."

Mr. Howard asked the Hon. the Provincial Secretary the following questions:-

1. Was any money spent, as a result of the meetings, during the First Session of the Twenty-fourth Parliament, of the Select Standing Committee on Forestry and Fisheries?

2. If yes, how much was spent (a) for a verbatim report, (b) for witnesses' expenses, and (c) on other items?

The Hon. W. D. Black replied as follows:-

Mr. Laing asked the Hon. the Minister of Public Works the following questions:-

Work boat with 16-horsepower outboard, including repairs (gasoline not included); rental rate, \$75 per month. T.D.-9 with blade, winch, operator, repairs, and lubricants (gasoline not included); rental rate, \$7.50 per operated hour. Five-yard dump-trucks with operator, repairs, and lubricants (gasoline not included); rental rate, \$5 per operated hour. D-1 Case tractor with 3/4-yard loader, operator, repairs, and lubricants (gasoline not included); rental rate, \$5.50 per operated hour. One 1,500watt light plant; rental rate, \$54.25 per month. One 350-watt light plant; rental rate, Two gas-powered chain saws, 30-inch bar, and replacement \$24.50 per month. chains, extra at cost (gasoline supplied by Department); rental rate, \$70 per month. One electric chain saw, replacement chains at cost; rental rate, \$11.76 per month. One 2-inch water-pump with hose; rental rate, \$26.95 per month. One 3/4-inch electric drill with bits; rental rate, \$11.55 per month. Two dual-tired flat-deck trailers; rental rate, \$56 per month.

"5. (a) Mr. J. Strang, under direction of F. Park, District Superintendent, Provincial Department of Public Works, Vanderhoof, B.C. (b) Former Civil Servant. (c) Extract from Annual Report, 1950, Minister of Mines: 'James Strang, Chief Inspector of Mines and Chairman of the Board of Examiners for Coal-mine Officials, retired at Victoria on January 31st, 1950. He was educated at public and private schools, graduating from Heriot Watt Technical College, Edinburgh. He had a first-class coal-miner's certificate from Great Britain and was assistant manager of the Preston Grange Colliery at Midlothian. He came to Canada in 1910 and was employed as surveyor, overman, and manager of the Extension mines at Nanaimo, holding the latter position for eight vears. He joined the staff of the British Columbia Department of Mines on December APRIL 14TH.

15th, 1926, as Inspector of Mines and Secretary of the Board of Examiners for Coal-mine Officials. He took over the position of Chief Inspector on April 30th, 1947, and also became Chairman of the Board of Examiners. He was a member of the Canadian Institute of Mining and Metallurgy and served as a member of the Ryan Safety Trophy Committee for British Columbia. He took a keen interest in his work and was outstanding in his ability to appreciate the miners' and operators' problems and to work with them. The same attitude was maintained toward his staff and associates in the Department of Mines. He took a great interest in mine-rescue and first-aid work and, during his tenure as Chief Inspector, was responsible for promoting mine-rescue training in metal mines to the extent that, before he retired, nearly every metalliferous mining area had a nucleus of men trained in mine rescue.'

The Lieutenant-Governor was pleased, in Her Majesty's name, to give assent to the said Bills.

The said assent was announced by the Clerk of the House in the following words:— "In Her Majesty's name, the Lieutenant-Governor doth assent to these Bills."

Then Mr. Speaker addressed the Lieutenant-Governor as follows:---

MAY IT PLEASE YOUR HONOUR:

We, Her Majesty's most dutiful and loyal subjects, the Legislative Assembly of the Province of British Columbia, in Session assembled, approach Your Honour at the close of our labours with sentiments of unfeigned devotion and loyalty to Her Majesty's person and Government and humbly beg to present for Your Honour's acceptance Bill (No. 43) initialed "An Act for granting certain Sums of Money for the Public Service of the Province of British Columbia."

To this Bill the Clerk of the Legislative Assembly, by the Lieutenant-Governor's command, did thereupon say:---

"In Her Majesty's name, the Lieutenant-Governor doth thank Her Majesty's loyal subjects, accept their benevolence, and assent to this Bill."

Then the Lieutenant-Governor was pleased to deliver the following gracious Speech:---

Mr. Speaker and Members of the Legislative Assembly:

In relieving you of your legislative deliberations at the conclusion of the Second Session of the Twenty-fourth Parliament, I do so with every assurance that the measures which you have enacted will confer benefit upon our people and further promote the developments which you have so wisely planned for the economic advancement of the Province.

I desire to express my appreciation of the careful manner with which you have attended to the business of this House.

Certain improvements in the Hospital Insurance Service and amendments to the "Workmen's Compensation Act," I am sure, will be most beneficial to my people.

The granting of an increase in the amount of the Provincial bonus paid to old-age pensioners and blind pensioners, also the increase to persons receiving social assistance, improvement in our labour laws, tax exemptions on children's clothes, children's boots and shoes, and other tax reductions, will greatly improve the welfare of our people.

It is gratifying to note that legislation has been passed concerning petroleum and natural gas, pursuant to my Government's policy to encourage exploration and, at the same time, ensure that the people of British Columbia derive benefit from this new development.

The enactment of legislation to permit the extension of the Pacific Great Eastern Railway from Squamish to North Vancouver and from Prince George to the Peace River country should encourage the further development of the Province.

The splendid financial position of the Province will commend itself to all.

I thank you for the supplies that you have granted for the Public Service, which will enable the continuation of my Government's programme throughout the fiscal year.

In closing this Session, I trust that the blessing of Divine Providence will accompany you to your respective homes.
