THREE O'CLOCK, P.M.

This being the first day of the second meeting of the Eleventh Parliament or Legislative Assembly of the Province of British Columbia, for the dispatch of business, pursuant to a Proclamation of His Honour the Honourable James Dunsmuir, Lieutenant-Governor of the Province, dated the 25th day of November, 1907.

His Honour the Honourable James Dunsmuir, Lieutenant-Governor of the Province, having entered the House, took his seat on the Throne, and was pleased to deliver the following gracious Speech:—

Mr. Speaker and Gentlemen of the Legislative Assembly:

In meeting you again at the opening of another Session, it is my privilege to be able to congratulate you on the prosperity which, during the past year, has prevailed in nearly all lines of trade and industry.

The Commission on Irrigation, the appointment of which you authorised last Session, has entered on its duties, and its report and recommendations will be submitted to you. In accordance with those recommendations, legislation will be introduced to secure a more equitable and efficient system of distribution of water for irrigation purposes.

The large increase in immigration, with the consequent demand for land under preemptions, warrants my Government in asking you to place a larger sum in the Estimates for an extension of the Provincial surveys.

A measure will be laid before you with a view to the restriction of the immigration of undesirable persons.

With the aim of encouraging and expediting railway construction, it is proposed to exempt from taxation, for a period of ten years from time of completion, certain railways already authorised. To do this you will be asked to pass an Act empowering the Government to grant such exemptions.

In accordance with your recommendation that a representative of the Government should be sent to London to lay before the Imperial Government the fact of the refusal of the Federal Government to entertain British Columbia's claim for more adequate and equitable treatment in the matter of Provincial subsidies, the Honourable the First Minister was assigned to undertake the duty, and his report of his mission and its results will be laid before you.

In order to secure a more efficient service in the conduct of the public business, it has been thought desirable to regulate the Civil Service, and a measure for effecting that and

creating a Superannuation Fund will be submitted for your approval.

With a view to obviate the necessity of our youth going abroad to perfect themselves in the arts and sciences, an Act to establish a Provincial University will be introduced during the Session.

For the more convenient prosecution of public works under appropriations by the Legislature, and with the object of securing uniformity between the Federal and Provincial systems in the method of accounting and the collection of statistics, it is deemed advisable to change the commencement of the financial year from July to April.

I am pleased to be able to inform you that the finances of the Province are in an excellent condition. This has enabled my Government to effect a large reduction in the public debt,

while still able to show a substantial surplus over the actual expenditure.

Measures will be submitted to you designed to secure to the Province the full benefits

that should accrue to the Treasury from the utilisation of its resources.

The Public Accounts for the past financial year, and the Estimates for the ensuing similar period, will be laid before you. The Estimates have been framed with due regard to economy, while providing for the outlay necessary to meet the requirements of the public service in a Province the scene of important industrial development.

On account of the increase in the demands for public works and buildings, and the development taking place in the northern parts of the Province, it is deemed advisable to create the office of Minister of Public Works, and you will be asked to approve of an amendment to the

Constitution Act to effect that.

I now commend these various measures to your attention, believing that their adoption will be to the advantage of the Province and the welfare of the people.

His Honour the Lieutenant-Governor was then pleased to retire.

Prayers by the Lord Bishop of Columbia.

The certificate of the election of William John Bowser, Esquire, for Vancouver City Electoral District, was read and Ordered placed on the Journals of the House.

Hon. W. J. Bowser, having been duly sworn, was introduced by the Hon. Mr. McBride and the Hon. Mr. Tatlow, and took his seat.

Mr. Speaker reported that, to prevent mistakes, he had obtained a copy of His Hononr's Speech.

Ordered, That the Votes and Proceedings of this House be printed, being first perused by Mr. Speaker, and that he do appoint the printing thereof, and that no person but such as he shall appoint do presume to print the same.

Ordered, That the Select Standing Committees of this House, for the present Session, be appointed for the following purposes:—

- 1. On Standing Orders and Private Bills;
- 2. On Public Accounts;
- 3. On Printing;
- 4. On Railways;
- 5. On Mining;
- 6. On Agriculture;
- 7. On Municipal Matters;

which said Committees shall severally be empowered to examine and enquire into all such matters and things as shall be referred to them by the House, and to report from time to time their observations and opinions thereon, with power to send for papers, persons and records.

Resolved, That if it shall appear that any person hath been elected or returned a Member of this House, or endeavoured so to be, by bribery or other corrupt practices, this House will proceed with the utmost severity against all such persons as shall have been wilfully concerned in such bribery or other corrupt practices.

On the motion of the Hon. Mr. Bowser, Bill (No. 1) intituled "An Act to amend the 'Supreme Court Act,'" was introduced and read a first time.

To be read a second time at the next sitting of the House.

Mr. Hawthornthwaite moved the adjournment of the House for the purpose of discussing a definite matter of urgent public importance.

Mr. Speaker *Eberts*, after considering the proposed motion, ruled that the same did not disclose a matter of sufficient definite urgent public importance to justify him in allowing the debate to proceed on the opening day of the Session.

Mr. Hawthornthwaite appealed from the ruling of the Chair.

Pursuant to Order, the House proceeded to take into consideration the Speech of His Honour the Lieutenant-Governor at the opening of the Session.

Mr. Taylor moved, seconded by Mr. Schofield,—

That a humble Address be presented to His Honour the Lieutenant-Governor, to thank His Honour for his gracious Speech at the opening of the present Session, and further to assure His Honour that:—

1. We are pleased to be congratulated on the prosperity which during the past year has

prevailed in nearly all lines of trade and industry in this Province.

2. We shall peruse with great interest the report and recommendations of the Commission on Irrigation, the appointment of which was authorised last Session, and we shall carefully consider any legislation introduced to secure a more equitable and efficient system of distribution of water for irrigation purposes.

3. We think the large increase in immigration, with the consequent demand for land under pre-emptions, warrants His Honour's Government in asking that a larger sum than usual

be placed in the Estimates for an extension of our Provincial surveys.

4. We shall carefully consider any measure laid before us with a view to the restriction

of the immigration of undesirable persons.

5. The construction of railways would doubtless be encouraged and expedited by a measure exempting from taxation for a period of ten years from time of completion certain

railways already authorised.

- 6. We are pleased to be informed that there will be submitted to us the report of the Honourable the First Minister touching his mission to London as a representative of His Honour's Government, to lay before the Imperial Government the fact of the refusal of the Federal Government to entertain British Columbia's claim for more adequate and equitable treatment in the matter of Provincial subsidies.
- 7. We consider a more efficient service in the conduct of our public business would be effected by a measure regulating the Civil Service and creating a Superannuation Fund.
- 8. We agree with His Honour that the necessity of our youth going abroad to perfect themselves in the arts and sciences would be largely obviated by the establishment of a Provincial University.
- 9. We deem it advisable for the more convenient prosecution of public works under appropriation by the Legislature, and with the object of securing uniformity between the Federal and Provincial systems in the method of accounting and in the collection of statistics, that the commencement of the financial year should be changed from July to April.
- 10. We are pleased to be informed that the finances of the Province are in excellent condition, and that this has enabled His Honour's Government to effect a large reduction in the public debt, while still being able to show a substantial surplus over the actual expenditure.

11. Measures submitted to us designed to secure to the Province the full benefits that should accrue to the Treasury from the utilisation of the resources of the Province, will have

our earnest support.

12. We learn with pleasure that the Public Accounts for the past financial year, and the Estimates for the coming year, will be laid before us, and that the Estimates have keen framed with due regard to economy, while providing for the outlay necessary to meet the requirements of the Public Service in a Province the scene of important industrial development.

13. We agree with His Honour in thinking that on account of the increase in the demands for Public Works and Buildings, and the development taking place in the northern parts of

the Province, it is advisable to create the office of Minister of Public Works.

14. We join His Honour in hoping that our deliberations will result in promoting the welfare of the people of the Province.

A debate arose, which was adjourned until the next sitting of the House.

4. Nicola Valley Coal and Coke Co., Nicola Valley?

The Hon. Mr. McBride replied as follows:—

"1. Union Colliery, 281 Chinese, 22 Hindus, 73 Japanese.

"2. None. Three Indians, presumably natives of British Columbia, are employed.

On the motion of the Hon. the Attorney-General, Bill (No. 5) intituled "An Act to amend the 'Oaths Act,'" was introduced, read a first time and *Ordered* to be read a second time to-morrow.

Mr. Hawthornthwaite moved, seconded by Mr. McInnis,-

Whereas, during the last Session of this House, a Bill was introduced intituled "An Act to Regulate Immigration into British Columbia," with the object and intent of preventing a further influx into this Province of "backward races," notably certain of the subjects of His Imperial Majesty the Mikado of Japan; and

Whereas the said Bill, as amended, successfully passed through the various stages in this Législature, was supported by the members of the Executive Council at that time present, and

was enacted, so far as it lay in the power of the Members of this Legislature; and

Whereas the Honourable James Dunsmuir, Lieutenant-Governor of this Province, refused

to assent to the passage of said Bill; and

Whereas the Hon. Richard McBride, Premier of British Columbia, has publicly stated that the Lieutenant-Governor was not advised by his Government to refuse to give his assent to said Bill; and

Whereas it has transpired during an investigation by the Deputy Minister of Labour, *MacKenzie King*, acting under instructions from the Dominion Government, into the causes and nature of the extraordinary immigration of Japanese labourers into this Province, that the Honourable *James Dunsmuir*, in his private capacity as an operator of coal mines in this

Province, had, on or about the time of the passage of said Bill, entered into a contract with the Canadian Nippon Company, of Vancouver, to procure five hundred Japanese coolies for exploitation in his coal mines; and

Whereas the passage of the aforesaid Bill would have had the effect of delaying or pre-

venting the coming into this Province of the labourers aforesaid; and

Whereas the Lieutenant-Governor has not acted in this matter in accordance with constitutional practice, in refusing his assent to the enactment of said Bill without the advice of his responsible Ministers, and has further laid himself open to grave suspicion as to the reasons that induced him to refuse his assent to said Bill; and

Whereas his action in these matters must inevitably tend to destroy such confidence as

the people of this Province have in Constitutional and Responsible Government;

Therefore, be it Resolved, That this House emphatically condemns all such unconstitutional proceedings and hereby appeals to the Governor-General of this Dominion to investigate into all of the aforesaid matters and charges, and should the facts prove to be as stated in this resolution, dismiss forthwith the Honourable James Dunsmuir from the office of Lieutenant-Governor of the Province of British Columbia.

A point of Order arose, and the debate was adjourned until to-morrow.

Mr. Williams asked the Hon. the Attorney-General the following questions:—

1. Under the provisions of what Statute is the Government authorised to employ Pinkerton detectives ?

2. Were said "detectives" residents of British Columbia?

3. Before employing these men, did the Government make any inquiries as to their character ?

The Hon. Mr. Bowser replied as follows:—

"1. There is no special Statute regarding the employment of such detectives, any more than there is for the employment of many other means of carrying on the administration of justice.

"2. There is nothing in this question to indicate the occasion referred to.

"3. Answered by the reply to question No. 2."

To the Honourable James Dunsmuir, Lieutenant-Governor of the Province of British Columbia:

We are pleased to be congratulated on the prosperity which during the past year has prevailed in nearly all lines of trade and industry in this Province.

We shall peruse with great interest the report and recommendations of the Commission on Irrigation, the appointment of which was authorised last Session, and we shall carefully consider any legislation introduced to secure a more equitable and efficient system of distribution of water for irrigation purposes.

We think the large increase in immigration, with the consequent demand for land under pre-emptions, warrants Your Honour's Government in asking that a larger sum than usual be placed in the Estimates for an extension of our Provincial surveys.

We shall carefully consider any measure laid before us with a view to the restriction of the immigration of undesirable persons.

The construction of railways would doubtless be encouraged and expedited by a measure exempting from taxation for a period of ten years from time of completion certain railways already authorised.

We are pleased to be informed that there will be submitted to us the report of the Honourable the First Minister touching his mission to London as a representative of Your Honour's Government, to lay before the Imperial Government the fact of the refusal of the Federal Government to entertain British Columbia's claim for more adequate and equitable treatment in the matter of Provincial subsidies.

We consider a more efficient service in the conduct of our public business would be effected by a measure regulating the Civil Service and creating a Superannuation Fund.

We agree with Your Honour that the necessity of our youth going abroad to perfect themselves in the arts and sciences would be largely obviated by the establishment of a Provincial University.

We deem it advisable for the more convenient prosecution of public works under appropriation by the Legislature, and with the object of securing uniformity between the Federal and Provincial systems in the method of accounting and in the collection of statistics, that the commencement of the financial year should be changed from July to April.

We are pleased to be informed that the finances of the Province are in excellent condition, and that this has enabled Your Honour's Government to effect a large reduction in the public debt, while still being able to show a substantial surplus over the actual expenditure.

Measures submitted to us designed to secure to the Province the full benefits that should accrue to the Treasury from the utilisation of the resources of the Province, will have our earnest support.

We learn with pleasure that the Public Accounts for the past financial year, and the Estimates for the coming year, will be laid before us, and that the Estimates have been framed with due regard to economy, while providing for the outlay necessary to meet the requirements of the Public Service in a Province the scene of important industrial development.

We agree with Your Honour in thinking that on account of the increase in the demands for Public Works and Buildings, and the development taking place in the northern parts of the Province, it is advisable to create the office of Minister of Public Works.

We join Your Honour in hoping that our deliberations will result in promoting the welfare of the people of the Province.

On the motion of the Honourable the Premier, seconded by the Honourable the Attorney-General, it was Resolved.—

The Hon. Mr. Bowser presented a Return of copies of correspondence between the Deputy Minister of Justice and the Hon. Attorney-General, re Chapter 21a of 1907, intituled "An Act to Regulate Immigration into British Columbia."

The following petitions were presented:-

By Mr. McGuire—From T. T. Beatty and others (re opium traffic).

By Mr. Thomson—From the Corporation of the City of Victoria, for leave to introduce a Private Bill to amend "The Victoria Water-Works Act and amending Acts."

Hon. Mr. Speaker *Eberts* gave the following ruling on the point of order raised on the motion moved by Mr. *Hawthornthwaite* on 21st inst.:—

The following resolution was moved by the Honourable Member for Nanaimo:

"Whereas, during the last Session of this House, a Bill was introduced intituled "An Act to Regulate Immigration into British Columbia," with the object and intent of preventing a further influx into this Province of "backward races," notably certain of the subjects of His Imperial Majesty the Mikado of Japan; and

"Whereas the said Bill, as amended, successfully passed through the various stages in this Legislature, was supported by the members of the Executive Council at that time present, and

was enacted, so far as it lay in the power of the Members of this Legislature; and

"Whereas the Honourable James Dunsmuir, Lieutenant-Governor of this Province,

refused to assent to the passage of said Bill; and

"Whereas the Hon. Richard McBride, Premier of British Columbia, has publicly stated that the Lieutenant-Governor was not advised by his Government to refuse to give his assent to said Bill; and

"Whereas it has transpired during an investigation by the Deputy Minister of Labour, MacKenzie King, acting under instructions from the Dominion Government, into the causes and nature of the extraordinary immigration of Japanese labourers into this Province, that the Honourable James Dunsmuir, in his private capacity as an operator of coal mines in this Province, had, on or about the time of the passage of said Bill, entered into a contract with the Canadian Nippon Company, of Vancouver, to procure five hundred Japanese coolies for exploitation in his coal mines; and

"Whereas the passage of the aforesaid Bill would have had the effect of delaying or

preventing the coming into this Province of the labourers aforesaid; and

"Whereas the Lieutenant-Governor has not acted in this matter in accordance with constitutional practice, in refusing his assent to the enactment of said Bill without the advice of his responsible Ministers, and has further laid himself open to grave suspicion as to the reasons that induced him to refuse his assent to said Bill; and

"Whereas his action in these matters must inevitably tend to destroy such confidence as

the people of this Province have in Constitutional and Responsible Government;

"Therefore, be it Resolved, That this House emphatically condemns all such unconstitutional proceedings and hereby appeals to the Governor-General of this Dominion to investigate into all of the aforesaid matters and charges, and should the facts prove to be as stated in this resolution, dismiss forthwith the Honourable James Dunsmuir from the office of Lieutenant-Governor of the Province of British Columbia."

The Legislature, by well established precedent, cannot pass a resolution of censure upon the Lieutenant-Governor for his conduct, except as a preliminary to an address to the Governor-General.

The above Resolution may be regarded as preliminary to a Message to His Excellency, but exception has been taken to it on two grounds: First, that the Resolution is out of order and should not be put to the House, inasmuch as it alleges that His Honour "has laid himself open to grave suspicion as to the reasons that induced him to refuse his assent to the Bill intituled 'An Act to Regulate Immigration into British Columbia, 1907,'" and Rule 15 was cited as an authority. The Rule reads as follows:—

"No member shall speak disrespectfully of Her Majesty nor of any of the Royal Family, nor of the Governor or person administering the Government of Canada, nor of the Lieutenant-Governor of Province, nor shall he use offensive words against any member of this House, nor shall he speak beside the question in debate. No Member shall reflect upon any vote of the House passed during the current Session, except for the purpose of moving that such vote be rescinded."

During the debate on this point it was strongly urged by the introducer of the Resolution that Rule 15 did not, and should not, in this case apply. In this I cannot for a moment agree The Rule is a most useful and wise one, and obtains in all Parliaments in the British Dominions, and in this Legislative Body has always been enforced. The reference I have quoted to His Honour's conduct in reserving his assent is, in my opinion, clearly an infringement of the above Rule, as I shall presently show.

The second point of order was that in reserving his assent to the said Bill his action was constitutional. Since the debate on the Resolution now under consideration, another debate on the Address in reply to the King's Speech arose, and during same it was moved to add the following as clause 15 thereto: "We censure His Honour's responsible Ministers for their action in connection with His Honour's non-assent to the Bill of last Session intituled 'An Act to regulate Immigration into British Columbia'"; and on the 24th inst. the House refused to affirm same, thereby doclaring that as between His Honour and his Ministers he had acted constitutionally. Now, when a Bill has passed the House, under and by virtue of section 55 of the "British North America Act," His Honour has three courses open to him: (1) That he assents to same in the King's name, (2) that he withholds the King's assent, (3) that he reserves the Bill for the signification of the King's pleasure.

I will not deal with the second course open to him, as nothing arises on that. The procedure with reference to the third course open to him has been decided by the House. He was therefore constitutionally entitled to reserve the Bill for the signification of the King's pleasure. As it appears, he took that course, and whether advised so to do under instructions from His Excellency or acting on his own discretion, if the occasion was one of urgency, he was acting, in my opinion, within his rights and according to the Constitution, and if so, as the Representative of His Majesty in this Province, it must be assumed that he acted in the public and not in his private interests, and it would therefore be highly improper to impute motives.

For these reasons I am of opinion the Resolution is one that should not be put to this House, and so I declare.

Whereas, during the last Session of this House, a Bill was introduced intituled "An Act to Regulate Immigration into British Columbia," with the object and intent of preventing a further influx into this Province of 'backward races,' notably certain of the subjects of His Imperial Majesty the Mikado of Japan; and

Whereas the said Bill, as amended, successfully passed through the various stages in this Legislature, was supported by the members of the Executive Council at that time present, and was enacted, so far as it lay in the power of the members of this Legislature; and

Whereas the Honourable James Dunsmuir, Lieutenant-Governor of this Province,

refused to assent to the passage of said Bill; and

Whereas the Hon. Richard McBride, Premier of British Columbia, has publicly stated that the Lieutenant-Governor was not advised by his Government to refuse to give his assent to said Bill; and

Whereas it has transpired, during an investigation by the Deputy Minister of Labour, MacKenzie King, acting under instructions from the Dominion Government, into the causes and nature of the extraordinary immigration of Japanese labourers into this Province, that the Honourable James Dunsmuir, in his private capacity as an operator of coal mines in this Province, had, on or about the time of the passage of said Bill, entered into a contract with the Canadian Nippon Company, of Vancouver, to procure five hundred Japanese coolies for exploitation in his coal mines; and

Whereas the passage of the aforesaid Bill would have had the effect of delaying or

preventing the coming into this Province of the labourers aforesaid;

Therefore, be it Resolved, That this House appeal to the Governor-General of this Dominion to investigate into all these matters, and should it be ascertained that the Honourable James Dunsmuir has acted unconstitutionally, that he be dismissed forthwith from office.

Mr. Speaker *Eberts* ruled the motion out of order, citing Rule 15 and his previous ruling of to-day and of 29th January.

Mr. Hawthornthwaite appealed from the ruling of the Chair.
