Prayers by the Rev. E. A. Wright.

By leave of the House, the Hon. W. A. C. Bennett made the following statement:—

"Mr. Speaker, yesterday when I arrived at my office, I was amazed to have a message from one of the Vancouver newspapers that a certain letter purporting to be signed by me had arrived in Ottawa at the Prime Minister's office in May, 1964.

"I immediately summoned all my small staff in the Premier's office to make sure no such letter of any type had been sent, not only as suggested but to anybody else at any time. They assured me no such letter had been sent.

"Realizing this was a completely phoney letter I immediately asked the Attorney-General to come to the Premier's office. He came forthwith. I asked him immediately to get in touch with the R.C.M.P. and tell them to get in touch with the Ottawa detachment and run down this phoney letter and investigate the case to the nth degree, which he did.

"Immediately following that I telephoned the Prime Minister of Canada in his office at Ottawa and talked with him and told him about this letter. He said he had never seen the letter, and he would send for it forthwith, and accepted my assurance that it was a phoney letter.

"I pointed out to the Prime Minister that a letter might arrive like that in the Prime Minister's office and would not be referred to him, but sent immediately by a member of his staff to the Minister of Immigration and become part of a file. At times I have been in Ottawa since and no mention was ever made of this letter. If a situation like this had not developed, I would never have heard about this phoney letter. The Prime Minister said he would immediately get in touch with the Department and see that he got the letter forthwith.

"The next development yesterday afternoon was this: The R.C.M.P. detachment, not the same officer, telephoned the Attorney-General and said that on the week-end before—it was Wednesday when we found out—a certain person had come to them and admitted to them that they had written a letter—this particular letter—without any knowledge of the Premier and without any permission of the Premier. Later in the afternoon the Attorney-General received by special delivery a letter from the R.C.M.P. confirming this. The peculiar thing about this is—and there are many peculiar things about this in the Prime Minister's office and the R.C.M.P.—if they had this statement over the week-end, why didn't they advise the Chief Law Officer of the Province, and through him the Premier, or why didn't they advise the Prime Minister of Canada? They didn't have any reaction until the Attorney-General had, hours before, telephoned them about this matter.

"So I again telephoned the Prime Minister's office this morning. The Prime Minister was not in his office, he was en route to Toronto. But I talked to his secretary and further explained the situation, about this statement that the R.C.M.P. had and didn't make known to us until we started to investigate yesterday and how odd it was. I advised the secretary of the Prime Minister that I intended to make a statement on the floor of this House at the opening today.
