The Hon. L. R. Peterson replied as follows:—

Mr. Strachan asked the Hon. the Minister of Health and Welfare the following questions:—

With respect to the Girls' Industrial School:—

- 1. What was the total number of staff employed as at (a) December 31st, 1957, and (b) December 31st, 1958?
- 2. What was the total number of social workers employed as at (a) December 31st, 1957, and (b) December 31st, 1958?
- 3. What was the total number of children held as at (a) December 31st, 1957, and (b) December 31st, 1958?

The Hon. E. C. F. Martin replied as follows:—

- " 1. (a) 40 and (b) 39.
- "2. (a) 3 and (b) 3.
- "3. (a) 69 and (b) 69."

- Mr. Campbell asked the Hon. the Minister of Education the following questions:—
- 1. What was the total grant for all school purposes to each of the following school districts in the fiscal year 1957/58: Qualicum, Courtenay, Campbell River, Alert Bay, and Quatsino?
- 2. What percentage of the total school budget does the Provincial Government contribution represent in each of these school districts for the fiscal year 1957/58?

The Hon. L. R. Peterson replied as follows:—

"1. School District No. 69 (Qualicum), \$257,318; School District No. 71 (Courtenay), \$667,180; School District No. 72 (Campbell River), \$310,476; School District No. 73 (Alert Bay), \$127,498; and School District No. 74 (Quatsino), \$30,883. These grants refer to the calendar year 1958.

"2. School District No. 69 (Qualicum), 61.41 per cent; School District No. 71 (Courtenay), 67.29 per cent; School District No. 72 (Campbell River), 44.02 per cent; School District No. 73 (Alert Bay), 56.06 per cent; and School District No. 74 (Quat-

sino), 13.58 per cent."

Mr. Strachan asked the Hon. the Minister of Education the following questions:—

- 1. Did the Provincial Government purchase any debentures issued by school districts in the Province in the years 1952, 1953, 1954, 1955, 1956, 1957, and 1958?
- 2. If the answer to No. 1 is yes, in which years, in what amounts, and in which districts?

The Hon. L. R. Peterson replied as follows:—

"1 and 2. This matter is not under the jurisdiction of my Department."

Mr. Sharp asked the Hon. the Minister of Health and Welfare the following question:—

Have Social Allowance basic rates been increased since 1952 and, if so, when and in what amounts?

The Hon. E. C. F. Martin replied as follows:—

"Effective April 1st, 1954, \$5 per month for each head of family or single person and \$2 per month for each dependent; effective April 1st, 1956, \$5 per month for each head of family or single person and \$2 per month for each dependent; effective April 1st, 1958, \$10 per month for family of two plus \$2 per month for each additional dependent and \$5 per month for each single person."

Mr. Strachan asked the Hon. the Minister of Health and Welfare the following questions:—

With respect to the Federal "Unemployment Assistance Act," 1956:—

- 1. Are all social workers in the Social Welfare Branch provided with a copy of this Act?
- 2. Have written instructions or explanatory notes been issued to all social workers regarding the Schedule of Agreement between the Federal Government and the Provincial Government under this Act?
- 3. If the answer to No. 2 is yes, do these instructions advise workers that they must adhere to the terms of this agreement when dealing with individual cases?

The Hon. E. C. F. Martin replied as follows:-

- " 1. No.
- " 2. No.
- "3. Answered by No. 2."

Mr. Brothers asked the Hon. the Minister of Education the following question:—
Has the Department of Education given any encouragement to the retention of capable teachers who have reached retiring age?

The Hon. L. R. Peterson replied as follows:-

"Legislation was passed in the 1958 Session and is found in section 151 of the 'Public Schools Act' whereby, on the request of a Board, re-engagement after retirement or deferment of retirement may be authorized year by year until the teacher has reached the age of 70 years. Changes in teachers' superannuation were also authorized so that the teachers concerned do not lose financially by retaining employment."

Mr. Campbell asked the Hon. the Minister of Education the following question:—
Do any school districts operate special schools for mentally retarded children under the auspices of the Association for Retarded Children of British Columbia or affiliated organizations and, if the answer to No. 1 is yes, (a) how many and (b) what was the enrolment in these schools in the fiscal years 1955/56, 1956/57, and 1957/58?

The Hon. L. R. Peterson replied as follows:-

"The school districts do not operate the schools but pay grants to eligible children in the schools operated by local chapters of the Association; (a) thirty-one school districts and thirty-three schools; (b) 1955/56, 118 (estimated); 1956/57, 317; and 1957/58, 321."

Mr. Squire asked the Hon. the Minister of Lands and Forests the following question:—

What was the total number of permanent staff employed on forest protection in each fiscal year, 1953 to 1957, and in the calendar year 1958?

The Hon. R. G. Williston replied as follows:—

The Hon. L. R. Peterson replied as follows:—

- "1. Total calendar year grant to School District No. 60 (Peace River North), \$254,171, paid in bi-monthly instalments.
  - "2. Yes; grant computation applies."

Mrs. Brown asked the Hon. the Minister of Education the following question:—

Are any immigrants now receiving instruction in English for New Canadians and, if so, how many?

(c) A capital allowance is made in the costs of new schools toward the establishment of basic book collections. This will depend on the size of the school. (d) Librarians are recognized as part of the entitlement of teachers in all schools enrolling 500 or more pupils."

Mr. Strachan asked the Hon. the Minister of Education the following questions:—

- 1. With respect to expenditure made in the Province for education in the year 1958, what was the total sum?
- 2. What portion of the total sum was expended on (a) ordinary expenditure and (b) capital expenditure?
- 3. What portion of the total sum was contributed by (a) the Provincial Government, (b) the city and district municipalities, and (c) by the Provincial Government on behalf of rural areas of any school district?

The Hon. L. R. Peterson replied as follows:—

- "1. Total 1958 net budgets of school districts, \$88,344,456.
- "2. (a) \$76,540,824 and (b) \$11,803,632.
- "3. (a) \$43,216,583, (b) \$35,737,081, and (c) \$9,390,792."

Mr. Nimsick asked the Hon. the Attorney-General the following questions:—

- 2. If the answer to No. 1 is yes, (a) how many, (b) what methods of transportation were used, (c) how many trips involved, (d) how many police or assistants were used to accompany the prisoners, and (e) what was the total cost of transportation (i) for prisoners and (ii) for police and assistants?

- 2. If the answer to No. 1 is yes, (a) what was the total number of resignations, (b) in which departments did the resignations take place, and (c) what reasons, if any, were given for the resignations in each case?

- 2. If the answer to No. 1 is yes, (a) how many individuals made such repayments during the fiscal years 1953 to 1957 and the calendar year 1958, and (b) how much was repaid in this manner in the fiscal years 1953 to 1957 and the calendar year 1958?

The Hon. E. C. F. Martin replied as follows:—

- 1. Is a new hospital being constructed or is one planned in the Fort St. John area?
- 2. (a) If yes, will the hospital be outside the municipal boundaries of Fort St. John, and (b) if so, for what reason?

The Hon, E. C. F. Martin replied as follows:-

"1. A hospital is being planned in the Fort St. John area.

"2. The hospital referred to in No. 1 is being planned by a religious order known as The Sisters of Charity of Providence, which owns and operates the existing hospital. This order proposes to construct the new hospital on a site adjacent to the existing hospital. Construction, which is a local responsibility, has not commenced, due to difficulties experienced in raising the community funds required to supplement the Government grants and the funds the order is prepared to supply. Some residents of the area feel that any new hospital built in the area should be constructed on a different site and be owned by the community rather than the above-mentioned order. Therefore, the location of the new hospital will not be known until the question of who is to own and operate it has been finally decided by the people of the area."

Mr. Strachan asked the Hon. the Minister of Health and Welfare the following question:—

Have written instructions gone out to every social worker in the Province instructing that Social Allowance may be granted to supplement unemployment insurance when the unemployment insurance is below the maximum scheduled rate of social assistance?

The Hon. E. C. F. Martin replied as follows:—

"Social workers have been notified of this policy through usual channels."

Mr. Strachan asked the Hon. the Minister of Health and Welfare the following question:—

What are the Social Welfare Branch (a) daily and (b) weekly rates paid for foster-home care of wards of the Superintendent of Child Welfare?

The Hon. E. C. F. Martin replied as follows:—

"Birth to 13 years, inclusive, \$1 per day; girls 14 and over, \$1.30 per day; and boys 14 and over, \$1.60 per day. The above rates for 'food and lodging only.' Other expenses met by Welfare Branch."

Mr. Shelford asked the Hon. the Minister of Education the following question:— What part of the Indian school population is attending the regular public schools of the Province?

The Hon. L. R. Peterson replied as follows:-

"The total Indian school population of the Province is estimated at approximately 8,700. In the past school-year there were approximately 2,100 Indian children in public schools; of these, approximately 1,300 were elementary pupils, 650 junior high school level, and 170 senior high school. The Province has co-operated in every way to ensure equal educational opportunity for these children."

Resolved, That the House, at its rising, do stand adjourned until 2 o'clock p.m. to-morrow.

And then the House adjourned at 5.19 p.m.

Prayers by the Rev. E. Laura Butler.

Mr. Dowding asked leave of the House to make a motion for the adjournment of the House for the purpose of discussing a definite matter of urgent public importance and submitted the following statement of the matter proposed to be discussed:—

The advisability of urging the Government to request the Attorney-General to make immediate representations to the Federal Government with a view to preserving the existing Trans-Canada Airline services between Victoria and Vancouver.

Members were allowed to speak in an endeavour to assist the Speaker in his decision.

The Speaker gave his decision as follows:—

Honourable Members,—I do not feel that the matter raised by the honourable first member for Burnaby comes within the scope of Standing Order 35. I refer you to two or three quotes from Beauchesne's Parliamentary Rules and Forms, fourth edition:—

"The definite matter of urgent public importance for the discussion of which a member may ask leave to move the adjournment of the House under Standing Order 26 must involve the administrative responsibility of the Government.

"The 'definite matter of urgent public importance,' for the discussion of which the adjournment of the House may be moved under Standing Order 26, must be so pressing that public interest will suffer if it is not given immediate attention."

"Urgency" within this rule does not apply to the matter itself, but it means "urgency of debate," when the ordinary opportunities provided by the rules of the House do not permit the subject to be brought on early enough and public interest demands that discussion take place immediately.

The matter requested for discussion, in my opinion, has not been brought up at the earliest possible moment. The withdrawal of this service has been a known possibility for several weeks and could, therefore, have been brought forward at an earlier date and, in fact, could have been discussed in ordinary debate before now. Further, it was announced earlier this week in this House that the Attorney-General was going to Ottawa to-day and instructions could have been given to him by this House before this.

I want to make it quite clear that I am not deciding on the urgency of the matter but on the urgency of the debate.

With all due respect to the arguments presented by members, I hold that the matter submitted does not come within the scope of Standing Order No. 35.

Mr. Brothers asked the Hon. the Minister of Recreation and Conservation the following questions:—

1. How much money was spent on game conservation projects from the inception of the Game Conservation Fund to March 31st, 1957, when the Fund was abolished?

2. How much money has been spent on game conservation projects since March 31st, 1957?

The Hon. E. C. Westwood replied as follows:-

"1. During the six years that the Game Conservation Fund was in existence, ended March 31st, 1957, the sum of \$70,817.76 was spent on conservation projects.

"2. From March 31st, 1957, to date the sum of \$105,867.60 has been expended on game conservation projects."

Mr. Dowding asked the Hon. the Provincial Secretary the following question:—

With reference to page 216, Annual Report of Mental Health Services, 1957, regarding the Child Guidance Clinic, what is the present time lapse between investigation, evaluation, and treatment as at December 31st, 1958?

The Hon. W. D. Black replied as follows:—

"No waiting-list at present at the Child Guidance Clinic; there is no time lapse between the time of investigation, evaluation, and treatment at the present time."

Mr. *Dowding* asked the Hon. the Provincial Secretary the following questions:—With reference to the Child Guidance Clinic:—

1. How many psychologists were employed there as at December 31st, 1958, and what were their respective gradings?

2. How many social workers were employed there as at December 31st, 1958, and what were their respective gradings?

The Hon. W. D. Black replied as follows:—

"1. Vancouver Island Clinic, one Grade 4; Burnaby Clinic, one Grade 5, one Grade 3, and two Grade 2; travelling, one Grade 4 and one Grade 2; total of seven psychologists.

"2. Vancouver Island Clinic, one Grade 4 social worker, one Grade 3 social worker, and one Grade 2 social worker; Burnaby Clinic, one Grade 1 Superintendent of Welfare, four Grade 4 social workers, nine Grade 3 social workers, and two Grade 2 social workers; total, nineteen."

Mr. Dowding asked the Hon. the Provincial Secretary the following question:—

Is there a medical record librarian on staff at the present time at the Provincial Mental Hospital, Essondale?

The Hon. W. D. Black replied as follows:—

"Supervisor of clinic office functions as medical record librarian."

Mr. *Tisdalle* asked the Hon. the Provincial Secretary the following questions:—With respect to The Woodlands School:—

1. How many crib cases were in residence on December 31st, 1958?

2. How many bed cases were in residence on December 31st, 1958?

The Hon. W. D. Black replied as follows:-

"1. Crib cases, 228.

" 2. Bed cases, 1,156."

Mr. Gregory asked the Hon. the Provincial Secretary the following question:—

In each of the years 1949 to 1958, inclusive, what percentage of persons employed in the Civil Service left the Civil Service?

The Hon. W. D. Black replied as follows:—

"In 1949, 17.09 per cent; in 1950, 18.43 per cent; in 1951, 24.56 per cent; in 1952, 23.32 per cent; in 1953, 25.60 per cent; in 1954, 26.67 per cent; in 1955, 26.85 per cent; in 1956, 26.45 per cent; in 1957, 27.84 per cent; and in 1958, 21.36 per cent."

Mr. Dowding asked the Hon. the Provincial Secretary the following questions:—

With respect to The Woodlands School:—

1. What was the ratio of teachers to pupils as at January 1st, 1958, and what is the present ratio?

2. Is there a male rehabilitation officer on staff at the present time?

The Hon. W. D. Black replied as follows:—

"1. On January 1st, 1958, there was a ratio of one teacher to every 26.6 pupils attending school; at the present time there is a ratio of one teacher to every 23.75 pupils attending school.

- 2. What portion of the amount transferred, and (or) transferable, was standing to the credit of (a) employees' accounts and (b) employer's account?

The Hon. W. A. C. Bennett replied as follows:-

- "2. (a) Nil and (b) \$3,269,794.27."

- 1. How much, if any, has been borrowed from the Provincial Treasury from October 26th, 1955, to the date of the latest available record, under the provisions of the "Housing Act"?
- 2. If any amounts have been borrowed and used, give the names of the municipalities or cities involved, together with the individual amounts and dates.

The Hon. W. A. C. Bennett replied as follows:-

"1. The 'Housing Act' does not authorize borrowings from the Provincial Treasury; \$384,033.60 has been paid to Central Mortgage and Housing Corporation since October, 1955, to date in respect of the Province's share of housing or land assembly projects.

"2. The names of the municipalities involved and the amounts paid are as follows: Duncan, \$51,743.58; Kimberley, \$30.07; Prince George, \$101,173.59; Saanich,
