Dr. Rothwell presented the report of the Select Committee on Mental Hygiene, as follows :---

LEGISLATIVE COMMITTEE ROOM, December 17th, 1925.

MR. SPEAKER:

(a.) Your Committee appointed to look into the question in the Province of British Columbia of the ever-increasing number of the inmates of our mental hospitals.

(b.) The causation and treatment of our subnormal children and mentally deficient. Their scientific and economical care.

Your Committee has found the task set them very stupendous and far-reaching.

The Committee met for organization purposes in November.

On November 27th they held a meeting with Senator Daniel Morgan, of Spokane, who is Chairman of the Committee in Washington Legislation in charge of charitable institutions.

A very profitable evening was spent, during which Senator Morgan outlined the experience and handling of the mental question in the State of Washington. He went fully into their organization in the Washington State, and outlined their methods of handling the mental cases.

A good deal of correspondence has been undertaken with the object of gathering reports and information. As a result a great deal of material has been accumulating.

Due to the short time at the disposal of the Committee your Committee feels unable to present anything in the nature of a final report on the subject, so would crave the indulgence of the House and ask permission to continue their investigations throughout the next year, and bring down a report at the next Session.

REPORT NO. 1.

LEGISLATIVE COMMITTEE ROOM, December 17th, 1925.

MR. SPEAKER:

Four meetings were held and several subjects discussed, including a proposed amendment to the "Placer-mining Act," which at this time was not recommended by your Committee.

The Bill (No. 72) now before the House respecting phosphate mines was thoroughly discussed and unanimously approved of.

Your Committee unanimously passed and recommends same to the consideration of the House the following resolution :---

Whereas in the development of the mineral areas of the Province it is essential that every effort be made to provide adequate transportation facilities to encourage those engaged in the development of this great basic industry to carry on their operations:

And whereas the "Mines Development Act" has provided the financial means by which much valuable assistance has been rendered to those engaged in developing and operating mineral properties throughout British Columbia:

And whereas the provision of more generous funds would permit the granting of a still greater measure of assistance and encouragement to the prospectors and operators and others to whom so much of this Province's progress is due:

And whereas it is desirable that the main trails to the principal mining camps and prospects be kept open and provision be made for new roads and trails to the many promising mineral areas to which attention is now being paid:

And whereas the system of administration as carried on under the provisions of the "Mineral Survey and Development Act" has proved of undoubted value in aiding mineral development and permitting adequate supervision over mining operations in the Province as well as affording protection to the investing public; a system which should receive full measure of support from the Legislature:

Therefore be it Resolved, That this Committee, impressed with the great importance of the development of the mineral areas of the Province, and fully recognizing the duty of the Government to in every possible and reasonable manner assist in such development, recommends an increased appropriation to the Department of Mines under the "Mines Development Act" and under the "Mineral Survey and Development Act."

All of which is respectfully submitted.

The report was received.

LEGISLATIVE COMMITTEE ROOM, December 11th, 1925.

MR. SPEAKER:

Your Select Standing Committee on Private Bills and Standing Orders begs leave to report as follows :---

That the penalty fee of \$300 paid under Rule 72 by the promoters of the undermentioned Bill be refunded.

Mr. Speaker delivered his reserved decision on the point of order raised by Mr. *Twigg* on the 18th instant on the second reading of Bill (No. 74) initialed "An Act respecting a Minimum Wage for Employees in the Lumbering Industry," as follows:—

"On second reading of Bill No. 74, the Honourable Third Member for Victoria objected to the Bill being proceeded with on the ground that certain provisions of the Bill required the expenditure of public moneys and that the consent of the Crown had not been given thereto.

"I do not think the point of order is properly taken at this stage of the proceedings. At pages 144 and 145 of Speakers' Decisions there is a case very much in point. Mr. Speaker Mara ruled that when it becomes incidentally necessary to authorize the application of money to a particular purpose the Bill may be introduced upon motion. Further on in the same decision he also says: 'Although the Bill is in order and can be read a second time, I think clause 2 ought not to be considered as part of the Bill until it has been reported upon by a preliminary Committee.' This decision shows clearly that the Bill may be read a second time.

"Bourinot at page 413 says: 'The consent may be given at any stage before final passage.' Further on page 414 he says: 'The consent should be properly given before the committal of the Bill, but according to the practice of the English House, it is not generally given before the third reading. A Bill may be permitted to proceed to the very last stage without receiving the Royal consent.'

"*May*, 13th edition, page 599, says: 'The mode of communicating the recommendation and consent is the same, but the former is given at the very commencement of a proceeding and must precede all grants of money, while the latter may be given at any time during the progress of a Bill in which the consent of the Crown is required.'

"I therefore rule that the motion for the second reading of the Bill is in order, but that consent of the Crown must be obtained before its final passage through the House."

The House resumed the adjourned debate on the second reading of the said Bill.

The Hon. Dr. Sutherland replied as follows :---

Mr. Lister asked the Hon. the Minister of Finance the following questions:-

1. Has W. H. MacInnes, the present Civil Service Commissioner, been assessed on account of taxes other than income-tax?

The Hon. Dr. MacLean replied as follows :---

"1. Other than penalty of \$39.12 paid in respect of arrears, the Department is not aware of any taxes other than income tax assessed against W. H. MacInnes.

"2, 3, 4, 5, and 6. Answered by No. 1."

Mr. I. A. Mackenzie asked the Hon. the Minister of Education the following questions :---

1. For what purposes other than teaching are the different departments in the Faculty of Agriculture of the University of British Columbia operated?

2. Have the breeding and improvement methods used by the University in the Department of Poultry been adopted to any considerable extent in the Province?

3. Has the Department of Dairying of the Faculty of Agriculture conducted experiments in the making of cheese? If yes, with what success?

4. Are the grains and roots produced by the Department of Agronomy of a distinctly superior quality?

5. What other special studies or experiments have been taken up by the Faculty of Agriculture?

6. What has been the total registration in the four-year course in the Faculty of Agriculture of all years since its establishment?

7. How many students have taken Courses in Agriculture other than the four-year course?

The Hon. Dr. MacLean replied as follows :--

"1. The five departments in the Faculty of Agriculture are operated as teaching, experimental, and research departments. The returns from them are expressed in experimental results of value to the Province rather than as cash revenue to the University. The Farm Department is operated for the production of roots and silage and some other crops for the Animal Husbandry and Poultry Departments. This department is not experimental. The product is given to the experimental departments. The sale of the by-products from the five experimental departments has amounted to \$73,036.21 cash revenue to the University.

"2. The breeding and improvement methods used by the University in the Department of Poultry have been adopted by 90 per cent. of the Record of Performance breeders of the Province. The average flock production outside of R.O.P. is 134. The average flock production in R.O.P. is about 176, an increase of 3½ dozen per bird. This is good breeding stock, but at 35 cents a dozen the increased value to R.O.P. breeders alone would be \$183,850 per annum. Applied to the whole Province this would represent \$1,500,000 annually. This is a direct result of experimental work. While the average production is as stated above, the University production is: For Rhode Island Reds, 200; for Barred Rocks, 205; and for Leghorns, 235.

"3. The Department of Dairying has perfected two types of cheese and established them on the market. The Kingston represents a high quality for sale in competition with high-priced imported products. The Camosun represents a simpler type that sells in competition with Canadian Cheddar. The latter can be made by any competent individual with simple home equipment and provides **a** cash product that finds ready sale. This work is just at the point now where it is being considered as an extensive commercial venture.

"4. The Department of Agronomy has produced grains and roots that show increases from 10 to 23 per cent. over and above commercial varieties. On a basis of 5 per cent. increase only, and used to the same extent that Ontario farmers use Ontario Agricultural College strains, the increased value would represent almost \$500,000 per annum.

"5. A careful study has been made of more than 500 sample farms in British Columbia the problems of farm organization, the problems of low unit cost, the factors of success or failure —and preliminary reports have been published, the editions of which are almost exhausted. More complete reports are in process of preparation. Although almost \$5,000 has been spent for manures and fertilizers over a period of ten years, not a dollar's worth of this expenditure has been used on the farm. It has been used for experimental purposes only. The results of chemical fertilizer tests are now in course of preparation, and it is estimated that, if followed, what is now a loss of approximately \$75,000 a year from their injudicious use might be turned into an annual profit of \$55,000. Some work has yet to be done and some further expenditures made before the bottom of the fertilizer problem is reached.

On the motion of Mr. Stoddart, seconded by Mr. Perry, it was Resolved,-

Whereas it is proposed to change the name of the old Cariboo Road to Fraser Canyon Highway:

And whereas the name for this old road was derived from the discovery of gold on Williams Creek as far back as the year 1857, and the miners, merchants, and also pioneer settlers paid a large amount of tolls towards the building of this road, which was first partly destroyed by the construction of the Canadian Pacific Railway between Yale and Spuzzum, also between Lytton and Spences Bridge, and at a later date the road was destroyed between Lytton and Spuzzum by the construction of the Canadian Northern Railway:

Therefore be it Resolved, That in respect to the old pioneers of this Province and our native sons especially of Cariboo, and in the interest of the history of British Columbia, this old historic road shall continue to be known as the Cariboo Road.

The Resolution was carried unanimously.

Mr. Colley asked the Hon. the Attorney-General the following questions :--

1. At what figure does the Department of Labour estimate the number of Chinese, Japanese, and Hindus employed in British Columbia industry in the first six months of 1925; in 1924, in 1923, in 1922, in 1921, in 1920, in 1919, in 1918, in 1917, in 1916, in 1915, in 1914, in 1913, in 1912, in 1911, in 1910, in 1909, in 1908, in 1907, in 1906, in 1905, in 1904, in 1903, in 1902, in 1901, and in 1900?

2. How many Chinese were employed in sawmills, in shingle-mills, in mines, in fishing, in agriculture, and in other industries in the first six months of 1925; in 1924, in 1923, in 1922, in 1921, in 1920, in 1910, and in 1900?

3. How many Japanese were employed in sawmills, in shingle-mills, in mines, in fishing, in agriculture, and in other industries in the same years?

4. How many Hindus were employed in sawmills, in shingle-mills, in mines, in fishing, in agriculture, and in other industries in the same years?

5. Has the Legislature made representations to the Federal Government in favour of a reduction in Oriental immigration into Canada? If so, what representations have been made? Have these representations produced any result? Has the Federal Government inaugurated more rigorous immigration regulations in regard to Japanese, Chinese, or Hindus? What effect has been produced by such regulations in regard to Japanese, Chinese, and Hindus?

The Hon. Mr. Manson replied as follows :---

"5. By resolution dated December 17th, 1924, it was unanimously resolved by the Legislative Assembly of the Province of British Columbia that it go on record as being utterly opposed to the further influx of Orientals into this Province; that the field of industrial and commercial activities of all Orientals now in British Columbia should be restricted by legislation; and that the 'Immigration Act' be amended to completely prohibit Asiatic immigration into Canada. Resolutions dealing with this subject were also approved by the Legislative Assembly of British Columbia on November 1st, 1921, and November 20th, 1922.

"Note.—No statistics are available in respect to years prior to 1918. It is understood that the Federal Government has inaugurated more rigorous immigration regulations in regard to Orientals, but it is not known as yet what effect such regulations have produced."

Mr. Twigg asked the Hon. the Attorney-General the following questions :---

1. Did the Vancouver police endorse the application of John Correlli, of Vancouver, for a beer licence?

2. If they did not endorse the application, did they approve of it?

3. What was the date of his application?

4. What were the premises on which he proposed to carry on business?

5. Was the application refused?

6. If so, why?

The Hon. Mr. Manson replied as follows :--

"2. Inspectors G. W. Sutherland and C. F. Tuley in their private capacity endorsed the application.

"3. March 17th, 1925.

"4. Klondike Hotel, 218 Carrall Street, Vancouver, B.C.

"5. Yes.

"6. The conditions and accommodations requisite for a beer licence in respect of the premises sought to be licensed were not deemed adequate."

Resolved, That the House, at its rising, do stand adjourned until 9 o'clock p.m. to-day.

Section 2, line 11: To strike out the words "to whom this Act applies," and insert in lieu thereof the words "in the lumbering industry, or of any employee in the coal-mining industry."

Section 3, line 2: To strike out the words "occupations to which this Act applies," and insert in lieu thereof the words "branches of the lumber industry and to employees in the coal-mining industry in this Province."

Section 8, line 1: To insert after the word "Employer" the words "engaged in the lumbering industry and in the coal-mining industry."

His Honour was pleased, in His Majesty's name, to give assent to the said Bills.

The said assent was announced by the Clerk of the House in the following words :----

"In His Majesty's name, His Honour the Lieutenant-Governor doth assent to these Bills."

Then the Honourable Mr. Speaker addressed His Honour the Lieutenant-Governor as follows :---

MAY IT PLEASE YOUR HONOUR:

We, His Majesty's most dutiful and loyal subjects, the Legislative Assembly of the Province of British Columbia, in Session assembled, approach Your Honour at the close of our labours with sentiments of unfeigned devotion and loyalty to His Majesty's person and Government, and humbly beg to present for Your Honour's acceptance Bill (No. 84) initial "An Act for granting certain Sums of Money for the Public Service of the Province of British Columbia."

To this Bill the Clerk of the Legislative Assembly, by His Honour's command, did thereupon say:—

"In His Majesty's name, His Honour the Lieutenant-Governor doth thank His Majesty's loyal subjects, accept their benevolence, and assent to this Bill."

Then His Honour the Lieutenant-Governor was pleased to deliver the following gracious Speech:--

Mr. Speaker and Members of the Legislative Assembly:

I wish to express my appreciation of the careful consideration you have given to the many important subjects which have been placed before you.

The amendments you have enacted to the School, Hospital, and Municipal Acts should all tend towards better living conditions, and therefore to a higher standard of human efficiency throughout the Province.

The Town Planning Bill is designed to encourage a more scientific and better-adjusted system governing the erection of buildings in populous centres, and should be the means of imparting an added attractiveness to our growing cities.

The Bill to amend and consolidate the legislation relating to Insurance is intended to secure greater uniformity and more harmonious operation of these laws, which are thus brought into conformity with those of the other Provinces of Canada.

By providing a ready means of arbitration in differences between employers and employees, the Bill relating to the Investigation of Industrial Disputes within the Province should make for the stabilization of our industrial undertakings.

The amendments to the "Workmen's Compensation Act" will be welcomed by the workers of this Province as providing greater security both to the wage-earner and to those dependent on his labours.

The reduction in taxes on income and personal property, contained in the amendments to the "Taxation Act," will afford a welcome relief to many of the taxpayers of the Province.

The legislation providing for the construction of the University buildings should prove beneficial to the Province in the furtherance of higher education. The land grant in aid of the Pacific Great Eastern Railway will, I trust, be of material assistance in the solution of this important problem.

I thank you for the Supplies so generously granted for the Public Service, and in relieving you from your legislative duties I trust that the results of your labours will be seen and blessed in the continued progress and prosperity of the Province.

The Hon, Mr. Sloan, Provincial Secretary, then said :---

Mr. Speaker and Members of the Legislative Assembly:

It is His Honour the Lieutenant-Governor's will and pleasure that the Legislative Assembly be prorogued until it shall please His Honour to summon the same for dispatch of business, and this Provincial Legislative Assembly is hereby prorogued accordingly.
