Prayers by the Rev. Dr. Campbell, Ph.D.

Mr. Speaker Manson gave his reserved ruling on the point of order raised on 23rd instant on leave being asked by Mr. I. A. Mackenzie to introduce a Bill intituled "An Act to regulate the Practice of Optometry," as follows:—

"The Honourable Member for Kamloops yesterday raised a point of order as to leave being granted the Honourable the Second Member for Vancouver City to introduce a Bill intituled 'An Act to regulate the Practice of Optometry.'

"I have since had the opportunity of perusing the proposed Bill and the authorities. The practice in this Province has not been strict. The proposed Bill does not appear to be 'for the particular interest or benefit of any person or persons,' but may fairly be said to be one dealing with the interests of the public.

"In this connection, it is interesting to note that in 1910, on the second reading of the 'Society of Apothecaries of London Bill,' which had been introduced as a Private Bill, the Speaker of the House of Commons drew attention to the fact that the Bill sought to empower the Society to grant diplomas in sanitary science and public health and for dentistry and dental surgery, and ruled that it should proceed as a Public Bill, as it dealt with public interests.

"In this Province, the 'Legal Professions Act,' the 'Medical Act,' the 'Dental Act,' and the 'Pharmaceutical Act,' were held by the Speaker of this Legislature to be Public Bills when introduced.

"My ruling therefore is that the proposed Bill may properly be introduced as a public measure, and the honourable gentleman may now again move for leave to so introduce it."

On the motion of Mr. I. A. Mackenzie, Bill (No. 17) intituled "An Act to regulate the Practice of Optometry" was introduced, read a first time, and Ordered to be read a second time at the next sitting.

On the motion of Mr. Whiteside, the Rules were suspended, and the Third Report of the Public Bills Committee, presented on the 23rd instant, was adopted.

The Hon, the Attorney-General raised a point of order that the proposed question involved a request for a declaration of policy by the Government.

Mr. Speaker Manson ruled as follows:-

Member for Rossland does not involve in its answer a declaration of policy on the part of the Government, and that it is fairly in order that the Hon. Member seek information from Ministers of the Crown as to whether or not the Government propose opening up a Statute for amendment during the Session."

- "6. No information.
- "7. No information."

Mr. Pooley asked the Hon. the Attorney-General the following questions:-

- 1. What quantity of liquor has been seized by the Provincial and municipal authorities under the provisions of the "Prohibition Act"?
 - 2. What was the nature of the liquor seized in each case?
 - 3. What was the quantity seized in each case?
 - 4. What became of this liquor?
 - 5. Was any of it sold? If so, how much? For what sum?
 - 6. Have all of these amounts been sent in to the Treasury?
 - 7. Was any of the said seized liquor shipped to any of the Government Vendors' stores?
- 8. If so, how much in each case and to which Vendor's store was same shipped, and the dates of each shipment?

The Hon, Mr. Farris replied as follows:-

- "1. (See Return presented to the House of liquor confiscated to the Crown and reported to the Prohibition Commissioner by the Provincial Police.)

Mr. Bourser asked the Hon, the Attorney-General the following questions:

The Hon. Mr. Farris replied as follows:-

Mr. Esting asked the Hon. the Attorney-General the following questions:-

- 1. Has James H. McVety been appointed as General Superintendent of Provincial Government Employment Service?
 - 2. If so, when, and at what salary?
 - 3. What is the age of said McVety?
 - 4. Is said McVety a returned soldier?
 - 5. If not, why was a returned soldier not appointed?
 - 6. Why was some one in the present service not appointed?
 - 7. Was this position formerly held by Colonel Bruce Powley?
 - S. Why is said Powley not still in charge of said work?

The Hon. Mr. Farris replied as follows:-

The Hon. Mr. Stoan replied as follows:-

(Question No. 4 was ruled out of order by Mr. Speaker.)

Mr. Hinchliffe asked the Hon. the Provincial Secretary the following questions:—

The Hon. Dr. MacLean replied as follows:-

The Hon. Mr. Pattullo replied as follows:-

 - 3. Who was the contractor?
 - 4. What was the total commission paid to contractor?
 - 5. What length of time was required to complete this work?
 - 6. What was the total mileage of new road constructed?
 - 7. What was the total cost of new road?

The Hon. Dr. King replied as follows:-

- " 1. Yes.
- "2. By contract on cost plus basis and day-labour.
- "3. A. W. Davis.
- " 4. \$9.354.37.
- "5. Seven months.
- "6. Six miles and a half.
- "7. \$141,937.69. This includes \$8,971.36 for plant and equipment now being used on the Rossland-Christina Lake section of Trans-Provincial Road and later on other works elsewhere."

The Hon. Mr. Hart replied as follows:--

- "3. Victoria, \$50,000; City of Salmon Arm, \$8,000; District Municipality of Salmon Arm, \$10,000; Municipality of Point Grey, \$100,000; New Westminster, \$15.67; District Municipality of South Vancouver, \$30,375.42.
 - "4. Answered by No. 3.
- "5. Victoria, \$50,000; City of Salmon Arm, \$8,000; District Municipality of Salmon Arm, \$10,000; District of South Vancouver, \$30,375.42; New Westminster, \$15.67. \$375.42 to Municipality of South Vancouver and \$15.67 to New Westminster were direct contributions.
- "6. Loans are to be repaid in five equal annual instalments, with interest at 6 per cent., payable half-yearly."
 - Mr. Pooley asked the Hon. the Attorney-General the following questions:-
- 1. Was Provincial Constable Mortimor, of Cumberland, dismissed from the service of the Government in the month of January or February, 1921?
 - 2. If yes, for what reason?
 - 3. Was an inquiry made by Chief Constable Stevenson into the conduct of said Mortimor?
- 4. Was the said Mortimor charged with accepting money from Mr. Doyle, in the nature of a fine for having liquor in his possession?
 - 5. Was said charge proved?
- 6. Was said Mortimor charged with selling firearms and opium to one Sam Lee, a Chinaman, at Cumberland?
 - 7. Was evidence to this effect given under oath by said Sam Lee?
 - 8. Did the Hon, the Attorney-General personally inquire into the above-mentioned charges?
 - 9. Is said Mortimor now in the Government employ?
 - 10. If so, in what capacity and when was he so appointed?
 - 11. On whose recommendation was said Mortimor appointed?
- 12. Have any other charges been made against the said Mortimor in connection with his conduct as a police officer?
 - 13. Were such charges investigated?
 - 14. If yes, who made the investigation?
 - 15. If yes, what was the decision arrived at?

The Hon. Mr. Farris replied as follows:-

- "1. His services were dispensed with on January 26th, 1921,
- "2. For indiscretions, which, after investigation, and in view of his previous military and police record, did not warrant his dismissal. His record is as follows: Joined the Lovat's Scouts, Black Watch, Scotland, 1900. Served South African War, February, 1900, until peace signed, June, 1902. Appointed a Lieutenant in Herschel Native Police, February, 1902. Retired on disbandment of Regiment, 1902. Joined South African Constabulary, July, 1902; from there transferred to Transvaal City Police, Johannesburg, December, 1902. Served until April, 1904, when appointed detective. In 1906 obtained special leave and served six months in the Zulu Rebellion in Natal. Returned to Johannesburg Police, and through fever resigned appointment in April, 1908. Came to Canada in November, 1908, and joined Dominion Police under Colonel Sir Percy Sherwood, 1908. Served in Police until April, 1909, being transferred to Dominion Transcontinental Railway Police, under Colonel Gordon Grant, and served under him until August, 1915, when resigned appointment to serve overseas. Enlisted in August, 1915, in 77th

Battalion, C.E.F. Served in 77th as Provost-Sergeant until promoted Lieutenant, and was in 77th until Regiment disbauded in spring, 1916. Joined the 47th Battalion in April, 1916, and served with them until after the Battle of the Somme, when received Staff appointment in France and served continuously in France until the Armistice, and thereafter in the Army of Occupation. Promoted Captain, 1917. Mentioned in dispatches. Awarded the Croix de Guerre. Has had continuous military and police service with British Government and in Colonies for twenty-one years. Was stationed at Cumberland, B.C., from October 19th, 1919, to January 26th, 1921, during which time he prosecuted and obtained convictions in 198 cases for infractions of various Provincial and Dominion Statutes, and which convictions realized in fines \$5,806. During the twenty months immediately prior to October 19th, 1919, the two Provincial officers stationed at Cumberland prosecuted and obtained 141 convictions, realizing \$2,377.

- "3. Yes.
- "4. Yes; by Tully Boyce, Union Bay, B.C., in a newspaper article signed by him.
- "5. No. Under instructions from Stipendiary Magistrate Baird, of Cumberland, B.C., Constable Mortimer on November 9th, 1920, accepted \$50 for bail, conditioned on the appearance of James Doyle before the Stipendiary Magistrate at Cumberland next morning at 11 a.m. to answer to a charge of unlawfully having liquor in his possession in a place other than a dwelling-house. On November 10th, 1920, after the Magistrate's Court was opened, the accused was called and did not appear, and the Magistrate ordered the bail of \$50 estreated, and the said sum of \$50 was paid by Constable Mortimer to the Magistrate, and an official receipt was issued therefor. The liquor in question taken from Doyle by the Constable was produced in Court on November 11th, 1920, and is now in the Police Office at Cumberland.
- "6. No. One Lee Sam made an affidavit on January 17th, 1921, stating, inter alia, that Mortimer sold him a Mauser pistol and ammunition for \$60, and that Mortimer obtained the said pistol from a returned soldier. The said Lee Sam further stated that Mortimer sold a Luger pistol to one Sin Que, delivering the same to the said Lee Sam, who gave it to the said Sin Que. The Constable states that on August 1st, 1920, he sold the said Lee Sam a Mauser pistol (a German war trophy), the property of one J. Irish, a returned soldier, and that a permit under the Criminal Code, in duplicate, was duly issued by Stipendiary Magistrate Baird, and an entry duly made in the Police records of the said sale. The Constable further states that, on or about December 23rd last, he was informed by one Greig, a returned soldier, that he, the said Greig, had a Luger pistol (German war trophy) for sale, and requested the Constable to sell same for him, which said pistol was sold by the Constable to Lee Sam, and a permit was duly issued to the said Lee Sam by Stipendiary Magistrate Baird, and entry duly made in the Police records of said sale. No charge was ever made against Constable Mortimer of selling opium to any one.
- "7. Answered in part by No. 6. Lee Sam made no allegation, under oath or otherwise, that Constable Mortimer sold opium to him or to any one else.
- "8. Personal representations were made to the Attorney-General on behalf of Mortimer. He referred the same to the Superintendent of Provincial Police, who dealt with him on his own authority.
 - " 9. Yes.
 - "10. Provincial Constable; February 1st, 1921.
 - "11. Attorney-General.
- "12. Yes. On or about September 30th, 1920, one Lock Twen Han, of Cumberland, B.C., a Chinese, complained that Constable Mortimer had searched his premises on September 29th, 1920, at night, without a search warrant.
 - "13. Yes.
 - "14. Chief Constable Stevenson.
- "15. The Chief Constable reported that Constable Mortimer had made a most emphatic denial to the allegations made by the Chinese in question; that on September 29th, 1920, in consequence of information received respecting the illegal sale of liquor, he applied for and obtained a search warrant from the Stipendiary Magistrate, and proceeded to the Chinese quarters in Cumberland and there conducted a search, without finding liquor, and that the search by the officer was conducted in an orderly manner, and that no ground of complaint existed against the Constable for his actions."

Mr. Esling asked the Hon. the Attorney-General the following questions:-

- 1. How much liquor was confiscated in Rossland during 1920?
- 2. What was the value of same?
- 3. Has this been forwarded to the Prohibition Commissioner or has it been returned to the original owners?
 - 4. If to the latter, for what reason?

The Hon. Mr. Farris replied as follows:-

- "1. Am unaware; but according to reports received by the Prohibition Commissioner from the Chief Constable at Rossland, the following liquor was confiscated to the Crown in the City of Rossland during 1920: 87 bottles Scotch whisky; 1 bottle brandy; 1% gallons rye whisky; 1 part bottle rye whisky; 9 bottles gin.
 - "2. \$300 approximately.
- "3. Forty-two bottles Scotch and rye whisky, brandy and gin, and three-quarters of a gallon of rye whisky were on December 6th, 1920, sent by the Chief Constable, Rossland, to the Vancouver Liquor Warehouse, and received there on December 9th, 1920. The balance of the liquor confiscated should be in the possession of the Rossland authorities, and has since December 13th last been the subject-matter of correspondence between the Rossland authorities and this Department.
 - "4. Answered by No. 3."

Mr. Bowser asked the Hon. the Minister of Mines the following questions:-

- 1. Has the Government entered into an agreement with the Coast Ranges Steel, Ltd.?
- 2. If so, what are the particulars of said agreement?
- 3. Who are the parties active in the promotion of said company?
- 4. Did this company pay the regular fees in connection with its incorporation to the Registrar of Companies?
 - 5. If not, what amount was paid, and on whose authority, and the reasons for same?

The Hon, Mr. Sloan replied as follows:-

- "1. Yes
- "2. Draft copy of Agreement attached.
- "3. F. T. Congdon, K.C., J. D. Kearns, Montague More, John Steta, and H. J. Landahl.
- " 4 No
- "5. \$50; under and by virtue of the authority vested in the Lieutenant-Governor in Council by the 'Companies Act.' For the purpose of assisting and encouraging the establishment of a steel industry in British Columbia."

DRAFT COPY OF AGREEMENT.

This Agreement, made this day of November, in the year of our Lord one thousand nine hundred and twenty,

Between

HIS MAJESTY THE KING in right of his Province of British Columbia, herein represented and acting by the Honourable William Sloan, Minister of Mines for the Province of British Columbia, of the first part;

and

COAST RANGE STEEL, LIMITED, a body corporate, duly incorporated under the laws of the said Province, of the second part.

Whereas the Party of the Second Part has been incorporated for the objects set forth in its memorandum of association, and particularly for the principal and real objects therein set forth, that is to say, to produce, acquire, and procure all the materials, power, plant, properties, buildings, and other things required in the manufacture and production of iron and steel, and to manufacture and produce pig-iron and steel within the said Province, and to use the same in manufacture, and to sell and dispose of the same and of the manufactured products of the same; all the other objects, whether strictly objects or in the nature of powers, in the said memorandum set forth being, until such principal and real objects are accomplished, ancillary and subsidiary to such principal and real objects and not primary objects of the Company:

And whereas it has been made to appear to His Majesty, represented as aforesaid, that British capitalists of ample means and ability are presently ready to invest the necessary moneys, not exceeding ten million pounds, by means of the said Company, in the establishment and conduct of iron and steel industries in the said Province, upon the execution of this Agreement, and upon receipt of the report of engineers now engaged within the Province upon investigating its iron and other resources, that conditions are suitable for the establishment and conduct of such industries:

And whereas it is of vital importance to the growth and prosperity of manufacturing and other industries in this Province that such iron and steel industries should be established with the view of placing upon the markets iron and steel and their products at as low prices as the same are sold from time to time in the Eastern markets of Canada:

Now, this Agreement witnesseth that, in consideration of the premises, His Majesty, represented as aforesaid, doth hereby covenant and agree with the Party of the Second Part that the said Province will pay to the Party of the Second Part bounties on pig-iron manufactured by the Party of the Second Part within the said Province in accordance with the provisions of the "Iron Bounties Act," being chapter 11 of the Acts of 1918, as amended by the "Iron Bounties Act Amendment Act," being chapter 10 of the Acts of 1920, that is to say:—

- (a.) In respect of pig-iron manufactured from ore on the proportion produced from ore mined in the Province, a bounty not to exceed three dollars per ton of two thousand pounds:
- (b.) In respect of pig-iron manufactured from ore on the proportion produced from ore mined outside the Province, a bounty not to exceed one dollar and fifty cents per ton of two thousand pounds:

Provided always that the construction and equipment plans of blast-furnaces for the manufacture of pig-iron and steel shall be submitted to the Lieutenant-Governor in Council, and approved on or before the first of July, 1921.

In witness whereof, and in pursuance of the Order in Council duly passed in that behalf approving of the foregoing Agreement, and directing the execution thereof by the Honourable William Sloan, Minister of Mines for the Province of British Columbia aforesaid, the said the Honourable William Sloan has hereunto set his hand and seal the day and year hereinbefore written.
