MR. SPEAKER:

Your Select Standing Committee on Public Accounts begs leave to report as follows:— Your Committee had under review the affairs of the Department of Industries for the calendar year 1928.

While our Commission authorizes only the examination of accounts to March 31st, 1928, the Department of Industries finds it more convenient to present their accounts for the calendar year, so they were reviewed as presented.

The results of the year's operations show there has been:--

Making a total reduction in assets for the year of\$81,597.93

Accounts still carried on the books of the Department number forty-three.

During the last year a few have paid the Department in full and have been released. In other cases the loan has been amortized, and now requires no attention other than to see that payments are met promptly. In a number of cases, however, the loans are in bad shape and the Department will suffer losses.

The original condition, which the creation of the Department was supposed to rectify, does not now exist. While most of the loans were made to returned soldiers, the control has now, for the most part, passed out of their hands, and the employment conditions are the same as in all branches of industry throughout the Province, and the returned soldier, as such, is not now a major factor in the operation.

We are of the opinion that the necessity for the continuance of the Department no longer exists, and we think that the Province might save money were the assets administered by the regular staff of the Finance Department, who could, with the technical advice of the Public Works Department, handle them satisfactorily, and with very little expense.

Your Select Standing Committee on Public Accounts begs leave to report as follows:-

The Medical Health Officer appeared before the Committee and explained the work of his Department.

He stressed very strongly the question of sickness-prevention, and he gave the Committee to understand that if this work were extended intelligently it might help to solve the hospital problem, which is now growing so acute in this Province. He impressed the Committee to such an extent that we feel justified in recommending to the Government that this matter be given very special consideration, and that when an inquiry is made into hospital matters generally, the question of sickness-prevention be one of the principal questions considered.

Land Settlement Board.—The Land Settlement Board officials appeared before the Committee. It was ascertained that the policy of the Board now was to make no new loans, and that the business consisted in collecting and administering solely. It was the opinion of the Committee that, now that the Dominion Government has authorized the loaning of money to farmers in this Province, the operations of the Land Settlement Board should be curtailed and these loans cleaned up as soon as possible.

Public Works Department.—The officials of the Public Works Department appeared before the Committee and the work of the Department of the Supervising Architect was inquired into. It was found that, while the office of Supervising Architect was originally for the purpose of looking after repairs to existing buildings only, and the salary was apparently fixed on that understanding, the work of the Department and the scope of its operations had been very much enlarged. The Committee were informed that now this Department designs all of the new buildings for the Province, the last two units at Essondale being mentioned.

It was felt by your Committee that, in view of the above facts, the salary of the Supervising Architect was entirely inadequate, and this Committee recommend to the House that a substantial increase be made. It was the opinion of the Committee that, generally speaking, throughout the Service the salaries of technical men were too low.

The work of the Boiler Inspection Department was reviewed and the form of accounts was questioned. The Public Accounts showed a total expenditure by this Department of \$7,717.71, whereas in reality it was \$52,428.38. It was the opinion of the Committee that the form of accounts should be changed, and the Chief Accountant of the Public Works Department informed the Committee that the Minister had already taken steps in this direction.

The tolls on the Cariboo Road were considered, and it was found that the-

Total receipts for the year under review were \$9,199.70
The actual expense of collection was 1,906.78

It was questioned whether these small returns were worth the effort, and the suggestion was made that it be a tax which would yield a substantial revenue, or that it should be a free road. Mention was made of the tax levied in the States on bridges, etc., showing that the tax idea is not a new one and tourists were accustomed to pay. No recommendation was suggested by the Committee, however, it being the opinion that for the time being matters should stand as they are.

MR. SPEAKER:

Your Select Standing Committee on Public Accounts begs leave to report as follows:—
The affairs of the Workmen's Compensation Board were under review, and Mr. E. S. H.
Winn, Chairman of the Board, appeared before the Committee.

Minor matters, about which there had been complaint, were put before Mr. Winn by the members of the Committee.

The question of the name of the fund which had been accumulated by the Board was discussed. It was felt that the title "Reserve Fund" was a misnomer and gave a wrong impression. The name leads the public to believe the fund is a general one accumulated for

no special purpose, and one which the Board has on hand as an emergency fund. The fund, in reality, is created to meet the obligations incurred by the Board through awards to workmen, but which obligations are for future payment. When a person is injured or has a claim, his case is established on an actuarial basis, and this fund provides the means of meeting his claim during the time that claim exists, whether for a period certain or for the term of the life of the recipient. In other words, it is a pension fund. It was felt that, at the earliest possible moment, the name should be changed to "Pension Fund" or some other suitable name.

Fairview Works.—For some years the Government has been paying fire insurance on the Fairview Works, the premiums amounting to \$600 or \$700 per year. It was the opinion of the Committee that the principal sum which the premium represents could not be collected in case of a loss, as the plant is of only scrap value, and the Government were wasting money in continuing this payment.

Officials of the Public Works Department were interrogated regarding the practice of awarding tenders to other than the lowest bidder in cases where the lowest bidder had complied with all the terms of the tender. It was felt that, were not the lowest legitimate tenderer awarded the contract, the result would be that the very purpose for which the tenders were called would be nullified, and that the Department might be accused of rejecting tenders so that some favoured individuals might get the contract. MR. SPEAKER:

Your Select Standing Committee on Public Accounts begs leave to report as follows:-

The Deputy Provincial Secretary was called and explained Votes Nos. 177 and 178, being grants to the City of Greenwood and the City of Rossland of \$1,000 and \$12,000 specifically. Apart from the fact that these grants have been running for a number of years, no justification for their continuance was suggested to the Committee. It is recommended that these grants be inquired into, and if no real justification for same exists, that they be discontinued.

Provincial Librarian.—The Provincial Librarian came before the Committee, and it was felt that no time should be lost in having this official pay a visit to the outlying portions of the Province, and especially to the historic Cariboo country, there to gather material for the Provincial Archives. It was felt that any delay would make it harder to get this information, and your Committee were pleased to learn that a substantial grant was in the Estimates this year for this purpose.

The Officer in Charge of Correspondence Courses appeared before the Committee and detailed the work of his Department. Questioning brought out the fact that about 350 children were taking this course and that the results showed that this method of teaching was a success, and a rough calculation showed that the cost was \$15 per pupil per year, as against the sum of \$70 per pupil for the ordinary school course. The work is done by the Superintendent and two others who are classed as "stenographers." These persons, however, have teachers' certificates (one a first and one a second class), and the Committee thought that the work these two people were doing entitled them to a better classification than "stenographer"; as a matter of fact, to the classification of "teacher" and remuneration commensurate with the work they are doing.

Your Committee inquired into the cost of operation and actual wages paid on the bridge across the Fraser River at New Westminster. The Committee were told that the actual annual wages paid for maintenance were roughly \$15,000, which, under the circumstances, was not considered excessive.

The work of your Committee has been very much hampered during the Session by failure to obtain a quorum, or, if a quorum were obtained, to retain it during the sitting. It is felt by the Committee that very much greater efficiency could be had were the numbers on the Committee reduced. Your Committee would suggest that, besides a reduction in numbers, the House name this particular Committee, so that its members are not members of any Standing Committee of the House. This, we believe would concentrate their work and allow the Committee to function to very much greater advantage.

On the second reading of Bill (No. 67) intituled "An Act to borrow the Sum of Three million Dollars for the Purposes therein specified" a debate arose, which was, on the motion of Mr. I. A. Mackenzie, adjourned to the next sitting.

On the second reading of Bill (No. 78) intituled "An Act to amend the 'Water Act'" a debate arose, which was, on the motion of Mr. *Pattullo*, adjourned to the next sitting.

Bill (No. 79) intituled "An Act to amend the 'Trust Companies Act'" was read a second time.

To be committed at the next sitting.

Bill (No. 22) intituled "An Act to amend the 'Audit Act'" was committed.

Reported complete without amendment.

Report adopted.

Bill read a third time and passed.

Bill (No. 62) intituled "An Act to amend the 'Municipal Act'" was committed.

Progress reported.

Committee to sit again at the next sitting.

Mr. Twigg presented the First Report of the Select Committee appointed by Resolution of the House on the 5th day of March, 1929, to inquire into and report upon certain appointments and expenditures under the provisions of the "Government Liquor Act," as follows:—

REPORT No. 1.

LEGISLATIVE COMMITTEE ROOM,

March 14th, 1929.

MR. SPEAKER:

The Select Committee appointed under the Resolution of the House on the 5th day of March, 1929, to investigate certain appointments of Inspectors under the provisions of the "Government Liquor Act," and more particularly as to the propriety of such appointments, the manner in which such appointees were remunerated, the nature of their services, and the propriety of any expenditures of public moneys in that behalf, begs leave to report as follows:—

Your Committee held three sittings to take evidence, between the 8th and 12th days of March, 1929. The evidence was given viva voce on oath and was taken down by a stenographer; the following witnesses being examined: Andrew Blygh, a former Justice of the Peace for British Columbia; P. Walker, Deputy Provincial Secretary; Thomas Cole, Inspector of Revenue; Walter Owens, Assistant Superintendent of Provincial Police; George Miller, Inspector of Liquor Board of British Columbia; Andrew N. Mouat, Comptroller-General for the Province of British Columbia; A. M. Manson, M.L.A.

Your Committee's inquiries were directed to certain payments made to Andrew Blygh, J.P., of Vancouver, B.C., and L. A. Menendez, of Victoria, B.C.

Your Committee find that by Order in Council dated the 18th day of January, 1921, issued pursuant to section 110 of the "Government Liquor Act," Andrew Blygh was appointed an Inspector under the Liquor Board at a salary of \$165 per month. At the time Andrew Blygh was a Justice of the Peace for the Province of British Columbia and continued as such until the 29th day of January, 1929.

Section 110 of the "Government Liquor Act" enacts as follows: "If he deems it advisable for the purpose of the due enforcement of this Act, the Lieutenant-Governor in Council may appoint one or more Inspectors or prosecuting officers who under the direction of the Attorney-General shall perform such duties as he may require, and who shall be paid such salaries, fees, and expenses as the Lieutenant-Governor in Council may fix."

Pursuant to the same section and by Order in Council issued in 1922, L. A. Menendez was appointed Inspector under the Liquor Board at a salary of \$60 per month. At the time the said Menendez was Private Secretary to the then Attorney-General, the Hon. A. M. Manson, and was receiving his proper salary in that capacity. The first payment to the said Menendez as Inspector was made in the month of May, 1922, and he received this salary continuously until August, 1928, when it was discontinued.

Your Committee finds that the said Blygh and Menendez received the respective sums of \$165 and \$60 per month as such Inspectors from the dates of their respective appointments by direct cheques from the Finance Department until April, 1923, when, as shown by advance warrant dated 25th of April, 1923 (Ex. 8), Mr. Manson directed that all future cheques for these salaries were to be made payable to the Attorney-General; also after this date the warrants

show that Blygh and Menendez were referred to as Officer "A" and Officer "B" respectively. The cheques were then endorsed by Mr. A. M. Manson, as Attorney-General, and deposited in a "Special Account" in his name in a bank in Victoria; and cheques were issued on this account to pay Blygh and Menendez each month. The exact reason for the change in method of payment was not made clear to your Committee, but Mr. Manson stated that from memory he thought the change was purely a routine one. Mr. Manson became Attorney-General in January, 1922, succeeding Mr. J. W. deB. Farris, K.C., in that position.

At regular intervals the Finance Department was reimbursed for their outlays by covering payments from the Liquor Board.

Your Committee finds that the services rendered by L. A. Mendenez as Inspector were of a purely clerical character, consisting of the examination, classification, and tabulation of reports from all Secret Service operatives employed by the Law Enforcement Branch of the Liquor Board in British Columbia. This entailed a great deal of work of a responsible character and your Committee feels that the extra salary of \$60 a month was justifiable.

The services of Andrew Blygh were of a rather indefinite character and he himself appeared to have no very clear conception of his duties or as to why he received his salary of \$165 a month. In addition to this salary he received the usual fees and emoluments arising from his office of Justice of the Peace. He even suggests that the salary was paid to him by virtue of such office. His conception of his duties was summed up by himself as "not any more than the secretary to Mr. Manson at any time" (109), and he strongly objected to being termed a Secret Service agent. On the other hand, he was so described by both Mr. Miller and Mr. Manson, and yet he was not on the recognized official list of Inspectors or Secret Service men as known to the officials in control of those services.

From 1923 he made weekly reports on liquor conditions in Vancouver direct to Mr. Manson and an indefinite number of these reports contained political observations. He admitted that prior to his appointment as an Inspector in January, 1921, he was actively engaged in politics, and his interest in the political movements of the day continued, if in a somewhat less active manner, until 1923, when he stated he again for some three years took an active part.

Your Committee is of the opinion that under the circumstances disclosed by the evidence the appointment and continued employment of Andrew Blygh as a salaried official of the Liquor Board was injudicious.

Your Committee is further of the opinion that it was an error of judgment on the part of those most responsible to place and retain Andrew Blygh in a position where his activities as an Inspector under the "Liquor Act" might conflict or be inconsistent with his duties as a Justice of the Peace.

Finally, your Committee is of the opinion that it would have shown the exercise of a wise discretion if his services as an Inspector had been discontinued so soon as it was apparent that his reports as such were acquiring a political tinge.

Your Committee submits with this report a transcript of the evidence and exhibits produced.

Mr. I. A. Mackenzie moved an amendment which purported to amend the report.

The report not then being before the House, the question having been put the motion to amend was negatived.

The main motion was carried.
