Mr. Leary asked the Hon. the Minster of Lands the following questions:-

- 1. What was the lumbering production in British Columbia between 1907 and 1916?
- 2. What was the lumbering production in British Columbia between 1917 and 1926?

The Hon. Mr. Pattullo replied as follows:--

- "1. 9.936.266 M.B.M.
- "2, 13,854,774 M.B.M.
- "Note.—These figures secured from Dominion Government statistics."

Mr. Jones asked the Hon, the Minster of Finance the following questions:-

- 1. What was the total sum of money known as arrears of assessed taxes written off as "uncollectable" for each financial year ending March 31st, 1926 and 1927?
  - 2. What is the amount of arrears of assessed taxes from April 1st, 1927, to January 1st, 1928?
- 3. Was a tax sale held in financial year ending March 31st, 1927? If so, what was the cost of advertising such tax sale?
  - 4. What were the net receipts of such sale?
- 5. Has a tax sale been held since April 1st, 1927? If so, what was the cost of advertising such sale?
  - 6. What were the receipts of such sale?

The Hon, Dr. MacLean replied as follows:-

- "1. (a) Year ending March 31st, 1926, \$97,727.81; (b) year ending March 31st, 1927, \$258,874.86. Included in the above are: (1) Adjustments under 'Soldiers' Homestead Act'; (2) adjustments under 'Proportional Allotment Act'; (3) forfeiture on account of tax sale. Our irrecoverable taxes are not in excess of 5 per cent. of the annual levy.
  - "2. \$874,503.19.
  - "3. Yes: \$15,792.09.
  - "4. \$68,589.52.
  - "5. Yes: \$14.616.16.
  - "6. \$34,153,29,
- "Note.—In connection with tax sales the amount of taxes received is no indication of the amount of taxes actually paid in as a result of such sale being advertised, as many taxpayers redeem their lands when they find that a tax sale is imminent."

Mr. Bruhn asked the Hon. the Minister of Public Works the following questions:-

- 1. Have surveys been made for the proposed highway connecting Golden and Revelstoke?
- 2. If so, what were the costs of same and of incidental engineering, and what is the estimated cost of such road?
- 3. Is it the intention of the Government to undertake construction of this road; and, if so, when?
  - 4. Had any offer been made by the Dominion Government to aid in said construction?
  - 5. If no, has any request been made to the Dominion Government for aid?

The Hon, Dr. Sutherland replied as follows:-

- "1. Yes; preliminary reconnaissance survey made.
- "2. Survey and incidental engineering costs, \$1,038. Estimate based on final location not yet made.
  - "3. Yes; this season.
- "4 and 5. This matter taken up with Dominion Government and it is expected that latter will aid to extent of building section through Glacier Park."

Mr. Wallinger asked the Hon. the Minister of Public Works the following questions:—

- 1. What amount of money was appropriated for the Kimberley District for road-work last year?
  - 2. On what roads was this money expended?

The Hon. Dr. Sutherland replied as follows:-

"We cannot answer these questions without having the boundaries of 'Kimberley District' defined."

Mr. Pooley asked the Hon. the Minister of Public Works the following questions:—

- 1. Has the road connecting Hardy Bay and Port Alice, Quatsino Sound, been fully completed?
- 2. What work in connection therewith was done during the just past season?
- 3. Was such work or any part of it done by contract?
- 4. If yes, who were the tenderers and the bid of each?
- 5. What is the total expenditure on this road to December 31st last?
- 6. What is the estimated final total cost?
- 7. Did contract contain any provisions regulating or prohibiting subletting?
- 8. Was any portion of the work sublet?
- 9. If yes, to what part, to whom, and at what spread in prices?

The Hon. Dr. Sutherland replied as follows:-

- "1. No. Work is proceeding on Hardy Bay-Coal Harbour Road.
- "2. General construction, \$17,705.30.
- "3. No.
- "4. Answered by No. 3.
- "5. From 1916-17 to date, \$162,310.56; from 1900 to 1916, \$28,735.30. Road subsequently relocated to overcome impossible grades.
  - "6. \$12,000.
  - "7 to 9. Answered by Nos. 3 and 4."

Mr. Lister asked the Hon, the Minister of Mines the following questions:—

- 1. Has the French Complex Ore Reduction Company ceased to function?
- 2. If so, what measure of success has attended its operations, and in what way have the mining interests of the Province been stimulated thereby?
  - 3. What has been the total amount of Provincial monetary aid given such company?
- 4. As guaranters of the bonds of the said company, has the Province been obliged to implement such guarantee, either as to principal or interest?
  - 5. If yes, in what total amount?

The Hon. Mr. Sloan replied as follows:-

- "1. Yes.
- "2. Effect of company's work cannot be measured, but undoubtedly it stimulated interest generally in the mining industry of the Kootenays.
- "3. Province guaranteed securities of French Complex Ore Reduction Company, Limited, to extent of \$40,000 under authority 'Complex Ore Process Aid Act,' 1916, and guaranteed securities of said company to extent of further \$25,000 under authority 'Complex Ore Process Further Aid Act,' 1918.
  - "4. Yes.
- "5. \$46,814. This sum is made up of \$25,000 retired, being second issue Government guaranteed securities, with \$5,138 interest on same; and \$16,676 interest on \$40,000 original issue Government guaranteed securities. Interest on latter amount continues."

QUARTER-PAST TWO O'CLOCK P.M.

Prayers by Mr. Speaker.

Mr. Hayward presented a petition from the Corporation of the City of Victoria, praying that the petition of the Provisional Liquidator of the Westholme Lumber Company, Limited, for leave to introduce a Private Bill be not granted.

The House resumed the adjourned debate on the motion "That Mr. Speaker do now leave the chair" for the purpose of going into Committee of Supply.

On the motion of Mr. Burde, the debate was adjourned to the next sitting.

On the motion of the Hon. Mr. Manson, Bill (No. 20) intituled "An Act to amend the 'Small Debts Courts Act'" was introduced, read a first time, and Ordered to be read a second time at the next sitting.

On the motion of Mr. I. A. Mackenzic, Bill (No. 21) intituled "An Act to include the Inhabitants of The Corporation of The District of South Vancouver and the Corporation of Point Grey, and the Respective Areas thereof, within the City of Vancouver" was introduced, read a first time, and referred to a Select Committee consisting of Messrs. Gray, Odlum, McRac, Creery, Neclands, Walkem, and I. A. Mackenzic.

Mr. Speaker delivered his reserved decision on the point of order raised by the Hon. Mr. Manson on the motion moved by Mr. Davie on February 8th, as follows:—

"Honourable Members.—On the debate on the motion moved by Mr. Davie on the 8th instant re old-age pensions, the operative part which reads as follows:—

"'Be it therefore Resolved, That this Legislative Assembly, endeavouring to represent the just cause of the aged persons of this Province and of their dependents, humbly petition the Canadian Government to alter the said Act so as to provide: (a) That the dwelling-house of any pensioner shall not be subjected to the repayment of any amounts paid to such pensioner by said pension authority; (b) reduction of the pension age from 70 to 65 years; (c) that an applicant for a pension shall be entitled to same regardless of such applicant's income up to an amount of at least \$365 per annum; and (d) exemption of the estate of a pensioner from repayments to the pension authority of amounts paid by way of pension in all such cases where such pensioner leaves him surviving any dependent.

"'And be it further Resolved, That an humble Address be presented to His Honour the Lieutenant-Governor, praying that he will cause to be conveyed to the Secretary of State for Canada the foregoing Preamble and Resolution.'

"A point of order was raised by the Hon. Mr. Manson, as to whether the motion was in order.

"Standing Rule 118 of the House provides that 'No Resolution leading up to the expression of an express or abstract opinion of the House recommending the expenditure of the public money shall be put from the chair, unless recommended by the Crown.'

"Under the legislation. Dominion and Provincial, re old-age pensions now in force, both Governments are committed to the expenditure of public money and the Resolution in question would necessarily, if carried out, lead to further expenditure of public money.

"This Legislature has always carefully guarded the prerogative of the Crown to recommend the expenditure of public money. (Sce Speakers' Decisions, pages 107, 137, 138, 139, 140, and House Journals, 1917, 1919, 1920, 1921, 1922, 1923, 1924, 1925.)

"The motion is out of order and I so rule."

Mr. Davie appealed from the ruling of the Chair.

Mr. Woodward moved, seconded by Mr. Uphill,-

Whereas the Dominion of Canada is rich in the natural raw products required to make a rich, happy, and prosperous people:

And whereas our minerals are the subject of much inquiry by outside capitalists who are looking for safe investments:

And whereas we have five Provinces in this great Dominion of Canada containing from 10 to 20 per cent. of the total coal wealth of the entire world:

And whereas coal-mines in Canada now operating and shipping coal are very much handicapped in finding profitable markets for their coal in the Provinces of Quebec and Ontario, which are the centre of population in Canada, because of their long railroad-haul:

Be it therefore Resolved, That this Legislative Assembly of the Province of British Columbia, now in Session, believes it would be in the interest of the Dominion of Canada to grant and pay a subsidy to the railroad for the carrying of coal from each Province, on a graduated scale to be regulated by the Railroad Commission as per the distance of each Province from the markets of Ontario and Quebec.

And be it further Resolved, That an humble Address be presented to His Honour the Lieutenant-Governor, praying that a copy of this Resolution and Preamble be transmitted to the Honourable the Secretary of State or other proper official at Ottawa.

And, further, that copies of same be sent to each and every Provincial Government.

A debate arose, which was, on the motion of Mr. Hinchliffe, adjourned to the next sitting.

The House resumed the adjourned debate on the motion moved by Mr. I. A. Mackenzic on February 8th, as follows:—

Whereas the forest wealth of British Columbia is one of our greatest natural resources:

And whereas in the past few years there has been a great increase in the demand for our forest products:

And whereas it would appear that the next decade will bring an even greater demand for our forest products:

And whereas it is of paramount importance to conserve this valuable asset as far as possible: Therefore be it Resolved, That the Standing Committee on Forestry be directed to investigate, during the present Session, this important problem, hear all necessary evidence, and report to the House their findings in regard to forest conservation.

And on the amendment thereto moved by Mr. Hinchliffe on February 9th, as follows:-

That all the words of the Resolution after the word "That," in the first line thereof, be deleted, and the following words inserted in lieu thereof: "the Hon. the Minister of Lands be requested to submit to this House, at the very earliest moment possible, a report in writing, giving full details of the steps (if any) that have been taken by the Government to conserve the forest wealth of this Province, and the results that have accrued, in order that this Legislature may direct the Standing Committee on Forestry to investigate this important subject, if, after due consideration of the report of the Minister of Lands, such a course be deemed advisable."

The debate continued.

The amendment was negatived.

Main motion agreed to.

The House resumed the adjourned debate on the motion moved by Mr. Woodward on February 14th relating to railway subsidies for the carriage of coal.

On the motion of Mr. Perry, the debate was adjourned to the next sitting.

Mr. Pooley asked the Hon. the Minister of Agriculture the following questions:—

MR. SPEAKER:

Your Select Standing Committee on Agriculture begs leave to report as follows:-

That we have heard various delegations, also the Committee of Control, regarding amendments to the "Produce Marketing Act."

Your Committee, after considering all amendments submitted, recommends there be incorporated into the "Produce Marketing Act" various amendments as per copy attached to this report.

Re extension of the operation of the "Produce Marketing Act," the following resolution was passed:—

That this Committee recommends that the boundaries of the district in which the Interior Tree-fruit and Vegetable Committee now operates under the "Produce Marketing Act" be enlarged so as to embrace the whole mainland of the Province at a point south of the 53rd parallel of latitude, but for the purpose only of controlling the marketing of vegetables.

And that such Committee shall have power to delegate to a local committee such of its own powers as may be thought advisable for the purpose of controlling the marketing of vegetables grown in any district desiring to have a local committee, provided that the actions of the local committee shall be subject to approval of the Committee.

All of which is respectfully submitted.

The Hon. Mr. Manson replied as follows:-

"1917, \$78,000,000; 1920, \$124,000,000; 1923, \$148,000,000; 1926, \$175,000,000; 1927, statistics not yet available."

Mr. Wallinger asked the Hon. the Minister of Finance the following question:-

What were the total sums collected in the Cranbrook District from: (a) Mines; (b) Liquor Store; (c) automobile licences; (d) hunting licences?

The Hon. Dr. MacLean replied as follows:-

The Lieutenant-Governor transmits herewith amendments to Bill (No. 16) intituled "An Act to amend the 'Provincial Parks Act,'" enclosed herewith, and recommends the same to the Legislative Assembly.

Government House,

February 22nd, 1928.

(ENCLOSURE.)

To amend Bill as follows:-

Strike out section 2 of said Bill, and substitute the following:-

- "2. The 'Provincial Parks Act,' being chapter 189 of the 'Revised Statutes of British Columbia, 1924,' is amended by inserting therein the following section:—
- "'19a. Where any area of lands has been reserved for a Provincial park under this Act, and where no Provincial Park Board has been appointed for the management thereof, or where the appointments to the Board having the management thereof have lapsed or have been cancelled by the Lieutenant-Governor in Council, the Lieutenant-Governor in Council may exercise in respect of that park any or all of the powers given to a Provincial Park Board under this Act, and may in addition make regulations:—
  - "'(a.) For the lease for any term of years of such parcels of land in the park as he deems advisable in the public interests, for public purposes, for the construction of buildings for ordinary habitation, for purposes of trade and industry, and for the accommodation of persons resorting to the park: Provided that such regulations shall remain in force until the day immediately succeeding the day of prorogation of the session of the Legislature next after the date of such regulation, and no longer, unless during that session such regulations are approved by resolution of the Legislature."

Add to said Bill the following section:-

"3. The reserve of lands for the Provincial park known as Mount Assiniboine Park, made by the Lieutenant-Governor in Council by Order approved the sixth day of February, 1922, is hereby cancelled."

Ordered, That the said Message, and the amendments accompanying the same, be referred to the Committee of the Whole House forthwith.

"Dear Mr. King,—Since coming to Victoria I have made some inquiries in connection with your case. It turns out to be a purely administrative matter and one coming within the jurisdiction of the North Vancouver Constituency. According to the rules amongst ourselves I cannot interfere. I would only be justified in doing so if a matter of principle were at stake. I am afraid that nothing can be done in your behalf, unless you can prevail upon Mr. Bryan to reconsider his recommendation. It is an accepted principle that each member knows more about the internal affairs of his own constituency than any one else can hope to know, and consequently we in Vancouver must defer to Mr. Bryan in this action.

"Yours sincerely,

"VICTOR W. ODLUM.

"Mr. Bryan tells me that he will not oppose you anywhere else but that he cannot support you in North Vancouver."

And whereas it would appear from the said letter and documents that certain members of this Legislature who are supporters of the Government have used their influence in regard to dismissals from or appointments to the Provincial Police Force:

And whereas it is essential for the impartial administration of justice that the Provincial Police Force should be absolutely free from political influence of every kind:

Therefore be it Resolved, That all the words of the original Resolution after the word "That" be deleted, and that the following be inserted in lieu thereof: "this Legislature regrets that the administration of the Provincial Police Force has not been kept entirely free from political influence."
