REPORT No. 3.

LEGISLATIVE COMMITTEE ROOM, November 15th, 1922.

MR. SPEAKER:

Your Select Standing Committee on Private Bills and Standing Orders begs leave to report as follows:—

That the preamble to Bill (No. 50) intituled "The Shaughnessy Heights Building Restriction Act, 1922" has been proved, and the Bill ordered to be reported with amendments.

All of which is respectfully submitted.

The report was received.

The Rules were suspended and the report adopted.

On the motion of Mr. Clearihue, Bill (No. 51) intituled "The Victoria City Act, 1922" was introduced, read a first time, and referred to the Committee on Private Bills and Standing Orders.

The House resumed the adjourned debate on the motion moved by the Hon. Mr. Sloan on November 10th, as follows:—

Whereas the "Immigration Act" of Canada and regulations thereunder have failed to stem the tide of Asiatic immigration into Canada:

And whereas the industrial and economic life of Canada, and particularly of the Province of British Columbia, is threatened by competition forced by a growing foreign population with a lower standard of living than that necessary for the well-being of Anglo-Saxon civilization:

And whereas there is a strong and compelling sentiment developing in Canada, especially marked in the Province of British Columbia, at present most affected, that effective protective measures must be adopted:

Therefore be it Resolved, That this Legislative Assembly places itself on record as being in favour of the enactment of such amendment to the "Immigration Act" of Canada as is necessary to completely prohibit Asiatic immigration into Canada.

And be it further Resolved, That an humble Address be presented to His Honour the Lieutenant-Governor, praying that a copy of the Resolution hereinbefore set out be transmitted to the Hon. the Secretary of State or other proper official at Ottawa.

And on the amendment thereto moved by Mr. Bowser, as follows:-

That all words in the Resolution after the words "Anglo-Saxon civilization" be struck out, and the following added:—

"And whereas there is a strong and compelling sentiment now in Canada, especially marked in the Province of British Columbia, at present most affected, for the total exclusion of Asiatic immigration into Canada:

"And whereas at the last Session of the House of Commons of Canada a resolution was moved requiring the total exclusion of Asiatic immigration into Canada:

"And whereas the said resolution was amended and passed by the said House of Commons so as to strike out the words 'total exclusion,' and substitute the words 'effective restriction':

"And whereas this resolution so passed as amended, if in any way carried into effect by law in Canada in actual practice, can only mean that some treaty or arrangement will be made with some Asiatic power or people or that regulations will be made in Canada for the admission into Canada of Asiatics under certain restrictions:

"And whereas, if any such treaty or arrangement is made or if any regulation is passed, unless the rights of this Province are preserved, it will have the effect of curtailing the Provincial right of this Province to enact legislation prohibiting the employment of Asiatics in industries of the Province or prohibiting the ownership of lands by Asiatics in this Province, both of which are a growing menace to our people:

"And whereas practically all Asiatic immigration into Canada comes into or through the Province of British Columbia, and as a result the menace of this immigration will always be much greater in British Columbia than in other parts of Canada:

"Therefore be it Resolved, That this Legislative Assembly places itself on record as being opposed to the making of any treaty or arrangement with any Asiatic power or the passing of any regulations by the House of Commons of Canada or under the 'Immigration Act' dealing with the immigration of Asiatics into Canada unless the same have been made subject to the approval of the Legislative Assembly of the Province of British Columbia before the same becomes effective, or unless such treaty or regulations specially reserves to the Province of British Columbia power and the right to pass laws prohibiting the ownership by Asiatics of land or interests therein in British Columbia and the employment of Asiatics in industries in British Columbia.

"And be it further Resolved, That this Legislative Assembly places itself on record as being in favour of the enactment of such amendment to the 'Immigration Act' of Canada as is necessary to totally prohibit any Asiatic immigration into Canada.

"And be it further Resolved, That an humble Address be presented to His Honour the Lieutenant-Governor, praying that a copy of the Resolution hereinbefore set out be transmitted to the Hon, the Secretary of State or other proper official at Ottawa."

And on the amendment to the amendment moved by Mr. Duncan on 14th instant, as follows:—

That the amendment be amended by striking out the following words in the eighth paragraph: "unless the same have been made subject to the approval of the Legislative Assembly of the Province of British Columbia before the same becomes effective, or."

A point of order was raised by the Hon. Mr. Oliver on the amendment moved by Mr. Bowser. Mr. Speaker reserved his decision.

The House resumed the adjourned debate on the motion moved by Mr. *Hinchliffe* on 10th instant, as follows:—

Resolved, That this Legislative Assembly regrets that the Board administering the "Mothers' Pensions Act" has adopted the policy that in all cases where the applicant is the wife or widow of a returned soldier, if the death or desertion of the husband occurred within six months of the date of his discharge from the Army, that the case would be dealt with by the Patriotic Fund and no assistance would be granted under the "Mothers' Pensions Act."

And on the amendment thereto moved by the Hon. Mr. Oliver on 13th instant, as follows:-

That all the words of the Resolution after the first word "That" be struck out, and the following words substituted therefor:—

"And whereas it would appear that an arrangement has been entered into between the before-mentioned Board and Patriotic Fund officials whereby the wife or widow of a returned soldier as beforementioned receives as large or a larger allowance than she would otherwise receive under the provisions of the 'Mothers' Pensions Act':

"And whereas it is alleged that as a result of the alleged policy and arrangement hereinbefore referred to wrong has accrued:

"Therefore be it Resolved, That a Select Committee, consisting of five Members of this House—namely, Messrs. Farris, I. A. Mackenzie, Hinchcliffe, Duncan, and Mrs. Smith—be appointed to confer with the Board administering the 'Mothers' Pensions Act' and with officials administering the Patriotic Fund for the purpose of ascertaining if wrong has been done as a result of the alleged policy and arrangement, and that such Committee shall report their findings and recommendations to this House."

- 2. What is the nature of the range improvements and cost of same for the year?
- 3. Have any of the stockmen been prosecuted for trespass on the ranges?
- 4. If so, and if convicted, give names and fine imposed in each case?

The Hon. Mr. Pattullo replied as follows:-

- "1, Collected, \$2,174.20.
- "2. The boundary between the Cariboo and Lillooet Electoral Districts divides several range units, and as fees are collected for the Cariboo Grazing District which includes the two electoral districts, the collections for the units so divided are approximated as nearly as possible. Stinking Lake, Big Bar Range; a dangerous lake, taking a heavy annual toll of cattle, fenced with 1½ miles, 5-strand barb-wire fence, cost \$535.39. Mud-hole, Lac la Hache, log fence, \$25; mud-hole, Lac la Hache, log fence, \$25; mud-hole, Lac la Hache, log fence, \$25. Other improvements to the extent of \$1,035 authorized. Progress not yet reported. Land and water rights have been reserved in 1922 for stock. On September 2nd, 1920, Lillooet Stock-raisers' Association passed resolution requesting no money be expended pending further consideration by association. Association has not had a quorum at last two annual meetings. The Department has, consequently, considered it advisable to go ahead with important work.

  - 6. What is the total cost of work done during the same period?

The Hon. Dr. Sutherland replied as follows:—

- "3. Day-labour.

- "4. Three miles graded 16 feet wide, 2 miles gravelled, and 3½ miles cleared and stumped.
- "5, Approximately 9% miles.
- "6. \$160,801.79. This includes approximately \$9,000 for plant and equipment that has since been used on other work."

Resolved, That the House, at its rising, do stand adjourned until 2 o'clock p.m. to-morrow.

Ordered, That the said Message, and the Bill accompanying the same, be referred to a Committee of the Whole House forthwith.

#### (IN THE COMMITTEE.)

Resolved, That the Committee rise and report to the House, recommending the introduction of a Bill (No. 35) intituled "An Act to amend the 'Water Act, 1914,'" a draft of which is annexed to this Resolution.

Resolution and Bill reported. Bill introduced and read a first time. Second reading at the next sitting.

Mr. Speaker delivered his reserved decision on the point of order raised by the Hon. Mr. Oliver on 15th instant on the amendment moved by Mr. Bowser to the motion moved by the Hon. Mr. Sloan on 10th instant, as follows:—

"On the adjourned debate on the motion moved by the Hon. Mr. Stoan on November 10th, objection was taken by the Hon. Mr. Oliver to the amendment proposed by Mr. Bowser, in that it proposes to strike out certain words of the original motion and then reinsert the words to be struck out with no change in the meaning, and with little or no change in the wording.

"In the original motion I find these words, which it is proposed to strike out: 'Therefore be it Resolved, That this Legislative Assembly places itself on record as being in favour of the enactment of such amendment to the "Immigration Act" of Canada as is necessary to completely prohibit Asiatic immigration into Canada.'

"And in the amendment these words are proposed to be added: 'And be it further Resolved. That this Legislative Assembly places itself on record as being in favour of the enactment of such amendment to the "Immigration Act" of Canada as is necessary to totally prohibit any Asiatic immigration into Canada.'

"These paragraphs are almost identical in wording; there is no change in the import.

"Again, in the original motion I find these words, which it is proposed to strike out: 'And be it further Resolved, That an humble Address be presented to His Honour the Lieutenant-

Governor, praying that a copy of the Resolution hereinbefore set out be transmitted to the Hon. the Secretary of State or other proper official at Ottawa.' And in the amendment to the motion I find the same paragraph without change proposed to be added.

"The question then arises, can an amendment propose to strike out certain words of the original motion and then reinsert them? May, 12th edition, page 261, says: 'An amendment is also out of order if it is inconsistent with words in the motion already agreed upon.'

"It would be inconsistent to strike out a whole paragraph of a motion and then reinsert it unchanged under the guise of an amendment.

"I would point out that if the amendment is agreed to, the House will have resolved that the words quoted shall not stand part of the question, and on this point May, page 267, says: 'That a question being once made and carried in the affirmative or negative cannot be questioned again, but must stand as a judgment of the House.'

"I am of the opinion that the presentation of this amendment is imperfect, and that the proper procedure would be by way of motion to strike out only such words as it is intended should not be part of the motion as amended, and to insert in their proper place the words which it is desired to add. The motion is not to insert, but to strike out and add. The right to do this is unquestioned. The point at issue is: Can a paragraph be struck out of the original motion and afterwards be added without sufficient alteration to change its meaning?

"May, page 258, says that an amendment is 'to substitute in their place, that is in place of the words struck out, other words of a different import.' Page 267 says: 'A mere alteration of the words of a question without any substantial change in its object will not be sufficient to evade this rule.'

"The paragraphs in question are alike in both motion and amendment, and I am of the opinion that it is not in order for the Honourable Mover of the amendment to first ask that they be struck out and then that they be reinserted. Such a proposal is contrary to the practice governing procedure in this House, and I must rule the amendment out of order."

That all the words of the Resolution after the first word "That" be struck out, and the following words be substituted therefor: "the Public Accounts Committee be instructed that it possesses all necessary power to procure the attendance of any witness whose evidence is necessary to the inquiry into any matter referred to it by this House, but that it has no power to inquire into any matter not so referred; and, further, that no report of Colonel Ross Napier

Her qualifications are as follows: (a) Intermediate and senior certificate of the Maritime Business College, Halifax; (b) diploma (post-graduate) of the Business Educators' Association of Canada; (c) teacher's certificate (Isaac Pitman & Sons); (d) several years' practical experience as book-keeper and stenographer.
  - "4 No
- "5. No. Commercial teachers' certificates obtained in other Provinces are accepted *pro tanto* by this Department.
  - "6: At rate of \$1,020 per annum; present salary, \$1,995 per annum.
- "7. No. The requirements for a commercial teacher's certificate have been materially raised during the present year."

Mr. Neclands asked the Hon, the Minister of Education the following questions:-

- 1. What was the average enrolment of pupils in the public schools of the Province for the year ending June 30th, 1922?
  - 2. What was the enrolment in the high schools for the same period?
- 3. How many students were enrolled at the University of British Columbia for the academic year 1921-22?
  - 4. What percentage of the pupils finishing the public school course enter high school?
  - 5. What percentage of students entering high school finish the three-year course?
- 6. What percentage of the children entering school at the age of 6 years reach the University?

The Hon. Dr. MacLean replied as follows:—

- "1. Enrolment for 1921-22 of pupils in public schools (including high schools), 91,919.
- "2. Enrolment in high schools, 8,634.
- "3. Undergraduates and graduates, 1,014; short courses, 217; total, 1,231.
- "4. Approximately 70 per cent.
- "5. Approximately 40 per cent.
- "6. Approximately 11 per cent. qualify for admission and about  $4\frac{1}{2}$  per cent. enter the University."
  - Mr. W. A. McKenzie asked the Hon. the Minister of Agriculture the following questions:-
  - 1. Is C. E. Whitney-Griffiths in the employ of the Department of Agriculture?
  - 2. If so, in what capacity?
  - 3. What salary and other allowances is he in receipt of?
- 4. What amount of money has been paid C. E. Whitney-Griffiths in salary and other expenses during the years 1917, 1918, 1919, 1920, 1921, and 1922?

The Hon, Mr. Barrow replied as follows:-

- " 1. No.
- "2. Answered by No. 1.
- "3. Is paid travelling expenses and per diem allowance when engaged in extension and educational work in connection with Farmers' Institutes.
- "4. For fiscal year 1917-18, no payments made; for fiscal year 1918-19, expenses \$135.56; for fiscal year 1919-20, per diem allowance \$117.50, expenses \$827.66; for fiscal year 1920-21, per diem allowance \$460, expenses \$744.66; for fiscal year 1921-22, per diem allowance \$605, expenses \$918.15."

Mr. Jones asked the Hon, the Minister of Agriculture the following questions:-

- 1. To whom was the contract given for the reclamation of the first unit of Sumas Lake?
- 2. What was the amount of the accepted tender for this work?
- 3. By whom is the work being carried on at present?
- 4. If contractors have been changed, what were the reasons?
- 5. What has been the total sum paid out on reclamation of Sumas Lake to November 1st, 1922?
- 6. What sum has been paid by the Land Settlement Board for machinery?
- 7. Has this amount been charged to the contractors?
- 8. If so, what is the balance still due from said contractors on account of said machinery?

The Hon. Mr. Barrow replied as follows:-

- "1. Marsh Construction Company, Limited.
- "2. \$1,182,063.99. This was a unit bid based on Engineer's estimate, and subject to increase or decrease, according to actual quantities of material moved.
  - "3. Marsh Construction Company, Limited.
  - "4. Contractors have not been changed.
- "5. \$1,439,195.72. Marsh Construction Company on original contract, \$1,056,088.03; other expenditures (Sumas Dam, McGillivray Creek pumping plant, engineering, purchase of right-of-way, debts of former Commissioners, etc.), \$383,107.69.
  - "6. \$45,000.
  - "7. Yes.
  - "8. Paid in full."

Mr. Bowser asked the Hon, the Minister of Railways the following questions:-

- 1. Was A. F. Proctor appointed Chief Engineer of the Railway Department?
- 2. If so, when?
- 3. What salary was the said Proctor receiving as Chief Engineer?
- 4. Has said Proctor resigned as Chief Engineer of the Railway Department?
- 5. If so, when?
- 6. Has the resignation of said Proctor been accepted by the Government?
- 7. If so, what was the date of acceptance of the resignation?

The Hon. Dr. MacLean replied as follows:-

- "1. Yes.
- "2. April 1st, 1918. Order in Council No. 1741.
- "3. \$300 per month at appointment. Later increased to \$375.
- "4. Yes.
- "5. October 20th, 1922.
- "6. Yes.
- "7. As of October 31st, 1922."

Mr. Lister asked the Hon. the Minister of Finance the following questions:-

- 1. Is W. A. McAdam now in the employment of the Department of Finance?
- 2. If so, in what capacity?
- 3. What salary is he in receipt of?
- 4. Was his original appointment or promotion approved of by the Civil Service Commission?
- 5. How long has the said McAdam been in the service of the Department?

The Hon. Mr. Hart replied as follows:-

- "1 Yes
- "2. Assistant Deputy Minister of Finance.
- "3. \$225 per month.
- "4. Original appointment was not under the Civil Service Commissioner; appointment to present position approved of by the Commissioner.
  - "5. Two years."

Mr. Wallinger asked the Hon, the Minister of Finance the following questions:-

- 1. What length of time was the Hon. Minister of Lands absent in Europe on his recent trip?
- 2. What was the total expense of this trip taken by the Hon. Minister of Lands?
- 3. For what purpose was the trip undertaken?

The Hon. Mr. Hart replied as follows:-

- "1. About three and a half months.
- "2. Account not yet rendered.
- "3. Immigration and other matters."

Mr. Menzies asked the Hon, the Minister of Education the following questions:-

- 1. Have any complaints been received by the Department of Education that the religious beliefs of pupils attending any of the high schools of the Province are being detrimentally influenced by the teaching of history in the Matriculation classes? If so, what school has been concerned with such complaint?
  - 2. Does the Department consider that the text-book in use lends itself to such abuse?
- 3. Has complaint been made by any School Board, on its own behalf or on behalf of others, that the text-book is objectionable from a religious standpoint? If so, what School Board has been concerned in such complaint?
- 4. Does the Department of Education intend to discontinue the use of such text-book in the High School Matriculation classes?

The Hon. Dr. MacLean replied as follows:--

- "1, Yes; Victoria High School.
- "2. No.
- "3. The Secretary of the Victoria School Board forwarded a copy of a letter which it received complaining of the text-book in matriculation history and the result of instruction given in that subject in the High School.
- "4. The book in use was prescribed by the University for matriculation candidates and was accepted by the Department. Other histories are being reviewed by the University and the Department with a view to the selection and authorization of a new book."

Mr. Hanes asked the Hon. the Minister of Agriculture the following questions:-

- 1. Is it the intention of the Government to spend \$75,000 or other sum to improve the Vedder River and Chilliwack River?
  - 2. If so, what portion of the cost will be charged to the Sumas Lake reclamation scheme?
  - 3. Has the cost been estimated by engineers?
- 4. Is it the intention of the Government to break up or remove the log-jam on the Chilliwack River?
  - 5. If so, will it be in the interest of the safety of the Sumas Lake reclamation scheme?

The Hon. Mr. Barrow replied as follows:-

- "1. Yes; to protect bridge at Vedder Crossing and to remove log-jams in Vedder River between Vedder Crossing and B.C.E.R. bridge to protect Provincial Highway, private property, and Sumas reclamation scheme, under provisions of 'River-bank Protection Act.'
- "2. Twenty-five per cent. to Sumas scheme, 25 per cent. to property-owners benefited, and 50 per cent. to Public Works Department for protecting roads and bridge.
  - "3. Yes: \$75,000.
  - "4. No work is intended above the Vedder Crossing.
  - "5. Answered by No. 4."

Mr. Menzies asked the Hon. the Minister of Education the following questions:—

- 1. Are any District Supervisors of Agricultural Education employed by the Department of Education? If so, what are their names, where are they stationed, and when were they appointed?
- 2. What duties do such District Supervisors perform and what salaries are they receiving from the Department of Education?

The Hon. Dr. MacLean replied as follows:-

"1 and 2. Yes. J. C. Readey, Chilliwack, April 1st, 1915, salary \$2,320; E. L. Small, Cloverdale, August 1st, 1916, salary \$2,220; J. E. Britton, Kelowna, August 1st, 1916, salary \$2,220; J. M. Shales, Langley, August 1st, 1918, salary \$2020; A. M. McDermott, New Westminster, April 1st, 1919, salary \$1,900; V. B. Robinson, Penticton, August 1st, 1920, salary \$1,900; W. H. Grant, Salmon Arm, August 1st, 1921, salary \$1,960. Contributions from School Boards towards salaries of District Supervisors to March 31st, 1923, by agreement, will be as follows: Chilliwack City and Municipality, \$1,450; Surrey Municipality, \$1,387.50; Langley Municipality, \$1,262.50; Kelowna and Rutland (7 months), \$977.50; Penticton Municipality (10 months), \$769.70; New Westminster, \$1,187.50; Salmon Arm City and Municipality, \$1,187.50.

"Duties of District Supervisors: (1.) Teaching in their respective high schools a two-year course in agriculture as outlined by the College of Agriculture and the Department of Education as preparatory to matriculation, and, in most cases, a year's course in general science preliminary to more advanced science and agriculture.

- "(2.) Supervision of instruction in elementary agriculture in the public schools of their respective districts, including nature-study and elementary science, school-gardening, school-supervised home-gardening, and other agricultural projects, such as potato-growing, corn-growing, seed-growing, chicken-raising, and the feeding and management of pure-bred breeding pigs, market hogs, calves, etc. The District Supervisor visits the schools of his district regularly, assisting the teachers by giving instruction in the class-room and in the garden, and by generally assisting them in more effectively carrying out this part of their school-work.
- "(3.) Special out-of-school instruction for high-school students in general farm methods, including farm surveys, dairying, orcharding, stock-judging, draining, field crops, etc.
- "(4.) Special extension courses for boys and girls not attending school, including adults who may wish to devote part of their time during the winter months to agricultural studies. These courses are sometimes held in conjunction with the College of Agriculture short courses.
- "(5.) Supplying timely articles on live agricultural topics for the benefit of the public through the local press.
- "(6.) Personal advice and assistance to farmers and fruit-growers, gardeners, etc., in their respective districts, dealing with many important local problems.
- "(7.) Assisting and working in co-operation with farmers' organizations in their respective districts.
- "(8.) Assisting the School Boards and the Department in the matter of school-grounds improvement.
- "(9.) Assisting in and usually leading in all local organizations for the benefit of the young people, such as athletic associations and community organization."

Mr. Esling asked the Hon. the Minister of Railways the following questions:-

- 1. Has the Government terminated its arrangement with the Northern Construction Company for construction-work on the Pacific Great Eastern?
  - 2. If so, on what date was such arrangement terminated?
- 3. What amount has been paid the Northern Construction Company for work done on the Pacific Great Eastern from January 1st, 1922, to date?

The Hon. Dr. MacLean replied as follows:-

- "1. Yes.
- "2. October 31st, 1922.
- "3. Total payments since January 1st, 1922, \$167,107.35, made up as follows: \$99,363.14 for work done since January 1st, 1922; \$76,744.21 for work done prior to January 1st, 1922."

Mr. Hunter asked the Hon. the Minister of Public Works the following questions:-

- 1. Were tenders called for the completion of the Denver-Three Forks Wagon-road?
- 2. If so, what were the amounts of tenders submitted?
- 3. What was the mileage to be completed?
- 4. What is the estimated cost of completing the said road?

The Hon. Dr. Sutherland replied as follows:-

- "1. Yes.
- "2. One tender submitted, \$45,700; tender not accepted; work done by day-labour.
- "3. Construction, 3.64 miles; reconstruction, 1,52 miles; total, 5.16 miles.
- "4. Estimated cost to complete the 5.16 miles, \$39,300."

Mr. W. A. McKenzie asked the Hon, the Minister of Lands the following question:—

What amount of money has been expended on oil investigations during each of the years 1919, 1920, 1921, and 1922 to November 1st?

The Hon. Mr. Pattullo replied as follows:-

"Expenditures by fiscal years, April 1st to March 31st: 1919-20, \$4,156.18; 1920-21, \$14,989.66; 1921-22, \$77,892.36; 1922 (to November 1st), \$28,462.87."

Mr. Catherwood asked the Hon, the Minister of Railways the following question:-

To what firm was the insurance on the building equipment, etc., of the Pacific Great Eastern Railway given for the years 1921, 1922-23?

The Hon. Dr. MacLean replied as follows:-

"The Alliance Insurance Co., through the firm of Gillespie, Hart & Todd, Ltd."

Mr. Guthrie asked the Hon. the Minister of Public Works the following questions:—

- 1. What are the names and nationalities of all the employees in and around Government House?
  - 2. What salary do they receive in each case?

The Hon. Dr. Sutherland replied as follows:-

- "1. No information on their nationality.
- "2. Head Gardener, E. Barlow, \$100 per month; Gardeners, W. Darling, W. Grant, C. Thomas, A. Godfrey, and G. Draper, \$4 per day; C. Young, Nightwatchman and Gardener, \$80 per month."

Resolved, That the House, at its rising, do stand adjourned until 2 o'clock p.m. to-morrow.
