Bill (No. 51) intituled "An Act for the Relief of the Corporation of the City of Victoria." All of which is respectfully submitted.

The report was received.

The Hon. the Premier presented a Return of copies of resolutions presented to the Premier and Members of the Executive by a large gathering of War Veterans, Patriotic and other Associations at the Parliament Buildings, April 10th, 1918.

The Hon. the Provincial Secretary presented the following papers :--

Copy of Sanitary Regulations governing Watersheds, under section 15 of the "Health Act."

Copy of Regulations *re* Logging Operations within the Health District established at Lynn Creek, under section 15 of the "Health Act."

The House resumed the adjourned debate on the motion moved by Mr. Nelson on 3rd April, as follows:--

Whereas the Consolidated Mining and Smelting Company of Canada, Ltd., have recently imposed a new and much higher schedule of rates for the treatment of lead and zinc ores carrying silver:

And whereas the mine operators claim that said schedule is unfair and excessive, and that the effect will be to greatly curtail shipments, and in many cases cause the closing-down of mines:

And whereas the management of the Consolidated Mining and Smelting Company state that this schedule is based on the actual cost plus a minimum of profit:

And whereas the Associated Boards of Trade, in convention at Nelson, appointed a committee to investigate the matters referred to:

And whereas the Federal Government has recognized said committee and are assisting in said investigation to the extent of appointing a metallurgist to act in conjunction with them:

And whereas the mining interests of this Province are seriously affected by this unsettled condition:

Now, therefore, be it Resolved, That an Order of this House be passed instructing the Standing Committee on Mining to take up the several allegations made and report its findings to the House forthwith.

And the amendment thereto moved by Mr. Hawthornthwaite on 3rd April, as follows :---

To strike out all the words after the word "Resolved" in the last paragraph of the Resolution, and add the following words: "That, in the opinion of this House, the appointment of a Royal Commission under the 'Public Inquiries Act' to investigate all these circumstances should be considered at earliest moment by the Government of this Province." The Hon. Mr. Sloan moved in amendment to the amendment, seconded by the Hon. Mr. Oliver,-

To strike out all the words after the word "House" in the second line, and substitute in lieu thereof the words "the Lieutenant-Governor in Council should forthwith appoint a competent person to act with the Committee of Inquiry being conducted at the suggestion of the Associated Boards of Trade of South-eastern British Columbia; which person shall report all the facts and evidence to the Lieutenant-Governor in Council. And if it should appear that the Consolidated Mining and Smelting Company of Canada is working an injustice upon the mining operators of Eastern British Columbia, or that further inquiry is necessary, that the Lieutenant-Governor in Council should appoint a Royal Commission under the 'Public Inquiries Act,' or take such other means as they consider efficient for the immediate relief of said operators."

Question proposed—" Shall the words proposed to be struck out of the original Resolution stand part of the question?" and *Resolved* in the negative.

Question proposed on the amendment to the amendment—" Shall the words proposed to be struck out of the amendment stand part of the question?" and *Resolved* in the negative.

Question proposed—" Shall the words proposed to be added to the amendment stand part of the question?" and *Resolved* in the affirmative.

Amendment as amended carried.

Question proposed on the original Resolution—" Shall the words proposed to be added stand part of the question?" and *Resolved* in the affirmative.

Resolution as amended carried.

The Hon. the Premier moved, "That the House proceed to the Orders of the Day, beginning with Committee of Supply."

Mr. Speaker *Keen* ruled that under Rule 44 a motion to proceed to the Orders of the Day took preference over all motions and was not debatable or open to amendment.

That the motion should not have coupled with it any addition, and that the words "beginning with Committee of Supply" were out of order. (See joint effect of Rules 40 and 44.)

Resolved, That the House proceed to the Orders of the Day.

On the second reading of Bill (No. 67) intituled "An Act to amend the 'Provincial Elections Act'" a debate arose, which was adjourned until the next sitting of the House.

The House resumed the adjourned debate on the question, "That Mr. Speaker do now leave the Chair" for the purpose of going into Committee of Supply.

Debate continued.

On the motion of Mr. Jones, the debate was adjourned to the next sitting.

Resolved, That the House, at its rising, do stand adjourned until 8.30 o'clock p.m. to-day.

And then the House adjourned at 6 p.m.

HALF-PAST EIGHT O'CLOCK P.M.

The House proceeded to the Orders of the Day.

The House resumed the adjourned debate on the question, "That Mr. Speaker do now leave the Chair" for the purpose of going into Committee of Supply.

Debate continued.

Mr. Ross moved the adjournment of the House for the purpose of discussing a definite matter of urgent public importance, relating to the disposition of aliens.

Nine Members rose in their places to support the motion.

Objection being taken that the motion could not be made during a debate and while an amendment was under consideration,

Mr. Speaker Keen decided that Rules 31, 32, 33, and 46 governed and that the motion could be made at this time.

On the question of urgency, Mr. Speaker ruled that no sufficient urgency was disclosed or shown by the Resolution, and notice could be given for to-morrow evening's session.

Mr. Ross appealed from the ruling of the Chair.

Mr. Jones moved in amendment, seconded by Dr. Rose,-

"And whereas, notwithstanding the passage of an Act providing for Civil Service reform by the present Administration, which was assented to on the 19th day of May, 1917, to come into force when proclaimed by Order in Council, no steps have been taken up to this time to make such legislation operative, and in the meantime the Government is filling vacancies in the Civil Service without regard to the requirements of said Act and without consideration of the special clauses of said legislation favouring returned soldiers:

"And whereas the public welfare of the Province of British Columbia can best be served by the active development of the natural resources of the Province in mineral, lumber, agriculture, and fishing, but the Estimates for the ensuing year do not disclose the adoption of any comprehensive scheme to secure such objects:

"Therefore be it Resolved, That this Legislative Assembly has no confidence in the Hon. the Premier as Leader of the Government or in the present Administration."

On objection taken, Mr. Speaker Keen ruled the motion out of order, no notice having been given of same. (See May, 12th edition, 258 and 476, and Speakers' Decisions, 152.)

The House continued to sit after midnight.

Resolution and Bill reported. Bill introduced and read a first time. Second reading at the next sitting. On the motion of Mr. *Hawthornthwaite*, Bill (No. 72) intituled "An Act to amend the 'Factories Act'" was introduced, read a first time, and *Ordered* to be read a second time at the next sitting.

Mr. Schofield asked the Hon. the Minister of Public Works the following questions:-

1. Has R. E. Beattie, of Cranbrook, been using the Government road-tractor on his farm?

2. If so, how long has he been using it, and for what purposes?

3. What arrangement was made with said Beattie for the use of said tractor?

4. In what work was this tractor formerly used by the Government?

5. When did the Government cease using it, and why?

6. What was the value of said tractor?

The Hon. Dr. King replied as follows :--

"1. No. The Government has not a road-tractor at Cranbrook.

"2, 3, 4, 5, and 6. Answered by No. 1."

Mr. Bowser asked the Hon. the Attorney-General the following questions :---

1. Were there not more than five escapes from the Girls' Industrial School since the new Superintendent took office?

2. If so, how many?

3. Have these escaped girls all been returned to the school, and are they now there?

The Hon. Mr. Farris replied as follows :---

"1. Yes.

"2. Annie Marie Cappello, Annie Wigman, Jessie Leon Drew, and Maud Charlton escaped March 15th, 1918, about 6.30 p.m. Birdie Willard and Ettie Alderman escaped about 6.45 p.m., March 17th, 1918. Jessie Leon Drew, Maud Charlton, Rose Frances French, Christiana Dave, Winnie Charlie, Kate Phillips, Ethel Hutchison, Anita Anderson, Gertie Bentley, and Frances Hazel Webster escaped on Monday evening, March 18th, 1918.

"3. All these girls were returned to the school but Annie Wigman, Annie Marie Cappello, Rose Frances French, Jessie Leon Drew, and Maud Charlton, who are now in Oakalla Prison Farm."

Mr. Bowser asked the Hon. the Attorney-General the following questions :--

1. Has J. A. Arnold, Police Magistrate, of Cranbrook, been dismissed from office?

2. If so, when, and for what reason?

3. How long has said Arnold held this position?

4. Who has been appointed his successor?

The Hon. Mr. Farris replied as follows :--

"1. Yes.

"2. March 27th, 1918; in the public interest.

"3. Since May 4th, 1914.

"4. John Leask."

Mr. F. J. A. MacKenzie asked the Hon. the Minister of Public Works the following questions:—

1. Was one Wm. White Superintendent of Roads in the Kamloops District when the present Government took office?

2. If so, how long had he been in the Service, and what salary was he receiving?

3. Was he dismissed from that office?

4. If so, when, and for what reason?

5. What was the age of said White when dismissed?

6. Has one D. Dalgleish been appointed to do the work formerly done by said White?

7. If so, when was he appointed, and at what salary?

8. Is said White now in the employ of the Government?

9. If so, in what position, and at what salary?

The Hon. Dr. King replied as follows :--

"1. Yes.

"2. 23 years employed; 12½ years as Road Foreman and 10½ years as Road Superintendent; as latter paid \$5.50 per day.

"3, Yes.

"4. December, 1916; work closed down. He was reappointed General Foreman in April at a salary of \$125.

"5. No record in Department.

"6. Yes.

"7. March 20th, 1918; salary \$150.

"8. Yes.

"9. Local Foreman; \$3.50 per day."

Mr. Schofield asked the Hon. the Minister of Public Works the following questions :--

1. Has J. F. Bridges, a millman in the vicinity of Cranbrook, been using one of the Government cars?

2. If so, for how long has he been using it, and for what purposes?

3. What arrangement was made with said Bridges for the use of this car?

4. By what official of the Government was this car formerly used?

5. What is the make of said car, and its value?

The Hon. Dr. King replied as follows :---

"1. No.

"2, 3, 4, and 5. Answered by No. 1."

Dr. Rose asked the Hon. the Minister of Lands the following questions :---

1. Are not the townsites at Britannia and Ocean Falls subject to section 68 of the "Land Act" and therefore subject to being subdivided and thus opened?

2. If so, why was not a demand made on the owners of these townsites to have them subdivided?

3. Did the Hon. the Minister of Lands in the election campaign of 1916 promise the public that if the Liberal Party were returned to power these closed towns would be opened?

The Hon. Mr. Pattullo replied as follows :--

"1. This is a matter of opinion.

"2. It has already been intimated that this whole question is under careful consideration. "3. The Minister of Lands assured the public in the election campaign of 1916 that any abuses in connection with this question or any other question affecting the public interests would receive consideration and thereafter necessary action by the Government were the Liberal Party returned to power."

Reported complete with amendments.

Report to be considered at the next sitting.

Bill (No. 60) intituled "An Act to amend the 'Forest Act'" was again committed. Reported complete with amendments.

Report to be considered at the next sitting.

Bill (No. 31) intituled "An Act to amend the 'Land Act'" was again committed. Progress reported.

Committee to sit again at the next sitting.

Bill (No. 43) intituled "An Act to fix a Minimum Wage for Women" was again committed. Progress reported.

Resolution and Bill reported. Bill introduced and read a first time. Second reading at the next sitting. Mr. Ross asked the Hon. the Attorney-General the following questions :---1. Has John Hosie, formerly an employee in the Legislative Library, been dismissed? 2. If so, for what reason? 3. How long was the said Hosie in the Government service? 4. What notice (if any) was given to the said Hosie? The Hon. Mr. Farris replied as follows :---"1. Yes. "2. On the ground that it was necessary to reduce the expenses of the Library Branch. "3. Since December 9th, 1912. "4. Notice was sent on March 28th, effective March 31st, 1918." Mr. Ross asked the Hon. the Attorney-General the following questions:-1. Has James D. Fraser, an employee in the Provincial Library, recently been dismissed? 2. If so, for what reason? 3. How long has said Fraser been employed by the Government? 4. Is the Government aware that the said Fraser is a veteran of the Fenian Raid? 5. What was the age of said Fraser when dismissed? 6. What salary was he in receipt of? The Hon. Mr. Farris replied as follows :---"1. Yes. "2. On the ground that it was necessary to reduce the expenses of the Library Branch. "3. Ten years. "4. Nothing on the file to show. "5. Sixty-eight or sixty-nine years. "6. \$95 per month." Mr. F. J. A. MacKenzie asked the Hon. the Minister of Finance the following questions:-1. Was one Charles M. Field, of Revelstoke, formerly a Judge of the Court of Revision and Appeal for West Kootenay District? 2. Was he dismissed by the Government? 3. If so, when, and why? 4. How long had he held that office? 5. Had there ever been any successful appeals from his decisions? 6. Who was appointed as his successor? The Hon. Mr. Hart replied as follows :--"1. Yes. "2. Yes. "3. December 29th, 1916; for greater efficiency of the Service. "4. Since 1904. "5. No information here. "6. H. N. Coursier." Mr. Anderson asked the Hon. the Attorney-General the following questions:-

1. What is the policy of the Government regarding the payment of monthly salaries to Stipendiary Magistrates?

2. Why did the following Stipendiary Magistrates receive salaries from the Government as shown by disbursement of Vote No. 16, Public Accounts for year ending 31st March, 1917: J. A. Forin, Nelson, \$500; G. Jay, Victoria, \$500; J. S. Chute, New Westminster, \$250; H. O. Alexander, Vancouver, \$500; A. S. Hood, Rivers Inlet, \$332; W. J. Quinlan, Ocean Falls, \$210.48? 3. Do these persons still continue to draw salaries from the Government?

4. Is it possible for Stipendiary Magistrates at other centres to obtain salaries from the Government?

The Hon. Mr. Farris replied as follows :---

"1. Not to pay salary to Stipendiary Magistrates except where such Magistrates act as Magistrates of Small Debts Courts.

"2. His Honour Judge Forin received as Stipendiary Magistrate's salary \$500 under an arrangement between the Dominion and Provincial Governments, entered into in the year 1900, and which is referred to in a Return appearing in Sessional Papers (Dominion), 1900, page 487. The Minister of Justice recommended payment to County Court Judges as Stipendiary Magistrates be continued by the Provincial Government in addition to the salary paid such County Court Judges by the Dominion.

"George Jay, Police Magistrate, City of Victoria, and Stipendiary Magistrate, received \$500 for the year ending March 31st, 1917, as Magistrate of the Small Debts Court.

"J. S. Clute, New Westminster, Stipendiary Magistrate, received \$250 for the year ending March 31st, 1918, as Magistrate of the Small Debts Court.

"H. O. Alexander, Vancouver, Stipendiary Magistrate, received \$500 for the year ending March 31st, 1917, as Magistrate of the Small Debts Court.

"A. S. Hood, Rivers Inlet, Stipendiary Magistrate, received \$332, salary and expenses, for acting as Stipendiary Magistrate, Rivers Inlet, during the year 1916-1917.

"W. J. Quinlan, Ocean Falls, Stipendiary Magistrate, received \$210.48 salary as Stipendiary Magistrate from July 19th, 1916, to March 31st, 1917.

"3. Yes.

"4. No."

Mr. Bowser asked the Hon. the Minister of Finance the following questions :---

1. Are all the Civil Servants in Victoria contributing one day's pay towards the Canadian Patriotic Fund?

2. If not, who is not contributing, giving particulars in each case of their names and salaries?

3. When was this system of contributing first adopted?

4. How much has been contributed to date?

The Hon. Mr. Hart replied as follows :-----

"Some Civil Servants contribute to the Canadian Patriotic Fund by way of deductions from their monthly cheques and some pay directly to the fund; consequently, am unable to answer the question."

Mr. Anderson asked the Hon. the Minister of Public Works the following questions :---

1. What was total cost of bridge across the North Thompson River near Barriere?

2. What was the total cost of following items: (a) Timber, lumber, and piling; (b) ironwork; (c) painting; (d) labour?

3. What was the estimated cost made by Department before construction?

4. When was construction commenced and when completed?

5. What is total length of this bridge, the number of spans and the length of each, with a description of type?

The Hon. Dr. King replied as follows :--

"1. \$34,190.31.

"2. (a.) Timber, \$2,494.47; lumber, \$4,292.91; piling, \$841.20. (b.) Ironwork, \$4,365.24; painting, nil; labour, \$15,355.65.

"3. Estimated cost, \$25,622. Nothing included in this estimate for haulage of material to bridge-site.

"4. Construction commenced November, 1912; completed August, 1914.

"5. About 430 feet deck measurement, made up as follows: One bay of approach; one Howetruss span of 125 feet; one swing span of 135 feet; one Howe-truss span of 125 feet; and one bay of approach." Mrs. Smith asked the Hon. the Premier the following questions :--

1. Is the "Civil Service Act" in force at the present time?

2. Has the Government appointed a Civil Service Commissioner as provided by section 3 of the said Act?

3. If not, why not?

The Hon. Mr. Oliver replied as follows :--

"1. No.

"2. No.

"3. Matter was under negotiation by late Premier with a view to bringing this Act into force at an early date, and has not yet been taken up by this Government."

Mr. Walters asked the Hon. the Minister of Public Works the following question :---

On March 7th the Hon. Minister, in reply to a question, promised to obtain a copy of the report made by the Engineer of the Dominion Government (if available) on a recent survey and examination of the old Yale-Cariboo Trail as it refers to the road between Yale and Spences Bridge: Can the Minister report any progress?

The Hon. Dr. King replied as follows :---

"The Department of Public Works at Ottawa advises that only a few short and isolated traverses were made along the road in connection with township subdivision; copies of the field-notes of these traverses can be supplied if they would be of service."

The Hon. the Premier presented a Memorandum referring to an Order of the House for a Return of: (a) All persons in the Permanent or Temporary Service who have resigned, been dismissed, or had their services dispensed with since 24th November, 1916; (b) dates of their leaving the Service; (c) their age and length of time in the Service; (d) reasons for their dismissals or their services being dispensed with; (e) salaries paid them at their time of quitting the Service; (f) list of those appointed in each case to take their places, their age and residence in each case, and the salaries they are now receiving; (g) also names, ages, residences, when appointed, and salaries now paid of all other persons appointed temporarily or permanently to the Service since the 24th day of November, 1916, as follows:—

"I desire to state that the work of securing the information asked involves a great deal of correspondence with outside offices, departments, and individuals, and while this work has been commenced it will take an indefinite period to even partially complete the record. A portion of the particulars required could probably be obtained after several weeks' work, but months must elapse before many of the details asked for are at hand.

"Departments and offices do not, as a rule, keep particulars of persons engaged for short periods, and the Civil Service Commission is not concerned with such cases beyond certifying to salary vouchers. A comprehensive search of the records of the Audit Office would no doubt produce certain particulars, but details of ages and residences are not obtainable from any source, in the absence of knowledge as to the present whereabouts of the persons concerned.

"Owing to reorganization of departments, etc., the reasons for changes in the staffs cannot now be accurately given. For these and other reasons I am of the opinion that it is not possible to supply the information asked for."

Pursuant to Order, the House resolved itself into the Committee of Supply.

(IN THE COMMITTEE.)

The Chairman reported to Mr. Speaker that the "Previous Question" had been moved, and that on objection taken he had ruled the motion to be in order, and that an appeal to the Chair had been taken.

Mr. Speaker *Keen:* "I think the 'Closure of Debate' Rule, being Rules Nos. 34 and 35, apply only when the Speaker is in the Chair or the Deputy Speaker is the Chairman of the Committee. A point of order was raised by Mr. Weart, who claimed that he had not voted and was not obliged to vote, although he remained in his seat.

Mr. Speaker *Keen* ruled the objection well taken. The old practice, "That a Member must vote if he remains in his seat when the question is put," having been changed in the English Rules, and there being no Rule of the House on the point. (*See* May, 12th edition, page 329.)

Mr. Ross moved, seconded by Dr. Rose,-

That this House regrets the inability of the Government to approve the Resolutions of a gathering of War Veterans, Patriotic and other Associations, as follows:---

Inasmuch as the delegates of the returned soldiers who went to Ottawa recently to confer with Sir Robert Borden and his colleagues on matters of vital importance in this crucial time of the Empire's history have come away from that conference in several instances disappointed men. Their disappointment will be shared by many and the feeling is widespread that promises made to the ear are being broken to the hope. It was known to the Government that the returned men had considered questions with regard to "enemy aliens," with respect to the conscription of men of alien races, and other matters of equal importance. The Government recognized the fact that the War Veterans were men who would debate these questions with tact, judgment, and experience, and, more than that, their sufferings and their sacrifices would give them a status for the expression of opinion which could not be ignored, but deserved and demanded consideration, and the Government, as was to be expected, very rightly asked the War Veterans to bring the result of their deliberations before them.

This has been done, and the result has been that for the present, at any rate, the War Veterans must bear the disappointment that "the Government is unable to accept their proposals."

There is not a returned man who is not alive to the difficulties and dangers of the complicated questions which now confront the Governments in all parts of the Empire. However, it was decided at a meeting of all returned men, held in this city on April 6th, that a public demonstration is necessary, and that all bodies interested in the enemy alien question should be asked to take part in the demonstration, and also to adopt the resolution as set forth. The resolution presented to Sir Robert Borden and his colleagues is as follows:—

"Whereas there are in Canada a great number of people of alien origin: Therefore be it *Resolved*, That the aliens of enemy origin in our midst should be employed in work of national importance in industries essential to the winning of the war, under proper surveillance, and their employer, for the time being, made responsible for them; and that their earnings, over and above an amount equal to the pay and allowance of a Canadian soldier, be taken by the Government for war purposes, or, failing their being employed, that such alien enemies be interned.

"Further, that measures be taken at once to make the 'Military Service Act' applicable to all allied aliens in the same manner and to the same extent as to the citizens of Canada, either by negotiating the necessary treaties or conventions with the remaining allied countries upon similar lines or the same as those provided for in the conventions recently adopted by the United States of America and Great Britain, or, failing the obtaining of such treaties or conventions, that such allied aliens be forthwith given the option of enlisting voluntarily in the Canadian Forces, or being deported to their country of origin as is being done under the Alien Slacker Bill just passed by an overwhelming majority in the House of Representatives at Washington.

"Further, that no steps should be taken to call out the second or other class under the 'Military Service Act,' or to return to France married men of the First Contingent, C.E.F., until the question of the disposition of the aliens has been settled in a manner satisfactory to the citizens of Canada; and that we urge the Government to take up and deal with these questions without further delay."

We respectfully beg to submit the following in addition to the foregoing :----

"(1.) That no enemy alien shall any longer hold public office, and that all questions having to do with the alien be taken out of the hands of the Provincial authorities and taken under Federal direction.

"(2.) That the Canadian Government establish an Alien Registration Bureau, the same as obtains in Great Britain, in which every neutral, allied, and enemy alien shall be registered, so as to be used to the best advantage in the national service; and, moreover, that all aliens be compelled to wear a badge or token, prominently displayed, designating that he is an alien in his class.

"(3.) That all enemy alien newspapers or periodicals should be suppressed, or, failing, it should be insisted that all editorials be printed in English.

"(4.) That no person of alien birth, whether naturalized or not, shall be permitted to have in his possession frearms of any description."

"Whereas greater production of food is of vital importance; and whereas, especially in the Western Provinces, the farmers are labouring under a great disadvantage owing to the unreliable condition of alien labour; and whereas much hardship has resulted from frequent breaches of contract during harvest time: Therefore be it *Resolved*, That it is the opinion of this conference of returned soldiers of Canada, assembled, that a law be passed punishing with a heavy fine such breaking of contracts where it is shown that the employer has fulfilled his contract."

"That whereas the present Provincial Government, under the leadership of the late Premier, passed a 'Civil Service Act,' making it obligatory for all Civil Servants to obtain positions through competitive examinations, and also containing a special clause concerning the applications of returned disabled soldiers; and whereas, although this Act is now on the statute-books of the Province of British Columbia, but is non-operative until a Commissioner or Controller be appointed: Therefore be it *Resolved*, That this delegation here assembled now ask the Hon. John Oliver, in his position as Premier of British Columbia, to immediately put this Act into force."

A debate arose, which was, on the motion of Mr. Mobley, adjourned to the next sitting.
