- 8. Were any of the claims by commercial fishermen under the independent operators' plan rejected solely on the grounds that the fishermen concerned had not paid a premium for the coverage?
  - 9. How many commercial fishermen suffered fatal industrial accidents during 1957?

(a) Death claims, none approved and none rejected; (b) claims for temporary total disability, fifty-four approved and none rejected; (c) claims for permanent partial disability, six approved and none rejected; (d) claims for permanent total disability, none approved and none rejected; (e) claims no time-loss, none approved and two rejected.
  - " 6. Answered by No. 5.
  - "7. \$27,382.24.
- "8. There were no claims by commercial fishermen under the independent operators' plan rejected solely on the grounds that the fishermen concerned had not paid their assessment; there were, however, one or two claims which could not be accepted because the fishermen concerned had not applied for workmen's compensation coverage.
- "9. Reports were received respecting five commercial fishermen who met death by accident in 1957.

- "10. All the five commercial fishermen referred to in No. 9 were covered under those sections of the Act which define certain categories of fishermen as workmen.
- "11. The Board does not have information respecting those not covered by the Act and with respect to whom no claim was filed.
- "12. A total of 228 commercial fishermen who were covered by the Act, either as workmen or as independent operators, sustained either temporary total disability or permanent partial disability; there were no permanent total disability claims; of the above number, 172 were automatically covered by the Act as workmen and 56 were covered by voluntary application as independent operators; the Board has no record of injuries to commercial fishermen who were not covered by the Act."

- 2. In how many of these cases has he been successful in changing the decision of the Board?

(7) Whereas the Canadian Medical Association, British Columbia Division, have stated in writing to the Minister of Health and Welfare that if their demands are not met the agreement between the British Columbia Government and the Canadian Medical Association, British Columbia Division, will terminate as of March 31st, 1958; and

(8) Whereas the cancellation of the agreement will result in the recipients being left without the medical protection to which they have been accustomed:

Therefore be it Resolved, That a Special Committee of this House, consisting of nine members, be appointed to examine and inquire into all such matters and things pertaining to the demand for an increase in the *per capita* rate which has been made by the Canadian Medical Association, British Columbia Division, and to report their observations and recommendations in respect thereof to the Legislature:

And be it further Resolved, That the Committee be composed of the Hon. W. D. Black, the Hon. E. C. F. Martin, and Messrs. Price, Speare, Gibson, Corbett, Turner, Eddie, and Gibbs.
