With reference to the written agreement made in 1958 between the Provincial Government and the British Columbia Medical Association for the provision of medical services to recipients of Social Allowance and to the Minister's answer recorded in the Journals of the House, page 62, 1959, which confirmed that these medical services were given to unemployed employables who remained on Social Allowance for a period in excess of three months:—

1. Have instructions been issued to Social Welfare offices to the effect that medical services are no longer to be granted to unemployed employables regardless

of the length of time they receive Social Allowance?

2. If the answer to No. 1 is in the affirmative, (a) on what date did the ruling go into effect and (b) did the ruling affect unemployed employables who had been in receipt of Social Allowance during the three-month period prior to this date?

- 3. If the answer to No. 1 is in the affirmative, did any meeting or discussion take place between the Government or officials of the Social Welfare Branch and representatives of the British Columbia Medical Association to discuss the proposal to refuse medical services under the terms of the relevant agreement to unemployed employables?
- 4. If the answer to No. 3 is in the affirmative, (a) (i) who were the members of the British Columbia Medical Association who attended the meeting or discussion and (ii) what was the relevant date or dates of said meeting or discussion; (b) did the proposal to refuse medical services to unemployed employables come from the British Columbia Medical Association; and (c) if the answer to No. 4 (b) is in the negative, did the British Columbia Medical Association oppose the said proposal?
- 5. If the answer to No. 1 is in the affirmative, has the Government received any official representations from any organizations in the Province praising their action in refusing medical services to unemployed employables and, if so, which organizations?

The Hon. W. D. Black replied as follows:—

The Hon. W. D. Black replied as follows:-

- "2. Eighty-six (in seven introductory and five final group sessions) and forty-six (in three introductory and three final group sessions)."

Mr. Brothers asked the Hon. the Minister of Lands and Forests the following questions:-

- 1. Did the Province of British Columbia once consider the development of the Columbia River basin by means of the so-called Dorr diversion plan?
- 2. If the answer to No. 1 is yes, then (a) how many acres of land would have been inundated at maximum storage level, (b) how many acres of presently used arable land would have been inundated at maximum storage level, (c) how many acres of potentially usable arable land would have been inundated at maximum storage level, (d) how many persons would have been displaced at maximum storage level, (e) how many homes would require to have been purchased to store water at its maximum height, and (f) what would have been the estimated cost of purchasing private property and homes to store water at its maximum height?

3. If the answer to No. 1 is yes, then would the fishing and hunting area in the East Kootenay be adversely affected and would the area which would have been inundated contain much wildlife?

8. Is the contract let for construction of this bridge and, if yes, to whom?

9. If not, when is it expected to be let and what is the estimated cost?

10. What has been (a) survey, (b) construction, and (c) right-of-way purchase costs to date?

11. What is the anticipated final cost of the said highway?

- 12. When is it anticipated that the Kinnaird Interchange will be constructed?
- 13. When is it anticipated that the new Columbia River Bridge will be constructed?
- 14. When is it anticipated the contracts will be called for the construction of the bridge across Christina Creek?

The Hon. P. A. Gaglardi replied as follows:-

Mr. Harding asked the Hon. the Minister of Lands and Forests the following question:—

With reference to the agreement between the Kaiser Aluminum and Chemical Corporation and the Provincial Government referred to in the Journals of the House, page 65, 1960, does the Provincial Government still retain the company's deposit in its care in the form of Pacific Great Eastern Railway bonds or in any other form?

The Hon. R. G. Williston replied as follows:—

"At the company's request, its investment in Pacific Great Eastern Railway bonds remains in the safe-keeping of the Department of Finance."

Mr. McKay asked the Hon. the Minister of Highways the following questions:—

With respect to the bridge being built over the Elk River on Highway No. 93 near Roosville (Bridge Project No. 292):—

The estimates which follow are based on a survey using a flowage 'take' elevation of 1,460 feet; this elevation is 14 feet higher than the proposed reservoir elevation; hence the estimates given would be considerably less if only an area to the proposed flooding elevation of 1,446 feet is considered; (a) approximately 40,000 acres, (b) estimates vary from 4,150 acres to 5,900 acres, (c) estimates vary from 15,000 acres to 20,000 acres, (d) about 1,600 persons, (e) about 470 occupied homes and sixty-six unoccupied, and (f) approximately \$6,800,000."
- Mr. Perrault asked the Hon. the Minister of Mines and Petroleum Resources the following questions:—

Since the signing of the Federal-Provincial agreement with respect to the Stewart-Cassiar Road:—

- 1. What is the total value of contracts let?

- 3. Of the total cost, what portion will be paid by the Federal Government?
- 4. What is the estimated date for completion?

The Hon. W. K. Kiernan replied as follows:---

- "4. Agreement with Federal Government allows until March 31st, 1963, with right of extension to 1964, if agreeable to both Governments."

- 1. Were any foster-home applications received in 1960 and, if so, how many?
- 2. Were any foster homes approved in 1960 and, if so, how many?
- 3. Were any foster-home applicants refused children for foster care in 1960?
- 4. If the answer to No. 3 is yes, how many were refused and for what reason?
- 5. Is psychiatric consultation available through the Social Welfare Branch to review applications for foster-home care?

The Hon. W. D. Black replied as follows:—

- "1. Yes; statistics for 1959/60, 477.
- "2. Yes; statistics for 1959/60, 481.
- " 3. Yes.
- " 4. Statistics are not kept.
- "5. No; it is not general social-work practice to use psychiatric consultation in assessing foster-home applicants."

Mr. Barrett asked the Hon. the Minister of Social Welfare the following questions:—

- 1. What was the total number?
- 2. How many were classified as (a) heads of families, (b) dependents, and (c) single?

The Hon. W. D. Black replied as follows:-

"1, 2, and 3. Information not available."

Mr. Barrett asked the Hon. the Minister of Social Welfare the following questions:—

- 1. Were any individuals given in-service training by the Social Welfare Branch training division during 1960?
 - 2. If so, how many?

The Hon. W. D. Black replied as follows:-

- "1. Yes.
- "2. Sixty-nine (in four introductory and five final group sessions)."

Mr. Barrett asked the Hon. the Minister of Social Welfare the following questions:—

- 1. What was the total number of staff employed by the Social Welfare Branch as at December 31st, 1960?
- 2. What was the total number of staff in the Social Welfare Branch field service as at December 31st, 1960?
 - 3. How many of field service staff held B.S.W. or M.S.W. degrees?

The Hon. W. D. Black replied as follows:—

- "1. Five hundred and seventy-three (includes administration and institutional staffs).
 - "2. Two hundred and seventy-eight (195 social workers; eighty-three clerks).
 - "3. Sixty-eight."

Mr. Barrett asked the Hon. the Minister of Social Welfare the following questions:—

The Hon. W. D. Black replied as follows:—

- "2. (a) Thirty-one, (b) thirty-one, (c) twenty-two, (d) and (e) eligible for reclassification to Social Worker—Grade 2 after successful completion of three years' service.
 - "3. (a) Five, (b) three, (c) nine, (d) twenty-one, and (e) fifteen."

Mr. Barrett asked the Hon. the Minister of Social Welfare the following question:—

What were the total case loads by regions in the Social Welfare Branch as at December 31st, 1960?

The Hon. W. D. Black replied as follows:—

2. Have contracts been let for the complete highway, except for black-topping?

- 3. If the answer to No. 2 is no, how many miles are still to be let and when will the contracts be called?
- 4. When will the highway be completed, less hard surfacing, and able to handle traffic?
 - 5. When will the highway be completed with hard surfacing?
 - 6. What is the anticipated total cost of the highway?

The Hon. P. A. Gaglardi replied as follows:—
