On objection taken, Mr. Speaker Weart ruled the question out of order as offending against Rule 45, and as being practically the same question ruled out of order on the 16th instant. (See also May, 11th edition, page 249.)

MR. SPEAKER:

Your Select Standing Committee on Private Bills and Standing Orders beg leave to report as follows:—

Your Committee have considered Bill (No. 50) intituled "An Act to amend the 'Vancouver Incorporation Act, 1900," and it appearing that there is likely to be a long discussion on some of the clauses of the Bill, and that there is great urgency for the passing of an amendment to section 214 of the "Vancouver Incorporation Act, 1900," and at the request of the petitioner, and no one appearing in opposition thereto, your Committee recommend that the Bill be divided so as to include the proposed amendments to said section 214 in a separate Bill, which is now reported as "An Act to amend the 'Vancouver Incorporation Act, 1900'" (No. 2), with the preamble proved.

Your Committee further report and recommend that the Standing Rules and Orders be suspended to allow said Bill to proceed in the usual way, inasmuch as the subject-matter contained in the said Bill has been duly advertised and was part of Bill No. 50, already introduced and read a first time.

Your Committee also recommend that no additional fees be required to be paid by the petitioner by reason of the Bill being separated as above.

That under the instructions of the House your Committee has divided Bill No. 50, being the "Vancouver Incorporation Act, 1900, Amendment Act, 1917," into two Bills by inserting section 27 of said Bill in a separate Bill, to be known as Bill No. 51, intituled "The Vancouver Incorporation Act, 1900, Amendment Act, 1917, No. 2."

That the preamble of Bill No. 51, intituled "The Vancouver Incorporation Act, 1900, Amendment Act. 1917, No. 2," has been proved, and the Bill ordered to be reported without amendment.

That the Standing Orders in connection with Bill No. 50 have not been complied with, inasmuch as the provisions of section 27 do not appear to have been contemplated in the notice for said Bill as advertised; but, as proof has been produced to your Committee that the subject-matter of said Bill No. 51 has been discussed in the Municipal Council and referred to in the daily press of the City of Vancouver, and as all of the parties immediately interested appeared before your Committee and objections were heard and considered, your Committee would recommend that the Bill be allowed to proceed.

The House resumed the adjourned debate on the motion of the Hon. Dr. MacLean, moved on the 27th March, as follows:—

That an humble Address be presented to His Honour the Lieutenant-Governor, praying His Honour to be pleased to direct an inquiry into the allegations contained in the petition of John McInnis, of Prince George, British Columbia.

On the point of order raised by Mr. *Bowser*, That the petition referred to in the motion was out of order inasmuch as the same was not presented within the time limit prescribed by section 287 of the "Provincial Elections Act," and upon which Mr. Speaker reserved his decision, Mr. Speaker *Weart* ruled as follows:—

"Yesterday, upon the calling of the Orders of the Day, to resume the adjourned debate on the motion moved on the 27th March, as follows: 'That an humble Address be presented to His Honour the Lieutenant-Governor, praying His Honour to be pleased to direct an inquiry into the allegations contained in the petition of John McInnis, of Prince George, British Columbia,' a point of order arose. My decision was reserved.

"I am asked to make a ruling upon a point raised by the Honourable the Leader of the Opposition (Mr. Bowser), who has drawn my attention to the fact that, as the petition of John McInnis et al. was received by the Deputy Provincial Secretary on the 28th day of February, instant, it is not properly before the House, as not complying with provisions of section 287, 'Provincial Elections Act,' chapter 72, 1911, and the motion cited is not in order.

"The right of petition to the Crown and Parliament for redress of grievances is accepted as a fundamental principle of the Constitution, and has been uninterruptedly exercised from very early times.

"Where there have been special reports concerning bribery, or riots at elections, and the misconduct of Returning Officers; undue influence or spiritual intimidation; the alteration of the poll; the absence, misconduct, or perjury of witnesses; defects or uncertainty in the law; the propriety of suspending the writ, or any other exceptional circumstances, the House has taken such measures as were assumed by law or usage or as appeared suitable to the occasion. (May, 11th, 659.) An effective mode of investigating corrupt practices at elections was established by the 'Corrupt Practices Act, 1863' (Imperial), and also by 15 and 16 Victoria, chapter 57 (Imperial), which provided for the appointment of a Royal Commission of Inquiry, and in 1869 Commissioners were appointed by Statute to inquire into corrupt practices reported.

"'A person may, at an election, be disqualified for being elected by reason of corrupt practices committed at an election previous thereto. So, also, a person not disqualified before an election may, during the election, become disqualified by reason of corrupt practices being committed at such election; but the latter disqualification can only arise ex post facto upon

investigation into such election. This disqualification always exists at common law,' and the statutory provisions to which reference will be made are 'intended only to give fuller effect to the common law of Parliament.'

"Section 287 of the 'Provincial Elections Act,' chapter 72, 1911, reads as follows: 'If upon a petition to the Legislative Assembly presented to the Deputy Provincial Secretary within twenty-one days after the return of a member to serve in the Legislative Assembly for any electoral district, or within fourteen days after the meeting of the Legislative Assembly, and signed by two or more electors of such district, and alleging that corrupt practices have extensively prevailed at the then last election for such district, or that there is reason to believe that corrupt practices have there so prevailed, or if upon the Judge making a report to that effect to the Legislative Assembly as hereinbefore provided, an address be presented by the Legislative Assembly to the Lieutenant-Governor, praying that such allegation may be inquired into, the Lieutenant-Governor may appoint Commissioners to inquire into the same.'

"The Legislature, by enacting section 287, apparently did so with the view of following English enactments, and to give a further right to the subject to seek redress, and placed a time limit within which that right could be exercised. And it would appear that the aforesaid section was enacted with the express purpose of meeting the apparent existing condition. The point raised is as to time.

"The petition in question was presented to the Deputy Provincial Secretary with a letter in the following words:—

"'PRINCE GEORGE, BRITISH COLUMBIA, February 22nd, 1917.

"' The Deputy Provincial Secretary, Victoria, B.C.

"'Dear Sir,—Enclosed find petition to be presented to the Legislature as per section 287 of the "Provincial Elections Act."

"'A number of statutory declarations dealing with this matter are now in the hands of the Attorney-General; these I wish attached to the petition.

"'Yours respectfully,

"'(Signed.) JOHN McINNIS."

"That letter specifically states that the petition is being presented in pursuance of said section 287, and the date of the receipt of that petition would appear to be 28th February, as appears by the stamp on the face thereof, and is clearly not within twenty-one days after the return of the member to serve in the Legislative Assembly for the electoral district; but the receipt of it is clearly one day before the opening of the present Parliament.

"The transmission of this petition by mail from Fort George to be presented in pursuance of the said section 287, I am inclined to think, places the onus upon the Deputy Provincial Secretary to see that the presentation comes within the meaning of the Statute, and from the date of its receipt it would be a continuous presentment, and clearly within the fourteen days after the meeting of the Legislative Assembly, as that fourteenth day is the time limit in which this petition could be received.

"The section of the Act is not specific in stating that the petition is to be accepted by the House, but, on the contrary, it contains a specific direction to present it to the Deputy Provincial Secretary to cause an address to be presented to the Lieutenant-Governor, praying that such allegations contained in the petition may be inquired into, etc. The petition was tabled in order that the members might peruse it and (from the facts therein stated, such facts being supported by any other evidence that might be adduced) determine as to the wisdom of supporting said motion or otherwise.

"The Legislature was called to meet on the 22nd February, the date of the petitioner's letter. At page 417 of the Gazette, the members elected to serve were relieved from attending at that date and were called to meet on March 1st. If a doubt exists, should not the subject receive the benefit of that doubt?

"I am of the opinion that the petition in question has been properly presented and comes within the provision of section 287 of said Act, and that the motion is in order. And so I adjudge."

Debate resumed.

Your Select Committee appointed to inquire into all matters relating to the Pacific Great Eastern Railway construction begs to submit a further interim report of the balance of 641 pages of evidence taken by the Committee, and recommends that same be printed forthwith.

The report was received.

The Standing Rules and Orders were suspended, and the report adopted.

Mr. Anderson asked the Hon, the Provincial Secretary the following questions:-

- 1. What is the total acreage of Colony Farm?
- 2. How many acres at Colony Farm are under cultivation?
- 3. How many acres at Colony Farm could be put under cultivation if improved, and what is the estimated cost of such improvements?
- 4. What are the total expenditures by the Government of British Columbia, at January 1st, 1917, in connection with Colony Farm on the following items: (a) Land; (b) buildings; (c) improvements; (d) cattle; and (e) horses?
- 5. How many head of cattle have been sold from Colony Farm and how much has been received from such sales?
- . 6. How many head of horses have been sold from Colony Farm and how much has been received from such sales?
- 7. At Colony Farm how many animals are there under the following heads: (a) Stallions; (b) mares; (c) geldings; (d) colts; (e) fillies; (f) bulls; (g) cows; and (h) calves?
- 8. Are sufficient dairy products produced at Colony Farm for the requirements of Essondale Asylum?
- 9. What is the total capital cost of Essondale Asylum to the Government of British Columbia?
- 10. What is the total acreage of land owned by the Government of British Columbia at Essondale?

The Hon. Dr. MacLean replied as follows:-

- "1. 338 acres of delta land, which is that portion of Government property commonly known as Colony Farm.
- "2. 262.86 acres under cultivation; 13 acres devoted to buildings; 3.90 acres to roadways; and  $59\frac{1}{12}$  acres taken up by dyke and portion outside of dyke.
  - "3. All of what has commonly been known as Colony Farm is at present under cultivation.
- "4. (a.) On May 11th, 1904, Lots 60, 170, 305, and 23, less 21½ acres, and a small portion of Lot 22 were obtained in exchange for Lots 59, 131, 135, 136, 137, 138, Group 1, New Westminster District. On December 19th, 1908, 12 acres, which is a portion of Lot 23, were purchased from Peter Peebles, of New Westminster, for the sum of \$2,300. On March 15th, 1909, 9½ acres, which is a portion of Lot 23, were purchased from one Henry Wilson for the sum of \$1,000. (b.) Expenditure on buildings on Colony Farm, \$207,286.88. This amount is made up as per attached statement. (c.) Improvements consisting of dyking, ditching, draining, paving, fencing, and miscellaneous amounted to \$108,121.38; also a sum of \$146,211.62 was expended for clearing land, but this amount represents the expenditure for all clearing done on the Government property at Essondale. I cannot segregate the expenditure on Colony Farm from the records at my disposal. (d.) For the purchase of cattle the sum of \$48,526.95. (e.) For the purchase of horses the sum of \$83,248.04.
  - "5. There has been 161 head of cattle sold, for which we received \$36,115.55.
  - "6. There has been 75 head of horses sold for the sum of \$26,314.
- "7. (a) Stallions, 6; (b) mares, 20; (c) geldings, 15; (d) colts, 4; (e) fillies, 22; (f) aged bulls, 3; (g) cows, 51; (h) calves, 79; made up as follows: 17 bulls from a few weeks to one year old, 37 heifers from a week to one year old, and 25 heifers from one to two years old.
- "8. All milk is supplied for the Essondale and New Westminster institutions, and during the summer months a portion of the butter required is supplied.
- "9. I have estimated the total cost of the Essondale Asylum at approximately \$700,000. It is absolutely impossible for me to give an exact cost in figures from the data which I have been able to obtain.
  - "10. Total acreage, 1,000 acres."

- "4. Answered by No. 3.
- "5. Answered by No. 3.
- "6. No."

Mr. Anderson asked the Hon. the Provincial Secretary the following questions:-

- 1. What is the total amount of money voted by the Legislative Assembly for assistance to King Edward Sanatorium for the treatment of tuberculosis at Tranquille, near Kamloops, B.C.?
  - 2. What is the total amount of money paid from such votes?
- 3. When were such votes passed by the Legislative Assembly, and what is the amount of money paid on each such vote?
