What is the anticipated date of construction of new Court-houses required at Williams Lake and Quesnel?

The Hon. W. N. Chant replied as follows:-

REPORT.

LEGISLATIVE COMMITTEE ROOM, March 18th, 1958.

MR. SPEAKER:

Your Select Standing Committee on Labour begs leave to report as follows:—

Pursuant to Order, your Committee invited representatives of labour, industry, and certain organizations interested in the matter to submit recommendations regarding means for alleviating seasonal unemployment.

Submissions were heard and considered by your Committee from the following delegations: British Columbia Chamber of Commerce; Provincial Council of Women; Canadian Labour Congress, British Columbia Federation of Labour; United Fishermen and Allied Workers' Union; Nanaimo and District Labour Council; Fisheries Association of British Columbia; British Columbia Research Council; Industrial Association of British Columbia; Canadian Manufacturers' Association; British Columbia Federation of Labour; International Railway Brotherhood; British Columbia Lumber Manufacturers'

Association; Interior Lumber Manufacturers' Association; International Brotherhood of Pulp, Sulphite, and Paper Mill Workers; Canadian Pulp and Paper Association; British Columbia Shipbuilders' Federation.

It was generally agreed that:-

(1) There is no single solution to the problem:

- (2) Seasonal unemployment, while mainly a Federal responsibility, is such that recommendations for its alleviation are varied and complex:
- (3) Some recommendations are incompatible, one with the other:

(4) Some are inconclusive:

- (5) Some necessitate projected planning and co-operation with other authorities:
- (6) Some require an examination of certain industries and sections of the labour force most affected:

And whereas the Committee deems that the following recommendations in particular, as they have a direct bearing on seasonal unemployment, warrant favourable consideration:—

- (1) That the several levels of government, industry, and the public be encouraged to plan construction, reconstruction, repairs, and maintenance of buildings and structures during the winter months:
- (2) That a programme to maintain and increase export markets be pursued:
- (3) That conditions favourable for the operation of secondary industries, particularly those making use of the primary products of this Province, be encouraged by all levels of government:
- (4) That as certain industries are particularly suited for the practice of scheduling employees' vacations during periods of slack employment, these industries should explore the possibilities of initiating such a programme, even to the extent of offering an incentive for employees to take vacations during the winter months:
- (5) That each industry should survey its own conditions to determine how work in that industry may be spread over a twelve-month period:
- (6) That merchants and salesmen be urged to give greater prominence to British Columbia products to overcome the preponderance of imported products, particularly food products:
- (7) That architects and engineers be encouraged to specify and require, and industry to use, materials made in British Columbia:
- (8) That the public be fully informed of the advantages accruing from the purchase of products made in British Columbia and encouraged to purchase such products:
- (9) That the Government of Canada be urged to initiate and extend every effort to increase fishery resources so that fishing seasons may be lengthened:

And whereas a continuing study of the problem of seasonal unemployment is required:

And whereas it has been recommended to this Committee that this Government, with others, establish research into the question of seasonal unemployment:

And whereas the British Columbia Research Council is a body qualified to pursue further research into the peculiar characteristics of seasonal unemployment associated with certain industries and sections of the labour force:

Be it therefore Resolved, That the Select Standing Committee on Labour recommends that this Government, in conjunction with the Government of Canada, prepare a reference on the problem of seasonal unemployment and make the necessary arrangements to refer it to the British Columbia Research Council for further study:

And be it further Resolved, That, pending a report on the problem from the British Columbia Research Council, those recommendations requiring projected planning and co-operation with other authorities be considered by the appropriate officials.

All of which is respectfully submitted.

LEGISLATIVE COMMITTEE ROOM,

MR. SPEAKER:

Your Special Committee on Bill No. 45, "An Act respecting Dental Technicians," begs leave to report as follows:—

This Bill was referred to this Committee for consideration and to report its observations and recommendations to the House.

Your Committee heard representations from and examined briefs submitted by the College of Dental Surgeons of British Columbia, the Dental Technicians and Public Denturist Society, the Dental Laboratory Association of British Columbia, and the Federated Legislative Committee of Elder Citizens' Associations.

Your Committee is aware of the grave concern of this House to maintain a high level of oral-health standards.

Therefore, it is recommended that Bill No. 45, "An Act respecting Dental Technicians," be amended as follows:—

(a) Section 4: A new clause (j) to read, "Providing for the prohibition of offpremise advertising and the limitation and control of on-premise advertising."

(b) Section 5, subsection (2): After the word "third," in the sixth line thereof,

to add the words " or any subsequent."

- (c) Section 6: To delete all the words after the word "denture" in the third line thereof.
  - (d) Section 7: (i) To insert as clause (c) the following:—
    "(c) An employee of a qualified medical practitioner."
- (ii) To reletter the present clauses (c), (d), and (e) to read (d), (e), and (f) respectively.
