Your Committee have heard a large amount of evidence in favour of the Bill, as well as

From this evidence it would appear that the applicants have already secured from the Dominion Parliament an Act known as the "Shuswap and Thompson Rivers Boom Company," which purports to give them the privileges sought under the Bill under review as to a portion of the streams included in the area comprised in the present Bill. Doubt is expressed as to the effectiveness of the Dominion Act, but your Committee would point out that the provisions of the British Columbia Rivers and Streams Act are available to the applicants, and seem to afford ample facilities for the successful operation of logging. Your Committee assumes this to be the case, as no evidence was adduced on the part of the applicants to indicate that its operation is inadequate for their logging operations.

Your Committee would point out that the area involved in the Bill presented for our consideration is approximately 18,000 square miles, and the granting of this concession by legislative enactment would be a practical surrender of the rights of the Legislature under the

Rivers and Streams Act over this tremendous area.

Your Committee suggests that if the applicants are unable to economically carry on their undertakings with the facilities afforded by existing legislation it is open to them to make a further application. In such an event the public interest should be carefully safeguarded and the fullest information secured for the guidance of this Legislature; to this end your Committee suggests that this evidence and information might best be secured by the appointment of a Commission, with such powers as may be adequate for this purpose.

 - 2. What supplies have been bought by either Company—

(a.) Within the Province?(b.) Without the Province?

3. What steps have been taken to ascertain if said Companies are carrying out their

agreement, as set out in section 15 of said Schedule?

4. What rate of wages are either Company, or their contractors, paying the following mechanics and labourers:—Foreman carpenters and carpenters; foremen employed and labourers, known as rockmen; foremen employed as pick and shovel men? What number of hours constitute a day's labour? Are wages paid monthly or weekly?

The Hon. Mr. Taylor replied as follows:-

"1. No specific steps, but the Government Agent at Prince Rupert is apprised of the requirements of such contract, and the Government stands ready to inquire into any complaint that may be brought to its attention as to the non-fulfilment of the terms of section 14.

"2. This information is not at present available.

- "3. The Government Agent at Prince Rupert has been communicated with, with a view to ascertaining if the companies are carrying out their agreement. The Government stands prepared to inquire into any complaint that may be brought to its attention as to the non-fulfilment of the terms of section 15.
- "4. Foremen carpenters, 60 cents per hour; carpenters, 40 to 50 cents per hour; rock foremen and foremen labourers, \$3, \$4 and \$4.50 per day; also \$75 to \$100 per month and board; rockmen \$2.75 to \$3 per day. Ten hours constitute a day's labour. Wages paid monthly."

Mr. Oliver asked the Hon. the Chief Commissioner of Lands the following questions:—

- 1. How many S. A. land grants are there that the holders thereof did not receive the grants of land called for by same?
- 2. How many of said S. A. grants were tendered for land on Kaien Island prior to any agreement with the G. T. Pacific Railway?

3. What became of these applications?

- 4. Have these S. A. land grant holders received anything for their S. A. land grants?
- 5. Is it the intention of the Government to compensate these applicants for loss of their S. A. land grants?

Whereas the excessive price of coal in British Columbia has the effect of retarding and preventing the establishment in this Province of industries depending upon a fuel supply; and

Whereas much of the product of the coal mines of the Province is being exported to foreign markets and sold at a price that enables it to compete with coal from other countries in such foreign markets; and

Whereas a belief exists that an understanding exists between the persons or corporations controlling or owning such coal mines to maintain the high prices now being charged to con-

sumers in this Province;

Therefore, be it Resolved, That an humble Address be presented to His Honour the Lieutenant-Governor by this House praying him to appoint a Royal Commission to inquire into the following questions:—

1. Whether or not a combine or understanding exists amongst the coal producers, or any of them, of this Province to establish and maintain prices charged for coal.

2. Whether or not coal is being sold by producers, or any of them, for consumption outside British Columbia for a less price than that sold for consumption in the Province.

3. Whether or not the prices charged by the producers, or any of them, for coal consumed in British Columbia is excessive.

4. Whether or not the prices charged by the producers, or any of them, of coal in British Columbia bears a reasonable proportion to the cost of production.

Your Committee concluded that these sections should not be incorporated into the present Bill, but concurred in the view that the requirements of these Municipalities, as well as those of the City of Victoria, are of a most urgent nature.

Your Committee is of the opinion that the whole matter of water supply for the localities interested should be made the subject of immediate investigation by a competent tribunal composed of men who are experts on the question, with a view towards settling the problems

presented, both speedily and economically.

Your Committee observes that a Board of Investigation is about to be constituted under the Water Act now before the House, and would suggest that the proposed Board of Investigation, when created, would seem to be the proper tribunal to consider the matters involved and take whatever action may be necessary.

Your Committee further recommend, in view of the urgency of the situation, that these problems should constitute the first business to be taken under advisement by said Board of

Investigation after its creation.
