The Annual Report of the Director of Provincial Mental Health Services for the Fiscal Year ended March 31st, 1955.

The Report of the Civil Service Commission, Province of British Columbia, from January 1st to December 31st, 1955.

Mr. Laing asked the Hon. the Minister of Agriculture the following questions:-

1. What action is being taken to prevent the proposed freight increase on feed-grains sought by the railways?

2. Has the Government made any study of the advantages or otherwise of a Provincial subsidy as paid by other Provinces?

The Hon. W. K. Kiernan replied as follows:-

"1. The Provincial Government has retained counsel to oppose the proposal of the Board of Transport Commissioners to increase by 10 per cent the domestic grain freight rates in British Columbia; our counsel has succeeded in having the hearing of the Board of Transport Commissioners on this matter of feed-grain freight-rate increase adjourned to the City of Vancouver where the hearings will be held some time in February; at that time it is our intention to ask that no increase be made and that the present rate be reduced.

"2. As there is no subsidy paid on feed-grain in any Province of Canada, it is not possible to make a study of the payment of such subsidies by the Province as implied in this question."

Mr. Laing asked the Hon. the Minister of Agriculture the following questions:---

1. In 1955 how many thousands of cases of 30 dozen each of eggs were imported from California and other United States points and how many thousands of cases were brought in from other Canadian Provinces?

2. In 1955 how many millions of pounds of butter entered the Province from other Canadian Provinces?

3. In 1955 how many car-lots of vegetables from the United States entered the Province for consumption and what additional tonnage came in by truck?

4. In 1955 what poundage of beef and pork came in from other Provinces for consumption here?

The Hon. W. K. Kiernan replied as follows:-

"1. From the United States, 12,439 cases; from other Canadian Provinces, 71,283 cases; production in British Columbia for 1955, estimated at 808,535 cases.

"2. Final figures for 1955 are not yet available; it is estimated that approximately 17,500,000 pounds of butter were imported; in 1954, total of 17,135,000 pounds of butter were imported from other Provinces in Canada; in last year for which complete information is available, 1954, British Columbia produced 7,099,000 pounds of butter, an increase of 1,633,000 pounds over 1953.

"3. The figures dealing with importation of vegetables from the United States to British Columbia in 1955 will not be available for some time yet; in 1954, importations consisted of 23,429 tons of potatoes and 40,594 tons of other vegetables; in 1953 British Columbia produced 101,700 tons of potatoes, and in 1954, 86,280 tons; heavy imports of American potatoes, encouraged by inequitable tariff structure, reduced prices of British Columbia potatoes to a point where production was effectively discouraged; similarly, vegetable production of 88,599 tons in British Columbia in 1953 was almost 20,000 tons lower in 1954.

"4. Figures showing imports of beef and pork from other Provinces in Canada during the year 1955 are not yet available; in 1954 imports consisted of 51,571,200 pounds of beef and 59,390,700 pounds of pork."

Mr. Laing asked the Hon. the Minister of Agriculture the following questions:----

1. Was the Minister of Agriculture provided with a copy of the brief presented by Dr. A. B. Kidd, Provincial Veterinarian, before the Royal Commission on the Milk Industry, March 16th, 1955, in which Dr. Kidd drew to the Commissioner's attention the very unsatisfactory production conditions on some dairy-farms?

2. If so, why was inspection action not taken immediately and, if not, is it not unusual for a public servant to present such a brief before such a Commission without first acquainting his Minister?

The Hon. W. K. Kiernan replied as follows:-

"1. No.

"2. The brief referred to was prepared by Dr. W. R. Gunn, Chief Veterinary Inspector, in whose absence on vacation and on whose instructions it was presented by Dr. A. B. Kidd; it is unusual and contrary to established practice for a public servant to present such a brief before a Commission without first acquainting his Minister of its contents." Resolved, That the House, at its rising, do stand adjourned until 2.30 o'clock p.m. to-morrow.

The Hon. W. A. C. Bennett replied as follows:---

Mr. Laing asked the Hon. the Minister of Finance the following questions:--

1. Was there an interruption of service at the Spillimacheen power plant of the British Columbia Power Commission in November and, if so, what caused the interruption, what action has been taken to rectify the situation, and has service been resumed to all customers, including Giant Mascot?

2. Were supplementary diesel units brought in and, if so, where obtained and what was the total cost of the interruption?

3. Were the engineers' reports unanimous on the efficacy of this plant when the Premier announced its construction in 1952?

The Hon. W. A. C. Bennett replied as follows:---

"1. Yes; frazil or anchor ice resulting from an abnormally early period of low temperature which occurred before the river had developed a protective ice cover plugged the intake to the power-house; additional air-bubbling equipment is being installed and some additional electric heating with an emergency power-supply has been provided at the intake; ves.

"2. Yes; two portable sets owned by the Commission, from Canal Flats and Bugaboo construction; one set from the Commission's plant at Clinton; two rented sets, one from General Machinery Company and one from Finning Tractor & Equipment Company; \$22,501.

"3. The engineers' reports were unanimous on the efficacy of this plant."

Mr. Gregory asked the Hon. the Minister of Finance the following questions:-

1. In the last twelve consecutive months' period for which figures are conveniently available, what total sum of tax was paid pursuant to the "Amusements Tax Act"?

2. What percentage of that sum was paid in respect of (a) moving pictures, (b) symphony concerts, (c) performances put on for charity, and (d) other types of amusement?

The Hon. W. A. C. Bennett replied as follows:---

"1. In the twelve months ended December 31st, 1955, \$2,040,634.96.

"2. (a) Moving pictures, 70 per cent (estimated); (b) symphony concerts, nil; (c) and (d) not known."

Mr. Laing asked the Hon. the Minister of Finance the following questions:-

1. Since its inception, what was the return in each fiscal year of the tax now commonly known as the Provincial sales tax?

2. Of the total in each year, (a) how much came from retail sales and (b) how much from industrial installation?

3. Since April 1st, 1955, what sum has been recovered from sales tax in arrears?

4. How many firms were found in arrears, how many years is the survey reviewing, and was legal action taken against any firms?

5. How many employees are engaged in arrears work, and what instructions are given them other than an arbitrary formula based on experience in similar lines of business, after spot checks?

The Hon. W. A. C. Bennett replied as follows:---

"1. 1948–49, \$14,335,119.48; 1949–50, \$24,625,370.25; 1950–51, \$28,843,-604.40; 1951–52, \$31,462,240.01; 1952–53, \$34,279,238.90; 1953–54, \$35,466,-768.64; and 1954–55, \$55,178,473.68.

"2. Not known.

"3. April 1st, 1955, to December 31st, 1955, \$891,847.85.

"4. From April 1st, 1955, to December 31st, 1955, 2,396; since the inception of the Act, on purchases for the firms' own use and for three years on sales; yes.

"5. Fifty-nine; they are given detailed instructions in accordance with recognized auditing and investigational procedures."

Mr. Gibbs asked the Hon. the Minister of Finance the following questions:-

1. During 1955, what total interest was paid on bonds in respect of Road and Bridge Toll Authority and from what funds were these interest charges paid?

2. Are the receipts from Lions Gate kept in a separate fund to retire the indebtedness on this single structure or are they to be considered in a merged Burrard Inlet fund and to be applied to discharge the obligation of the proposed Second Narrows Bridge?

3. Have any receipts from Lions Gate Bridge been used by the Toll Authority for any purpose other than maintenance of the bridge itself or retirement of its own indebtedness?

The Hon. W. A. C. Bennett replied as follows:---

"1. Revenues from Lions Gate, \$121,875.

"2 and 3. Net revenues applicable to projects within Burrard Inlet system; see page 250, Public Accounts."

Mr. Gibbs asked the Hon. the Minister of Finance the following questions:---

1. What was the volume of gasoline coloured purple sold in the fiscal years ended March 31st, 1954 and 1955?

2. What commissions were paid to vendors of gasoline coloured purple in the fiscal years ended March 31st, 1954 and 1955?

The Hon. W. A. C. Bennett replied as follows:---

"1. Year ended March 31st, 1954, 101,079,193 gallons (includes diesel oil used for purposes of internal-combustion engines which is included in the definition of 'gasoline' contained in the 'Coloured Gasoline Tax Act'); and year ended March 31st, 1955, 106,984,626 gallons (includes diesel oil used for purposes of internal-combustion engines which is included in the definition of 'gasoline' contained in the 'Coloured Gasoline Tax Act').

"2. Year ended March 31st, 1954, \$100,984.05, and year ended March 31st, 1955, \$106,853.01."

Mr. Gregory asked the Hon. the Premier the following questions:---

1. Has a contract been let for the clearing of Buttle Lake and, if so, when, to whom, and what payment is to be made?

2. Has clearing started yet?

The Hon. W. A. C. Bennett replied as follows:-

"1. Yes; October 13th, 1955; Trethewey Logging Company Limited and Cattermole Timber Limited; \$4,599,444, subject to additions and subtractions on the basis of fixed unit prices.

"2. Yes."

Mr. Nimsick asked the Hon. the Minister of Highways the following questions:---

1. Have any contracts been let on the construction of the Blueberry-Paulson Highway?

2. If so, (a) for what amounts, (b) what is the mileage in each case, (c) were tenders called in each case, (d) if not, why not, and (e) to whom were the contracts awarded?

The Hon. P. A. Gaglardi replied as follows:---

"1. One contract-Project No. 668.

"2. (a) \$674,271.90, (b) 6.53 miles, (c) yes, (d) see (c), and (e) P. F. Law Construction Limited, Vancouver, B.C."

"1. Information not available for calendar year; Department records are based on fiscal year, April 1st to March 31st.

"2, 3, and 4. Answered by No. 1."

Mr. Turner asked the Hon. the Minister of Highways the following questions:---

1. In view of the present high water-table in the Fraser Valley, what precautions have been made to prevent the recurrence of floods in that area?

2. In the event of a flood in that area, what organization and equipment are available for (a) rescue and (b) rehabilitation?

The Hon. P. A. Gaglardi replied as follows:-

"1. Not under the jurisdiction of this Department.

"2. (a) Civil Defence, Highway Department, and Municipal Works Departments, and (b) not under jurisdiction of Department of Highways."

3. Were allegations of misconduct made to the Attorney-General or the Royal Canadian Mounted Police against certain officers of the Royal Canadian Mounted Police about the apprehension, questioning, or conviction of Robert John Fraser at Prince George in 1955 and, if so, (a) who made these allegations, (b) on what date were these allegations made, (c) what was the nature of the allegations, and (d) what disposition did the Attorney-General and the Royal Canadian Mounted Police make of these allegations?

4. Has the Attorney-General received representations that Robert John Fraser has been wrongly convicted and, if so, (a) who made the representations, (b) on what date were these representations first made, and (c) what disposition was made of these representations?

5. Has the Government of British Columbia offered Robert John Fraser any compensation for any indignities or wrongful imprisonment he may have suffered?

The Hon. R. W. Bonner replied as follows:---

"1. Yes; (a) February 21st, 1955; (b) pleaded guilty through counsel on March 7th, 1955, before the County Court Judge, and was remanded to March 9th, 1955, for sentence; (c) one year hard labour with the addition of one whipping with four strokes of the paddle; on instructions from the Attorney-General's Department, received by the Warden of Oakalla Prison Farm on July 25th, 1955, the whipping was deferred pending further investigation of this matter; (d) Oakalla Prison Farm; and (e) April 2nd, 1955.

"2. Yes; (a) August 11th, 1955; (b) Deputy Governor-General of Canada; (c) investigation by the Royal Canadian Mounted Police disclosed Fraser not implicated in offence; (d) no; (e) transportation warrant given to Williams Lake; and (f) no.

"3. No; allegations made to Director of Remission Service Ottawa; (a) John Howard Society; (b) June 3rd, 1955; (c) that Fraser was 'persuaded to confess to the crime committed on the night of February 8th, 1955'; and (d) that on July 7th, 1955, a letter was received by the Attorney-General's Department from the Director of Remis-

sion Services enclosing the letter of the John Howard Society, dated June 3rd, 1955; as a consequence, on July 8th, 1955, the Royal Canadian Mounted Police were instructed to institute an investigation into these allegations.

"4. Answered in No. 3; (a) see No. 3 (a); (b) see No. 3 (b); and (c) see No. 3 (d).

" 5. No; the Government of British Columbia has received no representations either by Robert John Fraser or through his counsel."
