Prayers by Rev. Wm. Stevenson,

On the motion of the Hon. the Attorney-General, the following Bills were introduced, read a first time, and *Ordered* to be read a second time at the next sitting:—

On the motion of the Hon. Mr. Oliver, seconded by the Hon. Mr. Farris, it was Resolved,—
That on this and on all following days to the close of the Session there shall be two
distinct sittings in each day, one from 2 p.m. to 6 p.m., and the other from 8 p.m. until adjournment, unless otherwise ordered.

 - 8. Is not the title to said property now being questioned before the Courts?
 - 9. Is John R. Green not practising law in the City of Victoria?

The Hon. Mr. Oliver replied as follows:-

- "2, 3, 4, 5, 6, 7, and 8. Answered by No. 1.
- "9. Yes.
- "The following note has been received from the Land Settlement Board:-
- "'This Board loaned Mr. Green \$2,700, repayable at the expiration of three years, with interest payable in the meantime semi-annually at the rate of 7½ per cent. per annum on mortgage, dated November 27th, 1917, on Lots 1 to 20, inclusive, and Lots 22 to 36, inclusive, in Block 1, and Lots 1 to 14, inclusive, and Lot 16 in Block 2 of a subdivision of Lots 89 and 104 of Section 82, Victoria District, Map No. 1786.
- "'Lots 89 and 104 were 5-acre lots, but this acreage is at present reduced to the extent of the streets shown on Map 1786. A petition is now before the Supreme Court asking for cancellation of this map.
- "'This property may be locally known as the Glenford Orchard Subdivision, but we have no knowledge of this if such is the case. This is a fruit-farm, planted in apple-trees which were reported in good condition.
- "'There are some old buildings on the property which were not taken into consideration in making the loan, no value being placed on same.
- "'We have no information as to whether there is any one living on the property at present or not.
- "'We have notice from the Registrar-General that a caveat was lodged against the title to this property on March 8th, 1918, on behalf of the Royal Bank of Canada, claiming to be the registered owner of a mortgage for \$1,000, dated November 19th, 1914, but at the time our loan was made Mr. Green held an unencumbered indefeasible title to the property according to the records of the Land Registry Office."

Mr. Schofield asked the Hon, the Minister of Public Works the following questions:—

Prayers by the Rev. A. S. Colwell.

Mr. Pauline presented a petition from Thos. H. Smith, Malcolm White, Clement Stickney, and others, farmers in unorganized districts of Cowichan, Metchosin, and Falkland, re taxation of farm lands and improvements in unorganized districts.

The Hon. the Minister of Public Works presented a Return of: (a) Each trip made from Vancouver by R. J. Stewart, Inspector of Factories, since his appointment; (b) particulars of his official work on each trip; (c) instructions he received to make each trip and from whom received; (d) particulars of his expenses charged to the Department for each trip; (e) particulars of the dates covering each trip from the time he left Vancouver until his return, and the time he spent at each particular stopping-point.

The Hon. the Provincial Secretary presented the Twenty-fifth Annual Report of the Provincial Board of Health.

- Mr. Weart asked the Hon. the Minister of Labour the following questions:-
- 1. Have employment bureaus been established in various centres of population for obtaining suitable employment for working-men?
 - 2. If not, is it the intention of the Department of Labour to establish such bureaus?
 - 3. If so, when?

The Hon. Mr. Farris replied as follows:-

- "1. No.
- "2. Yes. Preparations are being made to establish a free employment bureau at Vancouver with the intention of extending the system to other centres of population as necessity requires. In the meantime the Department of Labour is doing what is possible to meet the demand for farm-help, and has mailed circulars to the farmers and fruit-growers of the Province informing them that all applications for help addressed to the Department will receive prompt attention. Arrangements have been made with the Young Women's Christian Association to register and distribute female help for fruit picking, packing, and canning, and with the free Municipal Employment Bureaus at Vancouver and Victoria to handle all requests for male help. Many applications are now being received and orders filled through these sources.
 - "3. Answered by No. 2."
 - Mr. W. A. McKenzie asked the Hon, the Minister of Public Works the following questions:-
- 1. In the work done in connection with the renovation of the Lands Department was water installed for the Minister of Lands?
 - 2. If so, what did it cost to do this for plumbing, etc.?
 - 3. Was this amount included in the item of \$2,176.85 for renovation of the Lands Department?

- 5. In the item of \$10 for lounge-cover, where is this being used, and what is the necessity for it?
