### MINUTES OF THE THIRD HOUSE OF ASSEMBLY OF VANCOUVER ISLAND—FIRST SESSION

### Wednesday, the 2nd day of September, 1863

The House met at 1. P. M. in accordance with the Proclamation of His Excellency the Governor.1

The Clerk of the House having called over the names of the Members elected to serve in Parliament for the various Districts of the Colony, His Honour the Chief Justice said.

Gentlemen, I have the honor to inform you that, in virtue of my Office of Chief Justice, I have been authorised, and empowered by His Excellency The Governor, to acquaint both Houses that, as soon as the Members of both bodies shall be sworn, His Excellency will declare the cause of his calling this Parliament.

And it being necessary that a Speaker of The House of Assembly should be first chosen, You, Gentlemen, of the House of Assembly, will proceed to the appointment of a proper person to be your Speaker, and you will present such person whom you shall so choose, for His Excellency's approbation, on the day following his Election at 1. o'Clock.

The House then proceeded to elect a Speaker.

Colonel Foster, after alluding to his past services, and dwelling on his great Parliamentary experience, proposed Dr. Helmcken.

Mr. Young seconded—and, On the motion being put by the Clerk of the House, Dr. Helmcken was elected unanimously Speaker of the House; and having taken his seat, Addressed the House amidst great applause, thanking it for the honor it had conferred on him; and adjourned the House to One o'Clock P. M. tomorrow.

The Speaker elect, Dr. Helmcken, accompanied by a Deputation of Members proceeded to Government House, and was presented to His Excellency the Governor who was graciously pleased to express his entire approval of his election as Speaker of the House.

On returning to the House Mr. Speaker took the Oath, and subscribed the appointed declarations in which he was followed by all the Members present; and, at two Oclock, His Excellency, who was attended by his suite, entered the chamber, and in a clear voice spoke as follows:

Honorable Gentlemen of the Legislative Council, & Gentlemen of the Legislative Assembly:

In opening the Third General Assembly of Vancouver Island, I have great pleasure in observing that among the events of national importance which have marked the period since the last meeting of Parliament, none have excited a more general degree of public interest than the marriage of His Royal Highness the Prince of Wales; that event has called forth expressions of the warmest sympathy and attachment from every part of the Empire, and I regret that you have not had an opportunity since that auspicious occasion, so intimately connected with the happiness of our Sovereign, and her family, of manifesting in your public character, the loyalty and devotion of this Colony.

I shall soon lay before you a copy of a communication which I lately received from Her Majesty's principal Secretary of State for the Colonies, containing proposals on the part of the Atlantic, and Pacific Transit, and Telegraph Companies, for establishing Telegraphic, and Postal communication between British Columbia and the head of Lake Superior, and also of the answer returned by Her Majesty's Government to these proposals.

By this contemplated arrangement it is proposed that Canada, British Columbia, and Vancouver's Island, should guarantee to the Company a profit on capital expended at the rate of not less than four per cent, nor more than five per cent, per annum, it being, however provided, that the total annual payment to be made by Vancouver Island, and British Columbia, jointly, shall in no case exceed the sum of £12,500 to be borne, if necessary, by the respective colonies, as may be agreed upon.

I have to recommend this project to your favorable attention, as the conditions are not unreasonable considering the magnitude of the undertaking and the advantages which this Colony will reap from the faithful execution of the enterprise.

Before concluding any arrangement on the terms proposed it should, however, be stipulated as an express condition of the guarantee that the Telegraph and Postal communication shall be extended to Vancouver Island.

I will also cause to be laid before you a dispatch containing the decision of Her Majesty's Government with reference to the form of government to be adopted in the colonies of British Columbia and Vancouver Island—a measure which will be carried into effect, and the colonies be placed under different Governors so soon as the proper financial arrangements are made for the permanent support of the Government.

Her Majesty's Government are of opinion that a permanent Act of the Legislature should be passed securing to the principal officers of the Colony salaries at the rates suggested in the aforesaid despatch; and, also that the initiation of all money votes should be secured to the Government.

When this is done Her Majesty's Government will be prepared to hold the Crown Revenue of Vancouver Island at the disposal of the Legislature of the Colony, retaining only such temporary power over the land as will enable Her Majesty's Government to close its transactions with Hudson Bay Company. When this is effected, Her Majesty's Government will be ready to transfer the management of the Revenue to the Colonial Legislature.

In concluding this subject I desire to call the attention of the Legislature to the opinion so impressively given in this despatch by the able statesman at the head of the Colonial Department in favor of a union of the Colonies under one Government, an opinion which comes with the weight of a wide experience in the workings of Colonial Institutions, and which will, I trust, exercise a due influence in your deliberations.

I have great satisfaction in stating that the native Indian tribes continue to evince a friendly disposition, and that nothing has occured to disturb the peace of the outlying settlements, which will be protected by the occasional visits of Her Majesty's ships.

I have to congratulate you, Gentlemen, on the state of the public revenue for the half year ending the 30th June last. You will observe by the return which will be laid before you, a remarkable increase for that period, representing a sum more than equal to the whole amount of revenue collected for the corresponding six months of the year 1862.

The half yearly Reports from the Treasurer and Harbor Master, which I have had prepared for your information, will exhibit that and other facts connected with the trade and financial condition of the Colony.

Gentlemen of the Legislative Assembly:-

I will cause to be prepared, and in due time submitted to you the Estimates for the year 1864, and in the mean time I have to call your attention to the importance of continuing the improvement of the Public Roads as recommended by the road commissioners, and of providing for the exploration of certain Districts, where valuable minerals are believed to exist.

Assistance will be asked for carrying these objects into effect, and also for establishing elementary schools in the country districts where the settlers have at present no means of educating their children. This latter object will not involve a present outlay of more than a few hundred pounds, to aid in the erection of school houses and of suitable residences of their teachers. The salaries of the teachers may be provided for, as required, in the annual Estimates.

Honorable Gentlemen of the Legislative Council, & Gentlemen of the Legislative Assembly

A Bill for restraining the issue of Writs of Capias in the case of actions accruing in a Foreign Jurisdiction, unless the defendant has been resident in the Colony for a term of 30 days; and also a Bill to alter and amend the Act for Incorporating the Town of Victoria, and Bill to facilitate the collection of Small Debts, and to reduce the costs, and modify the present procedures will, with other matters, be introduced and submitted in the course of the session for your consideration.

It being desirable that the Fire Department of Victoria should be placed under the control of the Mayor and Corporation, and that members of this institution should, in consideration of their valuable and efficient services, be exempted from doing duty on juries, measures having these objects in view will be submitted to you.

In the settlement of all these matters for the prosperity and happiness of the Colony much must depend upon your wisdom and foresight, and, in conclusion, I can but express the fervent hope that the blessings of the Almighty may ever rest upon your labors.

His Excellency then took his leave, and His Honor David Cameron, Esquire, Chief Justice, declared the House duly opened.

The Governor's speech was listened to with profound attention.

The Speaker then took the Chair, Mr. De Cosmos read pro forma a Bill entitled an Act to promote the security of Vessels entering the Harbor of Victoria.

Mr. Ridge moved, and Mr. Duncan seconded, that the House adjourn to 3 o'clock tomorrow, to consider the reply to the Governor's Speech.

Motion carried, and House adjourned accordingly.

The House met at 3 P. M. persuant to adjournment.

- Mr. Speaker informed the House that Mr. Tyrwhitt Drake has been appointed examiner of Recognisances to the House.
- Mr. Ridge, by permission, presented a Petition from certain Auctioneers of Victoria Town, praying for a reduction of the amount of Tax levied on them by present Act.

Ordered to lie on Table of the House.

Mr. Speaker read the Governor's Address.

Mr. Ridge moved the following Reply thereto, which was seconded by Mr. Powell, and after discussion, carried unanimously.

May it please Your Excellency

The House of Assembly of Vancouver Island and its dependencies, has received with satisfaction Your Excellency's Address at the opening of this session, for which they have to tender their respectful thanks.

The House fully appreciates the great importance of the topics alluded to, and the measures suggested in the Speech of Your Excellency, and beg to say, that they will devote their earliest and best attention to their consideration—as soon as they are put in possession of the requisite data to enable them to do so.

The House then adjourned to Monday next at 3. P. M.

Mr. De Cosmos moved that a Committee be appointed to draw up an Address of congratulations to H. R. H. The Prince of Wales on His marriage with the Princess Alexandra.

Seconded by Mr. Jackson, and Carried unanimously.

Moved by Mr. De Cosmos, seconded by Mr. Street, "That a Committee be appointed to enquire what better accommodation can be afforded to the Press."

Mr. De Cosmos—(pursuant to Notice)—Seconded by Mr. Street moved "That a Committee be appointed to report 1. On the mineral resources of the Colony—their character, extent, and location, so far as may be generally known.
What regulations may be deemed necessary to facilitate the development of the mineral wealth of the Colony."

Carried unanimously, and Committee appointed viz.: Messrs. Pidwell, Bayley, Powell.

Mr. Pidwell pursuant to notice brought forward his motion, "That The House go into Committee to consider the Despatch of His Grace the Duke of Newcastle dated June 15th 1863."

Motion not seconded.

Mr. Street brought forward the following resolution.

That a Committee be appointed to report on the extent, and condition of the Public Roads, throughout the Colony.

- 2. What improvements ought to be made in the Public Roads, specifying the particular Road.
  - 3. What new Roads ought to be opened.
  - 4. By whom Road appropriations may be best expended.
- 5. Whether it is not desirable to incorporate in the appropriations for Roads, the Amount to be expended in each District, and particularise what Roads are to be improved.

Seconded by Mr. Duncan.

The following Amendment was moved by Colonel Foster, and Seconded by Mr. Burnaby.

That a Committee be appointed to report on the State of Roads in this Colony, and to recommend such improvements and extensions to such Roads as may be thought advisable.

Mr. Street withdrew his motion, in favor of the amendment, which became the Resolution and was so carried, and

The following Members were appointed a Committee: Colonel Foster and Messrs. Street, Carswell, Burnaby, Jackson.

Mr. De Cosmos pursuant to notice, brought forward the following Resolution.

That a Committee be appointed to report

- 1. What improvements ought to be made in Victoria Harbor.
- 2 What improvements the Executive design making in Victoria Harbor.
- 3. At what time The Executive expect to commence the Improvement of Victoria Harbor, and why the improvements are delayed.
- 4. What funds are at hand at the disposal of the Executive to be expended in Harbor improvements.
- 5. From what source funds are raised, or purposed to be raised, for Harbor improvements.
- 6. Whether the funds in hand, or expected, be sufficient to make the necessary improvements, and if not, what is the deficiency?
- 7. Such Suggestions, or remarks as the Committee may think proper, in order to lay before this House the fullest information respecting the Improvement of Victoria Harbor.

Seconded by Mr. Duncan, and Agreed to.

The following Committee was then appointed viz.: Messrs. W. A. G. Young, A. De Cosmos, I. W. Powell, J. C. Ridge.

Mr. De Cosmos—from the Committee of the House appointed on the Address to H. R. H. the Prince of Wales, reported the same, which was read a first time.

The House then adjourned to Monday the 21st Instant at 3. p. m.

Mr. De Cosmos brought forward the following Resolutions-viz.

- 1. Resolved That This House is of opinion that a Treaty, establishing unrestricted commerce, and navigation, between this Colony, and the United States of America, would be mutually advantageous.
- 2. Resolved That the Government of British Columbia be invited to cooperate with the Government of this Colony in order to secure a reciprocity Treaty between both Colonies and the United States of America, on satisfactory terms to all the parties concerned.
- 3. Resolved That the Governor be requested to take steps either by the Appointment of Delegates or otherwise as he may deem expedient, to communicate the wishes of this House to the Government of British Columbia, and otherwise to secure the speedy establishment of a reciprocal Commercial Treaty between this Colony and the United States of America.

Dr. Helmcken had great pleasure in seconding the Honble. Mover of the Resolutions. The Treaty contemplated would tend greatly to bring about a Union of the Colonies of British Columbia, and Vancouver Island.

Mr. Young, and other Honble. members also spoke in favor of the Treaty.

The first Section was then put, and carried unanimously.

Second Section put and Carried (dissentiente Mr. Bayley).

Third Section put, and carried unanimously.

The Committee then rose.

Mr. Speaker took the Chair.

The Chairman reported the foregoing Resolutions as carried, and agreed to as a Whole.

Ordered That Report be adopted and a Copy of the same forwarded to His Excellency The Governor.

The House then adjourned to Friday next at 3. P. M.

# Monday, the 21st day of December, 1863

The House met this day at 3. P. M.

Present: Mr. Speaker in the Chair, Messrs. Burnaby, W. A. G. Young, Chs. Ridge, Dennes, Duncan, De Cosmos, Carswell, Dr. Powell, and Col. Foster.

The last minutes having been read, and confirmed.

Mr. Speaker read a Communication from the Legislative Council giving cover to a Bill intituled "An Act to amend an Act entitled An Act for the Protection of Wooden Bridges in Vancouver's Island and its Dependencies" which had been read a 3rd time and passed the Council on the 17th Instant.

- Mr. Ridge gave notice of motion (vide Notice Book Page 49.).45
- Mr. Young moved that the Standing Orders of the House be suspended in order that a Bill might be introduced to indemnify the Mayor and Corporation of Victoria.

2nded by Mr. Burnaby, and carried unanimously.

The Standing Orders having been suspended accordingly, "A Bill to indemnify the Mayor and Council of the City of Victoria" was introduced by Mr. Young, and read a 1st and 2nd time.

It was further committed on the 2nd Reading.

Mr. Young further moved That leave be granted to introduce "A Bill to render valid the collection of Licenses, and Assessments by the Mayor and Councillors of the City of Victoria."

Also "A Bill to enable the Governor to apply certain monies to the redemption of Municipal Debentures."

Leave granted, and Bills read a 1st time and ordered to be printed.

Mr. Dennes asked leave to postpone the motions of which he'd given notice till after the holidays.

Leave granted.

On the motion of Mr. Duncan 2ded by Mr. De Cosmos—The "Bank Note Act, 1863" was read a Second time, and committed.

The House then went into Committee of the Whole.

Mr. Speaker left the Chair.

Dr. Powell in the Chair of the Committee.

The Committee took up "A Bill to Incorporate the Chamber of Commerce"—which was agreed to without alteration or amendment.

Also "A Bill for the relief of John Copland"—which was agreed to as amended.

The Standing Orders having been suspended the Committee then took up the "Bill to indemnify the Mayor and Town Councillors of Victoria."

The Committee then rose.

Mr. Speaker resumed the Chair.

The Chairman reported that, having had under consideration the Several Bills submitted to it, The Committee had agreed to the "Bill to incorporate the Chamber of Commerce" without alteration or amendment.

Also that it had agreed to, as amended, "A Bill to relieve John Copland."

That it had agreed to, without alteration, or amendment, "A Bill for indemnifying the Mayor and Councillors of the City of Victoria."

Ordered That the Report be received.

The last named Bill was then read a 3rd time and passed.

Mr. Speaker then adjourned the House to the 7th day of January next.
