REPORT OF SELECT COMMITTEE.

CLAIMS OF LOUIS AND EDWARD GOLD TO CERTAIN LAND.

Mr. Speaker:

Your Select Committee appointed to enquire into the claims of Louis and Edward Gold to certain land in the vicinity of Lot 392, Group 1, New Westminster District, beg to report as follows:—

After hearing Mr. E. Gold and the evidence produced by him, and reading the correspondence which took place with reference to the land in question, most respectfully recommend that the Government should take into their consideration the advisability of allowing Messrs. Gold to complete the purchase of said land at \$2.50 per acre.

EVIDENCE.

Edward Gold, of Vancouver, British Columbia, saith:—That on the 24th of December, 1883, my father, Louis Gold, and myself applied to the Honourable Governor Trutch, Dominion Commissioner of Lands and Works, for a Crown Grant to the lands situate in New Westminster District, plans and description as in copy hereunto annexed.

He replied that our application would be filed first. My father and myself have expended over \$500 on said described lands, viz.: In making surveys, putting roads into and on the lands,

building house, clearing, burning, and slashing, and making rail fencing.

I produce account book, in my own handwriting, showing an actual expenditure of \$431.23, but as a matter of fact several other sums not set out in said book were also expended on said land, inasmuch as we bond fide believed we would be allowed to purchase said land. Said land is valuable as agricultural land, and is about four miles from Vancouver City. No other person or corporation claims, or pretends to claim, any interest in said land.

I beg to hand into your Hon. Committee copies, as supplied me from the office of Woods, Turner & Gamble, land surveyors, New Westminster, of the correspondence herein, which fully

sets out the description of the lands, and which I crave leave to refer:-

The piece of land applied for by me is marked A, in letter of 24th December, 1883, to Hon. J. W. Trutch.

The piece applied by my father, Louis Gold, is marked B in letter of 24th December,

1883, to Hon. J. W. Trutch.


My father, Louis Gold, is at present in Liverpool, England, and therefore unable to appear personally before this Hon. Committee, and I expect him to return in the course of the year. In all about \$800 or \$900 were spent on the two claims, but the book containing enpenditures on my claim was burned in the great Vancouver fire.




