"The 'News-Advertiser' editorially to-day refers to local rumours that Premier Prior, when acting Chief Commissioner last year, awarded a contract to his firm for the cable for Chimney Creek bridge. * * * * On making enquiries to learn if there was any foundation for these reports, the following is gleaned from a gentleman who came from the Terminal City recently:—In September last, it is alleged, a Vancouver agent was requested by the Lands and Works Department to tender for wire rope, etc., in accordance with certain specifications for Chimney Creek bridge. This he sent to the Department on September 30th. On December 19th he was advised by the Department that the contract had been awarded to E. G. Prior & Co. The length of time that elapsed between the sending in of his tender and the advice of the Department awarding the contract awakened his suspicions, so he started on a still hunt for information. Bit by bit, certain facts came to his knowledge. He learnt, as he states, that Messrs. Prior & Co. cabled for prices after the tenders had been opened, and then that a clerk from that firm had access to the tenders, which enabled them to put in a lower bid, and thus secure the contract when Mr. Wells returned:"

And whereas, when the substance of the statements contained in such extracts was brought to the attention of the Honourable Premier, the Hon. E. G. Prior, on the floor of the House on the same date, he failed to give any denial of the real gravamen of the charge, to wit, that his firm had put in its offer after all the other quotations of other firms had been received, and after a clerk from his firm had access to the tenders, but he admitted that after his election to a seat in the House of Commons at Ottawa some years ago he had changed his mercantile establishment into a limited liability company, meaning into the said firm of E. G. Prior & Co.,

with the express object in view of tendering for Government supplies:

Be it, therefore, Resolved, That a Committee of five members of this House, consisting of Messrs. Hall, Hayward, Helmcken, Tatlow and Curtis, be appointed to investigate forthwith the statements hereinbefore referred to, and that it is highly in the public interest that the House should not be prorogued until the report of such Committee be made, with power to call for persons, books and papers and report to this House, with the evidence.

Bill (No. 58) intituled "An Act to amend the 'Vancouver General Hospital Act, 1902," was introduced and read a first time.

Mr. Martin moved in amendment to add the following words:—"in view of the admissions of Sir T. G. Shaughnessy made before a Committee of this House."

A debate arose, which was adjourned until to-morrow.

Prayers by the Rev. Dr. Campbell, Ph. D.

Mr. Rogers presented 21 petitions from the Bank of British North America and others, asking for amendments to the Mineral and Placer Acts.

Laid on the table.

Mr. Hall presented a report from the Select Committee appointed to inquire into the letting of the contract to E. G. Prior & Co., Limited, for supplying a wire cable for the Chimney Creek bridge, as follows:—

To the Speaker of the Legislative Assembly of the Province of British Columbia:

SIR,—We, your Select Committee appointed to inquire into all matters connected with the granting of a contract to supply wire cable for Chimney Creek bridge, beg leave to report as follows:—

1. That Mr. Wells, Chief Commissioner of Lands and Works, was absent from his Department from the 24th October till early in December, 1902.

2. That Colonel Prior was acting Chief Commissioner in his absence.

3. That previous to Mr. Wells' departure, certain firms suggested by Mr. Waddell were communicated with, asking for bids for wire cable to be used in construction of Chimney Creek bridge. These bids were received from time to time, and not being endorsed on the envelope as tenders, were opened and treated as ordinary communications. In all, quotations were received from four firms, as follows:—

October 3rd.—Dominion Wire Rope Company, Montreal, \$5,917. October 4th.—Dominion Wire Rope Company, Montreal, \$5,581.

October 6th.—Darling & Company, Vancouver, \$3,881. November 8th.—Darling & Company, Vancouver, \$3,450.

September 30th.—W. A. McLennan & Company, Vancouver, \$5,225.

October 27th.—A. Leschen & Sons, St. Louis, \$3,380.

4. A schedule, summarising the above tenders, was submitted to the acting Chief Commissioner by Mr. Gamble on November 12th, 1902, who asked for instruction as to the awarding of the contract.

5. The acting Chief Commissioner wished to know why the firm of E. G. Prior & Company,

Limited, had not been asked to make a quotation.

6. The acting Commissioner instructed Mr. Gamble to hold the matter in abeyance until the firm of E. G. Prior & Company, Limited, were given an opportunity to bid, in consequence of which the firm of E. G. Prior & Company, Limited, sent in a bid on December 6th of \$3,216.39, being \$170 less than any of the former quotations.

7. The firm of E. G. Prior & Company, Limited, were notified on the 12th December of

the acceptance of their bid.

8. The condition attached to the firms first requested to send quotations was that the wire cable should be delivered not later than March 30th, 1903, at Ashcroft, in order to ensure transportation before the breaking up of the roads. No guarantee was given by E. G. Prior & Company, Limited, although they promised to endeavour to make delivery as near as possible to that date.

- 9. The firm of E. G. Prior & Company, Limited, was so incorporated in 1891, with Colonel Prior holding a controlling interest in that firm.
- 10. The acting Chief Commissioner, on the 15th of November, requested Mr. Gamble to send to his office, in the Department of Mines, the papers in connection with bids for wire cable, and as Mr. Gamble was going away he (Mr. Gamble) wrote to his draughtsman, Mr. Cookson to take those papers to Colonel Prior, which Mr. Cookson did about the 17th November, 1902,
 - 11. There is a conflict of testimony on the following points:
- (a.) Mr. Cookson swore that the only document he took to Colonel Prior after getting Mr. Gamble's letter was the schedule of tenders that Mr. Gamble had first placed before Colonel Prior.
- (b.) Colonel Prior swore that specifications for the cable accompanied the schedule handed him by Mr. Cookson, and that he showed only such specifications to Mr. Schwengers, an employee of E. G. Prior & Company, Limited, who was looking after the tendering for the wire cable for such Company. Mr. Schwengers also swore that he saw only the specifications in Colonel Prior's office.
- (c.) Mr. Gamble, on the other hand, swore that he instructed Mr. Cookson by note to send all the papers to Colonel Prior.
- 12. Colonel Prior swore that he had never communicated the other firms' bids to any member or employee of E. G. Prior & Company, Limited, which was corroborated by Messrs. Wynne, Schwengers and Mathews, members and employees of such Company; nor had he, Colonel Prior, assisted in any way in preparing the firm's bid, nor had he allowed any employee or member of his Company to have access to the said schedule of tenders.

All of which is respectfully submitted.

"Premier's Office, Victoria, B. C., 2nd June, 1903.

" Hon, R. G. Tatlow,

"President, Executive Council, Victoria:

"Dear Captain Tatlow,—As, under the circumstances, it is impossible for me to make an official statement in the House, I am handing you this letter that you may read it for the purpose of acquainting the Members of the Legislature of the position of affairs.

"After most careful consideration, and in view of the anticipated dissolution of Parliament, I have fully decided that the interests of the country would be best served by a division on party lines. Personally, I have always favoured this course, and feel sure the electorate,

as a whole, is desirous that local affairs in the Province should be so administered.

"The Government to be formed will be Conservative in character, and after dissolution it is the intention to make an appeal to the country at the earliest possible moment. In the preparation of the voters' list, and in all other matters pertaining to the forthcoming elections, everything will be done to permit of public opinion having the fullest and fairest expression at the polls.

"Had Parliament continued to the expiry of its legal existence a composite Government would have been formed, and I cannot allow this occasion to pass without placing on record my appreciation of the valued co-operation of the Liberals who were my colleagues in the Opposition ranks. They are entitled to, and have, my warmest thanks; and under other circumstances than those to which I have alluded, I should have had much pleasure in recognising their services by a proportion of seats in the Cabinet.

His Honour the Lieutenant-Governor having entered the House, and being seated in the Chair,

Then the Honourable Mr. Speaker addressed His Honour the Lieutenant-Governor as follows:—

MAY IT PLEASE YOUR HONOUR:

We, His Majesty's most dutiful and loyal subjects, the Legislative Assembly of the Province of British Columbia, in Session assembled, approach Your Honour at the close of

our labours with sentiments of unfeigned devotion and loyalty to His Majesty's person and Government, and humbly beg to present for Your Honour's acceptance a Bill (No. 69) intituled "An Act for granting certain Sums of Money for the Public Service of the Province of British Columbia."

To this Bill the Clerk of the Legislative Assembly, by His Honour's command, did thereupon say:—

"In His Majesty's name, His Honour the Lieutenant-Governor doth thank His Majesty's loyal subjects, accept their benevolence, and assent to this Bill."

Then His Honour the Lieutenant-Governor was pleased to deliver the following gracious Speech :—

Mr. Speaker and Members of the Legislative Assembly:

I note that several measures of importance have been passed by you during the currency

of the present Session.

It has afforded me much pleasure to know that definite steps have been taken towards the settlement of the Alaska boundary question, and that the legal profession of this Province will be represented among the counsel retained by the Dominion of Canada.

It is also gratifying to know that greatly increased attention on the part of prospective settlers to Canada has been directed to British Columbia, and that there has been a considerable number of arrivals during the present season.

I thank you for the liberal supplies granted to His Majesty.

In relieving you from further attendance, it is with the sincere hope that the results of your deliberations may prove of lasting benefit to the Province.

The Hon. Mr. Tatlow then said:—

Mr. Speaker and Gentlemen of the Legislative Assembly:

It is His Honour the Lieutenant-Governor's will and pleasure that the Legislative Assembly be prorogued until it shall please His Honour to summon the same for dispatch of business, and this Provincial Legislative Assembly is hereby prorogued accordingly.
