Mr. H. E. Winch asked the Hon. the Minister of Lands and Forests the following questions:---

2. If so, (a) what area does it include and (b) does it cover any area previously reforested by the Forestry Department and, if so, what financial arrangement, if any, has been made to reimburse the Government for moneys expended?

"1. No; a forest management licence has been issued to the Canadian Western Timber Company, Limited, of Vancouver; the lands on Vancouver Island committed to this agreement are company lands, the Crown lands being in the islands and on the mainland to the north of Campbell River.

"2. (a) The area includes 133,153 acres of company lands, and the boundaries of the Crown lands enclose 237,475 acres; of this Crown area, however, only the stands now immature (approximately 114,000 acres) and related waste lands (approximately 39,000 acres) are at the disposal of the company. (b) Yes; a small experimental plantation of which approximately 240 acres is considered to be established as a commercial plantation; since the moneys expended on this plantation were on an experimental basis, no reimbursement was considered necessary."

Mr. Smith asked the Hon. the Minister of Lands and Forests the following questions:---

1. Has any investigation been made of a western route for a highway to Alaska?

2. If yes, what was the result of such investigation?

3. Are any plans pending for further consideration of such a highway?

The Hon. Mr. Kenney replied as follows:---

"1. Yes.

"2. The area immediately east of the Coast Mountains was photographed from the air by the three-camera method from Hazelton to Telegraph Creek in 1947 and partly from Telegraph Creek to Atlin in 1948; bad weather prevented completion of the latter project.
