- "(b) where the deceased is survived by a spouse, to property or the transmission of a beneficial interest in property passing on the death of the deceased to or for the benefit of a dependent where the sum of the value of the property passing on the death of the deceased to or for the benefit of dependents does not exceed sixty thousand dollars, and where the sum of the value of the property passing on the death of the deceased to or for the benefit of dependents exceeds sixty thousand dollars there is exempt from duty in the case of each dependent an amount of property that bears the same ratio to the dutiable value of property passing on the death of the deceased to him or for his benefit as sixty thousand dollars bears to the sum of the value of the property passing on the death of the deceased to dependents or for their benefit; nor
- "(c) where a deceased is not survived by a spouse, to property or the transmission of a beneficial interest in property passing on the death of the deceased to or for the benefit of a child where the sum of the value of the property passing on the death of the deceased to or for the benefit of children does not exceed fifty thousand dollars, and where the sum of the value of the property passing on the death of the deceased to or for the benefit of children exceeds fifty thousand dollars there is exempt from duty in the case of each child an amount of property that bears the same ratio to the dutiable value of property passing on the death of the deceased to him or for his benefit as fifty thousand dollars bears to the sum of the value of the property passing on the death of the deceased to or for the benefit of children; nor
- "(d) to property or the transmission of a beneficial interest in property passing on the death of the deceased to or for the benefit of a father, mother, grandfather, grandmother, grandchild, daughter-in-law, or son-in-law of

the deceased where the net value of all of the property passing on the death of the deceased does not exceed fifty thousand dollars; nor ".

(b) Renumber clauses (f) to (n), inclusive, as clauses (e) to (m).

Section 11: (a) To strike out subsections (2), (3), (4), (5), and (6) of the

proposed new section 10A and substitute the following as subsection (2):—

"(2) There may be deducted from the duty imposed under this Act in respect of property or the transmission of a beneficial interest in property passing to or for the benefit of a father, mother, grandfather, grandmother, grandchild, daughter-in-law, and son-in-law of the deceased the amount (if any) by which the duty otherwise payable exceeds one-half of the portion of the amount (if any) by which the net value of all of the property passing on the death of the deceased exceeds fifty thousand dollars that bears the same ratio to the net value of all of the property passing on the death of the deceased that the duty otherwise payable in respect of property passing to or for the benefit of the person bears to the duty otherwise payable in respect of property passing to or for the benefit of all of the persons referred to in the heading of the second column of the Table of Rates in Schedule C."

 - 1. How many approved nursing homes in British Columbia?
 - 2. How many patients can be accommodated in these homes?
- 3. What is the *per diem* cost to the Province per patient for chronic cases in approved nursing homes?
- 4. What is the *per diem* cost to the Province per patient for chronic cases in hospital?
- 5. How many patients in Government-approved hospitals are carrying Provincial medical welfare cards?

The Hon. E. C. F. Martin replied as follows:—

- "1. As at February 28, 1963, there were sixty-six nursing-home facilities licensed as private hospitals under Part II of the *Hospital Act*.
 - "2. As at February 28, 1963, 2,516.
- "3. This Department does not make payments on behalf of patients to nursing-home facilities.
- "4. Payment for patients receiving active treatment in rehabilitation, chronic, and convalescent hospitals varies from one hospital to another. However, the average approved cost per patient-day for in-patient care in these facilities was \$14 in 1962.
- "5. This information is not readily available because a tally of the number of social welfare recipients in hospital is not kept. Claims submitted by hospitals in respect of these patients are processed in the same manner as other hospital claims."

Mrs. Mather asked the Hon. the Minister of Health Services and Hospital Insurance the following question:—

What was the current per diem per capita patient cost figure for the Provincial Infirmaries as at March 31, 1962?

The Hon. E. C. F. Martin replied as follows:— "\$9.17."

Mr. *Dowding* asked the Hon. the Minister of Health Services and Hospital Insurance the following questions:—

- 1. During the year 1962 did any psychiatrists resign from the Mental Health Services?
- 2. If the answer to No. 1 is yes, (a) what was the total number of resignations, (b) in which departments did the resignations take place, and (c) what reasons, if any, were given for the resignations in each case?

The Hon. E. C. F. Martin replied as follows:—

- "1. Yes.
- "2. (a) Four; (b) Crease Clinic and Provincial Mental Hospital, 3; Mental Health Centre, Burnaby, 1; and (c) to enter private practice, 3; personal reasons, 1."

Mr. *Dowding* asked the Hon. the Minister of Health Services and Hospital Insurance the following questions:—

- 1. What was the total number of psychiatrists employed at the Provincial Mental Hospital at Essondale as at December 31, 1962?
- 2. What was the total number of patients in the Provincial Mental Hospital at Essondale as at December 31, 1962?

The Hon. E. C. F. Martin replied as follows:—

- "1. Psychiatrists, 15; other medical specialists, 2; other physicians, 21; and total, 38.
 - "2. 2,762."

Mr. Perrault asked the Hon. the Minister of Health Services and Hospital Insurance the following questions:—

- 1. What was the total number of acute hospital beds available in British Columbia for patients on December 31, 1962?
 - 2. How many of these beds were in public hospitals?
 - 3. How many in Federal hospitals?
 - 4. How many in private hospitals?

The Hon. E. C. F. Martin replied as follows:—

- "1. 9,443.
- "2, 8,800.
- "3. 545. (It should be noted there is no fixed allocation of beds in veterans' hospitals between patients under care for pensionable disability and those under hospital insurance coverage. During 1962 the volume of care given to patients under British Columbia Hospital Insurance Service coverage in Federal hospitals required the use of approximately 545 beds.)
- "4. Ninety-eight. (This figure includes the average number of beds utilized for patient-care for which patient-days are accepted by the British Columbia Hospital Insurance Service in Hollywood Hospital, New Westminster.)"

Mr. Calder asked the Hon. the Minister of Health Services and Hospital Insurance the following question:—

With reference to Public Health Services, has the Provincial Government made any investigation into the need of a mobile dental clinic for dental treatment in unorganized areas of the Province?

The Hon. E. C. F Martin replied as follows:—

"Yes. Sets of especially designed transportable dental equipment, incorporating the latest high-speed air-rotor units, are available for this purpose."

Mr. Cox asked the Hon, the Minister of Social Welfare the following questions:—

With reference to persons being employed at the Boys' and Girls' Industrial Schools:—

- 1. What is the normal period of satisfactory temporary employment required before an employee is placed on permanent staff?
- 2. Are temporary employees entitled to participate in any benefits allowed to permanent employees?
 - 3. If the answer to No. 2 is yes, what are the benefits?

The Hon. W. D. Black replied as follows:-

- "1. Six months' probationary period.
- "2. Yes.
- "3. Full-time, casual, continuous employees are entitled to same benefits as permanent employees; part-time, casual employees are entitled to same benefits as permanent employees with the exception of group life insurance."

Mr. Calder asked the Hon. the Minister of Health Services and Hospital Insurance the following questions:—

- 1. Are there any community preventive dental clinics in British Columbia?
- 2. If the answer to No. 1 is yes, where are they located?

The Hon. E. C. F. Martin replied as follows:-

- "1. Yes.
- "2. They are located in the following centres: Fernie, Michel-Natal, Jaffray, Cranbrook, Kimberley, Edgewater, Invermere-Windermere, Creston, Crawford Bay, Golden, Parson, New Denver, Crescent Valley, Nakusp, Grand Forks, Greenwood, Rock Creek, Revelstoke, Salmon Arm, Armstrong, Vernon, Enderby, Keremeos, Princeton, Kelowna, Summerland, Kamloops, Barriere, Clearwater, Blue River, Lillooet, Bralorne, Ashcroft, Clinton, Lytton, Merritt, Hope-Boston Bar, Chilliwack, Haney, Mission, Agassiz, Grandview Heights, Halls Prairie, East Kensington, Kensington Prairie, Port Kells, White Rock, Boundary Bay, Delta Central, East Delta, Ladner Christian, North Delta, Vancouver Wireless Station, New Westminster, Port Coquitlam, Sechelt Peninsula, Squamish, Pemberton, Woodfibre, Port Renfrew, Sidney, Ganges, Duncan, Lake Cowichan, Ladysmith, Chemainus, Nanaimo, Parksville, Bamfield, Tofino, Ucluelet, Powell River, Westview, Texada Island, Lasqueti Island, Denman Island-Hornby Island, Cumberland-Fanny Bay, Campbell River, Sayward, Cortez Island, Alert Bay, Sointula, Port McNeill, Kokish, Nimpkish Lake, Port Alice, Port Hardy, Lac la Hache, Quesnel, Sandspit, Queen Charlotte Islands, Port Clements, Masset, Stewart, Prince Rupert, Terrace, Hazelton, Houston, Quick, Telkwa, Fort St. John, Burns Lake, Southbank, Vanderhoof, Prince George, Mc-Bride, and Tahsis."

Mr. Dowding asked the Hon. the Minister of Health Services and Hospital Insurance the following question:—

How many male and how many female patients were admitted to The Woodlands School during the calendar year 1962?

The Hon. E. C. F. Martin replied as follows:—

"Male patients, 122, and female patients, 95."

Mr. Dowding asked the Hon. the Minister of Health Services and Hospital Insurance the following question:—

At The Woodlands School, how many (a) psychiatric nurses, (b) psychiatric aides, (c) social welfare workers, (d) teachers, and (e) psychologists were employed on January 1, 1962?

The Hon. E. C. F. Martin replied as follows:—

"(a) 248, (b) 355, (c) 5, (d) 13, and (e) 3.

"Note.—The corresponding figures for January 1, 1963, are as follows: (a) 251, (b) 346, (c) 8, (d) 13, and (e) 3."

Mr. Dowding asked the Hon. the Minister of Health Services and Hospital Insurance the following questions:—

- 1. Are there any mentally retarded patients in the Provincial Mental Hospital at Essondale?
- 2. If the answer to No. 1 is yes, (a) how many are there at present and (b) how long have they been patients in the Mental Hospital?

The Hon. E. C. F. Martin replied as follows:-

"1. Yes.

- "2. (a) As of December 31, 1962, 255, and (b) less than one year, 16; one to five years, 21; six to ten years, 44; and over ten years, 174."
- Mr. Dowding asked the Hon. the Minister of Health Services and Hospital Insurance the following questions:—

With respect to The Woodlands School:-

1. Is there a known number of patients awaiting entry?

- 2. If the answer to No. 1 is yes, how many were known to be waiting as at December 31, 1962?
- 3. Were there any empty beds in The Woodlands School as at December 31, 1962?
 - 4. If the answer to No. 3 is yes, (a) how many and (b) what was the reason?

The Hon. E. C. F. Martin replied as follows:-

"1. Yes.

- "2. Applications have been received on behalf of 816 persons. Clinical assessment has shown that 253 of these persons are not in immediate need of institutional care. Therefore, they have been placed in the deferred category. It is planned to continue the clinical assessment programme with respect to all new applications for admission in order that those who do not require immediate care in an institution may be identified.
 - "3. No; all beds are assigned.
 - "4. Answered by No. 3."

- Mr. Dowding asked the Hon. the Minister of Health Services and Hospital Insurance the following questions:—
- 1. Did any graduate psychiatric nurses resign from the Mental Health Services during the year 1962?
 - 2. If the answer to No. 1 is yes, how many resigned?

The Hon. E. C. F. Martin replied as follows:—

- "1. Yes.
- "2. Personal and family reasons, 89; moving from the area, 42; other employment, 27; health reasons, 18; for further education, 13; miscellaneous reasons, 12; and total, 201."
- Mr. Calder asked the Hon. the Minister of Health Services and Hospital Insurance the following questions:—

With reference to Public Health Services:-

- 1. Is there a public health doctor at Cassiar?
- 2. If the answer to No. 1 is yes, (a) what is his name and (b) has the Provincial Government any agreement to share a retainer fee for this doctor with Cassiar and (or) the Indian Affairs Branch?
- 3. If the answer to No. 2 (b) is yes, what is the amount paid by (a) Cassiar and (b) the Indian Affairs Branch?

The Hon. E. C. F. Martin replied as follows:—

- "1. No; company doctor only.
- "2. Answered by No. 1.
- "3. Answered by No. 1."
- Mr. Calder asked the Hon. the Minister of Health Services and Hospital Insurance the fellowing questions:—

With reference to Public Health Services:-

- 1. Is there a public health nurse at (a) Lower Post, (b) Telegraph Creek, and (c) Atlin?
- 2. If the answer to No. 1 is yes, (a) what is the name and the salary paid to the public health nurse in each district, (b) has the Provincial Government any agreement with the Indian Affairs Branch to share the salary of the public health nurse for services rendered to the Indians in each district named, and (c) has the Provincial Government any agreement with the Department of Indian Affairs to share the cost of drugs provided to the Indians in each district named?

The Hon. E. C. F. Martin replied as follows:—

- "1. (a) No, Public Health Services administered through Peace River Health Unit; (b) yes, resident nurse; and (c) no, Public Health Services administered through Peace River Health Unit.
- "2. (a) Miss Lillian Whiteside is resident nurse at Telegraph Creek and receives a salary of \$356 per month, (b) one-half of Miss Whiteside's salary is recoverable from the Department of Indian Affairs, and (c) the Department of Indian Affairs pays for all curative drugs supplied to Indians. Biologicals for immunization are provided by the Provincial Government to all areas of the Province."

Mr. Dowding asked the Hon. the Minister of Health Services and Hospital Insurance the following question:—

What is the current per diem per capita patient cost at The Woodlands School?

The Hon. E. C. F. Martin replied as follows:—

"See Table A, page 21, Annual Report of the Mental Health Services Branch for year ended March 31, 1962."

Your Select Standing Committee on Public Accounts and Printing begs leave to report as follows:—

Your Committee summoned Mr. Willard E. The Hon. P. A. Gaglardi replied as follows:-

- "2. (a) \$164,230.53 and (b) \$124,344.09 to C.B.A. Engineering Limited, and \$29,886.44 to Boyles Bros. Engineering Drillers Limited and R. A. Spence."

2. If the answer to No. 1 is yes, (a) what was the substance of such recommendations, (b) were these recommendations accepted, and (c) if the answer to (b) is no, why were these recommendations rejected?

The Hon. P. A. Gaglardi replied as follows:—

- "2. (a) The alternate designs required 36-inch piles in lieu of 24-inch piles, (b) no, and (c) the design employing 24-inch piles was judged to be superior."

With respect to the Port Mann Bridge: -

1. Were any representations made by Perini Pacific Limited to the Department

of Highways concerning the definition of the term "glacial fill"?

2. Is there any record in the contractor's log book showing the time spent in drilling for (a) pile insertion through overburden and (b) the time spent drilling through glacial fill?

The Hon. P. A. Gaglardi replied as follows:-

"1. No representations were made concerning the definition of the term

'glacial fill.' Representations were made concerning the term 'glacial till.'

"2. No knowledge of records kept by the contractor. Consultants kept records of the time spent in drilling through the various layers described in the contract documents."

Mr. Calder asked the Hon. the Minister of Highways the following questions:—

- 1. With reference to the Bear River 1961/62 floods in the Stewart area, were any parts of the Bear River Road damaged, and repaired?
 - 2. If the answer to No. 1 is yes, what was the total cost of the road repairs?
 - 3. Were any parts of the Stewart-Cassiar Road damaged, and repaired?
 - 4. If the answer to No. 3 is yes, what was the total cost of the road repairs?
 - 5. Were any bridges of the Bear River Road damaged, and repaired?
- 6. If the answer to No. 5 is yes, what are the names of the bridges, and what was the total cost of repairs to each bridge?
 - 7. Were any bridges of the Stewart-Cassiar Road damaged, and repaired?
- 8. If the answer to No. 7 is yes, what are the names of the bridges, and what was the total cost of repairs to each bridge?
- 9. Were any bridges on the Bear River Road and Stewart-Cassiar Road totally destroyed, and then rebuilt?
- 10. If the answer to No. 9 is yes, what are the names of the bridges, and what was the cost of rebuilding each bridge?
- 11. Was any assistance given by the Stewart-Cassiar Road construction companies to the Department of Highways in combating the flood?
- 12. If the answer to No. 11 is yes, (a) what are the names of the companies, (b) how much, if anything, was paid per day to each company for machinery rental.
- (b) now much, if anything, was paid per day to each company for machinery rental, (c) how much, if anything, was paid per hour to each company for rental of a crawler-type shovel, or truck-mounted shovel, or front-mounted loader shovel, and (d) what was the total cost paid to each road construction company for assisting the Department of Highways in combating the flood?
- 13. What was the total cost spent by the Department of Highways in combating the flood?
 - 14. Was the Stewart wing dam or dyke damaged, and repaired?
 - 15. If the answer to No. 14 is yes, what was the total cost of the repairs?

The Hon. P. A. Gaglardi replied as follows:-

- "1. Yes.
- "2. \$106,733.26.
- "3. Yes.
- "4. Exact information not available as necessary repairs were carried out in conjunction with contract construction work.

- " 5. Yes.
- "6. Bear River Bridge No. 2 was damaged and repaired; Glacier Creek Bridge No. 85, while not destroyed, was rendered useless due to a change in course of Glacier Creek. A temporary bridge was built; a further change in the course of Glacier Creek and road repairs eliminated both the temporary bridge and Bridge No. 85. A new channel of Bear River required a temporary bridge near Bear River No. 2 Bridge; this was later washed out and a second temporary bridge built. A permanent bridge called the F. G. Goddard No. 83 was completed at this location in March, 1962. Costs were not segregated by individual bridge, but material costs other than native timber amounted to \$4,072.22.
 - "7. Yes.
- "8. Rufus Creek Bridge, and exact cost not available as relocation was involved, and carried out in conjunction with contract construction work.
 - "9. Yes.
 - "10. Bitter Creek Bridge No. 80 (answered by No. 6 with regard to cost).
 - "11. Yes.
- "12. (a) Dawson, Wade & Emil Anderson, Ben Ginter Construction Company; (b) daily costs for machinery rental varied from day to day; (c) Ben Ginter Construction Company received \$13 per hour for a 2½-cubic-yard front-end loader; Dawson, Wade & Emil Anderson received \$14 per hour for ¾-cubic-yard Bucyrus Erie shovel, truck-mounted, and \$25.50 per hour for ½-cubic-yard Northwest shovel, truck-mounted; and (d) Ben Ginter Construction Company, \$54,846.95; Dawson, Wade & Emil Anderson, \$36,408.23.
 - "13. \$114,534.11 (exclusive of contract work).
 - " 14. Yes.
 - "15. \$7,800.85."

Mr. Calder asked the Hon. the Minister of Highways the following questions:—

- 1. With reference to the \$56,368.94 which was spent on the Telegraph Creek–Dease Lake Road in 1957/58, what were the projects?
 - 2. How much was spent on each project?

The Hon. P. A. Gaglardi replied as follows:-

- "1. Day labour (minor betterments) and maintenance.
- "2. Day labour, \$20,000, and maintenance, \$36,368.94."

Mrs. Hobbs asked the Hon. the Minister of Highways the following questions:—

With respect to Project No. 779, contract awarded to Ben Ginter Construction Company, Kamloops, reference page J 89, Department of Highways Report, 1956/57:—

- 1. Has the project been completed?
- 2. If the answer to No. 1 is yes, what was the total amount paid the Ginter Construction Company for the project?
- 3. If the answer to No. 1 is no, (a) what is the total amount paid to the Ginter Construction Company to date and (b) how many miles have been constructed to date?

The Hon. P. A. Gaglardi replied as follows:-

- "1. Yes.
- "2, \$1,837,570.25.
- "3. (a) and (b) Answered by No. 1."

Mr. Perrault asked the Hon, the Minister of Highways the following question:—

With respect to construction equipment: What is the total value, based on new replacement prices, of the construction equipment owned by the Department of Highways, (a) in totals and (b) by categories: (i) Shovels, (ii) crawler tractors, (iii) scrapers, (iv) crushers, (v) pulvimixers, (vi) power-graders, (vii) trucks, and (viii) miscellaneous?

The Hon. P. A. Gaglardi replied as follows:—

"(a) \$26,765,200 and (b) (i) shovels, \$1,385,000; (ii) crawler tractors, \$3,764,000; (iii) scrapers, \$320,000; (iv) crushers, \$825,000; (v) pulvimixers, \$85,000; (vi) power-graders, \$6,203,000; (vii) trucks, \$6,785,600; and (viii) miscellaneous, \$7,397,600."

Mr. Perrault asked the Hon. the Minister of Highways the following questions:—

With respect to the Port Mann Bridge: -

1. Was the contractor's log book signed by a representative of the consulting engineers each day that drilling for piles was being done?

2. Did the bridge consultant request and require data concerning the time

spent drilling each type of material?

3. If the answer to No. 2 is no, has the Department of Highways demanded an explanation from the consulting engineers?

The Hon. P. A. Gaglardi replied as follows:—

"1. No.

- "2. The bridge consultant kept record of the time spent drilling each type of material.
 - "3. Answered by No. 2."

Mrs. *Hobbs* asked the Hon. the Minister of Highways the following question:— With reference to District Vote—Roads, how much was spent in each electoral district as at December 31, 1962?

The Hon. P. A. Gaglardi replied as follows:—

Mr. Perrault asked the Hon. the Minister of Highways the following question:-

With respect to rental contracts: What procedure is employed (a) to obtain quotations and (b) to award rental contracts for equipment engaged by the Department of Highways for day-labour work?

The Hon. P. A. Gaglardi replied as follows:—

"We have not had rental contracts as such, but have hired equipment on a daily basis at rates set out in a rental schedule drawn up in co-operation with other departments and the British Columbia Hydro."

Mr. Calder asked the Hon. the Minister of Health Services and Hospital Insurance the following questions:—

- 1. Has the Provincial Government any agreement with a non-resident doctor to visit (a) Alice Arm, (b) Good Hope Lake, (c) Lower Post, (d) Atlin, and (e) Telegraph Creek?
- 2. If the answer to No. 1 is no, has the Provincial Government made any investigation into the advisability of such an agreement?

The Hon. E. C. F. Martin replied as follows:—

"1. (a) Public Health Services are administered through Director, Skeena Health Unit, (b) no, (c) Public Health Services are administered through Director, Peace River Health Unit, (d) arrangements with physicians from Whitehorse for periodic visits, and (e) nursing services provided by resident nurse.

"2. Answered by No. 1."

Mr. Rhodes asked the Hon. the Minister of Highways the following questions:---

With reference to Bridge Project 267 (Port Mann Bridge) Contracts Nos. 1, 2, 3, 4, and 5:—

- 1. Have Contracts Nos. 3, 4, or 5 been completed?
- 2. If the answer to No. 1 is in the affirmative, which contracts have been completed and what was the final amount paid on each contract?
 - 3. Are any contracts uncompleted?
- 4. If the answer to No. 3 is yes, what are the total amounts paid to date on each uncompleted contract?
 - 5. Were there penalty clauses in all of the contracts let (Nos. 1, 2, 3, 4, and 5)?
- 6. If the answer to No. 5 is in the negative, which contract did not have penalty clauses and what was the name of the contractor involved?

The Hon. P. A. Gaglardi replied as follows:-

- "1. No.
- "2. Not applicable.
- "3. Yes, Contract Nos. 3, 4, and 5.
- "4. Contract No. 3, \$7,590,969.29; Contract No. 4, \$3,765,472.22; Contract No. 5, \$2,372,884.45.
 - " 5. No.
- "6. Contract No. 1, Miller Cartage & Contracting Limited; Contract No. 2, Vancouver Pile Driving & Contracting Company Limited; Contract No. 3, Perini Pacific Limited; Contract No. 4, John Laing & Son (Canada) Limited; and Contract No. 5, Dominion Bridge Company Limited."

Mr. Calder asked the Hon. the Minister of Highways the following question:— With reference to the maintenance of the Stewart-Cassiar Road: Is it the intention of the Department of Highways to consider the advisability of establishing a Department of Highways camp in the vicinity of Dease Lake in 1963?

The Hon. P. A. Gaglardi replied as follows:—
"Yes."

Mr. Perrault asked the Hon, the Minister of Highways the following questions:—

With respect to construction equipment:—

- 1. Has the Department of Highways made a survey of construction equipment, by categories, presently available in the Province of British Columbia from private contractors?
- 2. If the answer to No. 1 is yes, (a) when was the survey taken, (b) what is the approximate dollar total of the equipment available, and (c) what percentage of this equipment was idle at the time of the survey?

The Hon. P. A. Gaglardi replied as follows:—

" 1. No.

"2. Answered by No. 1.

Mr. Perrault asked the Hon. the Minister of Highways the following questions:—

With respect to new equipment purchases:-

- 1. By categories, what amounts were expended in (a) 1960/61 and (b) 1961/62 to purchase: (i) Shovels, (ii) crawler tractors, (iii) scrapers, (iv) crushers, (v) pulvimixers, (vi) power-graders, (vii) trucks, and (viii) miscellaneous?
- 2. What was the dollar total of new equipment purchases in (a) 1960/61 and (b) 1961/62?

The Hon. P. A. Gaglardi replied as follows:—

- "1. (a) (i) Nil, (ii) \$211,163.99, (iii) nil, (iv) nil, (v) nil, (vi) \$427,882.04, (vii) \$473,906.22, (viii) \$317,361.63, and (b) (i) nil, (ii) \$132,402.47, (iii) \$121,684.50, (iv) nil, (v) nil, (vi) \$391,125.25, (vii) \$848,548.69, (viii) \$766,460.29.
 - "2. (a) \$1,430,313.88 and (b) \$2,260,221.20."

Mr. Calder asked the Hon. the Minister of Highways the following questions:—

1. With reference to the flood-damaged sections of the Silbak Premier Road in the Portland Canal district, is it the intention of the Department of Highways to repair the flood-damaged sections and to maintain the road in 1963?

2. If the answer to No. 1 is yes, when will the work begin?

3. If the answer to No. 1 is no, what are the Departmental reasons for refusing to repair the flood-damaged sections of the road?

The Hon. P. A. Gaglardi replied as follows:-

"1. The flood-damaged sections are in the State of Alaska; maintenance on the British Columbia section will be carried out after the damaged sections are repaired.

"2. No information.

"3. Answered by No. 1."

Mr. Calder asked the Hon. the Minister of Highways the following questions:—

1. With reference to the Alice Arm–Dolly Varden Truck-road, was any money spent for maintenance, repairs, and snow-removal in 1962?

2. If the answer to No. 1 is yes, how much?

- 3. Was part of the 1962 road grant returned to the Prince Rupert district highways office?
 - 4. If the answer to No. 3 is yes, (a) how much and (b) for what reason?

The Hon. P. A. Gaglardi replied as follows:—

- " 1. Yes.
- "2, \$15,905.58.
- " 3. No.
- "4. Answered by No. 3."

Mr. Calder asked the Hon. the Minister of Highways the following questions:—

- 1. Was any money spent in 1962/63 in road construction and repairs, including snow-removal, on each of the following roads: (a) Telegraph Creek-Dease Lake Road, (b) Telegraph Creek-Glenora Road, (c) Cassiar to Stewart-Cassiar Junction Road, (d) Stewart-Cassiar Junction to Alaska Highway, (e) Atlin Highway, (f) Atlin-Surprise Lake Road, (g) Atlin-Spruce Creek Road, (h) Alice Arm Shore Road, (i) Stewart-Bear River Road, (j) Stewart-Hyder Road, and (k) Stewart-Premier Road?
 - 2. If the answer to No. 1 is yes, what was the amount spent on each road?

The Hon. P. A. Gaglardi replied as follows:—

- "1. Yes.
- "2. Telegraph Creek—Dease Lake Road, \$17,100.34; Telegraph Creek—Glenora Road, \$899.32; Cassiar to Stewart—Cassiar Junction Road, \$42,454.58; Stewart—Cassiar Junction to Alaska Highway, \$58,694.11; Atlin Highway, \$10,656.09; Atlin—Surprise Lake Road, \$607.05; Atlin—Spruce Creek Road, \$218.93; Alice Arm Shore Road (not available, included in expenditure of \$16,032.01 covering all roads in the vicinity of Alice Arm); Stewart—Bear River Road, \$52,759.61; Stewart—Hyder Road, \$5,273.87; and Stewart—Premier Road, \$719.02."

Resolved, That the House, at its rising, do stand adjourned until 2 o'clock p.m. tomorrow.
