That Standing Orders in respect to receiving petitions for Private Bills be suspended with reference to the petition of the Roman Catholic Archbishop of the Archdiocese of Vancouver, for leave to introduce a Private Bill for the purpose of amending "The Roman Catholic Archbishop of Vancouver Act," and for other powers.

That your Committee recommends that the fee of \$300 paid by the promoters of the above-mentioned Bill be refunded.

Return pursuant to section 53 of the "Administration Act," chapter 5, R.S.B.C. 1936, of the Official Administrator for the Year ended December 31st, 1937.

Three Returns pursuant to section 43 of the "Revenue Act," R.S.B.C. 1924; section 45 (2) of the "Revenue Act," R.S.B.C. 1936; and section 124 (a) of the "Taxation Act," R.S.B.C. 1924.

Mr. *Eyres* asked the Hon. the Minister of Municipal Affairs the following questions:—

1. Was an increase in salary recently made to the Commissioner appointed for the District and Municipality of North Vancouver?
2. If so, what increase was granted?
3. What is his present salary?

The Hon. Mr. *Gray* replied as follows:—

"1. Yes.

"2. Increase granted as from the 1st day of September, 1937. City of North Vancouver, \$300 per annum; District of North Vancouver, *nil*.

"3. \$3,900. City of North Vancouver, \$2,400 (originally \$2,100); District of North Vancouver, \$1,500 (same as now).

"NOTE.—The above municipalities were incorporated as 'The Corporation of the City of North Vancouver'; 'The Corporation of the District of North Vancouver.'"

Mr. *E. E. Winch* asked the Hon. the Minister of Public Works the following questions:—

1. Since the Pattullo Bridge was taken over from the contractors, were quantities of rock deposited on the river-bottom near the base of No. 5 or any other of the piers?
2. If yes: (a) What quantity of rock has been so deposited; and (b) cost of same?
3. What was the reason for this being done?
4. Was it due to faulty design or construction?
5. Is it considered probable that erosion will create a permanent need for additional protection to the piers of the bridge?

The Hon. Mr. *MacPherson* replied as follows:—

"1. Yes.

"2. (a) 755 tons; (b) \$2,021.25.

"3. To restore the regimen of the river-bed after settlement (during freshet period) of the riprap placed by the contractor. This is a natural sequence on all foundation-work in a river of changing currents, such as the Fraser.

"4. No.

"5. No. It is not considered probable, but it is impossible to definitely determine the action of the river during freshet periods or changing currents which may be created by new works in the river up-stream. It may be pointed out that similar protection has been given to the piers of the old bridge at various times, and the same may be said with regard to the C.P.R. bridge at Mission."

Mr. *Anscomb* asked the Hon. the Prime Minister the following questions:—

1. What salary does the Chairman of the Coal and Petroleum Commission receive?
2. Is he under contract; and, if so, with whom and for what period?
3. Where is the head office of the Commission?
4. What rent is paid for the said head office?
5. Is there any lease covering the head office premises?
6. If so, for what term, who is the landlord, and what rental?
7. How many are employed in the head office of the Coal and Petroleum Commission? Give the salaries paid to each.

The Hon. Mr. *Pattullo* replied as follows:—

"1. See previous reply to Mr. *Bruhn* on Wednesday, November 9th.

"2. Yes. Ten years. Dr. Carrothers will be appointed Chairman of proposed Public Utilities Commission.

"3. 620 View Street, Victoria, B.C.

"4. \$156.35 a month.

"5. Yes.

"6. From May 1st, 1938, to April 30th, 1939; The Central Holding Company; \$1,644.45 for the term of the lease.

"7. See previous reply to Mr. *Bruhn* on Wednesday, November 9th."

Mr. *Anscomb* asked the Hon. the Provincial Secretary the following question:—

Has the Commission appointed in November, 1934, or thereabouts, by the Minister of Mines, under the "Public Inquiries Act," to inquire into the various matters respecting the production and use of coal and petroleum products in the Province of British Columbia completed its labours and filed its final report?

The Hon. Mr. *Weir* replied as follows:—

"Final reports relative to petroleum products and coal have been filed, but the Commissioner has not yet completed his final report in connection with paragraph three of his commission."

Mr. *E. E. Winch* asked the Hon. the Minister of Public Works the following questions:—

1. Was application made by representatives of the Monkman Pass Highway Association for financial assistance toward the cost of present operations designed to construct the Monkman Pass Highway?

2. If yes, what amount (if any) was requested?

3. Was this request complied with? If not, why not?

The Hon. Mr. *MacPherson* replied as follows:—

"1 to 3. A delegation called on the Department March 30th, 1938, and asked for financial assistance. This work not included in general road programme."

Mr. *Bruhn* asked the Hon. the Minister of Public Works the following questions:—

1. Is the Government operating a ferry across the river at Sicamous between Revelstoke-Sicamous Road and Sicamous-Canoe Road?

2. If not operated by the Government, who is operating said ferry?

3. Does the Government contribute anything toward the operation of such ferry?

4. If so, what is the total contribution?

5. What is the amount of traffic crossing on this ferry of all kinds—vehicles, passengers, etc.?

6. What is the revenue derived to the Government from operation of said ferry?

7. If not operated by Government, what is the revenue derived by operation for each month during the fiscal year 1937-38?

The Hon. Mr. *MacPherson* replied as follows:—

"1. No.

"2. R. H. Congreve, Sicamous.

"3. The landing-stages are Government property; also the scow which is on loan to Mr. Congreve, who bears all other operating expenses.

"4. Costs for maintenance of scow and landing-stages: 1934-35, \$210.88; 1935-36, \$5; 1936-37, \$37.60; 1937-38, \$22; 1938-39, 77 cents (to October 31st).

"5. 1936-37: Vehicles, 753; passengers, no records available. 1937-38: Vehicles, 705; passengers, no records available.

"6. Nil.

"7. 1937: April, \$7; May, \$31.50; June, \$40; July, \$57.50; August, \$62; September, \$68; October, \$54.50; November, \$20.50; December, \$11.50."

Mr. *E. E. Winch* asked the Hon. the Minister of Labour the following questions:—

1. During the operation of the "Workmen's Compensation Act" what new classes have been created under the powers provided in section 29?

2. What extensions, if any, covering industrial or occupational diseases have been made by the Board?

3. When were these made and of what did they consist?

4. If any, how many fatal accidents occurred in Class 1 (lumbering, etc.) during the latest year for which reports are available: (a) Married employees, (b) single employees; and the total assessment against the industry to provide pensions or other compensation to the dependents of each of these respective groups?

The Hon. Mr. *Pearson* replied as follows:—

"1. The new classes created since the 'Workmen's Compensation Act' came into effect were as follows:—

"Class 13.—The Crown in the right of the Province of British Columbia (by amendment to the Act in 1918).

"Class 14.—Municipal employees: Fire and police department; construction and operation of public works and public utilities; construction or extension of waterworks, sewers, gasworks, and electric railways; road-making (with blasting); and school board mechanics.

"Class 15.—Canning and packing fish and fish-oil, and fertilizer manufacture; oyster-cultivation, fishing and whaling; and kelp-collection.

"Class 16.—Manufacture of explosives; manufacture of fireworks; manufacture of fuse; manufacture of chemicals; and manufacture of nitrogen products.

"Class 17.—Retailers' delivery; retailers' employees (on request) (created in 1919, and later consolidated with other classes).

"Class 18.—Great Northern Railway and subsidiaries.

"Class 19.—Dominion Government employees (by Dominion Act, 1918).

"Class 20.—Northern Alberta Railway Company.

"These sums, \$150,196.27 for dependents of married workmen, and \$16,883.38 for dependents of single men, totalling \$167,079.65, include funeral expenses partly paid to dependents and partly direct to the undertakers. Medical and hospital care for those fatal accidents are not included, as no payment for same was made to the dependents.

"The employers in the class within which the above cases come are rated for assessment purposes on an experience-rating basis which provides that the cost of each fatal accident is fixed at the average cost of all fatal accidents in industry. This means that the employer of a single workman is in no more favourable position than the employer of a married workman when a fatality occurs."

By leave of the House, the following notice of motion standing on the Order Paper in the name of Mr. *H. E. Winch* was withdrawn:—

Whereas it is in the best interest of the Province that no misunderstanding should exist in the public mind as to the policies of administration followed by the Department of Public Works; and

Whereas developments following recent calling for tenders for road-construction apparently disclosed that the methods used by the Public Works Department are such that privileged contractors are given a preference in bidding on said works; and

Whereas published statements of contractors are to the effect that *bona-fide* contractors of long establishment have been denied the right to tender on public works:

Therefore be it Resolved, That the Select Standing Committee on Public Accounts be directed to investigate the manner whereby tenders are called and contracts let, and report to the House their findings in regard to this matter, with any recommendations deemed necessary.

The Hon. Mr. *Hart* presented two Returns in reply to the following questions standing on the Order Paper in the name of Mr. *Anscomb*:—

1. In what securities as at March 31st, 1938, were the funds of the Teachers' Pensions Fund invested?

2. Give the details of each, with maturity dates, rates of interest, etc.

3. If any changes since March 31st, 1938, give full details.

1. In what securities as at March 31st, 1938, were the funds of the Superannuation Fund invested?

2. Give the details of each, with maturity dates, rates of interest, etc.

3. If any changes since March 31st, 1938, give full details.

Mr. *Eyres* asked the Hon. the Minister of Agriculture the following questions:—

1. Is sterility prevalent among the herds of dairymen of the Fraser Valley?

2. If yes, what action, if any, is the Government taking in the matter?

The Hon. Mr. *MacDonald* replied as follows:—

"1. Yes, to some extent.

"2. Department is assembling data with reference to plans in use in other countries where control measures against contagious abortion are being applied."

Mr. *Eyres* asked the Hon. the Minister of Agriculture the following questions:—

1. How many were employed by the Department of Agriculture on November 15th, 1937?

2. How many of these were returned soldiers?

3. How many returned soldiers have been appointed to the Agriculture Department since November 15th, 1936?

4. How many returned soldiers have been dismissed or discharged in the Agriculture Department since November 15th, 1936?

The Hon. Mr. *MacDonald* replied as follows:—

"1. Forty-nine males; eighteen females.

"2. Sixteen, plus four enlisted men.

"3. Nil.

"4. Nil."

Mr. *Anscomb* asked the Hon. the Minister of Labour the following questions:—

1. Has the Province of Alberta tendered 50 per cent. of interest due in payment of interest on the bonds of the Province held by the Workmen's Compensation Board?

2. If yes, has the Board accepted the 50 per cent. with or without prejudice?

The Hon. Mr. *Pearson* replied as follows:—

"1. Yes.

"2. (a.) In the case of fully registered bonds, the Board has accepted 50 per cent., but has endorsed all cheques as follows: 'Accepted without prejudice and on account only.'

(b.) In the case of other securities the Board has not accepted the 50 per cent. tendered."

Mr. *Maitland* asked the Hon. the Provincial Secretary the following questions:—

1. Has a regulation been brought in in relation to old-age pensions requiring the applicant to have lived in Canada for 700 days during the preceding two years?

2. If so, when was such regulation made, and by whom?

3. Has this regulation been applied to any person otherwise eligible for the old-age pension who because of illness has been to the United States for a period of more than thirty days?

The Hon. Mr. *Weir* replied as follows:—

"1. Yes, as part of the qualification with respect to residence in Canada and the Province where application is made.

"2. That regulation was recommended by the Interprovincial Board, was approved by the Lieutenant-Governor in Council in each Province in Canada, and was passed by Dominion Order in Council (P.C. 3050) December 9th, 1937, effective January 8th, 1938.

"3. This regulation has been complied with since it became effective, irrespective of the alleged cause of absence from Canada."

Mr. *Eyres* asked the Hon. the Minister of Public Works the following questions:—

1. Has any money been spent on maintenance and protection of Vedder Canal since its completion?

2. If yes, how much?

The Hon. Mr. *MacPherson* replied as follows:—

“1. Not by this Department; but an expenditure of \$29,649.63 has been made on the Vedder River south of the canal for the protection of classified highways in this vicinity.

“2. See answer to No. 1.”

Mr. *Maitland* asked the Hon. the Minister of Agriculture the following questions:—

1. Has the Government a request for the use of Government caterpillar tractors and equipment to be made available to farmers for land clearing and levelling purposes at low hiring charges?

2. If so, how many persons have signed the said request?

3. What actions have been taken by the Government in respect to the matter?

The Hon. Mr. *MacDonald* replied as follows:—

“1. Department of Agriculture has had a letter from an individual claiming that thirty-eight farmers have signed forms sent out by him requesting such service.

“2. Answered by No. 1.

“3. Matter before Advisory Board of Farmers' Institutes for discussion.”

Mr. *Eyres* asked the Hon. the Minister of Agriculture the following questions:—

1. Has any work been done during 1937 regarding soil-survey work in the Fraser Valley?

2. If any, where, and to what extent?

The Hon. Mr. *MacDonald* replied as follows:—

“1. Yes.

“2. Report covering approximately 545,000 acres on which field-work was carried on in the preceding year was completed in 1937, and maps based on field data were prepared in soil-survey office at Kelowna. Report and maps are being printed by Federal Department of Agriculture at Ottawa.”

Mrs. *Steeves* asked the Hon. the Minister of Labour the following questions:—

1. Are applicants for relief segregated into two groups; namely, “employables” and “unemployables”?

2. Which official, or agency, has the responsibility of deciding whether a relief applicant is placed in the employable or unemployable category?

3. Which tests, or sources of information, are used to determine a person's employability or otherwise?

4. Are children over the age of sixteen, who are still attending school, deemed to be employable or unemployable in cases where the head of the family is in receipt of a mother's allowance or another type of Government pension?

The Hon. Mr. *Pearson* replied as follows:—

“1. If an applicant for relief is deemed to be unemployable this Department refers such applicant to the Welfare Department of the municipality or Province, as the case may be. A segregation was made in March, 1938, and following months of persons in receipt of unemployment relief as employables who had since become unemployable.

“2. Employment Service of Canada.

“3. Unemployable persons are those who are more or less permanently precluded from seeking or accepting gainful occupation by reason of physical defect, mental defect, infirmity due to age, habitual alcoholism, etc.; and, in the cases of women, those who are widows or are separated from their husbands, or are unmarried mothers whose full time is required to care properly for dependents. Prior employment and physical history, and personal contact, are used in determining a person's employability or otherwise.

“4. Deemed to be unemployable.”

Mr. *Eyres* asked the Hon. the Minister of Agriculture the following questions:—

1. What was the total number of pounds of butter-fat produced in British Columbia during 1937?

2. What was the average price per pound received by the farmer for same butter-fat?

The Hon. Mr. *MacDonald* replied as follows:—

“1. Approximately 22,500,000 pounds.

“2. Approximately 30 cents, including butter-fat sold on fluid market.”

Mr. *Macintosh* asked the Hon. the Minister of Finance the following questions:—

1. What was the total number of parcels of land offered for sale at the last Provincial tax sale?

2. What was the total number sold?

The Hon. Mr. *Hart* replied as follows:—

“1. 14,991.

“2. 951.”

In British Columbia the Indian Affairs Branch requisitions and pays for services rendered in this connection by the Tuberculosis Division of the Provincial Board of Health. Under this arrangement 21 beds for Indians have been provided and the patients occupying them are receiving medical care. The Tuberculosis Division has also initiated a survey of Indian Reserves and schools in respect to tuberculosis. The Indian Affairs Branch has also provided some beds in outlying hospitals, and their own physicians, two of whom were sent to the Vancouver Tuberculosis Clinic for training in pneumothorax technique, have in hand other aspects of the problem as, for instance, isolation on reserves. As the Tuberculosis Division is prepared to give any service to Indians in respect to tuberculosis which the Indian Affairs Branch asks for, and for which it will pay, it is hoped that plans to deal with the subject will further develop.

And whereas it is essential that Speakers' decisions and Legislative Standing Orders should guarantee freedom of speech and opportunity to counsel:

Therefore be it Resolved, That this House resolve itself into a Committee of the Whole to consider the rights and privileges of private members; and, further, if found necessary, to recommend to the House the advisability of referring to the Select Standing Committee on Standing Orders and Private Bills the entire question of rights and privileges of members, with power to discuss and recommend ways and means for the revision of the rules, orders, and forms of procedure of the Legislative Assembly.

A debate arose.

The Hon. Mr. *Pattullo* rose to a point of order.

Mr. Speaker stated that it was not a question of privilege and ruled the motion out of order.

Mr. *H. E. Winch* appealed from the ruling of the Chair.

The ruling of the Chair was sustained on the following division:—

On the motion of Mr. *H. E. Winch*, seconded by Mr. *E. E. Winch*, it was *Resolved*,—

That an Order of the House be granted for Returns to be made by the Minister of Labour of all orders or circulars issued by the Provincial Relief Administration to municipal relief authorities and (or) Provincial Relief Administrators and Investigators from June, 1937, to date.

Mr. *E. E. Winch* moved, seconded by Mrs. *Steeves*,—

Whereas the Twenty-sixth Report of the Medical Inspection of Schools states there are 675 retarded and underprivileged children now attending school (exclusive of 450 attending special classes in Vancouver); and

Whereas it is not feasible to economically provide adequate facilities for the supervision and training of such children in schools and districts where only a few reside; and

Whereas it is essential to the best interests of the children and society in general that such children shall, so far as possible, be equipped during their formative years to adapt themselves to school and, later, adult life, and thereby enable them to become social assets instead of liabilities:

Therefore be it Resolved, That this House resolve itself into a Committee of the Whole for the purpose of considering the desirability of recommending that the Provincial Secretary and Minister of Education obtain special statistical reports from School Medical Officers, School Boards, Public Health Officers, and Social Service Officials relative to the nature and prevalence of mental and physical handicap among children of school and pre-school age for the purpose of devising ways and means to provide suitable and adequate facilities for special

treatment, training, and education of such children, in order to assist them toward a self-supporting status in adult life.

A debate arose, which was, on the motion of the Hon. Mr. *Weir*, adjourned to the next sitting.

The Hon. Mr. *Pattullo* rose to a point of order with reference to the following notice of motion standing on the Order Paper in the name of Mrs. *Steeves*:—

Whereas a brief was presented by the Government of British Columbia to the Royal Commission on Dominion-Provincial Relations; and

Whereas the above-mentioned brief wholly failed to take into account the changing economic requirements of modern times and the necessity of reconstituting Canada on a firm national basis for the purpose of using the national wealth to satisfy human needs:

Therefore be it Resolved, That this Legislative Assembly regrets the unconstructive and parochial character of the brief presented by the Government to the Royal Commission on Dominion-Provincial Relations.

And be it further Resolved, That this House is of the opinion that any future representations made by the Government to the above-mentioned Commission should be based on the principle of planned national reconstruction.

Mr. Speaker reserved his decision.

By leave of the House, the following notice of motion standing on the Order Paper in the name of Mr. *Cameron* was withdrawn:—

That an Order of the House be granted for Returns to be made by the Hon. the Minister of Finance of accounts submitted by Sergeant T. D. Sutherland, of the Provincial Police, for the month of July this year, in respect of his functions as Police Officer in charge of the Mackenzie District and as Relief Officer for said district, and that said accounts be referred to the Select Standing Committee on Public Accounts.

Mr. *Cameron* moved, seconded by Mr. *Guthrie*,—

That an Order of the House be granted for a Return to be made by the Hon. the Attorney-General of the log-book of the police-boat "Morci," and said log-book be referred to the Select Standing Committee on Public Accounts.

A debate arose, which was, on the motion of the Hon. Mr. *Wismer*, adjourned to the next sitting.

The Hon. Mr. *Pattullo* rose to a point of order with reference to the following notice of motion standing on the Order Paper in the name of Mr. *E. E. Winch*:—

Whereas the treatment of delinquency in British Columbia fails to take into account the physical condition and economic backgrounds of those who are technically termed as delinquents:

And whereas there is a lack of psychiatric service, sound educational programmes, and training facilities in our gaols:

Therefore be it Resolved, That the Government be requested to formulate and to put into effect a scientific policy for the treatment of delinquency, having as its purpose the prevention and cure of crime rather than the present policy of punishment and isolation of delinquents.

Mr. Speaker reserved his decision.

The Hon. Mr. *Pattullo* rose to a point of order with reference to the following notice of motion standing on the Order Paper in the name of Mr. *Paton*:—

Whereas it has been realized that large financial commitments have been made by Governmental bodies—Federal, Provincial, and municipal—and that it is advisable to make provision whereby the natural growth of the country may be planned in a systematic and orderly manner, so that adequate and efficient means of communication for an increasing population may be provided, and that economies may be effected in the industrial, business, and Governmental activities throughout the country:

And whereas it is deemed expedient that Provincial planning would comprise the following elements:—

Land Planning: The study of land use to determine the most logical utilization of land—agriculture, grazing, forest, and watersheds—and the control of the selection of future townsites and land settlement areas in general:

Public Works Planning: The formulation of a sound, long-range public works programme, with particular reference to highways:

Natural Resources: The investigation, conservation, and statistical recording of the natural resources of the nation—fish, game, minerals, building materials, water (power and domestic supply, flood-control), and human welfare:

Trade and Industry: A study of the supply of raw materials for industrial purposes, and the domestic and foreign distribution of manufactured goods:

And whereas the Dominion Government has now provided funds for low-rental housing projects, and as it is expedient that these projects should be protected by adequate zoning laws, provided by Provincial enabling legislation, the Provincial Governments should be impressed with the advisability and necessity of establishing Provincial Planning Bureaus for more economical and efficient planning and zoning throughout their domain:

Therefore be it Resolved, That this Legislature resolve itself into a Committee of the Whole House to consider the advisability of appointing a committee to consider the question of the Government adopting a long-term planning programme, with a view to the orderly and efficient development of the natural resources of the Province; and that to this end a Central Planning Bureau be established to carry on all phases of Province-wide planning, and to act in an advisory capacity to the municipalities and unorganized districts of the Province.

Mr. Speaker reserved his decision.

On the motion of the Hon. Mr. *Pattullo*, seconded by Mr. *Putnam*, it was *Resolved*,—

Whereas there exists in the valley of the Kootenay River between Kootenay Landing, in the Province of British Columbia, and Bonners Ferry, in the State of Idaho, a tract of alluvial land of approximately 74,000 acres in extent, of which roughly 50 per cent. lies north and 50 per cent. south of the International Boundary:

And whereas all such alluvial lands were, in their natural state, subject to annual overflow from the Kootenay River:

And whereas 32,000 acres in Idaho and 18,500 acres in British Columbia have been in part protected from such overflow by the construction of dykes and have produced abundantly:

And whereas to more effectively protect these valuable lands it will be necessary to clear out the channel of the Kootenay River in British Columbia:

And whereas to secure an equitable distribution of the cost of these works an arrangement or agreement between the Government of the Dominion of Canada and the Government of the United States will be necessary:

Therefore be it Resolved, That an humble Address be presented to His Honour the Lieutenant-Governor, praying that he will cause a copy of this Resolution and the Preamble thereto to be forwarded to the Honourable the Secretary of State at Ottawa, with the request that His Excellency the Governor-General in Council will take all necessary steps to secure an arrangement or agreement with the Government of the United States, under the authority of which the production from these lands may be more fully protected on terms and conditions which shall be just and equitable to all concerned.

The Hon. Mr. *Pattullo* rose to a point of order with reference to the following notice of motion standing on the Order Paper in the name of Mrs. *Steeves*:—

Whereas the Prime Minister has stated that the "Health Insurance Act" is not being put into operation because the Government is waiting for the report of the Rowell Commission:

And whereas in the brief presented by the Government to the Rowell Commission no request is made that health insurance become a matter of Federal jurisdiction, and no specific request is made for a Federal conditional grant for health insurance:

And whereas there is complete unanimity amongst all representative groups of the people of British Columbia on the matter of the urgent necessity of health insurance for this Province:

Therefore be it Resolved, That a Select Committee of this House be set up to inquire into all possible ways and means of making health insurance, on a sound actuarial basis, operative in British Columbia, and to report the result of its findings to this House.

Mr. Speaker reserved his decision.

Mr. *Eyres* moved, seconded by Mr. *Finland*,—

Whereas the Governments of Canada are endeavouring to find efficient ways and means to combat the great enemy, forest fires, which are depleting our timber resources:

Therefore be it Resolved, That this House urge upon this Government the advisability of making early arrangements with the Federal authorities for the use of our aerial defence machines for spotting and for dropping fire-extinguishing chemical bombs upon forest fires at their very beginning.

A debate arose, which was, on the motion of the Hon. Mr. *Gray*, adjourned to the next sitting.

By leave of the House, the following notice of motion standing on the Order Paper in the name of Mrs. *Steeves* was withdrawn:—

Whereas British Columbia is the only Province in Canada which has no Credit Union Act or any legislation relative to the establishment of credit unions:

And whereas there are many groups of citizens in this Province who would be benefited by such legislation:

Therefore be it Resolved, That this Legislature resolve itself into a Committee of the Whole to consider the advisability of the promotion of a credit union development in this Province, as presenting opportunities to citizens in the economic and educational field, and of urging the Government to make a thorough study of the matter of credit union legislation.

Mr. *Macintosh* moved, seconded by Mr. *Brahn*,—

Whereas British Columbia is a part of the Dominion of Canada:

And whereas by agreement between the Dominion of Canada and Japan a quota of Japanese immigrants to Canada is provided for:

And whereas the said agreement is not in the best interest of the people of British Columbia:

Therefore be it Resolved, That this House urges upon the Government that it make further immediate representation to the Federal Government for the abrogation of the existing agreement in regard to immigration with Japan.

A debate arose, which was, on the motion of Mr. *Strachan*, adjourned to the next sitting.

The Hon. Mr. *Wismer* presented a Return in reply to the following questions standing on the Order Paper in the name of Mr. *Paton*:—

1. Has the Liquor Control Board entered into any pension scheme or arrangement of such nature with its employees? If so, why, and on what authority was it done?
2. Were the employees of the Board consulted or notified? If so, when?
3. Is it compulsory on the employees?
4. What company carries the insurance?
5. What are the terms of the contract? Give full particulars.
6. Did more than one company tender for the business? If yes, was the lowest tender accepted?
7. What was the amount of the tender?
8. Who is the British Columbia agent of the company?
9. Who is the Victoria agent for the company?
10. What other companies submitted tenders?
11. What date was the contract with the company consummated?
12. On what date was the first premium paid and to whom?
13. What was the amount of the first premium and by whom was it paid?
14. Was the plan accepted the same as that which the other companies tendered on?

Mrs. *Steeves* asked the Hon. the Premier the following questions:—

1. Did the Government at certain times agree to guarantee bank loans made to the White Pine Lumber Company of Nakusp?
2. If yes, at what times and for which amounts?
3. Have any of these bank loans, which the Government has guaranteed, been repaid?
4. If yes, which amounts have been repaid?
5. Is the White Pine Lumber Company still operating?
6. If no, for what reason is it not operating?

The Hon. Mr. *Asselstine* (Minister of Trade and Industry) replied as follows:—

- "1. Yes.
- "2. July 11th, 1934, \$9,800; March 26th, 1936, \$29,500; September 1st, 1936, \$5,500.
- "3. Yes.
- "4. \$9,800, \$5,500, \$12,584.73 repaid against the \$29,500 loan. Security: Chattel mortgage on plant, machinery, and equipment.
- "5. No.
- "6. Owing to the lack of operating capital."

Mr. *Eyres* asked the Hon. the Minister of Public Works the following question:—

How much money has been spent on construction and maintenance of the Trans-Canada Highway between Hope and Rosedale during the years 1933 and 1937, inclusive?

The Hon. Mr. *MacPherson* replied as follows:—

"Expenditures, Hope-Rosedale Road, 1933-37:—1933-34: Maintenance, \$5,508.08; construction, \$15,737.42. 1934-35: Maintenance, \$3,272.71; construction, \$16,490.88. 1935-36: Maintenance, \$3,872.27; construction, \$36,636.89. 1936-37: Maintenance, \$4,833.42; construction, \$158,386.84. 1937-38: Maintenance, \$5,464.99; construction, \$60,359.42. Clearing slides: Maintenance, \$4,037.80. Total maintenance, \$26,989.27. Total construction, \$287,611.45. Total, \$314,600.72."

Mr. *Guthrie* asked the Hon. the Attorney-General the following questions:—

1. How many pheasants were released by the Game Board this year?
2. What was the total cost per bird at the time of release?

The Hon. Mr. *Wismer* replied as follows:—

- "1. 15,937.
- "2. Birds not less than 12 weeks old, \$1.30 each; adult or breeding birds, \$1.50 each."

Mrs. *Steeves* asked the Hon. the Attorney-General the following questions:—

1. Has the Government received a petition regarding the establishment of a beer-parlour in the Bridge Head area of North Vancouver District?
2. If yes, what action, if any, is the Government taking in this matter?

The Hon. Mr. *Wismer* replied as follows:—

- "1. Yes.
- "2. None."

Resolved, That the House, at its rising, do stand adjourned until 8.30 o'clock p.m. to-day.

And then the House adjourned at 5.25 p.m.
