Pursuant to Order, the House resumed the adjourned debate on the motion "That Mr. Speaker do now leave the chair" for the House to go into Committee of Supply.

The debate continued.

On the motion of the Hon. P. A. Gaglardi, the debate was adjourned to the next sitting of the House.

The Speaker delivered his reserved reasons on an amendment to the motion constituting the Committee of Supply, as follows:—

Honourable Members,—On Thursday afternoon last, when the Address in reply to the Speech of His Honour the Lieutenant-Governor had been agreed to, the motion "That this House will, at its next sitting, resolve itself into a Committee to consider the Supply to be granted to Her Majesty, and that this Order have precedence over all other business, except introduction of Bills, until disposed of "was moved by the Hon. W. A. C. Bennett, seconded by the Hon. R. W. Bonner.

Mr. Strachan moved in amendment, seconded by Mr. Dowding, that the motion be amended by inserting after the word "Bills" the following words: "and a daily 15-minute oral question period."

The Chair ruled the amendment out of order, quoting the authority of May, 16th edition, at page 721, which reads as follows:—

"Motions setting up these Committees are made without notice immediately after the House agrees to the address in answer to the Speech from the Throne, and are put forthwith from the Chair, no debate being permitted thereon."

The 17th edition of May confirms the earlier edition and clearly establishes that under the British House of Commons Order 15 no debate is permitted on the motion to constitute the Committee of Supply. Standing Order 15 is essentially the same Order as Standing Order 60 of this House, which reads as follows:—

"60. The Committee of Supply and of Ways and Means shall be appointed on motion, without previous notice, at the commencement of every Session, as soon as an Address has been agreed to in answer to the Speech of His Honour the Lieutenant-Governor."

Prior to the ruling of the Chair, Honourable Members directed my attention to several points which gave rise to some doubt as to the applicability of the English authorities in the present circumstance. The points raised were as follows:—

- 1. That the motion for Supply was a routine proceeding and therefore, under Standing Order 45, debatable.
- 2. That in a previous year debate was permitted on a similar amendment and therefore should be allowed on this occasion.
- 3. That as words have been added giving precedence to the Order for Committee of Supply, the motion was thereby rendered open to debate and consequently open to amendment.

These points are well raised and require close and careful consideration. They do not, however, in my respectful opinion, set aside the basic rule as stated in May, for these reasons:—

1. While a motion for constitution of the Committe of Supply is made at each Session, it does not for that reason alone become "a routine proceeding," as contemplated by Standing Order 45. Historically, the question of Supply to the Crown has not been a "routine" matter. On the contrary, it is a special proceeding, originating first according to ancient usage as a response to the royal demand for Supply implied in the Speech from the Throne (May, 16th edition, page 696). It is now governed by a Special Standing Order which constitutes a Committee of Supply once only for the whole of the current Session.

- 2. On the previous occasion when debate was permitted, no ruling was made by the Chair and the attention of the House was not directed to the propriety of debate. This circumstance should not, in my opinion, lead the House to abandon a rule which is otherwise well founded. The incongruity of debate is implicit in Standing Order 60 because by the terms of that Order it is mandatory for the House to constitute the Committee of Supply. An examination of the Journals will confirm that it has not been the practice of this House over many years to debate the motion for constitution of this Committee.
- 3. In considering the third point, that by reason of the addition of the words "and that this Order have precedence over all other business, except introduction of Bills, until disposed of" the motion becomes debatable, I have examined the Journals, which show that these words were first adopted in the Throne debate motion in the year 1922 and in the motion to constitute a Committee of Supply in the year 1955. It may have been preferable if originally the motion had been severed into two distinct propositions:—
 - (i) "That the House resolve itself into a Committee of Supply at its next sitting"; and
 - (ii) "That the Order for Committee of Supply have precedence over all other business, except introduction of Bills, until disposed of."

However, the House has not seen fit to do so and has, in fact, for a long period of time accepted the form of these motions without question. In my view, the additional words giving priority are of a procedural nature only, for the purpose of varying the effect of Standing Order 25, which governs the normal order of business of the House. They do not, in my opinion, change the essential nature of the motion. The proposed amendment on the other hand, if adopted, would not only further alter the daily routine of business but would also provide for oral questions, contrary to the long-established practice of this House. In this respect my interpretations are based upon what I conceive to be the effect of the rules in the light of the recorded decisions of former Speakers. (Journals, 1928, page 19; 1953, page 14; 1953, page 70; 1958, page 26.)

In considering the matters raised by Honourable Members, at the time, my ruling was made with some hesitation, but I am now satisfied, upon further consideration, that the proposed amendment was not in order for the reasons stated.
