Tuesday, October 25th, 1938.

THREE O'CLOCK P.M.

This being the first day of the second meeting of the Nineteenth Parliament or Legislative Assembly of the Province of British Columbia for the dispatch of business, pursuant to a Proclamation of the Honourable ERIC WERGE HAMBER, Lieutenant-Governor of the Province, dated the 21st day of September, 1938.

His Honour ERIC WERGE HAMBER, Lieutenant-Governor of the Province, having entered the House, took his seat on the Throne, and was pleased to deliver the following gracious Speech:—

Mr. Speaker and Members of the Legislative Assembly:

World events, during the past few weeks, have been such that, beyond other considerations, our thoughts find expression in gratitude and thankfulness that the crisis which overshadowed the world for so long has, for the present at least, been allayed.

We, who live in British Columbia, have much to be thankful for; yet, with turmoil and strife rampant in so many parts of the world, with feelings of unrest and fear uppermost in the minds of the peoples of so many nations, we cannot view with anything but apprehension the present untoward world conditions affecting, as they do, the peoples of all lands.

The intimation that His Majesty King George VI. and Her Majesty Queen Elizabeth have graciously consented to visit the Dominion during the summer of 1939 has been received by our people with feelings of patriotism, joy, and gratification.

While business conditions in British Columbia have continued on a stable basis, the unemployment problem is, nevertheless, still with us, and my Government has been endeavouring to bring about an improvement in conditions to ameliorate the lot of those unable to obtain steady employment or unable to work through disability. Further effort will be made as far as possible to create and stimulate new opportunity.

In the various departments of the Provincial Service, my Government has endeavoured to maintain the Service on a high standard of efficiency and to meet the many pressing demands as fully and capably as circumstances would permit.

During the year the Royal Commission on Dominion-Provincial Relations held sittings in Victoria and my Government presented the case of British Columbia. Supplementary representations will be made at further hearings of the Commission in Ottawa. In this regard my Government is endeavouring fully to co-operate with the other Provincial Governments, and with the Dominion Government, to bring about such changes in and adjustments of relationships as will enable each adequately to meet its responsibilities and public requirements.

The Board appointed by the Government under the "Coal and Petroleum Products Control Board Act," which was passed by the Legislature at its last session, has, with the

approval of my Government, fixed a maximum base price for the sale of gasoline, which will mean a very large annual saving to our people.

A measure will be submitted to you to provide for the creation of a Public Utilities Board. Amendments to various Acts will be submitted to you.

The Public Accounts will be presented and Estimates for the ensuing year will be laid before you.

I welcome you to this the second Session of the present Parliament, and I trust that the results of your deliberations and activities may be of much benefit.

That the Divine Blessing may rest upon the fruits of your labours is the prayer of all our people.

His Honour the Lieutenant-Governor was then pleased to retire.

Prayers by the Rev. *Hugh McLeod*.

Mr. Speaker reported that, to prevent mistakes, he had obtained a copy of His Honour's Speech.

The Certificate of the Deputy Provincial Secretary of the result of the by-election of a member to represent the Electoral District of Dewdney was read, as follows:—

“Now I do hereby certify that on the 7th day of June, 1938, the said writ was returned to me by the Returning Officer, with his certificate endorsed thereon, whereby it appears that the electors of the said district have chosen *David William Strachan* to represent the Dewdney Electoral District in the Legislative Assembly.

On the motion of the Hon. Mr. *MacDonald*, seconded by the Hon. Mr. *Pearson*, it was Resolved,—

That the Certificate of the Deputy Provincial Secretary of the result of the by-election of a member to represent the Electoral District of Dewdney be entered upon the Journals of the House.

Mr. *David William Strachan*, having been duly sworn, was introduced by the Hon. Mr. *Pattullo* and the Hon. Mr. *Weir*, and took his seat.

On the motion of the Hon. Mr. *Wismer*, Bill (No. 1) intituled “An Act to amend the ‘Bills of Sale Act’” was introduced, read a first time, and Ordered to be read a second time at the next sitting.

On the motion of the Hon. Mr. *Pattullo*, seconded by the Hon. Mr. *Hart*, it was Resolved,—

That the Speech of His Honour the Lieutenant-Governor be taken into consideration at the next sitting, and that this Order have precedence over all other business, except the introduction of Bills, until disposed of.

On the motion of the Hon. Mr. *Weir*, seconded by the Hon. Mr. *Gray*, it was Resolved,—

That the Votes and Proceedings of this House be printed, being first perused by Mr. Speaker, and that he do appoint the printing thereof, and that no person but such as he shall appoint do presume to print the same.

On the motion of the Hon. Mr. *Pattullo*, seconded by the Hon. Mr. *Hart*, it was *Resolved*,—
That the Select Standing Committees of this House, for the present Session, be appointed for the following purposes:—

1. On Standing Orders and Private Bills;
2. On Public Accounts;
3. On Printing;
4. On Railways;
5. On Mining;
6. On Agriculture;
7. On Municipal Matters;
8. On Forestry;
9. On Fisheries;

which said Committees shall severally be empowered to examine and inquire into all such matters and things as shall be referred to them by this House, and to report from time to time their observations and opinions thereon, with power to send for persons, papers, and records, and that a Special Committee be appointed to prepare and report with all convenient speed lists of members to compose the above Select Standing Committees of this House under Standing Order 68 (1), said Committee to be composed of Messrs. *Leary*, *Kenney*, *Straith*, *Maitland*, and *H. E. Winch*.

The Hon. Mr. *Pattullo* moved, seconded by Mr. *Maitland*,—

That this House express its sincere regret at the death of Frank Porter Patterson, who was member for the Electoral District of Dewdney and Leader of His Majesty's Loyal Opposition, and that the Clerk do convey to Mrs. Patterson and the family of the late Mr. Patterson the condolences and sincere sympathy of the members of the Legislative Assembly.

At the request of Mr. Speaker, the House expressed its approval of the motion by a standing silent vote.

2. In what grades are such schoolbooks required?

Mr. *E. E. Winch* asked the Hon. the Provincial Secretary the following question:—

What was the death rate from tuberculosis during the fiscal years 1936–37–38 for whites, Indians, and Orientals, respectively?

The Hon. Mr. *Weir* replied as follows:—

“Tuberculosis mortality rates per 100,000 population:—Fiscal year 1935–36: Whites, 54.5; Orientals, 124.4; Indians, 648.4. Fiscal year 1936–37: Whites, 49.5; Orientals, 110.7; Indians, 826.3. Fiscal year 1937–38: Whites, 45.8; Orientals, 119.9; Indians, 885.7.”

Mr. *E. E. Winch* asked the Hon. the Minister of Education the following question:—

What is the average age at which Normal School students graduate?

The Hon. Mr. *Weir* replied as follows:—

“Average age of students at the Provincial Normal School, Victoria, at time of graduation is 20 years and 9 months; at the Provincial Normal School, Vancouver, 21 years and 2 months.”

Mr. *Bruhn* asked the Hon. the Minister of Mines the following questions:—

1. Did a Keystone placer drill revert to the Government off the Perry Creek placer leases in the Cranbrook mining division?

2. If so, what disposition was made of the said drill?

3. Where is the said drill now being used, if at all?

The Hon. Mr. *Asselstine* replied as follows:—

“1. No.

“2 and 3. Answered by No. 1.”

Mr. *Crone* presented a petition from the City of Vancouver, for leave to introduce a Private Bill for the purpose of amending the “Vancouver Incorporation Act, 1921.”

The House resumed the adjourned debate on the Address in reply to the Speech of His Honour the Lieutenant-Governor at the opening of the Session.

The debate continued.

On the motion of Mr. *Hunter*, the debate was adjourned to the next sitting of the House.

By leave of the House, on the motion of Mr. *Leary*, seconded by Mr. *Kenney*, it was *Resolved*,—

That the name of *Louis LeBourdais* be added forthwith to the Select Standing Committee on Railways.

Mr. *Paton* asked the Hon. the Attorney-General the following questions:—

1. Did the Government purchase property at the corner of Bidwell and Georgia Streets, Vancouver, for the purpose of testing automobile drivers and automobiles?

2. If so, from whom was the said land purchased?

3. What was the price paid for the said land?

4. What is the cost of any building or buildings being erected on the said land?

5. What is the cost of any equipment to be installed on the said premises after the said erection?

6. Were any tenders called for the said buildings?

7. Was there any advertisement for tenders for the said buildings?

The Hon. Mr. *Wismer* replied as follows:—

“1 to 4. These questions should be asked of the Hon. the Minister of Public Works.

“5. Not determinable at the present time.

“6 and 7. These questions should be asked of the Hon. the Minister of Public Works.”

Mr. *Guthrie* asked the Hon. the Minister of Lands the following questions:—

1. How many unemployed workmen were brought from Vancouver to fight the Campbell River fire?

2. What was the total cost of bringing these men to the Island?

The Hon. Mr. *Gray* replied as follows:—

"1. 212.

"2. \$1,035.20."

Mr. *Hunter* asked the Hon. the Attorney-General the following questions:—

1. Against how many persons dealing in stocks and bonds were criminal proceedings launched during the present year?

2. How many convictions were obtained?

3. Were any of those charged registered as brokers; and, if so, how many?

The Hon. Mr. *Wismer* replied as follows:—

"The following answers are given on the assumption that the questions asked deal with matters relating to the 'Securities Act':—

"1. Since January 1st, 1938, criminal proceedings were instituted against ten members of brokerage firms, arising out of investigations conducted by a representative of the Securities Office.

"2. Seven convictions were obtained.

"3. Of those charged, referred to in the answer to question No. 1, six were directors of registered brokerage firms when the alleged offence was committed, and one was a registered salesman of a brokerage firm."

Mr. *Guthrie* asked the Hon. the Minister of Railways the following questions:—

1. How many gallons of fuel-oil were used on the Pacific Great Eastern Railway during the year 1937?

2. What was the total cost of same?

The Hon. Mr. *Pearson* replied as follows:—

"1. Information not available in the Department of Railways.

"2. P.G.E. is not operated by Department of Railways."

Mr. *Shepherd* asked the Hon. the Minister of Railways the following questions:—

1. Has the Fraser River New Westminster Bridge been turned over to the Dominion Government? If yes, was any value or consideration received?

2. Are any bonds still outstanding on this bridge for which the Province is responsible? If yes: (a) In what amount; and (b) what interest do they bear?

The Hon. Mr. *Pearson* replied as follows:—

"1. No.

"2. The cost of construction of the Fraser River Bridge was provided for, together with other undertakings of the Government, by an issue of 3-per-cent. inscribed stock, maturing in 1941, and amounting to \$9,921,936. Of this sum the following was held in the Sinking Fund at December 31st, 1937: 3-per-cent. stock, \$7,880,253.12; cash, \$1,009,930.96; total, \$8,890,184.08. The figures for the bridge alone cannot be segregated."

Mr. *E. E. Winch* asked the Hon. the Minister of Labour the following questions:—

1. Was an interdepartmental committee set up for the purpose of investigating and reporting relative to hospital staff working conditions?

2. If so, has this committee completed its investigation?

3. When will the report be presented to this House?

The Hon. Mr. *Pearson* replied as follows:—

"1. Yes.

"2. The investigations are completed and the report in the course of preparation.

"3. It is hoped to present the report before the House prorogues."

Resolved, That the House, at its rising, do stand adjourned until 2.30 o'clock p.m. to-morrow.

2. If yes, what amounts have been granted or guaranteed to each person or company; the terms of such loan; and the rate of interest in each case?
3. What payments have been received by the Government towards the liquidation of such loans?
4. What security for each advance has been received by the Department?

The Hon. Mr. *Asselstine* (Minister of Industries) replied as follows:—

"1. Yes; Nicola Pine Mills (1937), Ltd., Merritt, B.C., and Gray's Lumber Mills, Quesnel, B.C.

"2. Nicola Pine Mills (1937), Ltd., \$30,000 guarantee, advanced by bank as logs were delivered to mill and lumber placed in yards. Loan to be repaid by bank automatically applying \$1.50 per thousand feet B.M. out of proceeds received from sales of lumber; interest, 6 per cent. Gray's Lumber Mills, \$3,000 guarantee, advanced by bank as logs were delivered to mill and lumber placed in yards. Loan to be repaid by bank automatically applying \$1.50 per thousand feet B.M. out of proceeds received from sales of lumber; interest, 6 per cent.

"3. Nicola Pine Mills (1937), Ltd., \$7,398; Gray's Lumber Mills, \$310.87.

"4. Nicola Pine Mills (1937), Ltd.: Chattel mortgage covering machinery and equipment; mortgage on Company's property. Gray's Lumber Mills: Chattel mortgage covering machinery and equipment."

Mr. *E. E. Winch* asked the Hon. the Provincial Secretary the following questions:—

1. Was a survey made of the number of patients in mental hospitals suffering from tuberculosis?
2. Was any action taken to deal with the problem of adequate care of such patients?
3. What was the nature of such action?
4. What is the number of tubercular patients in mental hospitals?
5. Are they segregated from other patients?

The Hon. Mr. *Weir* replied as follows:—

"3. Cost per acre: Direct Forest Branch expenditure, \$3.63; plus Forest Development and Young Men's Camp labour, \$3.48; plus unknown cost of labour contributed by private sources."

Mr. *Anscomb* asked the Hon. the Minister of Education the following questions:—

2. How many people were in receipt of such pensions?

4. If yes, what is the: (a) Intended bed capacity of each such building; (b) number of present bed occupations, respectively?

The Hon. Mr. *Weir* replied as follows:—

“1. Provincial Mental Hospital, Essondale, 1,864 patients; Public Hospital for Insane, New Westminster, 371 patients; Provincial Mental Home, Saanich, 265 patients.

“2. Provincial Mental Hospital, Essondale, 2,735 patients; Public Hospital for Insane, New Westminster, 600 patients; Provincial Mental Home, Saanich, 262 patients.

“3. Wards ‘J’ and ‘K’ were opened January 24th, 1938. Wards ‘G’ and ‘Con’ were opened March 23rd, 1938.

“4. (a.) Ward ‘J,’ 25 patients; Ward ‘K,’ 25 patients; Ward ‘G,’ 23 patients; Ward ‘Con,’ 23 patients. (b.) Ward ‘J,’ 41 patients; Ward ‘K,’ 41 patients; Ward ‘G,’ 36 patients; Ward ‘Con,’ 35 patients.”

Mr. *Eyres* asked the Hon. the Minister of Lands the following question:—

10. What was the value of farm produce, auto-plates, and other computable goods or services produced or performed by inmates during the years 1933–38, respectively?
11. What number of women prisoners are at present in Oakalla?
12. Of what offences were they convicted?
13. Are they segregated according to ages, type of offence, or physical condition?

2. What is the *per capita* cost per day to keep a female prisoner at Oakalla?

The Hon. Mr. *Wismer* replied as follows:—

"1 and 2. The present *per capita* cost per day for the keep of all prisoners at Oakalla is 91.68 cents. Costs in respect of male and female prisoners, respectively, are not segregated."

Mr. *Eyres* asked the Hon. the Minister of Agriculture the following question:—

What, if any, action is the Government taking to discover the cause of red-water among the cattle of this Province?

The Hon. Mr. *MacDonald* replied as follows:—

"Investigation of the cause of red-water among cattle in this Province is under the jurisdiction of the Federal Health of Animals Branch, working under direction from Ottawa. Officials of the Provincial Department of Agriculture co-operate with the Federal investigators, but the investigation is not being duplicated."

Mr. *Maitland* asked the Hon. the Minister of Lands the following questions:—

1. What is the total cost to date of the Sumas Reclamation Scheme, including principal, interest, carrying charges, and all other expenditures in connection therewith?

2. How much has the Government received from the payment of rent in this area to date?

3. What is the total cost to date of the South Okanagan Irrigation Scheme, including principal, interest, carrying charges, and all other expenditures in connection therewith?

4. How much has the Government received from the payment of rent in this area to date?

5. What is the total cost to date of the Merville Reclamation Scheme, including principal, interest, carrying charges, and all other expenditures in connection therewith?

6. How much has the Government received from the payment of rent in this area to date?

The Hon. Mr. *Gray* replied as follows:—

"1. Impossible to estimate; but in 1937 royalty was paid on 15,932 beaver-pelts. Under trap-line registration system the Game Department has control in respect of overtrapping, and returns of trappers indicate that there is no need of concern as to any possible depletion of beaver.

Mr. *Shepherd* asked the Hon. the Minister of Railways the following questions:—

1. In whom is the title of the Fraser River New Westminster Bridge now vested?

2. Who has now control of its operation?

The Hon. Mr. *Pearson* replied as follows:—

"1. The Crown in the right of the Province of British Columbia.

"2. The Railway Department. See chapter 56, 1927."

Mr. *Shepherd* asked the Hon. the Minister of Labour the following questions:—

1. What proportion of the cost of maintenance of municipal unemployables is now being borne by the Provincial Relief Department?
2. When was the present agreement entered into with municipalities?

The Hon. Mr. *Pearson* replied as follows:—

"1. Forty per cent. of the cost of assistance granted monthly based on the amount of assistance received immediately prior to transfer. This arrangement does not cover indigents who were a full responsibility of municipalities prior to March 1st, 1938.

"2. Municipalities were notified of the arrangement on August 13th, 1938, payments being retroactive to March 1st, 1938."

Mr. *Guthrie* asked the Hon. the Minister of Labour the following question:—

The number of persons so assisted is as follows: 1933, *nil*; 1934, 8; 1935, 8; 1936, 28; 1937, 32; 1938, 34."

Mr. *E. E. Winch* asked the Hon. the Minister of Finance the following questions:—

1. Has any (a) hypothecation of anticipated revenue from specific sources, or (b) securities other than treasury notes been given to a bank, or banks, as security for temporary loans?
2. If yes: (a) What security, (b) what bank, and (c) what amount is involved?

The Hon. Mr. *Hart* replied as follows:—

Mr. *Anscomb* asked the Hon. the Minister of Finance the following questions:—

1. What rate of interest does the Treasury receive upon bank balances standing to the credit of the Province.
2. What rate of interest does the Government now pay upon current (a) Bank loans; (b) Treasury bills; (c) Federal Government loans?

The Hon. Mr. *Hart* replied as follows:—

"1. $\frac{3}{4}$ of 1 per cent.

"2. (a) *See* (b). (b) Treasury bills: To bank (guaranteed by Dominion), $2\frac{1}{2}$ per cent.; to bank (not guaranteed), $3\frac{1}{4}$ per cent.; to Dominion, 3 per cent. (c) *See* (b)."

Mr. *E. E. Winch* asked the Hon. the Minister of Education the following questions:—

1. What is the student capacity (a) day, (b) resident, respectively, of the Provincial Deaf and Blind School?

2. What number of (a) deaf, (b) blind students are now attending the Deaf and Blind School as day or resident pupils?

3. What is the known number of (a) deaf, (b) blind children of school age in the Province who, by reason of their infirmity, would be eligible for admission to the above school?

The Hon. Mr. *Weir* replied as follows:—

"1. (a) Day pupils: The total capacity for day pupils is contingent upon available space in the individual class-rooms. Roughly, the total capacity would represent the difference between a total enrolment of 90 or 95 and the number of children in residence. (b) Resident pupils, 54 (17 girls, 37 boys).

"2. (a) Deaf pupils, 66; (b) blind and with partial sight, 19.

"3. Applicants awaiting admission: Deaf, 10; blind and with partial sight, 5. Cases reported by teachers, school nurses, welfare visitors, and the like: Deaf, 16; blind and with partial sight, 36."

Mr. *Anscomb* asked the Hon. the Minister of Finance the following questions:—

1. What amount of money has been collected from the gasoline tax from March 1st, 1937, to February 28th, 1938?
2. What amount of money has been collected from motor-car licences from March 1st, 1937, to February 28th, 1938?
3. What amount of money has been collected from motor-truck licences from March 1st, 1937, to February 28th, 1938?
4. What amount of money has been collected from drivers' licences from March 1st, 1937, to February 28th, 1938.

The Hon. Mr. *Hart* replied as follows:—

- "1. \$3,108,551.65.
- "2. Passenger motor-vehicles, \$1,819,668.57.
- "3. Commercial motor-vehicles, \$629,881.26.
- "4. \$151,229."

Mr. *Anscomb* asked the Hon. the Minister of Finance the following questions:—

1. Was any amount refunded during the year 1938 of the 1-per-cent. tax?
2. If yes, how much?

The Hon. Mr. *Hart* replied as follows:—

- "1. Yes.
- "2. \$1,094,647.32."

Mr. *Anscomb* asked the Hon. the Minister of Finance the following questions:—

1. Was any money borrowed by the Province between July 1st, 1937, and October 1st, 1938?
2. If yes, from whom was the money borrowed, and for what purposes, and what amount at present remains unexpended?
3. What is the rate of interest on each loan?
4. When are the loans repayable?

The Hon. Mr. *Hart* replied as follows:—

- "1. Yes.
- "2. From the Canadian Bank of Commerce for Pacific Great Eastern Railway construction, \$125,000; unexpended at November 9th, 1938, *nil*. From the Dominion Government for unemployment relief purposes, \$2,000,000; unexpended at November 9th, 1938, *nil*. From the Superannuation Fund Account for Public Works, \$500,000; unexpended at November 9th, 1938, \$342,365.90.

"3. Rate of interest on borrowings from Canadian Bank of Commerce, 3¼ per cent. (as amended); from Dominion Government, 3 per cent.; from Superannuation Fund Account, 3 per cent.

"4. Loans repayable to: The Canadian Bank of Commerce, on demand; Dominion Government, one year from date of issue; Superannuation Fund Account, on demand."

Mr. *Anscomb* asked the Hon. the Minister of Finance the following questions:—

1. Are any amounts still available for borrowing purposes under the various Loan Acts, with particulars, as at February 28th, 1938?
2. If so, how much?

The Hon. Mr. *Hart* replied as follows:—

"1 and 2. Borrowing-powers available under various Loan Acts, at February 28th, 1938, were as follows: 'Loan Act, 1925,' \$63,213.50; 'Loan Act, 1927,' \$20,000; 'P.G.E. Construction Loan Act, 1928,' \$2,259,000; 'Loan Act, 1930,' \$73,590; 'Loan Act, 1932,' \$582,000; 'Loan Act, 1933,' \$2,795,000; 'Loan Act, 1935,' \$3,000,000; 'Loan Act, 1936,' \$2,042,300; total, \$10,835,103.50. 'Revenue Act,' R.S.B.C. 1936, contingent upon requirements. 'Unemployment Relief Act,' R.S.B.C. 1936, contingent upon requirements for loans from Dominion for relief purposes."

Mrs. *Steeves* asked the Hon. the Minister of Education the following questions:—

1. How often are the school-children medically examined in schools under Provincial Government control?
2. How are the doctors who perform this examination appointed?
3. What is their remuneration?
4. What supervision is there over doctors to ascertain whether a thorough and efficient job is done in the matter of the medical examination of school-children?
5. Is there any follow-up examination or treatment in cases where the examination reveals some serious defect?
6. If yes, how often are subsequent examinations given, and in which cases are treatments given?

The Hon. Mr. *Weir* replied as follows:—

"1. Under 'Public Schools Act,' R.S.B.C. 1936, at least once in each school-year or oftener if required by the Board of School Trustees.

"2. Appointment made by city and municipal school boards for their areas; in unorganized territories, by the Provincial Board of Health.

"3. Remuneration in cities and municipalities as agreed between governing bodies and the doctor; in unorganized territories an allowance is made of 50 cents per pupil and mileage of 25 cents a mile, one way.

"4. All doctors make a full report of their work, which report is used as a basis of consultation, if necessary.

"5. Any defects discovered are referred to the parents by the examining physician, with the suggestion that they consult their family physician.

"6. Where Public Health Nurses are employed, subsequent examinations are carried out to check up as to whether cases have been attended to by parents."

Mr. *E. E. Winch* asked the Hon. the Provincial Secretary the following questions:—

1. What is the total number of patients who have received treatment at Provincial clinics for V.D.?

2. What is the actual or average monthly number of patients receiving treatment at the Vancouver clinic?

3. What is the number of children now receiving such treatment?

The Hon. Mr. *Weir* replied as follows:—

"1. Total number of patients receiving treatment from May, 1937, to September, 1938, was 4,996.

"2. The actual number of patients receiving treatment at the Vancouver clinic from June, 1937, to September, 1938, was as follows:—1937: June, 1,201; July, 1,189; August, 1,213; September, 1,187; October, 1,296; November, 1,330; December, 1,340. 1938: January, 1,389; February, 1,611; March, 1,600; April, 1,517; May, 1,458; June, 1,486; July, 1,470; August, 1,528; September, 1,545.

"3. The number of children, 20 years and under, receiving treatment for syphilis and gonorrhœa at Provincial clinics at September 30th, 1938, is 164."

Mrs. *Steeves* asked the Hon. the Minister of Education the following questions:—

1. Is exclusion from the schools of children suffering from infectious diseases strictly enforced in unorganized districts?

2. If yes, by what method is it enforced?

The Hon. Mr. *Weir* replied as follows:—

"1. The local Medical Health Officer reports to the Provincial Board of Health the existence of an infectious disease and takes such measures as are necessary to handle the case. A pupil suffering from infectious disease is excluded from the school. The local Medical Health Officer is responsible for the oversight of the case.

"2. The local Medical Health Officer has full power to enforce the rules and regulations in regard to infectious disease."

Mrs. *Steeves* asked the Hon. the Minister of Mines and Minister of Trade and Industry the following questions:—

1. Were Government advertisements, relative to the Department of Mines and the Department of Trade and Industry, placed in "The Review," North Vancouver, of Friday, October 28th, 1938?

2. If yes, what price was paid for these advertisements?

3. Is "The Review" the only weekly newspaper being published in North Vancouver City and District?

4. Were these advertisements placed in other weekly newspapers in the Province?

5. If yes, in which papers?

The Hon. Mr. *Asselstine* replied as follows:—

"1. Yes.
