The Chairman further reported that in consideration of Vote 67 the Committee had divided, and recommended that the division be recorded in the Journals of the House.

By leave, Mr. R. G. Fraser presented Report No. 1 of the Select Standing Committee on Municipal Affairs and Housing.

Report No. 1

Legislative Committee Room,

February 6, 1984

Mr. Speaker:

Your Select Standing Committee on Municipal Affairs and Housing, appointed on August 5, 1983, and directed on September 9, 1984 by Resolution of this Assembly to consider a proposal that the Province of British Columbia adopt a system of concurrent triennial elections for local and regional office, begs leave to report as follows:

The Committee recommends that elections for all local elective offices in the Province be held simultaneously once every three years. For the advantages of this proposal to be realized to the fullest extent such elections ought to be as co-ordinated and comprehensive as possible, since exceptions would quickly nullify the financial and other benefits to be gained through adoption of a triennial election system. The Committee further recommends that the *School Act* and the *Municipal Act* be amended accordingly; and that the fullest encouragement and co-operation be extended to the City of

Vancouver with respect to a corresponding amendment of the Vancouver Charter. It is the Committee's final recommendation that the triennial election plan be phased in over a three-year period so that election dates under the present system will naturally coincide with triennial elections under the new system. This method of implementation will minimize confusion and avoid the necessity of altering the term of anyone who has already been elected to office.

This Assembly charged the Committee "to consider the Resolution of the Union of British Columbia Municipalities of 1982 proposing triennial elections". That resolution called for concurrent triennial elections for municipal office. At their 1983 convention in Penticton, the UBCM endorsed an even stronger resolution calling for the election of "all local elected officials" to a three-year term of office "on the same day in November every three years". The essence of their main arguments in support of this proposal was the following: (a) that it would increase the interest, awareness and participation of the electorate in the sphere of local affairs; (b) that it would reduce the costly burden of annual elections upon the Provincial taxpayers; and (c) that it would increase the productivity of newly-elected officials by lengthening the period between their mastering the procedures of their new offices and having to seek re-election. The UBCM also pointed out that similar systems of local elections have been adopted throughout much of the rest of Canada and have worked well.

The Committee discovered that the broad support for this proposal indicated by the UBCM was shared by a number of others in the Province. Vancouver Mayor Michael Harcourt has asked Vancouver aldermen to endorse such a change. Provincial school boards indicated that they either actively endorsed the plan or had no preference one way or the other, while others stated that their desire to maintain the status quo was far outweighed by the importance of keeping their elections in step with those of the municipalities.

The Committee then turned its attention to the experience of other Canadian jurisdictions which employ identical or similar systems of local elections, and the reports were unanimously favourable. Alberta adopted uniform triennial elections in 1970, and the first election under the new act was held in 1971. Minister of Municipal Affairs Julian Koziak wrote to the Committee that "the triennial election system is generally well-accepted and, in our opinion, did create more interest and increase turnout at the polls". Claude Bennett, the Ontario Minister of Municipal Affairs and Housing, identified a number of advantages inherent in the Ontario system of concurrent triennial elections and concluded "My view is that a uniform term of office serves to heighten public awareness of and interest in local government." No other province in Canada employs a term of office of less than three years duration for its municipal officers except Saskatchewan; and there, while the mayors of towns and villages are elected every two years, the aldermen of those towns and villages serve for four years. All jurisdictions reported that although there had been some objection to the new system initially, the level of satisfaction was high once the system was in place.

Objections received by the Committee fell into five broad categories:

- that less frequent elections would render municipal officials less accountable and/ or less responsive to the public;
- that the generally shorter time-frame governing municipal issues demands more frequent ratification of policy direction by the electorate;
- that an increasing degree of mobility in the populace and the demands of a longer term would discourage good candidates from seeking election;
- that the pursuit of provincial or federal office on one hand, and burnout and stress on the other would result in numerous resignations during the first 18 months in

office, which would necessitate costly by-elections in a triennial system that the current two-year/alternate-year system avoids; and

• that the election of an entirely new set of members to a municipal body would have disastrously disruptive effects upon the continuity and the quality of decision-making.

While the Committee acknowledges that these are legitimate concerns, it was also felt that there were compelling counter arguments. With respect to the first two objections, the Committee would respond that frequent elections involving only a tiny fraction of the electorate are not, in themselves, a guarantee of greater accountability or a higher degree of popular support. Experience elsewhere has demonstrated that less frequent elections will result in more interest, more participation, and more satisfaction among local voters. With respect to the third point, it may be observed that no jurisdiction that has adopted triennial municipal elections reported a noticeable drop in the calibre of candidates for office or an increase in the number of acclamations. The fourth item, concerning the need for by-elections, is quite likely more anticipated than real; certainly the two-year term is not immune from the need for by-elections from time to time. Again, it is significant that where triennial elections have been adopted this has not posed a perceptible problem. Finally, while it may be true that a total turnover in the membership of a municipal body could create problems in continuity and/or in the level of that body's grasp upon significant issues, but that is a factor that the public is fully capable of assessing. In 1983, the rate of re-election of incumbents holding municipal office in British Columbia was approximately 60 per cent, including retirees---suggesting a degree of stability which did not appear to be greatly altered in jurisdictions adopting a triennial system.

Further, the Committee found the following arguments in favour of triennial elections most compelling:

- less frequent, comprehensive elections serve to broaden popular awareness, interest and participation *vis-à-vis* municipal affairs, making the system more democratic and accountable;
- a longer term of office allows municipal politicians to adopt a decision-making horizon measured in years instead of months;
- the proportion of the municipal politician's time spent in learning how to do the job and running for re-election is reduced and the proportion of productive time is correspondingly increased;
- the greater expertise and broader perspective that occur as a consequence of these factors increase the elected official's ability to provide knowledgeable direction of municipal bureaucracies, and the result again is an increase in democracy and accountability as decision- and policy-making are more effectively placed in the hands of those whom the public has elected; and finally
- the adoption of a system of concurrent triennial elections will result in savings to both the taxpayer, who must bear the cost of annual elections, and to the candidates, who need contest fewer elections and will thus incur lower campaign costs.

The Committee strongly urges that implementation of a system of triennial elections be done on the basis of a so-called rolling enlistment of municipal offices as the date of election under the old system coincides with the date of the new triennial system. The chart appended to the end of this report represents this option graphically. There would be minor variations in the numbers affected each year if implementation were to be delayed, but the principle remains unchanged; three years after the decision is made to proceed with triennial elections, all municipal offices will be up for re-election con-

currently, no official's term of office need be shortened by legislative fiat, and the necessity for making explanations of both a new system and a complicated transition plan to electoral officials and the public will be greatly reduced. In the opinion of the Committee, this is not only the least disruptive approach to implementation from the perspective of the affected local bodies, but is likely the least expensive as well in view of its very modest requirement for dissemination of public information or retraining of electoral administrators.

In conclusion, the Committee wishes to reiterate its strong support for the adoption of the recommendations of the Union of British Columbia Municipalities with respect to the establishment of a system of concurrent, triennial elections for all locally elected offices including Regional District electoral area directors, school, park and other trustees. To this end, the Committee recommends changes be made as quickly as may be feasible to the relevant legislation. The Committee subscribes to the belief that these changes will improve the accountability of localy elected bodies, aid local officials in developing their expertise and judgement, raise the level of public interest and participation in local affairs, and generally strenghten the democratic process upon which every level of government in British Columbia—local, provincial and federal—is founded.

As Chairman, I would like to add a note of thanks to all those who made submission to this Committee, and especially to the members of the Committee: Mrs. Johnston, Messrs. Parks, Pelton, Reid, the Hon. W. S. Ritchie, Messrs. Blencoe, Passarell and Rose, for the time, effort and co-operation that made this report possible.

"In Her Majesty's name, His Honour the Lieutenant Governor doth thank Her Majesty's loyal subjects, doth accept their benevolence, and doth assent to this Bill."

His Honour the Lieutenant Governor was pleased to deliver the following gracious Speech:

Mr. Speaker and Members of the Legislative Assembly:

In closing this first session of the Thirty-third Parliament, I must say I was most impressed with the commitment you showed in your deliberations and with your determination that all segments of our society should share in resolving our current difficulties.

When you assembled here June 23 last to shoulder the burden of our people's concerns, you were well aware that yours would not be a simple task. We are not living through simple times. There were difficult decisions to be reached.

My Government was faced with the most severe recession since the 1930's. It had seen revenues plummet and remain depressed during a time when my Government most wanted to help its people weather the economic storm.

In difficult economic times of the past, our people looked to government for guidance — for a course to follow that would permit them, through their own fortitude, to continue enjoying the benefits they had worked so hard to realize. That guidance has been provided through the many essential services supplied by my Government. But those services cease to be of value when their cost threatens to impair our people's expectations and their ability to pay for the secure way of life they have earned.

Faced with this double edged problem of continuing to supply services at an affordable cost during a period of depressed revenues, yours was indeed a formidable task.

When my Government put before you certain proposals designed to ease the economic pressure on our people, it was fully aware that — in some segments of our provincial community — those measures would be troubling. Those proposals were not arrived at easily or without agony by my Government.

It is the role of government to lead, and having set its course and defined its goal, to move forward in its determination to better the lot of our people. And while faced with outspoken opponents to its legislative program my Government has been encouraged by the majority of British Columbians who wished to see those proposals implemented.

Through that period our people were still able to take comfort in the knowledge that unlike some countries of the world, our free democratic system encourages independent thought and open debate. We treasure that as a jewel. We would have it no other way. It is one of our greatest strengths.

And while that strength did at times upset the harmony of your deliberations it did, also, through that free exercise of independent thought and the ability to understand the aspirations of others, bring about solutions.

While you were in this Chamber exercising those precious rights without fear of reprisal for your individual beliefs, we all watched with horror as the details of a frightful and barbaric incident in the skies, which took 269 innocent lives, unfolded before us. A terrifying example of disdain for human rights and human life.

It brought into sharp focus the events of some months earlier as we witnessed the freedom with which our Sovereign, Her Majesty, Queen Elizabeth II and His Royal Highness, the Duke of Edinburgh, were able to visit with us without fear as they walked among and talked with our people.

And when Her Majesty invited the World to participate in Expo 86, we were reminded of our fortunate place as Canadians in the roster of nations.

You will be returning to this Chamber soon once again to take up the mantle of leadership of our people. My Government will again be bringing before you measures designed to accelerate a recovery from the economic problems we face, and to ease the constraints which have been put upon our people through conditions over which it has no control.

There will no doubt be periods of misunderstanding, of disagreement and of stress for you all. But I am confident from my understanding of our people's history of outstanding achievement and fierce pride that you will collectively resolve these problems and arrive at the best possible solution for the overall benefit of our Province.

Honourable Members, I now relieve you of your legislative duties, and I trust the blessing of Divine Providence will be with you as you shortly resume those responsibilities.

The Hon. J. R. Chabot (Provincial Secretary and Minister of Government Services) then said:

Mr. Speaker and Members of the Legislative Assembly:

It is His Honour the Lieutenant Governor's will and pleasure that this Legislative Assembly be prorogued until 2 o'clock p.m. Monday next, and this Provincial Legislative Assembly is hereby prorogued accordingly.

In 1975/76, the Social Credit Government gave a commitment to the Nishga regarding land claims. Has the Attorney General set a date to commence land claim negotiations with the Nishga? If so, what is that date?

The Hon. B. R. D. Smith replied as follows:

"In accordance with s. 91 (24) of the British North America Act, Canada has responsibility for Indians and lands reserved for Indians. The negotiation of Indian claims is therefore, principally a federal responsibility. Canada announced its intention to seek negotiated resolution of Indian claims in 1973. At that time it sought the participation of the Government of British Columbia. However, the Government of the day refused to participate. On January 12, 1976 the Government of British Columbia was represented at the Ministerial level at a meeting in New Aiyansh. A representative of the Government of British Columbia chaired four of those meetings at the invitation of the other parties."
