### Thursday, December 16th, 1926.

THREE O'CLOCK P.M.

This being the first day of the third meeting of the Sixteenth Parliament or Legislative Assembly of the Province of British Columbia for the dispatch of business, pursuant to a Proclamation of the Honourable ROBERT RANDOLPH BRUCE, Lieutenant-Governor of the Province, dated the 13th day of October, 1926,

His Honour Robert Randolph Bruce, Lieutenant-Governor of the Province, having entered the House, took his seat on the Throne, and was pleased to deliver the following gracious Speech:—

Mr. Speaker and Members of the Legislative Assembly:

I welcome you to this the Third Session of the Sixteenth Parliament of British Columbia. Since the last Session of this House General Viscount Byng of Vimy completed his term of office as Governor-General of Canada and returned to the Motherland, bearing with him the sincere appreciation of the Canadian people for his public service, and the very best wishes for himself and Viscountess Byng.

The high post of representative in Canada of His Majesty the King has recently been filled by the appointment of Viscount Willingdon as Governor-General. We of British Columbia join with our fellow-Canadians in extending a warm welcome to Viscount Willingdon and the Viscountess.

It is a matter of pleasure to note that business conditions in the Province have continued to improve and that substantial increases have occurred in timber, agriculture, mineral, and fishery production.

It is gratifying to observe that the products of British Columbia, in competitive exhibition with the products of other parts of the world, have won highest awards.

My Government has continued its efforts to obtain elimination of unjust and discriminatory transportation rates.

Renewed application has been made by my Government for the return by the Government of the Dominion of the unalienated portions of the lands granted in aid of the construction of the Canadian Pacific Railway.

Construction of main trunk roads has been carried on vigorously during the year and substantial progress has been made. Simultaneously every effort has been put forth to provide requisite settlers' roads.

A report of the Royal Commission appointed to inquire, inter alia, into the problem of mental disease in this Province will be submitted for your consideration.

The Annual Reports of the Departments of Government will be placed before you.

The Public Accounts for the fiscal year 1925-26 and the Estimates of Revenue and Expenditure for the fiscal year 1927-28 will be submitted for your consideration.

Legislation designed for the assistance and protection of the agricultural industry and for the protection of the public in connection with loan companies will be presented.

The removal by death of Arthur Ormiston Cochrane, late member for the Electoral District of North Okanagan, is very deeply regretted.

I now leave you in confidence that your duties will be faithfully performed and with the prayer that the blessing of Almighty God may be with you in your deliberations.

His Honour the Lieutenant-Governor was then pleased to retire.

Prayers by the Rev. Mr. Smith Paterson.

Mr. Speaker reported that, to prevent mistakes, he had obtained a copy of His Honour's Speech.

On the motion of the Hon, Mr. Manson, Bill (No. 1) intituled "An Act to amend the 'Interpretation Act'" was introduced, read a first time, and Ordered to be read a second time at the next sitting.

On the motion of the Hon. Mr. Oliver, seconded by Mr. Pooley, it was Resolved,—

That this House express its sincere regret at the untimely death of *Arthur Ormiston Cochrane*, Esquire, member for the Electoral District of North Okanagan; and that the Clerk do convey to Mrs. Cochrane and the family of the late member the condolence and sincere sympathy of the members of the Legislative Assembly.

On the motion of the Hon. Mr. Oliver, seconded by the Hon. Dr. MacLean, it was Resolved,—
That the Speech of His Honour the Lieutenant-Governor be taken into consideration at the
next sitting of the House, and that this Order have precedence over all other business, except
the introduction of Bills, until disposed of.

Ordered, That the Votes and Proceedings of this House be printed, being first perused by Mr. Speaker, and that he do appoint the printing thereof, and that no person but such as he shall appoint do presume to print the same.

Resolved, That if it shall appear that any person hath been elected or returned a member of this House, or endeavoured so to be, by bribery or other corrupt practices, this House will proceed with the utmost severity against all such persons as shall have been wilfully concerned in such bribery or other corrupt practices.

Ordered, That the Select Standing Committees of this House, for the present Session, be appointed for the following purposes:—

  - 3. On what date did the advertisement of such sale first appear? In what newspapers?
  - 4. Did such advertisement state the area of such licence?
- 5. Did such advertisement give any information as to the amount of timber to be sold or that was offered for sale?
- 6. Did the advertisement announce the upset price of the different kinds of timber in the said licence?

- 7. How much money was spent on advertising the sale?
- 8. What were the upset prices for each kind of timber?
- 9. What terms of payment were provided for?
- 10. How much eash was paid?
- 11. How many tenders were received and from whom? What were the prices?
- 12. What is the estimated quantity of the timber contained within the boundaries of said licence?
  - 13. What is the acreage?
- 14. Were there any negotiations by any person or persons or corporation for the said licence prior to its being advertised?
  - 15. If so, by whom?
- 16. Did the Powell River Company cruise the said licence before making a tender? If so, when? How long were their cruisers engaged thereon?
- 17. Did George H. McKinnon, a timber-cruiser, protest in writing to the Minister of Lands against such sale being made at this time of the year when communication with Graham Island is difficult and the season is not propitious for examining timber?
  - 18. Did any other person or persons make a protest to the Minister of Lands?
- 19. Did any person or corporation make request for time to inspect said timber with a view of making a bid to purchase this timber? If so, when, and who were the parties? Was extra time granted? If not, why not?
  - 20. What amount of money is the timber valued at?
- 21. What are the average prices in the Province paid for timber of this grade and kind per thousand feet on the stump?
  - 22. Why were tenders called for at this period of the year?
- 23. What facilities are provided for passengers to reach the Queen Charlotte Islands in the winter-time?

The Lumber Products Company was advised that if they would erect a pulp and paper plant in connection with the existing licences, which it is understood approximate over two billion feet, such additional Government timber as might be available and required to supplement the present supply up to capacity of proposed unit would be rendered available under the terms of the 'Forest Act.'
  - "20. \$694,312.50 plus royalty.

The Hon. Dr. MacLean presented a Return of moneys received and paid by the Official Administrator required by section 53 of the "Administration Act."

Pursuant to Order, the House resumed the adjourned debate on the Address in reply to the Speech of His Honour the Lieutenant-Governor at the opening of the Session.

On the motion of the Hon. Mr. Pattullo, the debate was adjourned to the next sitting.

Mr. Bryan presented a petition from the First Narrows Bridge Company, Limited, for leave to introduce a Private Bill for the purpose of giving it the necessary power to construct a bridge across the First Narrows at Burrard Inlet, and for other powers.

Mr. Hinchliffe moved, seconded by Mr. Pooley,-

Whereas the "Mothers' Pensions Act" as at present constituted and administered has certain undesirable effects upon citizens who may be potential beneficiaries under the said Act, and particularly in that it tends to discourage thrift, economy, and providence for the future:

Therefore be it Resolved, That a Select Committee of this House be appointed to examine the provisions of the "Mothers' Pensions Act," and the regulations made thereunder, and to inquire generally into the administration thereof, and to report to this House its findings in regard thereto, and to recommend to this Legislature such action as to the said Committee may appear advisable, in order to secure the extension of the benefits of the "Mothers' Pensions Act," and the reduction to a minimum of its present undesirable effects; and that the Committee to be appointed hereunder have power to summon and examine witnesses, and to call for the production of books, papers, and records.

The Hon. Mr. Manson moved in amendment, seconded by the Hon. Mr. Oliver,—

That all the words of the preamble of the said Resolution, and the first three words of the Resolution, and the words "in order to secure the extension of the benefits of the 'Mothers' Pensions Act' and the reduction to a minimum of its present undesirable effects" be struck out.

Amendment agreed to.

Resolution as amended agreed to.

- "3. Nickson Construction Company's tender was on a unit basis and amounted to \$118,903, which figure did not include the cost of 'piling delivered' at a unit rate of 20 cents per lineal foot. Hamilton Bridge Company's tender was on a lump sum basis and amounted to \$42,830. Reasons for increased cost over lump sum are: Extras, floor-plates, light-standards, cabin walls, \$1,121.91."
  - Mr. Coventry asked the Hon, the Minister of Public Works the following questions:—
  - 1. At what periods during 1926 was the Island Highway between Victoria and Duncan closed?
- 2. If at such times traffic was diverted over the Mill Bay Ferry, thereby carrying enormously increased traffic over the Saanich roads?
- 3. If due to the introduction of the ferry the traffic over the Saanich roads has been greatly increased at all times?
  - 4. If the slips of the Mill Bay Ferry were built at Government expense?
  - 5. If the operations of the ferry were subsidized by the Government?
- 6. If the Municipality of Saanich has received any compensation or increased assistance in funds for road-building and road-repairing as a result of this increased traffic over their roads?

The Hon, Dr. Sutherland replied as follows:--

- "1. April 25th to May 14th (portion closed at a time while tarviating). December 16th to 24th (Malahat closed entire length owing to weather conditions).
  - "2. The above periods do not constitute the 'peak' of traffic.
  - "3. No census of traffic taken.
  - "4. Yes,
  - "5. No.
- "6. Yes; under the terms of Part III. of 'Highway Act' relating to 'classification and improvement of highways."

Mr. Catherwood asked the Hon. the Minister of Public Works the following questions:—

- 1. Were repairs carried out in the Court-house at Prince Rupert a short time ago?
- 2. If so, what was the nature thereof?
- 3. Who did the work?
- 4. How long did he take to complete the work?
- 5. What was the cost thereof?
- 6. Where was the person employed?
- 7. Where is his place of business?
- 8. Was he a resident of Prince Rupert?

The Hon. Dr. Sutherland replied as follows:-

- "1. Yes.
- "2. Damp-proofing parapet, repairing plaster, and adding storm-sash to certain windows.
- "3. Local labour under the Department's regular foreman.
- "4. Seven weeks.
- "5. \$1,884.18.
- "6. In this instance, Prince Rupert.
- "7 and 8. The foreman's headquarters are in Victoria, but on special work may be sent to other localities."

Mr. Pooley asked the Hon. the Minister of Public Works the following questions:-

- 1. On what dates were the various buildings at the Point Grey University completed?
- 2. On what dates were the respective buildings taken over?
- 3. Have any repairs been done to any of the said buildings since the respective dates on which they were taken over?
  - 4. Were any of the buildings gone over with the cement-gun? If so, which building?
  - 5. When was the work done?
  - 6. Who did it?
  - 7. What was the cause of it?
  - 8. Why was it necessary to do this work?
  - 9. Were tenders called for it?

The Hon, Dr. Sutherland replied as follows:-

- "1. See No. 2.
- "2. Library, September 16th, 1925; Administration and Agriculture, March 7th, 1925; Arts, April 7th, 1925; Auditorium, May 8th, 1925; Applied Science, September 11th, 1925; Engineering, July 23rd, 1925; Forest Products Laboratory, June 22nd, 1925; Science Building, October 31st, 1925; Power-house, September 4th, 1925.
  - "3. No. Only what is covered by maintenance clause in contract.
  - "4. No.
  - "5, 6, 7, 8, and 9. See No. 4."

Mr. Pooley asked the Hon. the Minister of Public Works the following questions:-

- 1. What is the total cost of surveying the Cariboo Road, Fraser Canyon, up to the time construction started?
- 2. What is the cost of engineering to December 31st, 1926, on the Cariboo Road, Fraser Canyon, since commencement of construction-work?
- 3. What is the total cost to December 31st 1926, on this new route to the Interior known as the Cariboo Road, through the Fraser Canyon?

The Hon, Dr. Sutherland replied as follows:-

- "1. \$19,382.63.
- "2. Total engineering \$113,323 80

  Less preliminary survey expenditure, Lytton-Spences Bridge Section 9,499 94

  Total engineering costs of constructed section (=5.84 per cent. of total cost of work exclusive of engineering) \$103,823 86

  "3. Total expenditure, Hope-Lytton \$1,889,416 12

  Less engineering costs, including Lytton-Spences Bridge Section 113,323 80

  Total cost of work exclusive of engineering \$1,776,092 32 "

Prayers by Mr. Speaker.

Mr. Speaker *Buckham* delivered the following ruling relating to a notice of motion of Mr. *Browne* dealing with the matter of campaign funds:—

" Honourable Members:

"On Tuesday evening the honourable the member for Burnaby filed with the Clerk notice of a proposed resolution, and, as was my duty (May, 13th Edition, page 190), I took the notice of the proposed resolution into my consideration. I formed the opinion that the proposed resolution was not in order and last evening I so advised the honourable member, who now advises me that he is not disposed to accept my view.

"In order that I may have the benefit of the advice of the honourable members I have directed the Clerk to put the notice on the Order Paper for Monday next. The point of order may then be formally raised and debated."

Pursuant to Order, the House resumed the adjourned debate on the Address in reply to the Speech of His Honour the Lieutenant-Governor at the opening of the Session.

On the motion of Mr. Peck, the debate was adjourned to the next sitting.

Mr. Perry presented the Sixth Report of the Select Standing Committee on Private Bills and Standing Orders, as follows:— \*

LEGISLATIVE COMMITTEE ROOM,

January 20th, 1927.

MR. SPEAKER:

Your Select Standing Committee on Private Bills and Standing Orders begs leave to report as follows:—

That the Standing Orders in connection with the undermentioned petition have not been complied with, inasmuch as the copy of the petition, Bill, and notices were not deposited with the Clerk of the House eight clear days before the opening of the Session.

No. 10—The Lions' Gate Bridge Company, Limited.

Your Committee recommends that the Standing Orders be suspended to enable the petitioner to proceed with the Bill without payment of double fees.

The report was read and received.

The Rules were suspended and the report adopted.

On the motion of Mr. Walkem, Bill (No. 59) intituled "An Act to empower the Erection of a Toll-bridge across the First Narrows, or Lions' Gate, of Burrard Inlet" was introduced, read a first time, and referred to the Select Committee on Private Bills and Standing Orders.

On the motion of the Hon. Dr. Sutherland, Bill (No. 8) intituled "An Act to amend the 'Railway Act'" was introduced, read a first time, and Ordered to be read a second time at the next sitting.

On the motion of Mr. Twigg, seconded by Mr. Hayward, it was Resolved,—

That an Order of the House be granted for a Return showing: (1) The names of the members of the Export Advisory Committee representing the manufacturers at the present time and the names of those who have been members since November 1st, 1925, but who are now no longer members thereof; (2) the same information as regards the loggers' representatives; (3) for the period from November 1st, 1925, to November 1st, 1926, inclusive, the names of those persons or corporations to whom leave was granted by said Committee to export logs, and in each case the amount exported, the port of destination, the classification of logs, and the dates;

(4) the names of those persons or corporations to whom permission to export was refused by said Committee during the period from November 1st, 1925, to November 1st, 1926, inclusive, giving dates of such refusals in each case.

On the second reading of Bill (No. 4) intituled "An Act to amend the 'Provincial Elections Act'" a debate arose, which was, on the motion of the Hon. Mr. Manson, adjourned to the next sitting.

Bill (No. 11) intituled "An Act to amend the 'Royal Inland Hospital Act, 1896'" was read a second time.

Mr. Twigg asked the Hon. the Attorney-General the following questions:-

- 1. Is Gerald G. McGeer, K.C., still employed by the Provincial Government in connection with the application to the Board of Railway Commissioners for revision of the railway rates and removal of discriminations against British Columbia?
  - 2. If so, when was G. G. McGeer first employed?
- 3. (a.) What amounts of money have been paid to the said Gerald G. McGeer, K.C., for his professional services? (b.) How much money has been paid to him for expenses in each year? (c.) What amount of money is now owing to him for legal services and for expenses?
- 4. Is it the intention of the Government to dispense with the services of Gerald G. McGeer, K.C.?
  - 5. Is Gerald G. McGeer, K.C., employed on contract?
  - 6. If yes, what are its terms?
- 7. What amount of money per diem is Gerald G. McGeer, K.C., charging the Provincial Government for his services?
  - 8. What amount of money is allocated per diem for the expenses of Gerald G. McGeer, K.C.?
- 9. What amounts of money were paid to Gerald G. McGeer, K.C., or charged by him for his services and expenses for the months of September and October, 1926?
- 10. What amount of money is the Government committed to in respect of: (a) The services of Gerald G. McGeer, K.C., for the months of September and October, 1926; (b) the expenses of Gerald G. McGeer, K.C., for the months of September and October, 1926?
- 11. If the Government has no information respecting question No. 9, will the Hon. the Premier obtain such information and make answer to this question immediately?

The Hon. Mr. Manson replied as follows:-

- "1. Yes.
- "2. Continuously since January 26th, 1921. See Journals, 1926, page 62.
- "3. (a) and (b). See Public Accounts as follows: 1922–23, page A 75; 1923–24, page O 75; 1924–25, page O 68; 1925–26, page N 60; of which the following sums represent expenses and disbursements for postage, telegrams, telephones, printing, binding, etc.; maps, records, statistics and transcripts, expert assistance, advertising, travelling and miscellaneous expenses incurred incidental to the preparation and presentation of the freight-rates case, the express-rates case, and the Crow's Nest Pass rate case, between January 26th, 1921, and December 31st, 1925, the balance being solicitor's and counsel fees as allowed after taxation, and include all expenses incidental to Mr. McGeer's office and the office staff employed by him re freight rates: 1922–23, \$23,645.44; 1923–24, \$12,487.36; 1924–25, \$2,464.10; 1925–26, \$5,035.
- "N.B.—The Province of Alberta contributed the sum of \$18,443.68 towards counsel fees and expenses. See page N 60, Public Accounts, 1925–26.
  - "(c.) Not known until account rendered and taxed.
  - "4. Not under advisement at present time.
  - " 5. No.
  - "6. Answered by No. 5.
- "7. Bills have been taxed by Department Taxing Officer and have been allowed at a somewhat lower rate than the regular tariff by reason of the extended nature of the work.
- "8. Nil; being an uncertain amount and subject to production of vouchers covering transportation expenses, but a sum of \$10 per diem for subsistence has heretofore been allowed while away from home.

- "9. No moneys have been paid to G. G. McGeer, K.C., for his services or expenses for the months of September and October, 1926, although in the course of his retainer it was necessary for him to proceed to Edmonton on October 20th, 1926, and do other incidental work for which account will be rendered in due course.
- "10. (a) and (b). Amount not determinable until settlement of account covering these months.
  - "11. Answered by No. 9."

Mr. Pooley asked the Hon. the Minister of Lands the following questions:-

- 1. What is the annual rental which the Powell River Company is supposed to pay on Pulp Licence X8440?
- 2. What is the rate of royalty which they will be called upon to pay for every cord of timber cut on such licence?

The Hon. Mr. Pattullo replied as follows:-

- "1. \$6,575.19, subject to adjustment on survey,
- "2. Whatever the rates are at time of cutting. Under present Act timber used for pulp takes pulp royalty, while timber manufactured into lumber takes lumber royalty."
  - Mr. Lister asked the Hon. the Minister of Lands the following questions:-
- 1. Did Major Clarke make an economical survey of the irrigation districts in the Okanagan during last summer?
  - 2. If so, on which Department's authority?
- 3. Is the Hou, the Minister prepared to make a Return of a copy of the report of this survey to the House?

The Hon, Mr. Pattullo replied as follows:-

- "1. Major Clarke gathered together a large amount of statistical data.
- "2. Lands Department.
- "3. Report will be made to House when completed."

Mr. Bruhn asked the Hon, the Minister of Agriculture the following questions:—

- 1. Is one A. D. McFarlane, barrister, of Victoria, employed by the Department?
- 2. If not by the Department, has the Department any information showing whether said McFarlane is employed by the Commissioners in charge of the Sumas Dyking Project?
  - 3. If so, in what capacity?
  - 4. What are his duties?
  - 5. What salary does he receive?
- 6. If not employed at a fixed salary, what remuneration has he received to date and covering what period?

The Hon. Mr. Barrow replied as follows:-

- "1. No.
- "2. Yes; employed until recently by the Commissioners, Sumas Drainage, Dyking, and Development District.
  - "3. In legal capacity.
- "4. Employed on special work in connection with the following matters: Final settlement with the contractors, Marsh Construction Company; assessment roll; Court of Revision; appeals to Judge from Court of Revision; Sumas legislation; preparation of documents and securities as required by Act, and other matters.
  - "5. Not on salary.
- "6. \$6,000, covering period of approximately eighteen months up to December 31st, 1926. This amount covers considerable disbursements as well as fees, but particulars are not in the possession of the Department."

Resolved, That the House, at its rising, do stand adjourned until 2 o'clock p.m. to-morrow.
