Prayers by Mr. Speaker.

Order for Committee of Supply called.

Pursuant to Order, the House again resolved itself into the Committee of Supply.

By leave of the House, the following notice of motion by Mr. E. E. Winch was withdrawn:-

Whereas it has been reported in this House that the staffs of many hospitals in the Province contain an inadequate number of properly trained graduate nurses, which condition, should it exist, may tend to result in patients failing to receive, promptly and continuously, a sufficiency of skilled treatment at a time when their lives may depend upon such skill and service:

Therefore be it Resolved, That in the opinion of this House every hospital should be required to employ a sufficiency of graduate nurses, the number of which, in relation to the number of beds available for the accommodation of patients, shall not be less than one graduate for every six beds.

The Hon. Mr. Weir presented a Return in answer to the following questions by Mr. Planta:—

Mr. Bruhn asked the Hon. the Premier the following questions:-

Re the answers given to questions by the Hon. the Premier on November 5th relative to the existing New Westminster Bridge, and more particularly to questions 3 and 4, in which the Hon. the Premier stated that the (3) "Physical value to-day, \$550,000"; and (4) there was a "Net annual deficit, \$41,515.96." Would the Hon. the Premier please clarify his answers in the light of: (a) The expenses chargeable to the Fraser River Bridge, including labour, police, maintenance, and renewals, as set out in the Estimates, 1936–37 (page DD 113), totals \$60,691; (b) the revenues derived from the said bridge as shown in the Public Accounts for the year ended March 31st, 1936 (Details of Revenue for the Fiscal Year ended March 31st, 1936, page EE xvi.), amounting to \$60,926.08?
 - 2. When was the said Fraser River Bridge at New Westminster constructed?
 - 3. What was the cost of the said bridge when completed?
 - 4. Was it a toll-bridge: (a) Railway tolls; (b) passenger and vehicular tolls?
 - 5. If so, for what length of time were tolls collected?
- 6. What was the total amount of tolls so collected: (a) From railways; (b) from footpassengers, cyclists, and vehicular traffic?
- 7. Are tolls now collected from: (a) Railways; (b) from foot-passengers; (c) from cyclists; (d) from vehicular traffic?
 - 8. If not, when were such tolls, or any of them, abolished?

The Hon. Mr. Pattullo replied as follows:—

"1. Approximate life of bridge, fifty years; present age, thirty-two years; remaining useful life, eighteen years. Eighteen-fiftieths of the original cost, plus permanent improvements, is \$549,046, which is the present value of the bridge. Annual expenditure, including principal and interest, and average cost of maintenance and improvements for last ten years, \$114,805.39; average revenue, last ten years, \$73,289.43; annual deficit, \$41,515.96.

"2. Construction commenced August, 1902; official opening, July, 1904; opened for traffic,

October, 1904.

- "3. Original cost, \$1,018,382.87.
- "4. (a) Yes; (b) yes.
- "5. Highway traffic and passenger tolls were collected until April 1st, 1910; railway tolls are collected annually.

- 7. Are any bonds, debentures, or securities of any board or commission controlled or operated or whose finances are guaranteed by the Province of British Columbia held by the Government of Alberta?
- 8. If so, what are the amounts of such bonds, and the interest rates payable upon the same?
- 9. If the Province of Alberta has tendered a lower rate of interest than demanded by such bonds held by the Government of British Columbia, or by any board or commission controlled or operated by the Government of British Columbia, has the Government of British Columbia charged the difference as a contra account in remitting interest payments to the Province of Alberta upon British Columbia bonds, or the bonds, debentures, or other securities of British Columbia Government controlled, guaranteed, financed, or operated boards and commissions?

Mr. Bruhn asked the Hon. the Premier the following questions:—

When the Act, being "An Act to provide for the Construction of a Bridge across the Fraser River at New Westminster," assented to March 23rd, 1935, and being chapter 26 of the Statutes of British Columbia, 1935, was passed, did the Government obtain legal opinion as to the manner in which such Act was, or would be, affected by "An Act respecting the Fraser River Bridge Company, Limited," passed by this Legislature in the year 1934?
 - 2. If not, why not?
 - 3. Was such Act passed in 1934 repealed?
- 4. Was the Bill of 1934 presented upon the responsibility of the Honourable the Ministers of the Crown?

If the Act of 1934 has not been repealed, does the Government feel bound by section 8 of the said Act, which gave a franchise to the said Bridge Company for the construction of the said bridge, to the exclusion of any other bridge for foot-passenger and vehicular traffic for a distance of 24 miles above and 8 miles below the proposed site of such bridge?
- 8. Does the bridge now building under the Act of 1935 exclude the erection of a similar bridge, or bridges, in the 32 miles, being 24 miles above and 8 miles below the said bridge?
