THREE O'CLOCK P.M.

This being the first day of the third meeting of the Fourteenth Parliament or Legislative Assembly of the Province of British Columbia, for the dispatch of business, pursuant to a Proclamation of the Honourable J. A. Macdonald, Administrator of the Province, dated the 23rd day of December, 1918,

His Honour Sir Frank Stillman Barnard, Lieutenant-Governor of the Province, having entered the House, took his seat on the Throne, and was pleased to deliver the following gracious Speech:—

Mr. Speaker and Members of the Legislature:

In greeting you at this the opening of the third Session of the Fourteenth Legislature of British Columbia, I give thanks to Almighty God that He hath granted victory to the arms of Great Britain and her Allies; that her enemies have been compelled to sue for peace; and that a conference of representatives of the Allied nations is now in session to determine the conditions of peace.

My Government recognizes and rejoices in the strength displayed by the British forces, and appreciates the valiant part taken in this war by His Majesty's subjects in the Dominion of Canada, taking modest but just pride in the achievements of the brave men from this Province, many of whom have earned and received tokens of their distinguished conduct.

My Government is not forgetful of those who have paid the supreme sacrifice in order that freedom and justice might be secured and the right of self-determination established for all the nations of the earth. Their memories will be cherished by our people, and the principles for which they died, because of their sacrifice, shall be upheld by those who remain.

To those who have been spared and will return soon from overseas, I voice not only my own sentiment, but that of my Government and the people of British Columbia, when I assure them of a hearty welcome, feeling confident that they will resume their vocations with the same fortitude and courage displayed on the field of battle, uniting earnestly with those to whom they will be restored in efforts to re-establish the prosperity of the Province and develop its resources for the benefit of all.

Last summer my Government urged upon the Prime Minister of Canada the importance of summoning a conference, at which the several Provinces, as well as the Dominion, would be represented, for the discussion and co-ordination of plans for the re-establishment of returned and returning soldiers in civil life. As a result, representatives of the Dominion and all the

Provincial Governments met in Ottawa, following which certain plans were formulated in November last and assurances were given to the Federal Government that the hearty co-operation of the several Provinces would be accorded in carrying out the proposals agreed upon. Legislation to implement this pledge on the part of my Government will be placed before you.

A tract of land in the South Okanagan District has been purchased under the provisions of the "Soldiers' Settlement Act" for the benefit of returned soldiers, and you will be asked for appropriations to carry out development-work thereon.

A large area of Crown lands has been surveyed and reserved for the purpose of soldier settlement.

. Provision also is being made to acquire homesites within or adjacent to cities, and moneys advanced by the Federal Government for housing purposes will be utilized to erect dwellings thereon. Legislation necessary for these purposes will be placed before you.

A Bill designed to encourage stock-breeding within the Province and providing for a comprehensive grazing policy will be laid before you for your consideration.

A measure will be introduced granting relief in respect of timber licence fees to those engaged in active naval or military service.

It affords me pleasure to advise you that during the past year agricultural production has increased and new industries have been established within the Province. Early in the year my Government took effective steps to place the timber resources of the Province at the convenient disposal of the Imperial authorities for war purposes. Extensive contracts for the building of ships for both British and foreign Governments have been entered into by ship-building firms.

My Government has been active in urging upon the Dominion Government the necessity of completing the contractual obligations of the Canadian Northern Pacific Railway Company in respect of unfinished work in British Columbia. As a result of the representations made, the construction of the Canadian Northern Pacific Railway on Vancouver Island is progressing, and it is confidently expected that further construction in other parts of the Province will be proceeded with during the year.

Construction on the Pacific Great Eastern Railway is proceeding satisfactorily, and it is the intention of my Government to prosecute vigorously further extensions during the coming season.

Notwithstanding the comparatively small appropriations for the purpose, the Department of Public Works has effected the necessary repairs to roads, trails, and bridges.

You will be asked to consider the advisability of voting an emergency appropriation for the purpose of providing employment during the coming year by carrying on development-work of a productive character.

I am pleased to advise you that the value of mineral production for the year 1918 shows a substantial increase over that of the previous year. The prospects for the coming year are encouraging. There has been a decline in the production of placer gold, but the output of lode gold has increased. It is expected that the year 1919 will show a marked increase in this class of mining. The production of coal has been very materially increased during the year, and there is a prospect that new coal areas will be developed.

Amendments to the "Coal-mines Regulation Act" will be placed before you for consideration. Engineers appointed to investigate and encourage mining report a feeling of optimism and confidence among operators and prospectors throughout the Province.

A report dealing with the practicability of the electro-smelting of British Columbia iron ores will be laid before you.

It is proposed to submit for re-enactment the "Vancouver Island Settlers' Rights Act, 1904, Amendment Act, 1917."

My Government, through the Hon, the Minister of Education, has entered into an arrangement with other Western Provinces for the standardization of educational text-books.

Necessary amendments to the "Prohibition Act" will be laid before you.

Legislation disfranchising military deserters and other persons exempted from military service will be submitted.

A Bill to authorize the appointment of a Public Utilities Commission will be submitted for your consideration.

A Bill for the establishment of a Public Library Commission will be submitted.

A Bill to provide for the appointment of official school trustees for the better regulation of public schools in alien communities will be laid before you.

You will be asked to consider a Bill providing for the superannuation of Civil Servants. Amendments to the "Civil Service Act" will be submitted.

Protection from tax sales and for the further relief of returned soldiers is proposed.

The Public Accounts for the past fiscal year will be laid before you at an early date.

The Estimates of Expenditure for the coming year will be submitted for your consideration.

Gentlemen, in leaving you to your deliberations, I have confidence that the work you will undertake will be faithfully performed, and I pray the blessing of Providence upon your labours.

His Honour the Lieutenant-Governor was then pleased to retire.

Prayers by the Rt. Rev. Lord Bishop of Columbia.

Mr. Speaker reported that, to prevent mistakes, he had obtained a copy of His Honour's Speech.

Ordered, That the Votes and Proceedings of this House be printed, being first perused by Mr. Speaker, and that he do appoint the printing thereof, and that no person but such as he shall appoint do presume to print the same.

Ordered, That the Select Standing Committees of this House, for the present Session, be appointed for the following purposes:—

- 1. On Standing Orders and Private Bills;
- 2. On Public Accounts:
- 3. On Printing;
- 4. On Railways;
- 5. On Mining;
- 6. On Agriculture;
- 7. On Municipal Matters;

which said Committees shall severally be empowered to examine and inquire into all such matters and things as shall be referred to them by the House, and to report from time to time their observations and opinions thereon, with power to send for papers, persons, and records.

Resolved, That if it shall appear that any person hath been elected or returned a Member of this House, or endeavoured so to be, by bribery or other corrupt practices, this House will proceed with the utmost severity against all such persons as shall have been wilfully concerned in such bribery or other corrupt practices.

On the motion of the Hon. Mr. Farris, Bill (No. 1) intituled "An Act to amend the 'Equal Guardianship of Infants Act'" was introduced, read a first time, and Ordered to be read a second time at the next sitting.

Francis William Henry Giolma, elected to represent the Electoral District of Victoria City, having been duly sworn, was introduced by the Hon. the Premier and Dr. McIntosh, and took his seat.

Richard John Burde, elected to represent the Electoral District of Alberni, having been duly sworn, was introduced by the Hon. the Premier and Dr. McIntosh, and took his seat.

Edward Dodsley Barrow, elected to represent the Electoral District of Chilliwack, having been duly sworn, was introduced by the Hon. the Premier and the Hon. the Provincial Secretary, and took his seat.

The election returns of the result of the by-elections of Members to represent the Electoral Districts of Victoria City, Alberni, and Chilliwack were read, and *Ordered* to be placed on the Journals, and the same are as follows:—

Prayers by Rev. Dr. Campbell, Ph.D.

Mr. Hanes rose and proposed to move, under Rule 33, as a matter of urgency and of great public importance, the following Resolution:—

Whereas D'Arcy Tate, a witness before the Select Committee to inquire into the construction of the Pacific Great Eastern Railway, did refuse to answer questions put to him by said Committee as to the amounts and names of persons, whether members of the then Legislature or not, to whom he paid part or all of the sum of \$500,000 and other amounts, for gifts, influence, political or campaign purposes, and who did not appear before this House to answer said questions, although a warrant of the Hon. the Speaker of this House was issued to summon said Tate before this House to answer said questions:

Therefore be it Resolved, That the Speaker do issue his warrant or a subpœna to said D'Arcy Tate to personally appear before the bar of the House forthwith to answer said questions and to answer for his said conduct, and to be dealt with as the House may see fit.

Mr. Speaker Keen ruled that the motion did not disclose sufficient importance or urgency to allow the same to be moved without notice. (See ruling, April 12th, 1918.)

Dr. McIntosh appealed from the ruling of the Chair.

The Chair was sustained.

Pursuant to Order, the House proceeded to take into consideration the Speech of His Honour the Lieutenant-Governor at the opening of the Session.

Mr. Anderson (Kamloops) moved, seconded by Mr. Pauline (Saanich),—

That an humble Address be presented to His Honour the Lieutenant-Governor, thanking His Honour for his gracious Speech at the opening of the present Session.

We concur gratefully in the expression of thanks to Almighty God for the victory granted to the arms of Great Britain and her Allies, rejoicing in the defeat of their enemies, and trust that the Conference now in session to determine the conditions of peace may result in an agreement between the deliberating Powers which will secure lasting peace to the nations of the world.

We concur in the recognition by His Honour's Government of those who have paid the supreme sacrifice in order to secure freedom and justice and the right of self-determination for the nations of the earth. It will be our pleasure to assist every movement for cherishing by our people the memories of those brave men who gave up their lives for the principles of freedom and for the upholding of those ideals for which they died.

We appreciate the gracious welcome extended by His Honour on behalf of the Government and the people of British Columbia to those who shortly will return from overseas, and share the confidence expressed that they will carry with them in their return to civil life the fortitude and courage displayed on the field of battle, resuming earnestly their co-operation with the people of the Province in the development of its resources and industries.

We approve the action of His Honour's Government in urging upon the Prime Minister of Canada the importance of summoning the Conference for the discussion and co-ordination of plans for the re-establishment of returned and returning soldiers in civil life, and note with approval that representatives of the Dominion and the Provinces met in Ottawa, pledging the

hearty co-operation of the several Provinces in the carrying-out of proposals agreed upon. We shall give most careful attention to legislation submitted to implement this pledge on the part of His Honour's Government.

We are pleased to note that tracts of land have been purchased under the provisions of the "Soldiers' Settlement Act" for the benefit of returned soldiers, and will consider the granting of liberal appropriations for the carrying-out of development-work thereon.

We observe also with pleasure that provision is being made to acquire homesites within and adjacent to cities, and that moneys advanced by the Federal Government for housing purposes will be utilized to erect dwellings thereon. Legislation submitted for these purposes will have our careful attention and sympathetic consideration.

We shall give careful attention to any measures submitted for the encouragement of stock-breeding within the Province.

Such legislation as is introduced with a view to granting relief in respect of timber licence fees to those engaged in active naval or military service will have our best attention.

We note with gratitude His Honour's reference to the increase in agricultural productions and the establishment of new industries within the Province during the past year.

We approve heartily the action of His Honour's Government in taking effective steps to place the timber resources of the Province at the disposal of the Imperial authorities for war purposes.

We note also with pleasure the intimation that extensive contracts for the building of ships for British and foreign Governments have been entered into by ship-building firms.

We approve the action of His Honour's Government in urging upon the Dominion Government the necessity of completing the contractual obligations of the Canadian Northern Pacific Railway Company within the Province of British Columbia, and that as a result of the representations made construction of the Canadian Northern Pacific Railway on Vancouver Island is progressing. We share the confidence of His Honour's Government that further construction in other parts of the Province will be proceeded with at an early date.

We note with approval the intimation that construction on the Pacific Great Eastern Railway is proceeding satisfactorily, and approve the intention of His Honour's Government to prosecute further extension vigorously during the coming season.

We are grateful to note that appropriations for the purpose of the Department of Public Works have secured the necessary repairs to roads, trails, and bridges.

We shall be pleased to consider the advisability of voting an emergency appropriation for the purpose of providing employment by carrying on development-work during the coming year.

It affords us much gratification to learn that the value of mineral production for the year 1918 shows a substantial increase over that of the previous year, and we are encouraged by the knowledge that the prospects for the coming year are most promising.

We are gratified that the production of coal has been increased, and that new coal areas are in prospect of development.

We shall give careful attention to any amendments to the "Coal-mines Regulation Act" which may be submitted.

We shall give careful consideration to the report dealing with the practicability of electrosmelting of British Columbia iron ores, and are pleased to be informed that engineers appointed to investigate and encourage mining report a feeling of optimism and confidence among both operators and prospectors.

The proposal to re-enact the "Vancouver Island Settlers' Rights Act, 1904, Amendment Act, 1917," will have our careful attention.

We record our appreciation of the action of His Honour's Government, through the Hon. the Minister of Education, in entering into an arrangement with other Western Provinces for the standardization of educational text-books.

Necessary amendments to the "Prohibition Act" will be carefully considered when submitted. We approve the intention of His Honour's Government to bring down legislation disfranchising military deserters and other persons exempted from military service.

We shall take under careful advisement the question of the appointment of a Public Utilities Commission, and legislation submitted for this purpose will have our best attention.

The proposed measure for the establishment of a Public Library Commission and the Bill to provide for the appointment of official school trustees will be deliberated carefully.

Consideration of any measure for the superannuation of Civil Servants and amendments to the "Civil Service Act" which may be submitted will be reviewed carefully.

We shall be pleased to consider any measures for protection from tax sales and for the further relief of returned soldiers which may be proposed.

The Public Accounts for the fiscal year will have our attentive scrutiny.

We shall be pleased to consider the Estimates of Expenditure for the coming year which may be submitted by His Honour's Government for consideration.

We assure His Honour that all measures laid before us shall have our serious and attentive consideration.

Pursuant to Order, the House resumed the adjourned debate on the Address in reply to the Speech of His Honour the Lieutenant-Governor at the opening of the Session.

On the motion of Major Burde, the debate was adjourned to the next sitting of the House.

Mr. Hanes moved, seconded by Dr. McIntosh,—

That, whereas W. J. Bowser, a witness before the Select Committee to inquire into the construction of the Pacific Great Eastern Railway, and who on the 24th day of April, 1917, did refuse to answer questions put to him by the Committee, the Speaker do issue a subpæna or warrant to the said W. J. Bowser to personally appear at the bar of this House, or rise in his place forthwith to answer the said questions and to answer for his said conduct, and to be dealt with as the House may see fit.

Mr. Speaker Keen ruled the motion out of order on the following grounds:-

"This motion of the Hon. Member for North Vancouver is, I think, out of order, as it refers to the action of a Select Committee which does not now exist, and cannot therefore make any report to this House.

"Our Rules only refer to witnesses and the Committee which is dealing with them. Hence I am forced to consult May under our Rule 131. I find that May (12th ed.), page 521, provides the method of ordering witnesses to the bar of this House, and page 522 provides for ordering any Hon. Member to attend in his place for examination, with which this motion is not in accord. I therefore rule the motion out of order."

Mr. Hanes moved, seconded by Dr. McIntosh,-

That whereas D'Arcy Tate, a witness before the Select Committee to inquire into the construction of the Pacific Great Eastern Railway, and who on the 13th day of April, 1917, did refuse to answer questions put to him by the said Committee:

And whereas said D'Arcy Tate neglected or refused to attend before the bar of the House to answer said questions when a warrant was issued by the Speaker to compel him to do so:

Therefore be it Resolved, That the Speaker do issue his warrant or subpæna to compel the said D'Arcy Tate to personally appear at the bar of this House forthwith to answer the said questions and to answer for his conduct, and to be dealt with as the House may see fit.

Mr. Speaker Keen ruled the motion out of order on the same grounds stated in dealing with the previous resolution.

Mr. Bowser moved, seconded by Mr. Ross,-

That an humble Address be presented to His Honour the Lieutenant-Governor, asking him to cause to be laid before this House copies of all Orders in Council passed since the 4th day of September, 1917.

The Hon. Mr. Oliver moved in amendment, seconded by the Hon. Mr. Farris,—

That all the words of the Resolution after the word "Governor" be struck out, and the following words substituted therefor: "praying that he will cause all Orders in Council passed since the 4th day of September, 1917, to be made available for the perusal (within the General Office of the Deputy Provincial Secretary) of the Members of this House at any time during office hours; and further, that such address be prepared and presented by such Members of this House as are of the Executive Council."

A debate arose, which was adjourned to the next sitting of the House.

Mr. W. A. McKenzie asked the Hon. the Minister of Agriculture the following questions:—

- 1. Is Mr. F. R. E. DeHart, of Kelowna, a member of the Provincial Land Settlement Board?

Whereas D'Arcy Tate, a witness called before the Committee to inquire into the construction of the Pacific Great Eastern Railway, and who on the 13th day of April, 1917, was asked the following questions:—

"Mr. Taylor: Now, the question I ask you is, to what extent did you take care of these campaign funds; I want to know what disposition you made of them? A.—Well, I refuse to answer.

"Mr: Taylor: Mr. Tate, I was asking you about two cheques which you were given of \$50,000 each; and you say that there were several others amounting to \$500,000; but there were two cheques issued by P. Welch out of the Pacific Great Eastern Construction Company's moneys, and those were obtained formerly from the Government; the dates are January 16th, 1915, and subsequent dates.

"Q.—To what extent did you take care of campaign funds? A.—I don't think that is a proper question. I fulfilled my duty, and I took care of campaign funds.

"Mr. Taylor: And to what extent did you take care of the campaign funds? A.—I would ask my counsel if that is a proper question for me to answer.

"Mr. Maclean: Well, the position I wish to take is this-

"Witness: In the first instance-

"Mr. Maclean: Just one minute. If the Chairman desires this information I am going to ask Mr. Tate to give it. If you rule, Mr. Chairman, although Mr. Tate does not want to give this information, naturally on account of it being a private matter, yet if you rule that he should give it, and insist that it should be given, then I say Mr. Tate is bound to submit to the ruling of the Chair.

"The Chairman: Mr. Tate is not bound to submit to a ruling of this Chair unless it is right, and I understand by Tate he was obligated by the promoters and joint promoters of this scheme to take from the funds that he obtained in this way—he was to take care of the campaign fund; and my ruling is that that is all pertinent to this inquiry. It is not a case of what I desire or don't desire. I am simply here to give my ruling, and I rule it is pertinent to this inquiry.

"Mr. Taylor: Will you answer the question now, Mr. Tate? How much of this \$500,000—how much of the moneys (you stated them as being \$500,000, and if they were more we will not limit them to that) have you contributed to campaign funds for any party? I don't care what the party is. I want you to name the party afterwards? A.—Well, I still think, Mr. Taylor, that I should decline to answer that question, as being outside the scope of this investigation.

"Q.—Do you refuse to answer? A.—I have to take that responsibility, I am afraid.

"Q.—Then, I understand that you defy the ruling of the Committee? A.—That is not a proper word to use—'defy.'"

And whereas said D'Arcy Tate refused to answer said questions:

And whereas said D'Arcy Tate did not attend before the bar of the House to answer said questions when a subpœna or warrant was issued by the Speaker of the House to have him do so:

Therefore be it Resolved, That an Order of the House be granted that the said D'Arcy Tate do personally appear at the bar of this House on the 11th February, 1919, or on such other date or dates as may be fixed upon for that purpose by the Speaker of the House, to answer the said questions and any other relative questions, and to be dealt with as the House may see fit.

Mr. Ross, on a point of order, objected to the Resolution as being the same as a Resolution moved on February 5th on the same subject-matter.

Mr. Speaker Keen ruled the motion to be in order.

A debate arose, which was adjourned until to-morrow.

On the motion of the Hon. Mr. Oliver, seconded by the Hon. Mr. Pattullo, it was Resolved,—
That the petition of the Taylor Engineering Company by A. J. Taylor and the petition of
the Dolly Varden Mines Company be referred to a Select Committee of this House, consisting
of Messrs. Whiteside, Pauline, Yorston, W. A. McKenzie, and Cowper, with instructions to inquire

into all the allegations contained in the said petitions, and to report its findings and recommendations to this House; and that the said Committee shall have power to call for the attendance of persons, the production of books, papers, and all things necessary in carrying out a full inquiry; and the Committee shall have power to administer oaths or affirmations and to take evidence under oath.

On the motion of the Hon. Mr. Oliver, seconded by the Hon. Mr. Farris, it was Resolved,—That the Public Accounts for the year 1917-18 be referred to the Public Accounts Committee.

Mr. Bowser asked the Hon. the Minister of Finance the following questions:-

- 1. What amounts have been borrowed by the Government from all sources since it took office in 1916?
 - 2. From whom was it borrowed and under what authority in each case?
 - 3. What rate of interest does each loan carry on its face?
- 4. What rate of interest does each loan actually cost the Province, including all discounts and commissions?
 - 5. Were any commissions paid on account of any of these loans?
 - 6. If so, to whom, and their amount?
 - 7. How much is still due on account of said loans?
 - 8. When are each of these loans to be paid?

The Hon. Mr. Hart replied as follows:-

- "1. On account Municipality of the District of South Vancouver, \$790,000 (against which are held as collateral bonds of the municipality amounting to \$989,902.58); on account Land Settlement Board, \$800,000; on account Pacific Great Eastern Railway Company, \$1,520,000; on account Consolidated Revenue Fund, \$4,000,000.
- "2. Amounts for Land Settlement Board were obtained through sale of debentures to the Workmen's Compensation Board under authority of the 'Loan Act, 1917'; amounts for Pacific Great Eastern Railway borrowed from the Canadian Bank of Commerce under authority of the 'Loan Act, 1916'; South Vancouver was in exchange of securities under authority of the 'South Vancouver Aid Act, 1918'; \$1,000,000 for the Consolidated Revenue Fund obtained from Brent, Noxon & Co. under authority of the 'Loan Act, 1916'; \$3,000,000 borrowed from the Dominion of Canada under authority of the 'Loan Act, 1918.'
- "3. South Vancouver, 6%; Compensation Board, 61/8%; Pacific Great Eastern, 5%; Brent-Noxon loan, 5%; Dominion loan, 6%.
- "4. Compensation Board, 61/8%; Pacific Great Eastern, 5%; Brent-Noxon loan, 6.88%; Dominion loan, 61/8%.
 - "5. No commissions were paid.
 - "6. Answered by No. 5.
 - "7. Total amounts.
- "8. South Vancouver loan, 1923; Land Settlement Board, 20 years; Pacific Great Eastern are 6-month Treasury bills; Brent-Noxon loan, 10 years; Dominion loan due 1923 but may be paid sooner."

Mr. Bowser asked the Hon. the Attorney-General the following questions:-

- 1. What is the total amount to date which has been paid A. Henderson, K.C., of Vancouver, or his legal firm, by this Government since it took office for professional services?
- 2. What was the date of the last services rendered by said Henderson to the Attorney-General's Department or any other department?

The Hon. Mr. Farris replied as follows:-

- "1. Total amount, 1917, \$1,798.70, made up as follows: Vancouver Spring Assizes, counsel fees and disbursements, April 16th to May 15th, \$1,180.45; Kamloops Fall Assizes, counsel fees and disbursements, October 5th to October 19th, \$618.25. Total amount, 1918, \$125, made up as follows: Re Mary Ann Wigman, counsel fees on Habeas Corpus application, May 20th to May 31st, \$50; re B.C.E.R. and City of Vancouver, counsel fees, August 14th to August 17th, \$25; re Vancouver Club prosecutions, "Game Act," counsel fees, November, December, \$50.
- "2. Answered by No. 1."

Mr. Ross asked the Hon. the Minister of Lands the following questions:-

Mr. Ross asked the Hon. the Minister of Lands the following questions:-

2. If any such leases have been applied for or granted, what are the names and addresses of the applicants and the locality of land in each case?

Mr. Ross asked the Hon. the Minister of Lands the following question:-

The Hon. Mr. Pattullo replied as follows:-

Mr. Bowser asked the Hon. the Attorney-General the following questions:-

- 1. Was the Resolution of the House passed on April 16th, 1918, relative to the abolition of Grand Juries communicated to the Federal Government?
 - 2. If so, what reply was given?

The Hon. Mr. Farris replied as follows:-

- "1. Yes.
- "2. No reply."

Mr. Ross asked the Hon. the Minister of Mines the following question:-

What public sampling-works, concentrating plants, custom smelters or refineries, or other plants or processes (if any) have been acquired, constructed, maintained, or operated under the provisions of section 3, chapter 43 of Statutes of 1917 ("Ore Purchasing and Treatment Act")?

The Hon, Mr. Sloan replied as follows:-

" None."

Mr. Ross asked the Hon, the Minister of Mines the following question:-

Has a Department of Ore Purchasing been established, maintained, or operated under the provisions of section 11, chapter 43, Statutes of 1917 ("Ore Purchasing and Treatment Act")?

The Hon, Mr. Sloan replied as follows:-

" No."

Mr. Bowser asked the Hon, the Minister of Finance the following questions:—

- 1. Is the Government now arranging for another loan?
- 2. If so, how much, and at what rate of interest?
- 3. Is the Government contemplating floating any more loans in the near future?
- 4. If so, for what amount?

The Hon. Mr. Hart replied as follows:-

Dr. McIntosh asked the Hon, the Minister of Lands the following questions:—

- 4. Did the Government consult the Land Settlement Board before purchasing?
- 5. If not, why not?

- 7. If so, at what price or prices?

- 8. If purchased, did the Minister of Lands agree to the purchase before consulting the Government?
 - 9. Had the Government any knowledge of the land being offered at a lower figure?
- 10. Did the Minister of Lands, before purchasing this land (if it was purchased), consult the Land Settlement Board as to the advisability of purchase, and as to the price of this property?
 - 11. If not, why not?
- 12. Did the Government or Minister of Lands consider the purchase of the Coldstream Ranch?
 - 13. If so, at what price was it offered?
- 14. Did the Government or Minister of Lands consult the Land Settlement Board as to the advisability of purchasing this property?

The Hon, the Premier on a point of order objected to the question as asking for declaration of Government policy.

Mr. Speaker Keen sustained the objection. (See Speakers' Decisions, page 128.)

Mr. Ross asked the Hon. the Minister of Finance the following question:

Is it the intention of the Department to provide better facilities than now exist for assessment purposes for the residents of Fort George Electoral District by establishing an office at Prince George instead of Quesnel?

The Hon. Mr. Hart replied as follows:—

Mr. Ross asked the Hon. the Minister of Lands the following questions:-

- 1. What leases (if any) have been applied for or granted under the provisions of section 79, subsection (2), chapter 129, R.S.B.C., 1911, as enacted by section 23 of chapter 43, Statutes of 1918?
- 2. If any such leases have been applied for or granted, what are the names and addresses of the applicants and the locality of the land in each case?

The Hon. Mr. Pattullo replied as follows:-

Mr. Ross asked the Hon. the Minister of Lands the following question:-

What were the amounts at the credit on December 31st, 1918, of the following accounts: (a) Lands Department Trust Account; (b) Forest Branch Trust Account; (c) Water Rights Branch Trust Account?

The Hon. Mr. Pattullo replied as follows:-

- "(a) Lands Branch Trust Deposit, \$72,641.68; (b) Forest Branch Trust Deposit, \$86,128.42; (c) Water Branch Trust Deposit, \$35,403.46."
 - Mr. Bowser asked the Hon, the Provincial Secretary the following questions:-
- 1. Has the practice of publishing appointments in the Gazette to the Civil Service been discontinued?
 - 2. If so, when was this done?
 - 3. How many years prior was this practice carried on by former Governments?
 - 4. What are the reasons for not gazetting said appointments?
- 5. What opportunity has the public now for knowing who has been appointed to the public service?

The Hon. Dr. MacLean replied as follows:-

- "1. In part.
- "2. July 1st, 1918 (on appointment of Civil Service Commissioner).
- "3. Practice having varied from time to time no definite reply can be given.
- "4. To avoid duplication of work. All appointments to the Civil Service will appear in the Annual Report of the Civil Service Commissioner.
 - "5. Answered by No. 4."

Mr. Bowser asked the Hon. the Premier the following questions:-

- 1. Upon what basis was the recent bonus to Civil Servants given?
- 2. To whom was it paid, giving names and the amount each one was receiving at the time as a monthly salary, the amount of the monthly bonus, and the amount paid to date to each person?
 - 3. Under what salary was the bonus paid?
 - 4. Was the bonus paid to every Civil Servant under this salary?
 - 5. If not, who was omitted, and why?

The Hon. Mr. Oliver replied as follows:-

- "1, 2, 3, 4, and 5. The recent bonus to Civil Servants was granted on the following basis, namely: Such amounts as the deputy of each department certified as being necessary and desirable within the following limits:—
 - "Bonus to be figured on the basis of the salaries on the pay-roll of March 31st, 1918.
- "Full bonus to those in the Service since April 1st, 1918; to persons appointed since April 1st, 1918, proportionate amount.
- "Where salaries have been increased since March 31st, 1918, owing to promotion to more important duties, such increase not to affect the bonus; otherwise increases since March 31st, 1918, figured to March 31st, 1919, to be deducted from the bonus. In the case of an employee with dependents receiving less than \$125 per month, this deduction not to reduce bonus below \$60.
- "No bonus to exceed two months' salary; nor be in excess of the amount that will make the total remuneration for the year equal to what may be received by the lowest paid in the next highest class.
- "No person to be entitled to such portion of the bonus as remains unpaid should they leave the Service prior to March 31st, 1919.
 - "'With dependents' to be defined as being the sole support of the persons referred to.
- "Bonus to be paid 40 per cent. forthwith, 20 per cent. with the salaries of January, February, and March, 1919, respectively.
 - "(a.) To employees without dependents receiving less than \$125 per month, a bonus of \$60.
 - "(b.) To employees with dependents receiving from \$50 to \$99 per month, a bonus of \$180.
 - "(c.) To employees with dependents receiving from \$100 to \$124, a bonus of \$140.
 - "(d.) To employees with dependents receiving from \$125 to \$149, a bonus of \$100.
 - "(e.) To employees with dependents receiving \$150 to \$174, a bonus of \$60.
- "The names and amount of bonus is set out on the following Orders in Council: 1918, December—2771, Department of Lands; 2772, Department of Public Works; 2773, Department

of Provincial Secretary; 2774, Department of Agriculture; 2775, Department of Premier; 2776, Department of Attorney-General; 2777, Department of Finance; 2778, Department of Education; 2779, Department of Fisheries; 2780, Department of Labour; 2781, Department of Mines; 2800, Department of Land Settlement. 1919, January—108, Department of Lands; 109, Department of Provincial Secretary; 110, Department of Attorney-General; 111, Department of Finance; 112, Department of Public Works; 113, Department of Agriculture; 115, Department of Railways; 121, Department of Provincial Secretary."

The Hon. Mr. Barrow replied as follows:-

Mr. Bowser asked the Hon. the Provincial Secretary the following questions:—

- 2. When was he appointed and at what salary?

- 4. What allowance did he receive for services as Commissioner?
- 5. What is the age of the present Civil Service Commissioner?
- 6. When was the "Civil Service Act" brought into force?
- 7. How many appointments have been made since the "Civil Service Act" was brought into force, and what are their names, positions, and salaries?
- 8. How many competitive examinations have been held under section 8 of the "Civil Service Act," and who competed and who was successful in each case?
- 9. Were notices of these competitive examinations published in the Gazette as required by section 11 of the "Civil Service Act"?

The Hon. Dr. MacLean replied as follows:-

The Hon. Dr. King replied as follows:-

- 6. Is it the intention of the Government to utilize all such lands exclusively for occupation by returned soldiers?

The Hon. Mr. Pattullo replied as follows:-

- "2. Approximately 22,000 acres in South Okanagan. In addition to lands purchased, other areas have been reserved exclusively for soldiers.

Therefore be it Resolved, That the requests set forth be humbly recommended to the Dominion Government to instruct the proper officers to grant the request for the enlargement of the inquiry.

Be it further Resolved, That an humble Address be presented to His Honour the Lieutenaut-Governor, praying that a copy of the preamble and Resolution hereinbefore set out be transmitted forthwith to the Honourable the Secretary of State (or other proper officer) at Ottawa.
