In reference to alteration of Land under Pre-emption Record and Crown Grant Application.

Sir,—I have the honor to apply for a Crown Grant of my pre-emption claim No. 1170, situated at Boundary Bay.

I enclose original pre-emption record, No. 1160, to J. Brennan, with transfer to him from C. Hunt, No. 5, and certificate of improvement to C. Hunt, No. 13; also transfer from Brennan to myself, No. 8, and pre-emption record, No. 1170.

Gemmell's pre-emption record, No. 1170, New Westminster District, and in which you state that I offered him, under date 20th April, 1874, a piece of land not included within his record, and not as valuable; and, in reply, beg to inform you that my object in making the offer above referred to was in order to facilitate his obtaining a Crown Grant by conforming to lines as surveyed; but as he did not accept the offer the matter ended there.

Subsequently, Mr. Mahood was dispatched to adjust the boundaries of pre-emptors in this Township, but Mr. Gemmell was absent, and nothing further could be done.

I beg, therefore, to call your attention to the Notice in the British Columbia Gazette, under date 3rd October, 1874, as I believe the pre-emption record above referred to covers land in Section 10, Township No. 1.
