- "3. The application was refused as the municipality has no legal claim to any proportion of such statutory payments."

The Hon. Mr. Taylor replied as follows:-

- "2. The stock of the Pacific Great Eastern Railway Company is held as follows: Firm of Foley Bros., Welch & Stewart, 186,750 shares; D'Arcy Tate, 62,490 shares; Timothy Foley, 240 shares; J. W. MR. SPEAKER:

Your Select Standing Committee on Municipal Matters beg leave to report as follows:— Your Committee has carefully considered, at numerous sittings, the provisions of Bill (No. 8) intituled "An Act to amend the 'Municipal Act.'"

A number of amendments to the Bill as well as to the general "Municipal Act" were submitted for the consideration of the Committee on behalf of certain ratepayers and certain classes of ratepayers as well as on behalf of the Union of British Columbia Municipalities. Such amendments as have been approved by the Committee have been incorporated in the Bill which is now recommended to the favourable consideration of the House.

All of which is respectfully submitted.

Mr. Macgowan asked the Hon. the Premier the following question:-

What (if any) action does the Government propose to take in connection with lands, coal rights, water rights, stocks in companies, and other properties owned or held by Germans or their representatives in British Columbia?

The Hon. Mr. Bowser replied as follows:-

"By section 91 of the 'British North America Act' the Parliament of Canada has exclusive legislative authority in all matters relating to aliens, and therefore we have no power to legislate so as to discriminate against aliens."

Mr. Macgowan asked the Hon, the Premier the following question:-

Does the Government propose to take any action along lines similar to Australia in the disfranchisement of German-born electors for the period of the present war?

The Hon, Mr. Bowser replied as follows:-

"The Government is now considering this question."

Mr. M. A. Macdonald asked the Hon, the Minister of Mines the following questions:-

- 1. What number of leases have the Spruce Creek Power Company obtained from the Crown on Spruce Creek, in the Atlin Mining Division, and at what rentals?
 - 2. What rentals (if any) are in arrears, giving the amount?
 - 3. Up to what year have the rentals been paid?
- 4. What water records have been granted by the Crown to the company, and what is the amount of arrears for rentals (if any)?
 - 5. Is the company at present operating the leases, or any of them; and, if so, what leases?
 - 6. Has the Government taken any steps to collect the rents; and, if so, what steps?

The Hon. Mr. Campbell replied as follows:-

- "1. Sixteen, as follows: Six creek leases at \$75 annual rental; ten bench leases at \$50 annual rental, with \$1,000 annual expenditure in development-work on each lease.
 - "2. To December 31st, 1915, \$7,175 on all.
 - "3. Eight paid to 1908; eight paid to 1909.
 - "4. Water Records No. 11 and No. 92; \$4.20 and \$67.20 respectively.
 - "5. Yes; No. 187 ('Pretoria') and No. 228 ('Bloemfontein').
- "6. Company has been in prolonged litigation. Its attention has at various times been called to the matter of rentals. The litigation being ended, the company is now arranging for payment of arrears of rental."

Mr. M. A. Macdonald asked the Hon, the Minister of Lands the following questions:—

- 1. What is the total amount of money collected from the owners of timber lands and the holders of timber licences, for the purposes of the Forest Protection Fund, during each of the years 1912-13, 1913-14, 1914-15, 1915-16?
- 2. What is the total amount contributed to the said Forest Protection Fund during each of the years before mentioned?
- 3. What is the total amount of lumber reported as cut in the Province during the year from January 1st, 1915, to December 31st, 1915, as per section 22 of chapter 76 (1912)?
- 4. What is the total amount returned as the wholesale selling price of such lumber, free on board-at point of manufacture, as per section 22, chapter 76 (1912)?

The Hon. Mr. Ross replied as follows:-

"1. For the fiscal years from April 1st to March 31st the collections for the Forest Protection Fund from the owners of timber lands and other holders of licences and leases were as follows:—

"The totals as shown in the Public Accounts include certain refunds made by railway companies and others for patrol and fire-fighting which are not included as contributions within the meaning of this question.

"In replying to questions 1 and 2, I should point out that section 125, subsection (2), of the 'Forest Act' provides that the Government should contribute from revenue amounts equal to the sums receivable from owners of timber lands and holders of licences, etc. The estimated areas in respect of which contributions are thus payable to the fund are:—

Licences	8,460,000	acres.
Leases	945,000	,,
Crown grants	1,669,199	,,
Total	11,074,199	acres.

"At 1½ cents per acre, therefore, the sums receivable from owners and holders of timber lands and from the Government should each be approximately \$166,000 per annum, the total revenue of the fund being thus in the neighbourhood of \$332,000 per annum.

"The Government contribution thus being in each year in the neighbourhood of \$166,000, an amount is voted annually in the Estimates by way of deposit to meet this charge.

"At April 1st, 1914, taking contributions on a dollar-for-dollar basis, the fund had a credit of \$15,144.83. The severe financial depression, intensified by the outbreak of war in the following August, reduced immediate collection, while at the same time the Province experienced what was in many ways the worst fire season on record. Consequently there was a very heavy expenditure on fire-fighting during the summer, and in order to carry the fund until collections should come in a special warrant of \$100,000 was approved on January 15th, 1915, and placed to the credit of the fund. This amount will be repaid from collections, and as it is not a contribution but a loan, it is not included among the contributions in the answer to question 2. Although the 'Forest Act Relief Act' allows payments to be temporarily deferred during the war, the Forest Protection Fund contributions must be paid before any licensee taking advantage of this 'Relief Act' can reinstate his licence. Hence there is full security for all arrears. The fund, moreover, improved its position during the past year by a substantial surplus over operating cost. For these reasons it would be somewhat premature at the present time, under the exceptional circumstances created by the war, to make any pro rata increase in the levy for this year.

"Should it prove at the expiry of the 'Relief Act' that any licences now in arrears are not reinstated, then the amounts contributed by the Government to the Forest Protection Fund in respect to the areas comprised in such licences will be refundable to the Treasury.

"3. The total amount of lumber cut in 1915, as referred to in section 22 of chapter 76 of the Statutes of 1914, has not yet been obtained.

"4. The wholesale selling-price of such lumber is not computable until the returns of cut lumber referred to in the previous question have been obtained.

"I should point out that the work involved in carrying out section 22 of the 'Timber Royalty Act' is very considerable, and in view of its complex character, and the need of establishing, from the start, an efficient system of returns under the Act, it necessitates the special assignment of officials thoroughly familiar with the lumber industry and departmental work.

While a small vote of \$5,000 was included in last year's Estimates for the expense of this work, it was not necessary for it to be undertaken until the present year. As the officials in question were not available owing to the depletion of staff by enlistment last year, and the pressing need for assisting the lumber industry in the crisis through which it has been passing by a campaign for wider markets for British Columbia products, a revote of the \$5,000 has been made in the Estimates just passed for the carrying-out of the work during the present calendar year."

Mr. Brewster asked the Hon. the Minister of Education the following questions:-

- 1. Has the Government established an assisted school on Pender Island?
- 2. How many children attend such assisted school?
- 3. What is the area of the Port Washington School District?
- 4. Who are the owners of the land embraced in the Port Washington School District?
- 5. What amount of school taxes is contributed by the owners of land in the Port Washington School District?
- 6. What was the amount of taxes contributed by the owners of land in Port Washington School District to the Pender Island School before the separation?

The Hon. Mr. Taylor replied as follows:-

- "1. Yes.
- "2. Since the opening of the school in August, 1915, twelve children have been enrolled; the average daily attendance for March was 9.60.
 - "3. 975 acres (approximately).
- "4. Andrews Bros., A. Davidson, L. G. Hamilton, Max Enke, J. McKinnon, Wm. Reid, Thos. Reid, J. Willey, James Simpson, S. Percival, M. Walsh, H. Bagshaw, Wm. Falconer, W. P. Holland, L. H. Shapter (Est.), A. K. Richardson, N. N. Grimmer, P. H. Grimmer, G. W. Grimmer, Washington Grimmer, H. G. Scott, F. Moore, Miss Bradley, J. F. Cartnell, Captain P. Nye, P. M. Newnham, Ferguson Bros., and C. A. Proctor.
 - "5. No assessed school taxes for 1916.
 - "6. \$77.10 contributed in 1915."

Mr. Williams asked the Hon. the Minister of Education the following questions:-

- 1. Has the Government erected public schools at the following points: Powell River, Britannia Mine, Britannia Beach, Granby Bay, Bevan?
- 2. If so, has land on which buildings are erected been deeded to Board of Trustees or Government?
- 3. If not so deeded, why has departmental rule requiring site to be conveyed been varied in the case of these towns?
 - 4. Is there a public highway leading to all or any of these schools?

The Hon. Mr. Taylor replied as follows:-

- "1. A four-room Government school-house was erected at Powell River in 1912; a two-room school at Bevan (No. 7 Mine) in 1912; and a two-room school has just been completed at Granby. The Government has not yet erected school-houses at Britannia Mine nor at Britannia Beach.
 - "2. Yes, in the case of Powell River and of Bevan.
- "3. At Granby the need of a school-house was so urgent that the Department decided to proceed with the erection of the building on receipt of a promise from the Granby Consolidated Mining, Smelting, and Power Company that they would secure in favour of the school trustees a ninety-nine years' lease of a school-site from their New York directors. The Department is unable to state whether this agreement has yet been implemented.
- "4. A public highway leads to the Bevan School; the Powell River School is built on certain town lots and is presumably accessible by road or street; no information is at present available regarding means of access to the Granby site."

Mr. M. A. Macdonald asked the Hon. the Minister of Finance the following questions:-

- 1. What is the total cost of printing the full report of the Royal Commission on Agriculture?
- 2. Was any other printing done by the King's Printer for this Commission?
- 3. If so, at what cost?

The Hon. Mr. Campbell replied as follows:-

- "1. Full report, 2,000 copies, \$1,522,21.
- "2. Yes.
- "3. First report, 10,000 copies, \$427.50; office stationery, etc., \$59.15."
